OF THE

EASTERN BAPTIST ASSOCIATION.

PORTAUPIQUE, Saturday, July 3rd, 1858.

The Association met at Portaupique on Saturday, July 3rd, 1858, in accordance with the Resolution of last year. In the absence of the Moderator and Clerk of the previous year, the meeting was called to order by the Pastor of the Church, Rev. James Reid, at 2, P. M. Prayer having been offered by Rev. A. D. Thomson, the following officers were chosen by ballot :- Moderator, Rev. E. F. Foshay; Clerk, Bro. H. C. Upham; Assistant Clerk, Bro. Benj. Douglass; Treasurer, Bro. Cyrus Black.

Resolved, That the destitution in so many places in our country of the stated preaching of the gospel renders obligatory upon us greater exertion in this department of Christian labor; and this Association does therefore most earnestly recommend to the Churches it represents increased zeal and benevolence in the Home Mission work, and that the delegates now present use their exertions, either by the formation of Societies, auxiliary to the Home Missionary Society, or by such other means as shall be deemed expedient, greatly to increase the contributions of the Churches.

Report of Committee on Education presented by Rev. Dr. Cramp. Addresses were delivered by Rev'ds. Dr. Cramp, A. D. Thomson, Wm. Hall, J. E. Balcom, D. W. C. Dimock, and the Report was adopted. (See Appendix E.)

Committee on Christian Messenger presented their report, which was adopted, after remarks by Rev'ds Dr. Cramp, D. W. C. Dimock, and others. (See Appendix G.)

Brethren W, Faulkner, J. King, C. Black, B. Douglas, and W. F. Cutten were appointed Delegates to the Convention.

Report of Committee on Sabbath Observance presented, and after remarks by Revd's. W. Hall, J. Reid, and Brother T. Soley, adopted. (See Appendix H.)

After kind and complimentary remarks by several brethren, the following Resolution was unanimously adopted:—

Resolved, That the thanks of this Association are hereby tendered to the Brethren of Portaupique, Economy, and Great Village, for their kind and Christian hospitality, and the enlarged liberality with which they have entertained the Ministers and Delegates composing this Association.

The Committee on Sabbath Schools having failed to report, the following Resulution was adopted:

Resolved, That this Association esteem the religious education of the young to be of paramount importance, deeply so, to the present, and in all probability, to the rising generation, and they would earnestly recommend to the Churches, the establishment and cordial support of Sabbath Schools and Bible classes.

The following Resolution was also unanimously adopted :-

Resolved, That in view of the great mercy of our Heavenly Father, which has been bestowed upon many of our Churches during the past year, in their being revived, and receiving additions to their numbers, of souls converted by the grace of God,—we hereby thank the Divine goodness, and implore the gracious assistance of the Holy Spirit to lead us on to a fuller consecration of ourselves to the service of God.

After which Prayer was offered by Rev. D. W. C. Dimock, the Union Hymn sung, and the Association adjourned to meet next year at Pugwash, the Moderator having pronounced the benediction.

CIRCULAR LETTER.

TO THE CHURCHES COMPOSING THE EASTERN NOVA SCOTIA BAP-TIST ASSOCIATION.

Dear Brethren,—Since we last addressed you much has transpired in our world to cheer the friends of Zion. In the neighbouring republic God has poured out his Spirit in a remarkable manner, reminding us of the gracious promise—"a nation shall be born in a day," and that the time is drawing near when the knowledge of His glory shall cover the earth as the waters do the channels of the great deep. In this gracious revival the Baptist churches have shared largely, and when we look at the rapid progress that Baptist principles have made during the last fifty years, and believing, as we do from the Bible and History, that amid the fires of persecution, and the tortures of the Inquisition, the Baptists have kept the ordinances as they were delivered by the great Head of the Church, we cannot but feel that our mission is peculiar, and fraught with heavy responsibilities.

In order that we may do the work assigned by our Heavenly Father it is not only necessary that we cultivate personal piety, but we must carry out the discipline of the Church as taught in the Bible. Nothing will more effectually destroy the religious influence of a church, and render inefficient the preaching of the Gospel, and all means of grace that she may employ, than the neglect of this duty. In the days of Joshua Israel could not stand before her enemies while iniquity was harbored among the people (Joshua vii., 5). David says, "If I regard iniquity in my heart the Lord will not hear me."

What David said of himself is also true of a church, if she winks at sin in her members, in vain do they gather together the name of our Lord Jesus Christ to withdraw from every brother that walketh disorderly. The Scriptural separation of an offending member from the Church will prove an inestimable blessing to him, if by it he be brought to repentance and is a sincere Christian, as well as to the Church from which he is removed. Says the Apostle Paul, "deliver such a one to Satan for the destruction of the flesh that the Spirit may be saved in the day of the Lord Jesus Christ." cipline we do not barely mean the separation of unworthy members from our Communion. Necessary as this may be it is only a small part of the work. This should not be left to the Pastor, as unhappily it too often is, but is a solemn duty which belongs equally to every member of the Church.

In the proper execution of Gospel discipline much may, and ought to be done, by the members individually, and much of the peace and purity of a church depends upon the faithful discharge of these duties. Many differences have been brought into churches, which have marred their peace and retarded their progress, that might have been settled by individual Before any difficulty is allowed to enter the Church the rule laid down in the 18th chapter of St. Matthew should be carefully attended to. If we are walking in the light and comfort of the Gospel we will never seek to expose our brother's faults, by telling them even to the members of the same church, but, on the contrary, if we see one of our brethren fall we will make some effort to give him the helping hand, considering ourselves lest we also be tempted, and bearing in mind the words of the Apostle, "Let him that thinketh he standeth take heed lest he fall."

In this way we may bear each others' burdens, and so fulfil the law of Christ. The Scriptures give particular encouragement to believers in the use of personal and private efforts for

"If any of you do err aiding each other in the divine life. from the truth, and one convert him, let him know that he that converteth a sinner from the error of his ways shall save a soul from death, and hide a multitude of sins." The following remarks, made by Rev. Andrew Fuller, on personal effort are to the point:-" In cases of evil report, where things are said of a brother in our hearing, which, if true, must affect his character and the purity of the church, it cannot be right to go on to report. Love will not lead to this; many reports, we know, are unfounded, or if true, in the main they have been aggravated, or there may be circumstances attending the case which, if fully understood, would make things appear very different from the manner in which they have been represented. Now it is almost impossible that any one but the party himself should be acquainted with all the circumstances, or be able to give a full account of them. No time, therefore, should be lost ere we enquire at the hand of our brother, or, if on any consideration we feel that to be unsuitable, it would be proper to apply to the Pastor of the Church, who may conduct it with greater propriety." If the Saviour should make known to us the condition of our churches, as he did to the seven churches of Asia, the state in which they were, while we hope that there is much that he would approve, have we not reason to fear that there is much in our discipline which he would condemn, as he did also those things which he exposed so faithfully in them?

Let us then, dear brethren, examine ourselves by the light of inspiration, and seek in all things to be conformed to the Word of God, that, as churches, we may prosper, and do the work

REPORT OF COMMITTEE ON THE BIBLE CAUSE.

The Bible is more extensively circulated and more closely studied than at any former period in the world's history. Immense sums are annually expended in translation and distribution; the most powerful minds are engaged in critical labor; and illustrations of its pages are continually sought, and obtained, in the prosecution of antiquarian research. No book has been so scrutinized and tested. Its trial has uniformly resulted in "praise, honor, and glory."

Without referring particularly to the various institutions that have been founded for the translation and circulation of the oracles of God, the Committee express their hope that the Churches of this Association will constantly recognize the duty of sharing in this glorious enterprise, and that their contributions for the object will be proportioned to its importance.

Habitual use of the Scriptures is undoubtedly incumbent on all Christians. They should also be earnestly desirous of promoting reverential regard for the Holy Book amongst all classes. It should be daily read, consulted, and honored in the family and in the school. Every young person should be taught to "cleanse his way" by "taking heed thereto" according to God's word.

The Bible is the Baptists' statute-book. They have no other law in religious matters. Under bondage to no man, they are the Lord's freemen. They ask no aid from the civil power, in in regard to things religious, either in the form of compulsion or gift. As they would not themselves submit to the dictation

of Pope, prelate or presbytery, so they would avoid the very semblance of dictation to others. They have greviously suffered heretofore from ecclesiastical tyranny, but they would not be guilty of imposing on their fellow-men. While they would place the Bible, if possible, in the hands of all, they could not enforce its use by law. Conscience, however ill-directed, must be left to its freedom.

REPORT OF COMMITTEE ON TEMPERANCE.

Your Committee are deeply impressed with the conviction that it is the imperative duty of every person to abstain from the use of ardent spirits and to endeavor to advance the cause of Intoxicating liquors are still drunk in our Province to a great extent. Many disgraceful cases of drunkenness Temperance. occurred at the last Election in this county. many places where ardent spirits are sold; where many of our fellow-beings are ruining both themselves and their families, and causing iniquity to abound in our land. use of spirituous liquors as one, of the most powerful engines by which the Wicked One maintains his kingdom in this pre-Your Committee therefore would affectionately request all the Pastors and Members of the Churches to exert all their influence in this noble and commendable enterprise. Let us endeavor to enlighten the public mind concerning this great evil, by frequently lecturing on Temperance, and by circulating Temperance publications. Let us also use all legitimate means to obtain a Prohibitory law, similar to that now in force in the State of Maine.

In regard to the Address, which has been sent to us by the Grand Division of the Sons of Temperance in Halifax, we recommend that it be resolved, That this Address be cordially received; that we heartily concur in the remarks contained in that document; and that we will endeavor, by all means in our power, to advance the cause of Temperance in all our Churches

Churches.

In connexion with the use of ardent spirits your Committee beg leave to affirm, that it is their decided opinion that the use

of Tobacco is also injurious, both to the body and the mind. Much money is wasted in purchasing it. Much time is spent in using it; and Physicians generally avow that it injures the human frame. And may it not also be said that this evil habit is frequently the occasion of leading many of our young people to the card-table, the ball-room, and other haunts of vice? Your Committee therefore would express the hope that all the members of our Churches and all others who love their fellowmen would be disposed to give up the use of tobacco, which is so injurious and so costly, and to consecrate the amount hitherto spent upon it to benevolent objects.

REPORT OF COMMITTEE ON THE HOME MISSIONS.

Your Committee do not hesitate to commend to the Churches the cause of *Home Missions*, as presenting the largest of all yearly demands upon their sympathies and contributions. Still the cry of weak and declining Churches, and the more urgent call from places long destitute of the preached gospel, come to our ears with imploring earnestness. These claims, as they are investigated from month to month, only show us greater delinquencies in the past and more work for the future. If we would be true to our master, to ourselves, and to the perishing around us, we must not forget what remains to be done at home. While so much of our country—our own beloved country—is unevangelized, we may not deal with a slack hand.

Your Committee are happy to learn that the Board of the Nova Scotia Missionary Society have prosecuted their labors during the past year with so much encouragement and success. From the report of the Board, it appears that the numbers of stations, or permanent missions occupied by our missionaries is 4; that 57 out-stations and other places have been visited; that upwards of 166 weeks' labor have been performed; 592 sermons preached, 156 lectures delivered; 982 pastoral calls and visits to families made, and 18 persons baptized; that the income of the Society has amounted to £446 6s. 104d., and its expenditures to about £407—leaving a balance of nearly £40.

The Academy at Horton, new under the superintendence of Mr. Hartt, has been greatly blessed. Many who have received instruction there are occupying posts of usefulness and honor. It is very desirable that the number of pupils be increased, especially on account of the College, which is almost entirely dependent on the Academy for a supply of Students. The Committee earnestly recommend the Institution to Baptist parents. They may be assured that the Executive Committee will continually exert themselves to increase its efficiency, and adapt its appropriate the selves to increase its efficiency, and

adapt its arrangements to the demands of the age.

The past year, your Committee learn, has been a trying one for Acadia College. In a pecuniary point of view the pressure has been unexampled. A special meeting of the Convention was called, in order to take the state of affairs into consideration, and to devise, if possible, remedial measures. meeting was held at Wolfville on the 4th ult. After much inquiry and discussion, a resolution was unanimously passed, to the effect that the College should be sustained. only be accomplished by vigorous benevolence, on an enlarged The Denomination, it may be confidently hoped, will respond to the appeal. Encouraging success has already attended the labors of the Rev. A. D. Thomson, the Agent, who has secured the addition of about £1700 to the Endowment Fund, besides collecting a considerable sum for the annual expenses of the College. A separate agency for the latter purpose has been recently engaged in by the Rev. D. Freeman, of Halifax.

Professor Stuart left the College in March last. The vacancy thus occasioned will be filled, your Committee have reason to believe, by some gentleman that has formerly studied

in the Institution.

During the past year, twenty-four Students have been in attendance, six of whom graduated at the Anniversary on the 3rd ult. Six have matriculated, who will commence their studies next Term; others will probably be added to their number.

Eleven students have received instruction in the Theological Institute. One of them, the Rev. E. O. Read, has been ordained Pastor of the second Horton Church. Three of the former students have been ordained since the last meeting of this Association, viz.:—Rev'ds. T. A. Higgins, at Liverpool, D. M. Welton, at Windsor, and R. D. Porter, at Dartmouth.

In conclusion, the Committee commend the Educational Institutions of our Denomination to the generous sympathies of the members of this Association. Our influence in the community must depend on the amount of our knowledge and piety. Without knowledge, piety will be weak and vapoury; without piety even knowledge may be devoid of blessing.
