ANNUAL REPORT  
OF THE  
**ST. GEORGE'S SOCIETY,**

*For the year ending on the 5th January, 1848.*

This being the day fixed by the Constitution for the Election of Officers for the current year, the Board of Management of the St. George's Society, elected on the 5th January, 1847, have now the honor, on retiring from office, to submit the following Report of their proceedings during the past year, and of the present condition of the Society.

The Board are happy in drawing the attention of Members, generally, to the fact, that after an existence of Twelve Years, the Society continues successfully to carry out the beneficent objects for which it was founded, dispensing annually a considerable sum in aid of distressed persons of British origin, without trenching upon its permanent fund. Members are, no doubt, aware, that by the Articles of the Constitution, which provide for the management of the Society's resources, the permanent fund is gradually augmenting in amount, so that it affords at one and the same time a proof of the prosperity of the Society, and of the success of its operation; as well as a substantial pledge of its stability and endurance for years to come.

The Annual Report of 1847, and that of the Charitable Committee, were as usual printed in pamphlet form yearly in the spring, together with a list of the past Officers, and Members. Copies were distributed to Members of this, and forwarded to other Societies enrolled under the banner of St. George.

The death of the excellent Lord Metcalfe having left the Society without a Patron, it was thought proper to appoint a deputation to wait upon the Lord Bishop of Montreal, as an Englishman of the highest distinction in this part of the province, requesting His Lordship to accept the office; and the Board have already had the satisfaction of reporting to the Society, that the Right Reverend Prelate was pleased to comply with the request.

The Anniversary of St. George was celebrated on the 23rd April, with the accustomed ceremonial, and with complete success. His Lordship the Bishop of Montreal, Patron of the Society, acceded to the wish expressed that he would preach the Sermon on the occasion. The Society attended Divine Service as usual, in procession—a well selected and admirably performed musical service elicited the approbation of all present—and the collection in aid of the Charitable Fund amounted to £33 : 17 : 5.

By order of the Society application was made to the Lord Bishop for a copy of the admirable Sermon preached on the Anniversary, and the same having been kindly granted, 300 copies were printed for sale to the Members and others interested in the publication. A few copies still remain in the hands of the Treasurer, from whom they can be obtained at a moderate charge.

The visit of the Governor General and Countess of Elgin, daughter of the late Earl of Durham, a liberal Patron of this Society, afforded to the Members an opportunity of paying due respect to the Representative of the Sovereign in this Province. The Society joined the Sister Societies and the City Authorities in the demonstration, proceeding to the Queen's wharf in procession, with their Banners and Insignia, to meet their

Excellencies; and notwithstanding the extreme inclemency of the weather, the attendance of Members was numerous and imposing. An Address of congratulation was afterwards presented to His Excellency, to which a suitable acknowledgement was returned by His Lordship.

The Board has had to sustain the loss of Doctor John Racey, one of the Physicians to the Society, who fell before the raging sickness of the last season. In the discharge of his duties to the sick generally, and to the distressed of British origin as our Physician, he had acquired for himself public esteem, and the gratitude of the Society. As a last mark of respect for his worth, his remains were attended to their resting place by the Members, and a letter of condolence was addressed to his widow by order of the Board. Besides the lamented Dr. Racey, the Society has also, during the past year, to regret the loss by death of two old and highly esteemed citizens, resident in the City, namely, A. Anderson and James Hunt, Esquires, and Mr. Edward Wade, also a respectable citizen.

According to the Treasurer's Report which has been filed for reference, the actual state of the Society's funds will be found highly satisfactory, under the management of that zealous officer. It will be observed, that the permanent fund, at interest, produced last year the sum of £74.

The Charitable Committee have conducted their operations with judicious economy during the past year. Their Secretary's book lies on the table for the information of Members. It appears that the number of cases enquired into and relieved was 35, without reference to the number of individuals in each family respectively, and the amount of money distributed was

£84 : 14 : 2. A report of each case is printed at the end of this Report, for the use of the Members.

 being an addition of 12 Members since the 5th January, 1847. Twenty-five new Members have been enrolled during the year, including two Life Members.

The matters which remain over for the action of the Society during the current year are :

**THE INCORPORATION OF THE SOCIETY :—**With respect to this subject of much interest to the Members, the Board beg to state that the shortness of the last Session of the Provincial Parliament, and the consequent pressure of public business effectually prevented the accomplishment of the object in view.

**SEAL,—THE DIPLOMA AND BADGE :—**The obtaining a proper form of Diploma for the Members being dependent on procuring an Act of Incorporation, which authorised the use of the Seal, the Board need make no further remark on these heads. The Badge to be worn by members in procession, and on days of ceremony, has long been mooted, but no definite settlement has ever been arrived at on this subject.

Pending the proceedings on the subject of the Incorporation, the Treasurer was instructed by the Board to procure a temporary Seal for the ordinary purposes of the Society. Two seals have been procured, one of which is now in the possession of the Secretary, and the other of the Treasurer.

In conclusion, the Board beg leave to congratulate the Members generally on the continued success and pre-

### OBITUARY NOTICES.

---

EDWARD WADE.—A native of Kingston, Canada West, son of Mr. Francis Wade, late a pensioner from the Royal Artillery, native of Bristol, England. Mr. E. Wade was a watchmaker, and by his industry accumulated property, leaving his family in competent circumstances. He died on the 29th March, 1847, in the 44th year of his age.

JAMES HUNT, Esquire.—A native of Dartmouth in Devonshire, came to Canada in 1803. During a period of upwards of forty years, Mr. Hunt was actively engaged in commerce; and being a connexion of the highly respectable house of Newman, Hunt and Company, at Oporto, the deceased was Agent in Canada for the sale of the products of Portugal in these Provinces, large consignments of which he annually received. As a Bank Director, and in other offices of trust, he long enjoyed the confidence and respect of his brother Merchants. By a steady perseverance and the highest integrity, he accumulated a large fortune. He died on the 31st March, 1847, aged 67 years.

ANTHONY ANDERSON, Esquire, J. P. Life Member.—

This Gentleman was a native of Elsdon, in the county of Northumberland, born on the 10th October, 1768, came to Quebec in the year 1784, and was at the time of his decease the oldest resident of the British born inhabitants of Quebec. He was appointed a Magistrate, for the District of Quebec, upwards of twenty years ago, and continued in that office up to the time of his death; he was Member of the Quebec Agricultural Society, from its first formation, and for many years President of that institution; and received in the year 1828 from that body a valuable Cup, as a mark of the esteem in which he was held by the Society, for his zeal in the cause, and for the example set by him in the promotion of British Agriculture in this District. On two occasions since that period, he was presented with testimonials from the Society of its esteem for his exertions in the cause of Agriculture. He was elected a Member of the Provincial Parliament of Lower Canada, for the County of Megantic, and served until the termination of that Parliament.

Mr. Anderson was proprietor of a valuable landed estate called Hedley Lodge, near Quebec, on the north bank of the River St. Charles, where he resided, and which he cultivated under his own eye. He was also co-proprietor of Dorchester Bridge. As an Agriculturalist he brought his large farm to such a state of perfection, as to attract the notice of experienced farmers from the Mother Country. Lord Dalhousie, when Governor General, took much interest in his establishment, and the result of His Lordship's frequent visits was a lasting friendship between the noble Governor and the English Farmer. His stock of cattle was of a superior kind, which he most liberally distri-

lated amongst his fellow Agriculturalists, for the purpose of improving the breed of every description of cattle. He may be truly considered a public loss, in as much as there is no one to take his place in this important branch of national wealth. He died at his residence, Hedley Lodge, near Quebec, on 3rd April, 1847, in the 80th year of his age, having resided in Quebec upwards of 60 years.

JOHN RACEY, M. D. Edinburgh.—A Life Member, born at Quebec, son of John Racey, Esquire, a native of Bath, England. Doctor Racey commenced his Medical Studies in Montreal, and finished them in Europe. He was skilful in his profession, and for several years enjoyed a highly respectable practice. As one of the Physicians of the St. George's Society of Quebec, the poor have cause to regret the loss of his valuable services, which were always freely offered gratuitously, together with the necessary medicines: nor was his philanthropy confined to the poor of that origin, but cheerfully extended to all of every denomination, language and creed. He fell a sacrifice to his exertions in aiding his suffering fellow creatures during the prevalence of the contagious fever, typhus, of last summer and autumn. He died in the 39th year of his age, at Quebec, on the 25th October 1847.

The following additional notice has been contributed by one who appreciated, from having witnessed, his exertions and his benevolence.

As the circumstances which are here to be related, took place but a few weeks before the death of Dr. Racey, and are immediately connected with the awful prevalence of the malady to which he fell a victim, it may perhaps not be thought inappropriate, nor felt uninteresting, that a simple detail of them should be attached to the obituary notice of him in this Report.

After the rule had been enforced at the Marine Hospital, on account of the immense demand for admission, of restricting that advantage to those who had properly a claim to it as Mariners, or as Emigrants of the current year, it is well known that some very distressing cases occurred of patients labouring under fever, for whom no receptacle could be found,—another rule of exclusion operating against them at the Hôtel Dieu, (the only other hospital for civilians, in the place,) since no persons can be admitted into that institution whose disorder is of an infectious or contagious character.

It was under these circumstances that two unfortunate Irish Settlers, a father and his son, belonging to a distant township, in the district of Quebec, who had been working in town during the summer, presented themselves in a state of very serious illness, at the door of the Rectory in this Parish. They had been refused admission at both hospitals, and the father, having had one dollar at command, had spent it in calèche-hire, driving from one part of the suburbs and out-skirts of the City to another, in quest of a lodging. No body could be prevailed upon to take them in, for it was evident upon the first inspection of their persons, that they were in a state of disease, and the alarm respecting the fever was at its height. What was to be done? Endeavours were immediately used to find some of the medical gentlemen connected with the hospitals, in the hope that if it were impossible to stretch a point, in so extreme a case, in one of the public institutions, the rules of a small private hospital opened for the benefit, in particular, of the Captains of passenger vessels, might admit of the reception of the sufferers there, provision being made for the necessary expence. But this proved impracticable. The two poor fellows, in the meantime, the weather being fine, had thrown themselves down upon the grass at the Rectory door, to await the result.

Dr. Racey was the only physician found at home. He entered with the kindest feeling of interest into the case, and a long time was spent in consultation, but spent in vain, till he at last bethought himself of an unoccupied stable in the rear of his own premises. It was a perfectly clean and roomy place, and the offer was at once thankfully accepted—the men were removed there—a mattress was procured for them, and Dr. Racey was requested to give himself no other trouble about them than in affording the benefit of his medical attendance and medicines, arrangements being undertaken for sending them all other needful supplies, and seeing to their other wants. When, however, they were visited with this view, it appeared that Dr. Racey had been already supplying them from his own house, and had provided some additional comforts for their manner of lying. In about a week, they were sufficiently recovered, under his care, to return to their home in one of the townships, where it is

believed that they are now alive and well with the rest of the family—a home which they might perhaps have never seen, and which would then have presented the spectacle of a desolate widow, surrounded by fatherless children, but for the considerate benevolence of Dr. Racey as an instrument in the hands of Divine Providence, and his professional watchfulness over their case.
