## UP TO DATE ICE CREAM PLANT

Gray's Wholesale Has Installed Thoroughly Modern Equipment.

With the recent installation of thoroughly up-to-date equipment the ice cream plant of Gray's Wholesale has new ranks among commercial enterprises as second to none for its size in this province.

Like the manufacture of many other commodities on the market, the production of thoroughly wholesome ice cream is a new more or less of a science and requires a plant containing valuable and thoroughly modern machinery as well as an expert to operate it. The new equipment that Mr. Gray has added to his plant is an up-to-date in every particular a money can purchase and ensures the production of ice cream that will rank first class in every respect.

The equipment of Gray's plant now includes two pasteurizers each with a capacity of 200 gallons; a viscolizer and a large freezer capable of handling one gallon of ice cream per minute. Besides its efficiency the new plant employs a system of production which cannot fail to turn out a thoroughly wholesome product.

From the time the raw material is placed in the first vat and the operation begins until the finished product emerges from the freezer, human hands play no part in the process except to apply the power to the different machines, each of which has its own independent motor.

When the necessary formula is prepared it is run into one of the pasteurizing vats where pasteurization is applied through the agency of a revolving coil through which water of the desired temperature automatically runs through a pipe to the viscolizer through which it passes at 3000 pounds pressure and through 3 one thousandths of an inch space.

The viscolizer is connected with the second pasteurizer which is used as a holding vat and here the mixture is thoroughly purified by the process through which it has passed, is held at the necessary low temperature. From this vat a feed pipe conveys it to the freezer and from there it emerges the finished product.

It can be readily seen that modern equipment of this kind employing such an up-to-date and sanitary process of manufacture, assures for ice cream the absolute freedom from all impurities which may be found in some made with out scientific treatment and where pasteurization is not employed.

A plant of this kind is indeed a noteworthy addition to provincial enterprises and the fact of its establishment here is something that the individual ice cream user cannot too highly appreciate.

## SPECIAL MEETING OF COUNCIL

Legere Lot Deal in Connection With Subway Project Temporarily Settled.

A special meeting of the town council was held last evening in the Firemen's Hall. There were present Councilors Belle-Ile, Graham, Matthews, Duncan, Moore and Giller. On motion Councilor Belle-Ile was appointed chairman of the meeting, and Mr. F. A. O'Leary secretary.

The chairman in calling the meeting had been called to consider two petitions which had been largely signed by the ratepayers.

The secretary read the petition which asked that the town council purchase the Legere lot of land as an approach to the Central street subway.

Councilor Duncan spoke in favor of the purchase and moved that a committee of three be appointed to meet Mr. Legere and arrange all details with him this committee to have full power to make the purchase. This motion was seconded.

Councilor Matthews felt that such an important transaction should only be dealt with when all the councilors were present.

Councilor Graham expressed the opinion that the motion was out of order because the lot was not yet purchased. Before dealing with the matter he contended it would be necessary to rescind the former motion.

Councilor Graham moved that the petition be received and placed on file. This was seconded by Councilor Moore.

The chairman, Councilor Belle-Ile, then called Councilor Moore to the chair, when he spoke strongly in favor of buying the lot which cost \$1000 and Legere had already gone to in the erection of the building he was now putting up upon the lot.

In resuming the Chair Councilor Graham's motion which was carried, Councilor Duncan voting nay.

Council then adjourned.

## SPOUL LOT CHANGES HANDS

New Owner Plans Removal of House and Erection of Three Storey Brick Bldg.

Mr. W. Hassell Stevens has purchased the Dr. Sproul property, situated at the corner of the Subway and Roseberry street, and has also secured a lot of land on Patterson street, where he now has a crew of men putting in a concrete basement wall, as it is his intention to have the Sproul house moved to the latter lot. The Graphic understands the price paid for the Dr. Sproul property was in the vicinity of \$5,000.

Mr. Stevens is having plans prepared for a three storey brick building to be erected upon the Sproul lot, the building being considerably larger than the one now situated there. The lower floor of the new building will be used as a store, which will have three entrances on the Subway. The upper portion of the building will be fitted up as tenements, entrance there to be had from Roseberry street.

## BROTHERHOOD OF R. R. TRAINMEN

Tuberculosis Sanitarium is Proposed Now Before Organization.

Toronto, June 4.—A scheme for a tuberculosis sanitarium to care for members of the organization, endorsed by the members of Brotherhood of Railway Trainmen, in session at Massey Hall.

The Sanitarium scheme could be approved of until the next convention but in the meantime a tuberculosis fund will be created, by which members suffering from that disease may receive funds to provide themselves with the treatment they require.

The fund is to be created and maintained by a monthly assessment of 25 cents, commencing September 1, and continuing until such time as \$10,000 has been accumulated above the estimated requirements for one year, by which time plans will be set for the building.

Every member of the organization afflicted or threatened with tuberculosis will be entitled to the protection of the fund from January 1, 1923.

## SORRID TRAGEDY AT GROSSE ISLE

Four Boys' Under Twelve Years Perish in St. Lawrence—Bodies Washed Ashore.

Four little bodies, inert and lifeless, strewn along the muddy beach about a mile and a half from the Canadian Quarantine Station at Grosse Ile, is the tragic tale of a Polish family that was on its way towards Canadian citizenship. The bodies belonged to four little Polish boys, ranging in age from eight to twelve years, and they met their untimely death in the waters of the St. Lawrence because they were too impatient to submit to the delays involved in the immigration act and were apparently trying to evade them by making for the promised land in a row boat.

While definite particulars of how the little party escaped from the station are lacking it seems clear that they must have scaled the walls and made for the beach where they found the row boat. Perhaps they were over-enthusiastic about the good time, rather than imbued with the grand idea of outwitting the immigration authorities. At all events they got out into the current where their little craft was caught in a strong wind. In a few minutes the boat was upset and the youngsters were sprawling helplessly in the water. The rest is easy to understand.

Immediately the lads were missed from the station a search was instituted. This search lasted practically all day long and resulted, late in the afternoon, in the sad discovery of the four dead bodies on the muddy beach to the east of the station.

## CAMP SUSSEX TO OPEN ON JUNE 28

Extensive Training in Different Branches—650 Men Expected to Attend.

The militia camp at Sussex will commence June 28th and last till July 6th. Arrangements are now in progress for getting the camp ready and it is expected about 650 men will be present, and extensive courses in the different branches of training will be given. The camp will be in charge of a Camp Commandant, who will be assisted by a G. S. O., a Senior Engineer Officer, a Signal Instructor, a Supply Officer, a Medical Officer, a Paymaster, a Cavalry Instructor and two infantry instructors. The names of the officers and instructors will be announced at a later date.

The following units will comprise the camp: 8th Princess Louise Hussars, New Brunswick Dragoons, 1st Brighton Field Co., and the 10th Infantry Brigade, composed of the Carleton Light Infantry, the Cork Regiment, the North Shore Regiment and the New Brunswick Rangers.

Owing to the limited funds available for training purposes this year the plan is to keep the officers and non-commissioned officers together as much as possible, with the view that the organization will have competent instructors for training and will be ready to carry on when more funds are available.

## GRAND JURY RETURNS TRUE BILL

True Bill Returned in Case of Father Delorme.

Montreal.—The grand jury in the case of the father of the boy returned a true bill charging the father of the boy with the murder of his half-brother, Raoul Delorme, 24 year old Ottawa College student whose dead body was found in the snow in a suburb of this city January 6 last. Trial was set for Friday next here.

When asked to plead to the charge Father Delorme maintained silence. His lawyer announced that he would raise a plea of insanity when the case came to trial. Mr. Justice Monet refused the request for delay in arraignment the accused, stating that he was to be considered as a layman and not as a priest. He was therefore not entitled to more consideration than any other prisoner.

During the arraignment proceedings Father Delorme made an attempt to seat himself in the dock but was reproved by the judge who told him sternly to "stand up straight." The accused was impassive throughout the proceedings.

## HARDING TO VISIT CANADIAN CITIES

President Harding Accepts Invitation of Sir Auckland Geddes.

Washington, June 2.—President Harding tentatively accepted yesterday an invitation tendered him by Sir Auckland Geddes, the British Ambassador, to visit the cities of Vancouver, British Columbia this summer during his proposed Alaskan trip.

The President was said to have told the ambassador that his plans for a trip to Alaska still were dependent on early adjournment of Congress but that in event the trip was made possible he will be pleased to stop at the two British Columbia cities during the voyage to Alaska.

## ERNEST McEACHERN SENT UP FOR TRIAL AT SUSSEX SOON

Preliminary Hearing in Charge Against Ernest McEachern. Only Small Number of Men Will Meet in Annual Camp in June.

The following is an additional report of the preliminary hearing in the case of Ernest McEachern at Richibucto, charged with murdering Gordon Meshean.

The evidence given at the preliminary hearing by Mrs. Meshean, widow of the deceased, was substantially the same as that given before Coroner D. V. Landry, Buctouche, on May 17th last.

It was established that the accused and the deceased had always been on good terms, and that within a very short time previous to the trouble, the accused and deceased had some hay transaction, at which time they had dinner and tea together at the home of the deceased.

Before the coroner's inquest, she swore that she asked her husband while he was holding the accused down on his back, if she would take the axe into the house. At the preliminary hearing she stated that this request was volunteered by her husband, the deceased.

She further testified that her husband died on Sunday morning, May 15th, that the deceased had thought he was well enough to sit up. She, assisted by Robert Meshean, brother of the deceased, helped the deceased up and he sat on the end of the bed where he rested a moment; then helped him to a rocking chair. Shortly after this, he asked to be put back in bed, and he expired in about 7 or 8 minutes. On this Sunday morning, the deceased, contrary to instructions of the attending physician, Dr. Marc Delaney, was given solid food, was given prunes, and possibly some toast.

The evidence given by Dr. Delaney, who had attended the deceased throughout his illness, was to the effect that Mr. Meshean apparently passed the crisis after the fourth or fifth day. At that time his temperature had reached the highest point, likewise respiration and pulse, but from that time temperature lowered until during the last week it was normal, and the patient was on the road to convalescence. He stated positively that at the last three visits the deceased showed no temperature whatever.

He further stated that his orders were that the accused be given liquid diet only.

It was brought out on cross-examination of Dr. Girvan, who assisted Dr. Delaney in performing the post mortem that he did not notice the fourth fracture of the skull as testified by Dr. Delaney.

He further testified that as a matter of practice, it was absolutely essential that in a case of fracture particularly, the patient should be kept sacredly quiet. All medical skill received perfect quiet after an operation.

Dr. D. V. Landry, the coroner, who performed the post mortem, was called to identify a number of exhibits. He identified the two sticks brought to court as those put in evidence before him, and marked exhibits "A" and "B" respectively. On a knot on exhibit "A", being the larger stick, a number of hairs had been attached which were removed in the coroner's Court and placed in an envelope, and marked exhibit "C".

The smaller stick, exhibit "B", was not furnished in evidence before the magistrate, and on cross-examination of Dr. Landry it was brought out that on a knot on the smaller stick were a number of hairs.

Charles Meshean, a brother of the deceased, testified to his finding of the sticks.

The accused was then sent up for trial.

It is not decided whether an application will be made for bail.

## MANSLAUGHTER TRIAL BEGINS

Prisoner Committed for Trial At the Circuit Court in October Next.

Richibucto, June 1.—The preliminary hearing into the charge against Ernest McEachern of having caused the death of Gordon Michael, Mill Creek, Buctouche, was commenced here this morning before Magistrate Diggle, E. R. McDonald, of Shediac, appeared for the Michael family; H. A. Powell, K. S. of St. John, and Hon. A. A. Dymart, of Buctouche, appeared for the prisoner. Witnesses examined were Mrs. Michael wife of Gordon Michael; Dr. Delaney of Buctouche, and Dr. K. G. Girvan of Rexton, N. B. The trial will be continued tomorrow.

## EDMUNDSTON BONDS

Montreal, May 31.—A bond issue of Edmundston, N. B., has been awarded to the Provincial Bank of Canada at a fraction above 101. The issue is for \$100,000 and bears interest of six per cent and is for a period of twenty years.

## CANADIAN TRADE DISCUSSED BY U. S.

Trade With Canada and New Tariff Bill Hotly Debated in American Senate.

Washington, June 2.—Trade with Canada and the effects of the new tariff bill on this trade, were once more at the front in the Senate discussion of the tariff question today.

Senator Robertson, of Arkansas, one of the Democratic leaders strongly opposed putting duties on brick and shutting off Canadian importations in order to aid what he called the "most oppressive monopoly known" in the United States. He declared that United States citizens living along the Canadian border ought to be able to purchase brick manufactured in the Dominion.

As the result of a sharp fight common brick will go on the free list and there is a strong movement to lower duties on other forms of brick which are of utmost importance to building in the United States.

## TWO ARRESTED

Spring, N. S., June 8.—A second city arrest in the \$10,000 Martinello robbery by the police Saturday when they apprehended Peter Demestek, who is charged with complicity in breaking into Alex. Martinello's safe and taking therefrom cash, bonds and valuable papers.

Peter Swandsky, the first suspect arrested, was Saturday committed for trial to the Supreme Court.

## SALARIES OF NOTED MEN

The Prime Minister of Canada has a salary of \$15,000 a year, in addition to his occasional indemnity of \$4,000 as a member of Parliament. The President of the United States has a salary of \$75,000 a year, with an additional sum of \$25,000 a year for travelling expenses. The Civil List of King George is fixed at \$470,000 per annum, of which \$110,000 is appropriated to the petty purse of the King and Queen; \$125,000 for salaries of the royal household; \$20,000 for

and \$5,000 remains unappropriated. The White House salary for the King and Queen is \$70,000 to Queen Mary in the event of her surviving the King.

**A GOOD WORD.**  
 Besides its undeniable contribution to world peace and international friendship the disarmament conference at Washington brought before the public eye a word which was hitherto practically unknown. It is a short word of only six letters, yet it is a big word for it means a great deal. And it is much more deserving of a place in our vocabularies than many of the slangy phrases that are created from time to time and which tend to taint the conversation of the parlor, the theatre, the ballroom and even the church with a coarse, street-talk flavor. The word we refer to is "Agenda." It means things that are to be done.

With its full meaning taken into consideration, the word agenda is a good one at any time of the year but at this particular season when nature has awakened from her long winter inertia and human activities have recommenced with renewed energy and interest, agenda is an especially good word to get into our thoughts. It will undoubtedly serve as an incentive for it will remind us of the many things still to be done and help to keep us from lagging—or taking too many days off to go fishing.

Most human beings have one propensity in common. Namely, the tendency to rest on what they have accomplished whether these achievements be great or small. But to think of the many things yet to be done in an impatient to even the tired mind and body to forget our wearying thoughts of the past and press on to what duty demands in the future.

Another common frailty of the human animal is that of telling those about him how tired he is and what a hard day he has had. It may seem ridiculous, but telling the other fellow

how tired we are invariably adds to our feeling of fatigue—at least, it prevents our forgetting it for it is more or less a psychological condition. Bone and muscle naturally have something to do with our weariness after a hard day at the office or factory, on the farm or in the household but whether we are to brood over our condition and make ourselves the more uncomfortable or forget our fatigue is a matter of our own volition and one which depends very largely on our mental attitude. Here again the word agenda fits in admirably, for it is curiously less tiring to forget our weariness and plan for the many things yet to be done.

Agenda. Yes it is a good word to get into common speech. For in every life, regardless of its accomplishments or failures of the past or its prospects for the future, there are always many things yet to be done.

Dear Sir—  
 I noticed recently in the columns of your paper, and also in St. John Telegraph as well as other publications, reference to the vacant N. B. senatorship and, who should fill this vacancy, what county should enjoy the honor.

Some of our publications suggest that some man who has been in the public eye, and picking the plums for some time, should fill this vacancy. Perhaps these men who, while they have been in the public eye, may never have known anything about a hard fought battle or self sacrifice and abuse that the men in the smaller counties have had to endure in order to give the people good economic government.

My mind goes back to the many political battles that the late George Haddow fought for the liberal party in the County of Restigouche. Although one of the finest type of men, and no one disliked an election more than he did, still he fought on at great self-sacrifice, for three or four successive elections and all the consid-

eration he received for the declining years of his life, was a second rate Customs House position, with the paltry sum of nineteen hundred dollars per year.

For the self-sacrifice and loss and abuse, which he endured nothing less, than a senatorship should have been offered him. Then the late John Reid took up the fight and carried the county in 1900 and carried it again in each succeeding election, at great personal sacrifice and until after the census in 1911 when it became known that the county would become a part of the electoral district of Madawaska and Restigouche. In the 1911 election which was to be the last election in which these two counties would figure separately, it was understood, between Mr. Reid and the then liberal leader at Ottawa that if Mr. Reid and Mr. Michaud carried their respective counties at the election when the amalgamation of the counties took place Mr. Michaud would stand for both counties and Mr. Reid would get a senatorship.

This would have been a splendid arrangement and should the wisdom of the great Liberal chieftain Sir Wilfrid Laurier as both the English and French speaking people would be represented in both counties and then would be a representation from the Federal Government in both counties. Owing to the fact that the Liberal government was defeated in that election this place never matured and as a result of the strenuous campaign Mr. Reid only lived to attend two sessions after the election.

Mr. Reid was the representative of the county, and while we all deplore his loss the County of Restigouche is if the principle was right there, and still a party to that arrangement and could not carry it out, that same principle is right now.

As the mandate of Sir Wilfrid Laurier has fallen on W. L. McK. King as Premier of Canada, he is in duty bound to still carry out that arrangement and have the present vacancy filled by a man from Restigouche County.

We have the utmost faith in the fairness and good judgement of the Hon. McK. King, Premier and his Col-

league, Hon. B. C. Copey that they will see that these seats are evenly distributed throughout the province. The County of Restigouche with its great manufacturing industries as well as farming and fishing should not be ignored in fact the electors of our county realizing its growing importance feel that we are justly entitled to a representative of the Federal Government living in our County and the only remedy for that now is to have a Senator living in our midst and in asking that we are only asking for what is our reasonable rights.

Dear Sir—  
 In the issue of "The Tribune" of June 1st an account was given of the last special meeting of the Town Council, which was called for the purpose of reconsidering the advisability of purchasing the Lagere lot opposite Central Street, in order to protect the Town from any future liability that is apt to occur on account of having two sewers through said lot.

When he quoted the Town Solicitor as stating that the town has acquired prescriptive rights for the sewers to be there, he is mistaken, the Town Solicitor never made such assertions and the party who informed him to that effect, if he is a councillor, was simply trying to get a report out that would justify him in the eyes of the public for turning down the purchase of that lot.

This is an admission on the part of this councillor that in doing so, he has not acted in the best interests of the town, as his oath of office should direct him to do.

At the second meeting that the town council held on this matter, Councillor Duncan and myself were authorized by his Worship Mayor McK. Kay to get legal advice from Mr. A. T. LeBlanc concerning the sewer rights in this matter, which we did. This legal advice was given to us in writing over Mr. LeBlanc's signature and it said clearly that if the town had had their sewers through this land for a period of at least 20 years without any protest of any kind against same if had acquired the legal right for the sewers to be there; but should the town at any time have to enter on said land, it would have access to said sewers, it was then liable each time for damage caused by said digging.

This legal advice was read before the council last meeting on the subject; but there seemed to still be strong doubts in the minds of some of the members of the council. Councillor Moore went so far as to express his doubts as to the correctness of Mr. LeBlanc's advice in the matter, stating that the gentleman having expressed himself favoring the purchase of the lot and Editor Mail No 2 without swearing also strongly advised the construction of a subway on central street, that for those reasons he would like to have our solicitor before making any further action in the matter.

Mr. Moore also added that if the Town Solicitor's advice was corroborating Mr. LeBlanc's that he would favor the purchasing of the lot in order to protect the town from any further liability.

The Town Solicitor's legal advice was a very clear one corroborating in every way Mr. LeBlanc's. When he was asked if any protests made by the owner of the land respecting said sewers on his property would have any effect, he said that the town would acquire a prescriptive right for said sewers to be on that land only when 20 years had elapsed from the time of the last protest. He also said that the town had a legal right to buy land and could easily get legislation to sell, should it not need the land for any other purposes, then the land could be sold reserving the rights to the sewers and access to same thus protecting itself against any future liability.

The Councillors who are opposing this purchase are doing so without giving one single good reason for their attitude. The whole town is practically unanimous for a subway on Central Street. It is also unanimous or practically so in saying that it is a crime to let anyone build a brick house on any kind of a house on that lot that sooner or later we must have.

The house that is being built on that lot, is a brick one and is being placed right over those two sewers of ours. What do you think the damages should be if we had to go and tear up the owners basement and cement floor to gain access to our sewerage.

Why are those men opposed to that project is unexplainable, they will not stand up and give plausible reasons for their attitude, they simply sit there and not a word to any except "NAY." I fail to see where they can reconcile this attitude of theirs with the town's best interests.

The past councils including last with 90% of the ratepayers have been approving a subway on Central Street for some time past, and are eager to see this go through, with the exception of those who have changed their minds through some unknown cause.

We have two dangerous crossings in this particular section of our town and with the ever increasing population the need for this subway is getting more imperative every day and cannot see anything to justify any of

our councillors in thus acting in direct opposition to the best interest of the town and against the vast majority's wishes. It is more than probable that the ratepayers will remember of this action on some of our councillors at the next civic election, and that they will elect someone whom they will be able to carry out the wishes of the whole town.

Sometimes they got by while they lived, only to be unmasked by subsequent investigators. Sometimes they made discoveries slightly before their time and claimed a supernatural origin for natural phenomena. Occasionally a man amasses the people of his own time and leaves a mystery which is never solved. To one of these classes belongs Eugene Dennis, a Kansas City girl, who is attending High School, who appears to be a somewhat remarkable gift. She makes no claim of being in communication with the "spirit world." She does not know how she performs her wonders, and is in every respect an ordinary flapper, who admits she is fond of boys and chocolates, and no brighter, save for her queer gifts, than the ordinary girl of her age. The theory is advanced that she has "psychic eyes", whatever that may be. This she is a tricker appears to be an unpalatable theory. She has already been investigated to establish this point by a man who is an acknowledged expert.  
It was about a year ago that Miss Dennis began to startle her friends by her powers, one of her first victims being a youth who was driving her in his car and chose a shady spot just outside the town where he thought he might safely stop and retreat. He set with a kiss. He was getting into the car for the exercise, with Miss Dennis not adverse, when suddenly a rapt look crossed her face and she screamed: "A man—but an automobile—quick—if they do not hurry he will die—send a message to the hospital—quick." Then she fainted. The amazed boy shook her and she came round. She told him to hurry with his car into town, as there had been an accident, and if help did not come immediately a man would die. He put on all speed in the direction she pointed out and presently saw two wrecked automobiles and a little group of people. They told him that the victim of the collision had already been taken to the hospital. It would appear that Miss Dennis was somehow or other made aware of the accident at the moment it happened. In fact she saw it.  
Some time ago she paid a visit to Omaha and it was from there that the first public news of her queer gift emanated. One of her woman friends remarked that she had lost a valuable diamond ring the day before and Eugene, without going into a trance but merely concentrating her mind, told her where it had been dropped. She said it would be recovered if she hurried, because in half an hour a man with a vacuum cleaner would be busy with the rug. The man hurried to the roof, and at the designated spot picked up the ring. She had not recovered from her amazement and delight when a servant knocked at the door and asked if it would be convenient for him to clean the rugs. There were several other similar incidents which found their way into the newspapers, with the result that the American Society for Psychical Research in New York, became interested and commissioned an investigator.  
It happened that the best investigator for one phase of the problem is a resident of Omaha. He is David Abbott, whose business is the manufacture of paraphernalia for magicians. It is that half of the tricks of the professors of legerdemain are the invention of Abbott. He has often said that he can duplicate any trick of the professional mediums and was eager to interview Miss Dennis. It was arranged that she should live at his house for a few weeks. She did so, and Abbott's report, which has been forwarded to the society, will say that she remains a mystery to him, and that there can be no possibility of fraud in what she performs. Nothing more dramatic in the history of these investigations ever occurred than the incident one evening recently, when Mr. Abbott invited some twenty-five guests to meet the girl and witness a demonstration of her powers. For a while she remained chatting with them telling them things about their past lives, which astonished them,
