Mercury. Burrant Struppico.--From a Parliamentary Re-turn it appears, that the total number of vassels which entered the ports of the United Kingdom da-ting the year 1837, was 146,100, with an aggregate burden of 14,625,200 tons, exhibiting an increase of 4,000 vassels, and, 1,155,400 tons, over the arrivals of the previous year. Of the arrivals, 82,100 vassels with a burden of 3,215,600 tons, were from foreign parts, and 123,000 vessels, with a burden of 10,400. 400 tons, were engaged in the coasting trades. Of the last number, a very considerable proportion must have been steam-vessels, which arrived at the ports between which they ply three or four imes a week, and whose arrivals give an idea rather of the attent, frequency, and value of the intercourse ex-isting, than of the number of vessels employed.
