
The 1999 Guide contains a wealth of new information, particularly on Web sites of the UN and of all its specialized agencies, institutions, commissions, committees and other related organizations.

### Message from the Prime Minister

or over 50 years, the United Nations has embodied Canada's highest hopes for a world at peace. There are simple reasons for our commitment to the UN: it stands for the rule of law, social and political justice, international co-operation and the setting of universal standards, as well as the peaceful resolution of disputes.

These are important principles for Canadians because they closely relate to how we understand ourselves as a country. Although it is sometimes forgotten, the greatest hope of the global community is to achieve what we in Canada have achieved for ourselves: a means of living together in peace and understanding.

The United Nations has struggled against racism and colonialism, against disease and illiteracy. It has stood up for those who have no voice—the oppressed, including millions of women and children around the world.

The UN has contained many conflicts and brought relief to their victims. But the work is far from finished: peace remains elusive for millions around the world, the gap between rich and poor countries is far too wide, and the rights of nations and of individuals under international law must still be defended.

The United Nations and its family of specialized agencies have established a framework for multilateral relationships among states—for disparate activities ranging from co-ordinating the distribution of mail and the registration of patents, to co-operation in the management of the world's oceans and outer space. They have also set and defended universal norms and values, co-ordinated research and technology transfers, and promoted sustainable development in many fields.

While there may not be an immediate solution to every problem, we value the means by which we can pursue potential answers together with mutual respect, tolerance, accommodation and compromise.

Today as much as ever, we need the United Nations to maintain international stability and order, and to tackle issues that know no borders.

Canada's strong commitment to the UN and its humanitarian principles is a reflection of our deep, unyielding belief in the future—a belief helping us build a country that the United Nations has named the best country in the world in which to live.

# Message from the Minister Foreign Affairs

ince the United Nations came into being in 1945, Canada's commitment to it has been unwavering. After 54 years, and in an increasingly globalized world, the UN still provides the best hope for co-ordinated and integrated solutions to the major issues facing the planet at the beginning of a new millennium.

New threats and challenges—terrorism, crime, drugs—arise from a world in which the face of conflict has changed. Economic and social insecurity is mounting worldwide, and increasingly the well-being of the individual is at risk. As a result, a new security concern—human security—is emerging as a global issue.

We must work together to confront these challenges, and this means working through a vibrant United Nations. A key factor in Canada's decision to run yet again for a seat on the United Nations Security Council was our recognition of the UN's central place in a global system. Canada was successful in its bid and began serving a two-year term on the Council on January 1, 1999. In electing us to this seat, the UN membership was acknowledging Canada's long-standing contribution to promoting peace and security around the world.

We have made human security and the protection of civilians in armed conflict the cornerstone of our agenda for our term on the Security Council. But well before beginning our Council term, Canada was working to advance human security in other ways. Our leadership in the international efforts to ban anti-personnel mines is a clear example. Although the Ottawa Convention banning such mines was not negotiated through UN channels, it now resides with the UN and is enshrined as part of the UN legal system. Only the UN has the capacity to give the Convention the global weight it needs to be an effective international safeguard.

Canada also led in another recent global effort to protect human security. From our preparatory work to chairing the negotiating conference, Canada strove vigorously to establish the International Criminal Court—an international tribunal mandated to try cases of crimes against humanity, genocide and war crimes.

These recent actions are representative of Canada's long-term commitment to the United Nations and to the UN's central role as the most important multilateral body in the world.

Producing the *Canadian Reference Guide to the United Nations* is a modest way of helping Canadians, and others throughout the world, understand that role by explaining the key functions of the UN and its many components, agencies and commissions. It is also a way to highlight the importance of the UN to Canada, plus Canada's part in the history and effectiveness of the UN as a vital global institution. I hope you will find it an informative and useful tool.



## Overview of the United Nations

### Introduction

The United Nations officially came into being on October 24, 1945. By that date a majority of the 50 countries that had signed the UN Charter in San Francisco on June 26, 1945, had ratified it in their national parliaments. The UN replaced the League of Nations, which had been created by the Treaty of Versailles in 1919. Canada, a participant at the San Francisco Conference (April 25 to June 26, 1945), is one of the founding members of the United Nations.

The actions of the UN are guided by its Charter, which defines the United Nations' purposes as follows:

- to maintain international peace and security;
- to develop friendly relations among nations; and
- to achieve international co-operation in solving international problems of an economic, social, cultural or humanitarian character, and in promoting and encouraging respect for human rights.

The actions of the United Nations are based on certain principles:

- all of its members are equal;
- all members must fulfil their Charter obligations;
- international disputes are to be settled by peaceful means;
- members may not use force or the threat of force against other members;
- members must help the United
   Nations in any action it might take
   in accordance with the Charter; and
- the United Nations may not interfere in the domestic affairs of any state.

Currently, there are 188 member states. For a complete list of member states, along with the year each was admitted to the UN, see Section 10 of this Guide.

The UN resembles a world parliament, although it does not legislate in the manner of a national parliament. But through their actions and their votes, its members help set international policy.

### **The United Nations family**

The United Nations family has six main organs: the General Assembly, the Security Council, the Economic and Social Council, the Trusteeship Council, the International Court of Justice, and the Secretariat. All act in concert with dozens of related specialized agencies, funds and programs in order to develop an increasingly co-ordinated but diversified action plan in the spheres of peace and security, humanitarian assistance, human rights, and economic and social development.

The United Nations family also includes 16 organizations, each operating in its own particular field of expertise (e.g., health, funding, agriculture, civil aviation, telecommunications). These specialized agencies, such as the World Health Organization, the International Civil Aviation Organization and the World Bank, along with the six main UN organs, make up what is called the United Nations system. A brief description of the roles and functions of these 16 organizations can be found in Section 9 of the guide.

### **General Assembly**

All member states have seats in the General Assembly. The Assembly can discuss all matters within the scope of the UN Charter. Its recommendations carry moral weight as an expression of world opinion; however, the General Assembly cannot compel action by any nation.

Decisions on important questions—peace and security, admission or expulsion of members, budgetary matters—need a

two-thirds majority. For other issues, only a simple majority is required.

The regular session of the General Assembly begins each year in mid-September and continues until mid-December. Special or emergency sessions are sometimes convened when circumstances warrant. When the Assembly is not in session, its business is conducted within special organs and committees.

The General Assembly receives reports from all other UN organs, appoints the Secretary-General and members of other UN bodies, approves the budget, and directs the work of the Secretariat.

The General Assembly has six main committees:

- Disarmament and Related International Security Questions (First Committee);
- Economic and Financial (Second Committee);
- Social, Humanitarian and Cultural (Third Committee);
- Special Political and Decolonization (Fourth Committee);



- Administrative and Budgetary (Fifth Committee); and
- · Legal (Sixth Committee).

### **Security Council**

The Security Council is the main organ responsible for maintaining global peace and security. It has 5 permanent members -namely, China, France, Russia (which assumed the Soviet Union's seat), the United Kingdom and the United Statesand 10 members elected by the General Assembly to serve two-year terms. On October 8, 1998, Canada was elected to serve a new two-year term as a nonpermanent member; this is the sixth time since 1948 that Canada has sat on the Security Council. The new term runs from January 1, 1999, to December 31, 2000.

Council members are on call 24 hours a day in case an international crisis occurs. Any UN member or the Secretary-General may call a Security Council meeting if a threat to peace exists. Even a non-member state may request a meeting if it feels that such a threat exists. When a meeting is called, those countries directly involved in the issue under consideration

> are invited to take part in discussions but they may not vote on Council resolutions. It takes a nine-member majority for a resolution to be carried, but none (except for procedural questions) can be adopted if opposed by

one of the five permanent members (giving them a "veto").

In the event of a conflict pitting one or more countries against another, the Council can order economic sanctions against the aggressor, and all other UN members are obliged to comply with these. If the sanctions fail to stop the aggression, the Security Council can authorize member states to launch joint military action, as it did in the case of the Korean War in 1950 and when Iraq invaded Kuwait in 1990, as well as in Somalia, Rwanda and Haiti. Although these operations were approved by the Council, they were conducted entirely under the authority of the states that launched them. The Council authorizes such operations only as a last resort, when all peaceful means of resolving a dispute have failed.

In most cases, the Council tries to negotiate a cease-fire between the combatants. Once the fighting stops, UN peacekeeping forces may be sent to keep the two sides apart or to help implement a peace accord.

Last, the Security Council recommends the admission of new members to the UN. It also makes recommendations on filling the posts of Secretary-General and of judges on the International Court of Justice.

### **Economic and Social Council**

The Economic and Social Council (ECOSOC) is the real backbone of the United Nations system. Under the authority of the General Assembly, the Council is the principal co-ordinating body for the economic and social activities carried out by the UN and the various funds, programs, organizations and specialized agencies that make up what is called the United Nations system or extended family. It has 54 member states, each elected for a three-year term. Canada's last term on the Council ended December 31, 1998.

The activities overseen by ECOSOC are aimed at promoting economic growth and progress in the developing world, respect for human rights, and international co-operation in such areas as housing, family planning, environmental protection and crime prevention. More specifically, ECOSOC's main functions and powers are as follows:

- to serve as the main body for examining international economic and social issues of a global or interdisciplinary nature and for developing, on the basis of studies and reports commissioned by the Council, practical recommendations on these issues for member states in the economic, social, cultural, education, public health and other related spheres;
- to ensure effective, universal observance of human rights and basic freedoms;

- to convene international conferences on questions in its areas of expertise and prepare draft conventions for submission to the General Assembly;
- to co-ordinate the activities of specialized agencies while consulting with them and making recommendations to them, as well as to the General Assembly and UN member states; and
- to consult the over 1500 nongovernmental organizations (NGOs) enjoying consultative status with the Council on questions that come under its scope.

To successfully carry out its mandate, the Council has several commissions and committees with specific responsibilities. This structure includes nine functional commissions charged with studying issues and making recommendations in their fields of expertise. They are as follows:

- · the Commission on Human Rights;
- the Commission on Population and Development;
- the Commission for Social Development;
- the Commission on the Status of Women;
- the Commission on Crime Prevention and Criminal Justice;
- · the Commission on Narcotic Drugs;

- the Commission on Science and Technology for Development;
- the Commission on Sustainable Development; and
- · the Statistical Commission.

The Council also has regional economic commissions charged with promoting economic development in each region, and strengthening economic relations among the various countries there and between these countries and the rest of the world. They are as follows:

- the Economic Commission for Africa (Addis Ababa, Ethiopia);
- the Economic and Social Commission for Asia and the Pacific (Bangkok, Thailand);
- the Economic and Social Commission for Western Asia (Beirut, Lebanon);
- the Economic Commission for Europe (Geneva, Switzerland); and
- the Economic Commission for Latin America and the Caribbean (Santiago, Chile).

The Council also has four standing committees: (1) the Committee for Programming and Co-ordination; (2) the Commission on Human Settlements; (3) the Committee on Non-Governmental Organizations; and (4) the Committee on Negotiations with Intergovernmental Agencies.

Last, the Council supervises the work of a great many expert bodies on questions such as the environment, natural resources, and economic, cultural and social rights. It also oversees the governing boards of several UN organs, including the United Nations Children's Fund, the Office of the High Commissioner for Refugees, the World Food Programme and the United Nations Population Fund, to name but a few.

### **Trusteeship Council**

The Trusteeship Council is the only UN body that is no longer active; however, its mechanisms are still in place and could be re-activated if circumstances change. It was originally set up to ensure that the governments charged with administering the territories under UN trusteeship (11 at the time of the Council's inception) suitably prepared them for autonomy or independence. Its role came to an end in 1994, when the last of these territories —Palau, an island group in the Pacific Ocean, which had been administered by the United States—opted for a new status. The Trusteeship Council, which had been composed of the five permanent members of the Security Council, will not sit again unless required by special circumstances.

### **International Court of Justice**

The International Court of Justice (also called the World Court) is the United Nations' main legal organ. The Court sits in The Hague in the Netherlands and has 15 judges, who are elected by the General

Assembly on the recommendation of the Security Council. In selecting judges, care is taken that the principal legal systems of the world are represented. The Court settles legal disputes between member states and renders advisory opinions for the UN and its agencies. Only member states may refer issues to the Court. A state can refuse to submit to its jurisdiction (except where otherwise expressly provided by treaty), but if it accepts, it is obliged to comply with the decision rendered.

### **Secretariat**

The Secretariat is headed by the Secretary-General and provides the services that keep the UN and the programs of its five main bodies running on a day-to-day basis (those organs being the General Assembly, the Security Council, the Economic and Social Council, the Trusteeship Council, and the International Court of Justice). The Secretariat operates out of UN headquarters in New York, as well as offices in Geneva, Nairobi and Vienna.

The Secretariat employs about 8600 civil servants—4700 of them in New York—from 170 countries. Their duties include administering peacekeeping operations, organizing international conferences, studying world economic and social trends, preparing studies on such subjects as human rights, disarmament and development, providing simultaneous interpretation and translation services, and providing information on the United Nations to media the world over.


### **Budget and personnel**

The UN budget for the year 1999 is US\$1.25 billion. This amount covers the operations of the Secretariat for the United Nations system in New York, Geneva, Nairobi and Vienna, as well as the five regional economic commissions. In addition, there is the UN funds and programmes budget, which comes to nearly US\$5 billion for the year 1999. Added to this are the budgets of specialized agencies such as the World Bank and the International Monetary Fund, bringing total operating expenditures for the entire United Nations system to over US\$18 billion a year.

The Secretariat and the various components of the United Nations system are funded through member states' dues and through donations from the private sector, other national and multilateral agencies, and individuals. Member states' dues are set according to total gross domestic product (GDP), adjusted for a series of factors including per capita income and population. For the year 1999, Canada's share was set at 2.754 percent (US\$28.6 million).

Including Secretariat staff, UN personnel total slightly over 52 000 people working in 29 agencies, institutions and programs of the UN system throughout the world.

## Main Spheres of Activity of the United Nations

### International peace and security

Along with economic and social development and the protection of human rights, international peace and security—whether their achievement or their preservation—have always been and still remain the central concern of the United Nations and the international community.

Through the Security Council, whose main responsibility this is, the UN has helped settle disputes between nations, prevent conflicts and put an end to fighting. It has conducted complex peacemaking and humanitarian operations, and has played a crucial role in resolving some of the longest-running conflicts of recent years.

To carry out this mission, the UN uses various means ranging from unobtrusive diplomatic initiatives undertaken during unofficial meetings to the deployment of military contingents, often called Blue Berets, made available by member states.

Maintaining international peace and security is a collective effort that requires the active involvement of individuals, countries and organizations. The UN Secretary-General plays a major role in peacekeeping and in restoring peace in

the event of armed conflict. He acts both personally and through his special representatives. He can call the Security Council's attention to any situation that might jeopardize international peace and security, can lend his good offices in mediation or can take discreet diplomatic initiatives. He also practises preventive diplomacy to avert the outbreak of hostilities.

International peace and security are also a priority for an increasing number of countries working together to create innovative coalitions and partnerships in order to further global action on human security issues. For example, with Norway's support, Canada has established a flexible framework for promoting co-operation between countries with common views from all continents, with the aim of achieving progress on issues that affect human security, such as children in armed conflicts and small arms proliferation.

In addition, broad coalitions of nongovernmental organizations and states
co-operate with the United Nations to
promote peace in the world, along with
protection of human rights. The very
rapid passage of the Convention on
Anti-Personnel Mines (the Ottawa
Convention) may be the finest example
of this new collective approach in favour
of international peace and security.

Last, multilateral organizations, such as the Commonwealth, La Francophonie, the Organization of American States, and the Organization for Security and Co-operation in Europe, are working, sometimes independently and sometimes in conjunction with the UN, to prevent new conflicts or end ongoing ones.

### **Peacekeeping**

The most visible and spectacular type of UN action is still the deployment of peacekeeping missions. Since 1948, the UN has conducted about 40 peacekeeping operations, 30 of them within the past 12 years. Taking part in these have been over 750 000 military personnel, 1500 of whom gave their lives for the cause of peace.

Thousands of police officers and civilians have also served in these operations. It was in recognition of their contribution to world peace that the Blue Berets received the 1988 Nobel Peace Prize. In the minds of many people, the best symbols of the United Nations are the UN peacekeeping contingents at work in the four corners of the world.

In the beginning, in the late 1940s, the first United Nations peace soldiers were unarmed military observers posted along cease-fire lines in Kashmir and the Middle East. It was not until 1956 that organized units were deployed during the Suez Crisis: Lester B. Pearson, then Canada's Secretary of State for External Affairs, suggested using peace soldiers to separate the belligerents after they had agreed to a cease-fire. This operation has been used

as a model for almost all peacekeeping missions launched by the United Nations since that time. Mr. Pearson himself received the Nobel Peace Prize in 1957 for this contribution to world peace.

In recent years, UN peacekeeping missions have become much more complex. To traditional and essentially military tasks, such as supervising cease-fires, separating belligerents and maintaining buffer zones, have been added political and humanitarian activities. Civilian police officers, election observers, human rights observers and other civilians have joined the UN peace soldiers. Their duties include ensuring that food aid gets through, and helping former adversaries implement complex peace agreements.

Working with the United Nations agencies and other humanitarian organizations, the Blue Berets have helped refugees return to their countries, monitored respect for human rights, and undertaken mine clearance and reconstruction work. UN peace soldiers have also been used for disarming and demobilizing former combatants, training and supervising civilian police, and organizing and

observing elections.

Every peacekeeping
operation is sent in by the
Security Council, which rules
on the size of the operation as
well as its general objectives and
timetable. Since the UN does not have its
own military forces, member states decide
whether to participate in a mission and,

if so, they determine what type of personnel and equipment they are prepared to offer.

To succeed, a peacekeeping mission needs to meet certain conditions. In particular, it must have a clear and feasible mandate, effective command, political and financial support from the UN member states and, above all, co-operation from the parties to the conflict. The mission has to be undertaken with the consent of the government of the country where it is deployed and, generally, of the other parties involved; and in no case must it be used to promote the interests of one party to the detriment of the other.

Impartiality is the primary "weapon" of the peace soldiers, who in any case carry only light arms and cannot use force except in cases of legitimate self-defence or when armed persons attempt to prevent them from carrying out their assigned duties.

Last, peacekeeping by the UN must not be confused with peace enforcement or other forms of military intervention. On many occasions, the Security Council has authorized member states to use "all necessary means," including force, to end armed conflicts or threats to peace. With this authorization, member states formed military coalitions in 1950 during the Korean War and in the 1990s in response to the invasion of Kuwait by Iraq, as well as in Somalia, Rwanda, Haiti, and Bosnia and Herzegovina. Although sanctioned by the Security Council, such interventions are entirely the responsibility of participating states.


### **Peacebuilding**

The term "peacebuilding" first gained currency in 1992 with its appearance in the landmark report entitled *An Agenda for Peace*, by Boutros Boutros-Ghali, then UN Secretary-General. This document outlined the new challenges and opportunities for promoting international peace and security in the post-cold war world.

One of the principal challenges for the United Nations has been the proliferation of conflicts within states. In 1997, for example, of the 87 armed conflicts around the world, 84 of them were within states. Nearly all these conflicts took place in developing countries, and they have often been characterized by long-term cycles of violence. While conflicts generally occur within states rather than between them, they tend to spill over into surrounding areas, with dire consequences. Growing international awareness of the human and financial costs of such conflicts has prompted the UN and the international community to think differently about international security, and has led to the emergence of the concept of peacebuilding.

Peacebuilding is the effort to strengthen the prospects for internal peace and decrease the likelihood of violent conflicts. Its goal is to enhance the indigenous capacity of a society to manage conflict without violence.

Peacebuilding lies at the intersection of international security and development. It may encompass a wide range of activities. For example, support for conflict prevention and dispute resolution, demobilization

of combatants, resettlement of displaced persons, local institution-building, election monitoring, democratic and judicial reform, civilian police training, and post-conflict economic and social reconstruction are all activities with important peacebuilding dimensions.

As the linchpin of the global security system, the UN has a critical role to play in all these areas. Many activities related to peacebuilding are in fact carried out by modern peacekeeping operations, as these have expanded their scope to deal with new realities. However, peacebuilding is a wider concept than peacekeeping because it seeks to deal with the root causes of conflict, to address not only the immediate but also the medium- and longer-term challenges for ensuring peace in troubled areas.

Active in peacebuilding at the UN are not only the Security Council and the office of the Secretary-General, but also other specialized agencies, including the United Nations Development Programme (UNDP), the UN High Commissioner for Human Rights (UNHCHR), the United Nations Children's Fund (UNICEF), the UN High Commissioner for Refugees (UNHCR) and the United Nations Civilian Police. Regional organizations (e.g., the Organization for Security and Co-operation in Europe, NATO, the Organization of American States and the Organization of African Unity) as well as a range of national and international non-governmental organizations are working with the UN on these challenges. Finally, through its two-year term on the Security Council, as well as through national efforts such as the

Canadian Peacebuilding Initiative, Canada is striving to enhance the capacity of the UN to undertake effective peacebuilding activities in areas of conflict.

### Disarmament

Stopping the arms race and reducing, and then completely abolishing, the arsenals of weapons are main UN concerns. The UN has commissioned research and made recommendations. As a permanent forum for dialogue, it has facilitated negotiations conducted at the bilateral level or within the Disarmament Conference meeting regularly in Geneva.

In 1996, the General Assembly crossed a historic watershed when it passed the Comprehensive Nuclear-Test-Ban Treaty (CTBT), which banned all nuclear testing. The previous year had seen a great step forward, when the states parties to the 1970 Treaty on the Non-Proliferation of Nuclear Weapons (NPT), ratified by 187 countries (all but 4 members of the international community), extended its provisions indefinitely. Under this treaty, states possessing nuclear arms promised not to supply them to other countries and to reduce their own nuclear arsenals. Countries without nuclear arms undertook not to acquire such weapons.

The concern with disarmament has been unwavering over the last 30 years. During this time, the UN has presided over the conclusion of treaties banning the emplacement of nuclear arms in space (1967), or on the seabed and the ocean floor (1971). Other treaties banned the development,

production and stockpiling of bacteriological (1972) and chemical weapons (1992), limited conventional armed forces in Europe (1990), and banned or limited the use of certain types of weapons.

The International Atomic Energy
Agency, based in Vienna, is responsible
for enforcing the guarantee agreements
reached under the various disarmament
treaties in order to ensure that nuclear
materials and equipment intended for
peaceful uses are not diverted for military
purposes.

Canada has always been closely involved in these issues and in the negotiation of multilateral disarmament treaties. On all these matters, Canada's position on non-proliferation, arms control and disarmament has been based primarily on maintaining, defending and strengthening the application of three basic global treaties: the Treaty on the Non-Proliferation of Nuclear Weapons, the Chemical Weapons Convention, and the Biological and Toxin Weapons Convention. These basic instruments are complemented by the Comprehensive Nuclear-Test-Ban Treaty and the treaties creating Nuclear Weapon-Free Zones.


Also in connection with nuclear disarmament, Canada is encouraging the United States and Russia to speed up the process of implementing the Strategic Arms Reduction Talks (START) agreements reached between these two countries. Although Canada is pleased that implementation of START I, which came into force on December 5, 1994,

seems to be ahead of the agreed timetable, it is still concerned at Russia's delay in ratifying the START II treaty signed on January 3, 1993. Finally, to reassure states in all areas of the world about their own security and to achieve some progress on various other security issues debated at the United Nations and in other forums, Canada is calling for a rapid start on negotiating a START III treaty, which it regards as essential to the pursuit of nuclear disarmament.

### **Anti-personnel mines**

Under Canada's leadership and the collective efforts of a broad coalition of states and non-governmental organizations from all over the world, substantial progress has been made over the last two years on the issue of banning antipersonnel mines, culminating with the signature in Ottawa on December 3 and 4, 1997, of the Convention on the Prohibition of the Use, Stockpiling, Production and Transfer of Anti-Personnel Mines and on Their Destruction. The Ottawa Convention, signed by 135 countries and already ratified by over 84 states, assumed the force of international law on March 1, 1999.

Under the provisions of the Convention, states signatory undertook in particular to: (a) provide data on their stocks of anti-personnel mines and their national implementation measures to eliminate these mines; (b) destroy all their stockpiled anti-personnel mines within 4 years following passage of the convention; (c) destroy the anti-personnel mines in minefields within 10 years; and





(d) co-operate with Convention enforcement measures.

The UN estimates that tens of millions of such mines are buried in over 70 countries, and that a further 2 million are still being set every year. These devices, often undetected, kill or mutilate some 20 000 people a year. It is estimated that by the end of 1998, even before the Convention had officially come into force, over 11 million mines stockpiled in 15 countries had been destroyed and a new global norm against their use had virtually ended the international trade in these deadly weapons.

Canada is in the forefront of the international drive to get rid of these mines: in December 1997 it created the Canadian Landmine Fund, with a budget of \$100 million over five years. This amount will be used to help several countries conduct mine clearance activities, to provide assistance to victims, to develop new mine-detection and mine-destruction technologies, and to help signatory states comply with the treaty. So far, Canada has made a \$10 million contribution for mine clearance and assistance to victims in Bosnia and Herzegovina, and another contribution of almost \$3 million for similar programs in seven countries in Central Europe, Africa and the Middle East. Last, nearly \$4 million has been committed for mine clearance and support to community rehabilitation programs in Central America.

### Economic and social development

Together with international peace and security, economic and social development forms the most important component of the UN's work in the world. The United Nations believes that there cannot be lasting global peace until all peoples experience well-being. The UN Charter states clearly that the United Nations' principal functions must include promoting higher living standards, full employment, and economic and social progress. The United Nations therefore delivers numerous programs to improve living conditions throughout the world, and commits a very large part of its human and financial resources to these activities.

Three quarters of the world's people are concentrated in developing countries, and it is estimated that 1.5 billion of them are living in poverty. The per capita average annual income in the world's 49 poorest countries amounts to US\$360, whereas it is more than US\$23 000 in the richest 24 countries, or 65 times greater. As the gap is growing, one of the priorities and essential tasks of today is to close it.

To try to do this, the UN has a number of tools, one of which is to hold world conferences that focus on major problems and attempt to identify practical solutions. Over the past 10 years, the UN has organized world conferences on the environment and development (1992), human rights (1993), the correlations between population and development (1994), social development (1995), improving the status of women (1995), human settlements (1996), and food security (1996).

Every 10 years since 1961, it has also adopted International Development Strategies recommending measures to reduce the gap between the poor and rich countries.

But it is mainly through agencies and specialized programs that the UN works to achieve its mission in the economic and social fields. The United Nations Development Programme is the spearhead of this effort. This is the program that funds most UN development activities, operating in 174 countries and territories, with an annual budget in the order of more than US\$1 billion. In addition, the activities it supports generate added annual investments of over US\$9 billion from donor countries, specialized agencies, NGOs and the private sector.

The United Nations Children's Fund works with children so that they are protected and can live in conditions allowing them to flourish. With an annual budget of nearly US\$1 billion, UNICEF is active in 150 countries; its programs deal with such needs as vaccination, health care, nutrition and basic education.

Many other UN agencies are working on development in conjunction with governments and NGOs. For example, the United Nations Environment Programme (UNEP) promotes preservation of the natural environment and measures to combat pollution throughout the world. The World Food Programme (WFP) is the main international food aid provider.

In the area of population, when developing countries need assistance they go first to the United Nations Population Fund (UNPF). As for the United Nations Centre for Human Settlements or UNCHS (Habitat), it works to improve housing conditions for some 600 million people living in unhealthy surroundings.

Last, the United Nations Conference on Trade and Development (UNCTAD) promotes international trade, especially by seeking to increase the integration of developing countries into the world economy. Section 8 of this Guide provides a detailed description of the mandates, objectives and activities of these agencies and programs.

In addition, 16 specialized UN institutions, connected with the United Nations by special agreements, develop standards and directives, help draft policies, and provide technical and other forms of practical assistance in virtually all areas of economic, social and developmental life. These institutions include the World Bank (IBRD), the Food and Agriculture Organization (FAO), the United Nations Educational, Scientific and Cultural Organization (UNESCO), and the World Health Organization (WHO). These institutions and their activities are described in Section 9 of this Guide.

Canada is a very active participant in all the major United Nations programs, commissions and committees, and in the activities of specialized UN agencies and institutions, in part through its development assistance program managed by the Canadian International Development Agency (CIDA). The Agency contributes about \$150 million a year to the core

budgets of the various UN agencies dealing with the many facets of development. This participation in the UN organs is important to Canada, enabling it to take part in development efforts in many more countries and sectors than it could have done with only its own bilateral development assistance program.

Whether in programs addressing basic needs-family planning, nutrition, education-or programs dealing with health, environmental protection, women's education, agricultural development, food, irrigation, the eradication of poverty, the protection of human rights, humanitarian aid or vaccination, Canada is present wherever its resources permit and where its action may serve to improve the lot of the world's poorest people. It participates not only through CIDA but also through a number of federal departments, including Agriculture and Agri-Food, Environment, Transport, Natural Resources, and Justice, to name but a few.

### **Human rights**

Since its founding in 1945, the UN has attempted to achieve the objectives of justice and equality defined by the Charter and applying to individuals as well as to states. One of its first tasks was to draft the Universal Declaration of Human Rights (see p. 62 of the Guide), which enshrines the basic rights and freedoms that all human beings can claim: the right to life, liberty and nationality; freedom of opinion, conscience and religion; the right to work; the right to education; the right to take part in the nation's public business, etc.

The Declaration, the first draft of which was written by a Canadian, John Peters Humphrey, was passed a little over 50 years ago by the UN General Assembly on December 10, 1948. Every year, Human Rights Day commemorates this event, which is unique and of fundamental importance in the history of humanity.

Two international agreements adopted in 1966—the United Nations Convention on Economic, Social and Cultural Rights, and the United Nations Convention on Civil and Political Rights—extend the area of rights established by the Declaration. These three instruments together make up the International Charter of Human Rights, both a standard and a goal for all nations and all peoples.

Since that time, they have been joined by about 60 other instruments concerning human rights, notably the International Convention on the Elimination of All Forms of Racial Discrimination, the Convention on the Elimination of All Forms of Discrimination against Women, the Convention against Torture, and the Convention on the Rights of the Child.

To afford better protection for human rights and ensure that they are respected, the UN has acquired certain tools. The United Nations High Commissioner for Human Rights, a position created in 1993, co-ordinates all the activities of UN system agencies in this area, attempts to prevent violations of basic rights, investigates violations

that do occur and works with governments to remedy such problems.

The UNHCHR also serves as Co-ordinator for the International Decade of the World's Indigenous People (1995–2004), which was proclaimed by the UN General Assembly to highlight the importance of improving the situation of Indigenous peoples worldwide. A major objective of the International Decade is adoption of a declaration on the rights of Indigenous peoples. Another UN initiative is the Working Group on Indigenous Populations, created by the Commission on Human Rights in 1982 to promote and protect the human rights and fundamental freedoms of Indigenous peoples; this meets annually in Geneva.

The Commission on Human Rights is the only body that, when breaches of basic rights are brought to its attention, examines them in public sessions. Through its Special Rapporteurs, the Commission also studies the situation in all member states and monitors more closely the conditions in certain of them.

Canada has played a leading role in the development and adoption of most of these conventions and instruments. Indeed, the protection and promotion of human rights has long been a basic and integral component of Canadian foreign policy. Canada feels that multilateral bodies, such as the United Nations, are often the most effective instruments for influencing governments and advancing the cause of respect for human rights in the world.

When very serious violations occur, the UN has special tools at its disposal. For example, in 1993 the Security Council created an international tribunal to try persons accused of committing war crimes during the conflict in the former Yugoslavia. A similar tribunal was set up for Rwanda in 1994. Up to September 1999, a Canadian, Louise Arbour, was the chief prosecutor of both courts.

With substantial Canadian leadership, global efforts are under way to implement the newly established International Criminal Court, which will provide a permanent tribunal for prosecuting cases of genocide, crimes against humanity and other war crimes.

### **Humanitarian affairs**

When a country is struck by war, famine or natural disaster, the UN and the agencies that belong to the UN system furnish assistance to the population. Under the United Nations Emergency Relief Co-ordinator, who directs the UN's Humanitarian Affairs Department, organizations such as the World Food Programme, the United Nations Food and Agriculture Organization, the United Nations Children's Fund, the United Nations Development Programme, the World Health Organization and the United Nations High Commissioner for Refugees work together and deliver part of this assistance directly.

In recent years, for example, the UN and the agencies of the extended UN family have assisted tens of millions of people who were victims of conflicts or natural

disasters in the former Yugoslavia, the Great Lakes region of Africa, and various regions of Asia and Latin America.

As a member of the Security Council since January 1999, Canada has made the protection of civilians in armed conflict a priority. Under our Council presidency in February, a special debate was held on this topic.

Canada's annual contribution to the different humanitarian aid programs in the UN system varies depending on the the conflicts and natural disasters of the day. On average, however, this contribution may range from \$200 to \$300 million per year. It is channelled mainly through UNDP, WFP, UNICEF, the UNHCR, and the United Nations Relief and Works Agency for Palestine Refugees in the Near East (UNRWA).


Canada's Department of National
Defence (DND) is also often called upon in
natural disasters or within the framework
of UN peacekeeping missions. Canadian
military aircraft transport emergency relief,
and Canadian troops often distribute the
aid directly to disaster or conflict victims.
Canadian soldiers particularly distinguished themselves in this respect in the
conflict in the former Yugoslavia, bringing
in provisions and medical supplies often
at the risk of their lives.

### **International law**

The United Nations has greatly contributed to extending the primacy of law by codifying and developing international law. The UN has been behind hundreds of treaties and conventions dealing with virtually all realms of human activity, from international trade to environmental protection, and including international terrorism, civil aviation and telecommunications. It has given particular attention to protecting basic rights.


Among the most important of these instruments, the number of which is now approaching 500, are the Convention on the Elimination of All Forms of Discrimination against Women (which enunciates the principle of equality of the sexes), the United Nations Convention against Illicit Traffic in Narcotic Drugs and Psychotropic Substances (an essential tool in the struggle against the drug trade), and the United Nations Convention on the Law of the Sea. This last has been called the most complex of all legal texts developed by the UN to this day; it aims to ensure access to the riches of the sea for all countries under equitable conditions, to preserve the marine environment from pollution, to promote freedom of navigation and to facilitate research.


Canada has been and continues to be highly active in the area of codifying law at the international level. For example, the Law of the Sea Convention, which entered into force in November 1994, in particular bears a marked Canadian influence. It was actually Canada that convinced the rest of the international community that the oceans are part of the common heritage of humanity and should therefore be protected.

### Canada and the United Nations

he United Nations is the only multilateral organization whose membership approaches universality and whose agenda encompasses all areas of human activity, in every region of the world. It is, in effect, the marketplace at which much of the world's multilateral diplomacy is conducted, and the mechanism through which the views of the international community are given expression.

It is also the forum in which grievances are aired and, with member state consensus, resolved. The UN's ability to live up to its founders' ideals, and to its potential, is almost exclusively determined by the 188 countries that collectively constitute the United Nations. Our successes are its successes; our failures, its failures. This organization can only accomplish what its member states allow it to.

Canada has been an active and committed participant in the United Nations since its founding in 1945 in San Francisco, where Canada took a leading part in the drafting of the UN Charter. Individual Canadians have played vital roles within the United Nations, and many of the UN's great accomplishments have had a Canadian dimension. For example, John Peters Humphrey was the principal author of the Universal Declaration of Human

Rights 50 years ago; Lester B. Pearson helped invent the concept of peacekeeping, winning the Nobel Peace Prize for his efforts to resolve the 1956 Suez Crisis; and Maurice Strong chaired both the 1972 United Nations Conference on the Human Environment, in Stockholm, and the 1992 United Nations Conference on Environment and Development, in Rio de Janeiro, serving as well as founding Executive Director of the United Nations Environment Programme.

Canadians have occupied key positions within the United Nations system, including the Presidency of the General Assembly (Lester B. Pearson, in 1952–53), and Canada served on the Security Council in 1948–49, 1958–59, 1967–68, 1977–78 and 1989–90. In January 1998 a Canadian, Louise Fréchette, was appointed the first-ever UN Deputy Secretary-General.

The UN's basic purposes and its other underlying principles have guided Canadian foreign and defence policy from the outset. Over the past half-century, Canada has made a significant, constructive and sustained contribution in all areas of UN activity: peace and security, development assistance, human rights, and social, economic and environmental affairs.

As the cornerstone of a rules-based international system, the UN has always been a vital forum through which we have sought to influence world affairs, to defend our security and sovereignty within a stable global framework, to promote our trade and economic interests, and to protect and project Canadian values such as fairness, equal opportunity and respect for human rights.

The promotion of human rights and justice, the prevention and abatement of environmental degradation, the alleviation of poverty, and the promotion of development and human security on a global basis—these can be achieved only through multilateral discussion and negotiation. The sole global forum available is the UN. It is therefore no surprise that support for the UN is deeply entrenched throughout Canadian society.

The UN remains as relevant to Canada today as it was in 1945, if not more so. The 1995 Foreign Policy White Paper, *Canada and the World*, put it unambiguously:

The UN continues to be the key vehicle for pursuing Canada's global security objectives. Canada can best move forward its global security priorities by working with other member states. The success of the UN is fundamental, therefore, to Canada's future security.

Canada has participated in virtually every major UN peacekeeping operation. The UN remains a vital instrument through which Canadians and others are working to bolster human security by ridding the world of anti-personnel mines, halting the

traffic in military small arms or putting an end to the conscription of children as soldiers. Most recently, Canada chaired the negotiations leading to the creation of an International Criminal Court, thereby helping to end impunity for war criminals.

Canada gives particularly strong support to the ongoing process of UN reform, in order to help ensure that the organization remains responsive to the interests and concerns of its membership, and capable of dealing with threats to global security. To this end, Canada is pledged to work to strengthen the UN's capacity for preventive action, to enhance the UN's rapid reaction capability, to improve the functioning of the UN's decision-making bodies and to put the UN on a sounder financial footing.

We are the eighth-largest contributor to the UN budget, after the United States, Japan, Germany, France, the United Kingdom, Italy and Russia. Our share amounts to US\$28.6 million, or 2.754 percent of the UN's budget for the year 1999. We always pay our annual assessed contributions in full, on time and without condition.

Canada is a member of all the UN specialized agencies. It takes part in all major UN programs and is actively engaged throughout the United Nations system. We have seven diplomatic missions accredited to the United Nations: in New York (Permanent Mission of Canada to the United Nations), Geneva (Permanent Mission of Canada to the Office of the United Nations at Geneva, to the Conference on Disarmament, and

to the World Trade Organization), Montréal (Permanent Mission of Canada to the International Civil Aviation Organization), Nairobi (Permanent Mission of Canada to the United Nations Centre for Human Settlements and the United Nations Environment Programme), Paris (Permanent Delegation of Canada to the United Nations Educational, Scientific and Cultural Organization), Rome (Permanent Mission of Canada to the Food and Agriculture Organization) and Vienna (Permanent Mission of Canada to the International Organizations in Vienna).

Public opinion surveys consistently show that Canadians have a high regard for the UN. In fact, 90 percent of Canadians in a recent poll said that Canada should continue to put a high priority on its role in the UN. The United Nations is not perfect; indeed, as noted earlier, it is only as efficient and relevant as its 188 member states allow it to be. The UN has, however, demonstrated the ability to adapt, institutionally and operationally, as new issues

have emerged and as relations

between countries continue to
evolve. The United Nations
remains crucial to Canada
and, we believe, essential to
the conduct of diplomacy
in an ever more interdependent world. It is a
precious resource that we
are committed to preserving.

Following are some of the major sectors of UN activity in which Canada has been, and will continue to be, particularly active.

### **Security Council**

For the sixth time since 1948, Canada has a seat as a non-permanent member of the UN Security Council. Canada's term on the Council runs from January 1, 1999, to December 31, 2000. Canada intends to make use of its term to work for progress on issues to which it attaches particular importance: promoting the concept of human security, including conflict prevention and peacebuilding; human rights; and humanitarian issues. Canada will also work to make the Council more open, transparent and responsive to all UN member states, and to make it more representative of new geopolitical realities.

### **Peacekeeping**

Since its beginnings in 1956, peace-keeping has become an integral and high-profile component of UN operations. Since 1957, when Lester B. Pearson was awarded the Nobel Peace Prize for his leadership in developing the concept of peacekeeping, Canadians have felt a commitment to peacekeeping and have accepted frequent requests to join the Blue Berets in operations around the world.

One of a growing group of countries to which the UN regularly turns when it requires peacekeeping advice and expert military contributions, Canada has participated in almost all the peacekeeping operations mandated by the UN Security Council—in Cyprus, Bosnia, Haiti and elsewhere.

Canadians have served in more than 30 separate missions. Among them have

been men and women from the Royal Canadian Mounted Police, Elections Canada, the Canadian Red Cross, and other governmental and non-governmental agencies based in Canada.

In 1994, Canada established the Lester B. Pearson Canadian International Peacekeeping Training Centre in Cornwallis, Nova Scotia. The Centre offers instruction in the theoretical foundations of peacekeeping, as well as its more practical aspects.


In 1995, at the 50th session of the UN General Assembly, Canada presented a ground-breaking study on a UN rapid reaction capability. The study urged the UN and its members to develop a rapid deployment capability, which could be swiftly mobilized to respond to humanitarian crises. It also recommended the establishment of an operational-level headquarters for force deployment. The study's recommendations are already being acted upon by the UN.

### Peacebuilding and human security

Canada's traditional role as a peacekeeper is today being complemented by our leadership in responding to two of the most significant challenges we face in the post–cold war world: peacebuilding, or building sustainable peace in countries prone to recurring cycles of violence; and human security, or promoting the safety and security of people.

Canada was one of the first countries to promote the concept of peacebuilding

in 1996, when it launched the Canadian Peacebuilding Initiative. Because peacebuilding lies at the intersection of international security and development, the Initiative is a joint undertaking of Canada's Department of Foreign Affairs and International



A key goal of the Peacebuilding Initiative is to improve co-ordination among international actors. This involves strengthening the UN's capacity to prevent conflict, to respond rapidly when conflict erupts and to provide for post-conflict reconstruction.

Under the Initiative, Canada has worked to improve UN capacity to respond to these challenges. Among other things, it has contributed to the UN Trust Fund for Preventive Action and the Trust Fund for Children and Armed Conflict, and has promoted strengthening the role of Special Representatives of the Secretary-General, and the conflict prevention capacity of regional organizations and the UN itself. Canada has also supported the UN Lessons Learned Unit to develop guidelines for demilitarization, demobilization and re-integration of combatants in post-conflict situations. At home, Canada has developed a national roster of Canadian civilians who are available

on short notice to provide assistance and expertise to international peace support operations organized by the UN and regional organizations.

Closely linked to Canada's efforts to promote peacebuilding is its work to marshal international support for the concept of human security. While traditional approaches to international relations have focussed on the security of states and territory as ends in themselves, human security recognizes that in today's world there are many new threats to the safety and security of people. Small arms proliferation, international drug trafficking and organized crime, environmental degradation, and civil conflict are only some of the threats that extend beyond borders and require truly international solutions. With its two-year term on the Security Council, Canada is striving to expand the UN's role in addressing human security issues, such as the proliferation of small arms, the protection of children in armed conflict and the toll of modern conflict on civilians.

Non-proliferation, arms control and disarmament

As we seek new tools for the UN to respond to threats to security, we must not relax our efforts in traditional areas of concern, such as non-proliferation, arms control and disarmament. With the indefinite extension of the Nuclear Non-Proliferation Treaty in 1995 and the opening for signature of the Comprehensive Test-Ban Treaty in 1996, the international


community took a historic and definitive step forward on nuclear disarmament. Canada is firmly committed to pursuing the goal set out in the Test-Ban Treaty of reducing and ultimately eliminating nuclear weapons.

We are equally concerned that there be no relaxation in the international condemnation of chemical and biological weapons, and in support for treaties dealing with them. Nor should the international community neglect the threats to security arising from excessive and destabilizing accumulations of conventional weapons. We believe that more can and should be done at the multilateral level to address such concerns, including issues related to small arms and light weapons.

# **Elimination of anti-personnel mines**

A deadly legacy of conflicts that may have ended decades before, anti-personnel mines victimize more than 20 000 people every year. Most of the casualties are civilians, many of them children, and almost all live in developing countries.

That is why, in October 1996, Canada hosted the Ottawa Conference entitled "Toward a Global Ban on Anti-Personnel Mines," bringing together more than 70 states to discuss a strategy for achieving a global landmine ban. In the Ottawa Declaration, participating states committed to ensuring "the earliest possible conclusion of a legally binding international agreement to ban anti-personnel landmines."



gathering produce speedy action, Canada's Minister of Foreign Affairs, Lloyd Axworthy, invited the participants to return to Canada's capital one year later to sign a global treaty banning landmines. Some 122 countries accepted the invitation and signed the Ottawa Convention on December 3 and 4, 1997. It became the most rapidly ratified international treaty ever when it came into force on March 1, 1999.

Canada is proud of the momentum created through the Ottawa Process toward a global ban on landmines. To act on its commitment, it has pledged \$100 million over five years to create the Canadian Landmine Fund, which is being used to further the goals of the Ottawa Convention (Section 6). # Economic and social development

Sustainable development is a cornerstone of Canadian foreign policy. Canada
sees the United Nations and the UN funds,
programmes and specialized agencies
(where it plays a leading role) as key
instruments for promoting economic and
social development. Canada was and is
very active in the UN reform process; we
want the administrative savings achieved
by the different funds and programmes to
be applied as "development dividends" to
finance the alleviation of poverty and
economic growth generation in developing
countries.

Through bilateral assistance and participation in UN funds, programmes

and institutions, as well as in the regional development banks, Canada has supported African development for many years. We have been a leading player in addressing the problem of debt: we were among the first to forgive the official development assistance (ODA) debt of the least-developed and other poor countries, and were equally prompt in reducing the debts of the poorest highlyindebted countries. We have a long tradition of development assistance in Asia and are active partners in building new forms of co-operation in the Asia-Pacific Economic Cooperation (APEC) forum and other regional forums. Further, Canada is a full partner in Latin American and Caribbean development, and we maintain an active program of assistance to Central and Eastern Europe and the former Soviet Union in order to assist in their transition to democracy and market economies.

## **Environment**

Solving environmental problems is a top international priority for Canadians. Canada is a leader on the issue of biodiversity, and was one of the first countries to ratify the Convention on Biological Diversity. Montréal was chosen as the site for the Permanent Secretariat of the Convention.

At the United Nations Conference on Environment and Development in 1992, Canada played a strong role in developing the Forest Principles. Since then, Canada has launched the International Model Forest Programme, the Montréal Criteria and Indicators Process, and the Intergovernmental Working Group on Forests

(co-sponsored with Malaysia), and was an active participant in the Intergovernmental Panel on Forests, sponsored by the UN Commission on Sustainable Development. Canada is also a proponent of a legally binding instrument on sustainable forest management.

In addition, Canada has been a key player in international ocean issues. Over the past three decades, Canada has provided approximately \$600 million worth of assistance to developing countries to help them sustainably develop their fisheries. Canada has supported the drafting of an Ocean Charter, which has now been endorsed by UNESCO, and was instrumental in securing the UN Agreement on Straddling Stocks and Highly Migratory Stocks. This agreement focusses on the conservation and sustainable utilization of fisheries resources.

Canada played an active role in the negotiations leading to the UN Convention to Combat Desertification. Canada considers desertification to be both a develop-

mental and environmental problem.

It is providing \$800 million in

bilateral desertification-related

programs, aside from multilateral and partnership funding.

All of these measures are necessary if the international community and our international institutions are to keep pace with the changing nature of global environmental problems.

## **Human rights**

Since the end of the Second World War, Canada has been a consistently strong voice in the world's councils for the protection of human rights and the defence of democratic values. From the drafting of the Universal Declaration of Human Rights over 50 years ago through actions taken in a vast range of forums and circumstances, Canada has always been there.

Canada is an active participant in the annual meetings of the UN Commission on Human Rights in Geneva, and it regularly co-sponsors a number of resolutions. Sometimes these are on specific countries where the human rights situation is particularly serious. They may also be on issues Canada feels strongly about, such as violence against women, freedom of expression or impunity.

Other Canadian initiatives have included efforts to ensure consideration of human rights issues in all UN activities, leadership in establishing the position of UNHCHR, and support for the increasing number of human rights field operations of the Office of the High Commissioner for Human Rights, including units attached to UN peacekeeping operations.

Canada also played a significant role in establishing the International Criminal Court. It actively took part in the preparatory discussions and chaired the June 1998 international negotiating conference.

Canada's contribution helped bring about an international court in which to try



cases of genocide, crimes against humanity and other war crimes.

Canada plays a major role as well in the preparation, debates and follow-up of various UN world conferences concerned with human rights—for example, the 1993 Vienna World Conference on Human Rights and the upcoming 2001 Conference on Racism.

As a signatory of all the principal UN treaties on international human rights, Canada regularly submits its human rights record to review by UN monitoring bodies.

By working through the Canadian International Development Agency, via bilateral assistance as well as participation in the UN funds, programmes and special institutions, Canada continues to help

societies build human rights capacity through strengthening the electoral process, the judicial system, legislatures and independent media.

## Women

Canada is committed to drawing attention to violations of the human rights of women. On International Women's Day, March 8, 1993, the Commission on Human Rights adopted by consensus a first-ever resolution, introduced by Canada, aimed at integrating the rights of women into the UN human rights mechanisms.

Canadian efforts have also sought to gain recognition that violence against women is a breach of human rights.

Canada helped draft the UN Declaration on the Elimination of Violence against Women, adopted by the General Assembly in December 1993. In 1994, Canada was behind the Commission on Human Rights' creation of the post of Special Rapporteur on violence against women.

## Children

A Canadian priority, and a key element in our efforts to improve human security, is strengthening respect for children's rights, particularly by eliminating exploitative child labour, the sexual exploitation of children, the widespread use of child soldiers and the victimization of children in armed conflict.

At the multilateral and bilateral levels, Canada is working in partnership with



developing countries to protect children, strengthen their rights and assist victims of the sex trade. Canada supports the negotiations of an International Labour Organization (ILO) convention on the elimination of exploitation of child labour, and it also supports the ILO's International Programme for the Elimination of Exploitation of Child Labour.


## **Indigenous peoples**

In partnership with like-minded states and organizations of Indigenous peoples, Canada is working hard at the UN to promote and protect the human rights, well-being and sustainable development of Indigenous peoples. At the Working Group on the Draft UN Declaration on the Rights of Indigenous Peoples, Canada has played a lead role with a view to achieving adoption of the Declaration by the UN General Assembly before the end of the International Decade of the World's Indigenous People in 2004. Canada supports the establishment of a permanent forum for Indigenous peoples within the UN system; this is another major goal of the International Decade.

### **UN reform**

Over 50 years after its creation, the forces of globalization have presented the United Nations with challenges and pressures unimagined by its founders. As we enter the 21st century, Canada believes we need to re-invent and not merely restructure the United Nations in order to ensure that it remains credible and relevant to the lives of individuals.

Renewing the United Nations: A Programme for Reform, a document presented by Secretary-General Kofi Annan before the United Nations General Assembly in July 1997, proposes the most extensive and far-reaching reforms in the 54-year history of the international body. The reform process should help enhance the credibility and effectiveness of the UN. Canada's reform efforts at the UN have focussed on making the United Nations more effective, not simply less expensive. These efforts include simplifying the structure of the UN Secretariat services involved in development, strengthening the Economic and Social Council, reducing overlap in UN specialized agencies, reviewing the UN's funds and programmes to ensure better co-ordination of their activities in the field, and streamlining the UN machinery in the economic and social fields so that the efficiency savings achieved may be devoted to the UN's development activities.

The Office of the United Nations High Commissioner for Refugees (UNHCR) was founded in 1950 and began operating on January 1, 1951, taking over from the International Refugee Organization. The UNHCR was mandated to assist people who had been uprooted from their homes during and after the Second World War. Thanks to the adoption of the Convention on the Status of Refugees in July 1951, UNHCR was able to help refugees find safe havens and offer them the opportunity

to rebuild their lives. Before the Convention, such people at most could apply to emigrate to another country. If they were refused, they had no recourse and no way of ensuring their own safety.

UNHCR's work is humanitarian and non-political. Its main functions are to offer refugees international protection, seek lasting solutions to their problems and provide them with material assistance in the form of food, shelter, medical assistance, education and other social services.

The Office of the High Commissioner seeks to help refugees wishing to return to their country of origin and become reintegrated into their communities. When this is unfeasible, UNHCR tries to assist them in their country of refuge or to find them a new host country.



The convention governing UNHCR's activities excludes, however, people guilty of crimes against peace, war crimes or crimes against humanity. Also excluded from any UNHCR assistance are people who have committed serious non-political crimes outside the country in which refuge is sought, as well as those who are guilty of acts contrary to the purposes and principles of the UN.

According to conservative estimates, there are currently over 15 million refugees within the meaning of the Convention on the Status of Refugees ("Convention refugees"). Canada is a prime destination for those seeking refuge and asylum. Since 1959, it is estimated that Canada has accepted slightly over 500 000 refugees from around the world. In recent years, however, Canada has tightened its admission criteria to allow only true Convention refugees.

Subsequently, its mandate was broadened to include the victims of the 1967 war.

By December 1997, UNRWA was providing essential services to nearly 3.5 million refugees, a third of whom were living in 59 different refugee camps.





Created in 1977, the International Fund for Agricultural Development (IFAD), which has 161 member states, grew out of the 1974 World Food Conference. The Conference had been organized to find solutions to the food crises of the early 1970s, particularly in the countries of sub-Saharan Africa. The aim of the Fund

is to combat rural hunger and poverty in developing nations. IFAD's programs focus on small agricultural producers, landless peasants, nomadic shepherds and rural women living in poverty.

Created in 1919 by the Treaty of Versailles, the International Labour Organization (ILO) is mandated to promote social justice and respect for workers' rights throughout the world. It became a UN specialized agency in 1946.

The ILO develops international labour conventions and recommendations that set the minimum standards to be followed in the areas under its mandate: freedom of association, the right to organize, collective bargaining rights, the abolition of forced labour, equality of opportunity and treatment, etc. It offers technical assistance in various sectors: vocational training and rehabilitation, employment policy, labour administration, labour law, staff relations, working conditions, management training, co-operatives, social security, labour statistics, and occupational health and safety. The international convention creating the International Maritime Organization (IMO) was adopted in 1948 in Geneva, but it was not until 1958 that the Organization officially began operating. The IMO held its first meeting the following year. It has a staff of only 300, making it one of the smallest agencies in the United Nations

system. The Organization has 155 member states.

The IMO's mandate is to improve safety at sea and control marine pollution caused by ships. Its first order of business, which it carried out in 1960, was to adopt a new version of the International Convention for the Safety of Life at Sea (SOLAS Convention), the primary instrument for marine safety. Since then, the Organization has focussed on a number of issues, including the facilitation of international maritime traffic, the transportation of hazardous goods and efforts to end unfair trade practices by shipping concerns.

The International Monetary Fund (IMF) is one of the major institutions that grew out of the 1944 Bretton Woods Agreement. The creation of the IMF, which now has 182 member states, resulted from the international community's efforts to develop an effective monetary system in order to avoid a repetition of such economic crises as the Great Depression of

the 1930s, which ruined millions of people around the world.

The IMF works closely with the World Bank. Its original mandate was to bring stability to currency exchange rates and discipline to the international monetary system, to promote international trade and capital flows, and to support high rates of sustainable economic growth. The IMF has become the central institution of the international monetary system. It oversees the economic policies of member states, provides economic and financial advice, and gives short- and medium-term financial assistance to countries facing balance of payments problems and other difficulties.

The IMF is funded by the annual contributions of its members, prorated



according to their gross domestic product and adjusted every five years. The sums held by the Fund—close to US\$287 billion —are used to grant loans to members in financial difficulty. The IMF's other main function is to co-ordinate its members' efforts to achieve greater international co-operation in setting economic policy.

Canada is the eighth-biggest contributor to the IMF, after the six other G-7 countries and Saudi Arabia.

A product of the July 1944 Bretton Woods Agreement, the World Bank was set up to help with the postwar recovery of Europe; hence its official title, the International Bank for Reconstruction and Development (IBRD). When the role of the Bank in Europe was taken over by the Marshall Plan, its focus shifted to providing loans and technical help, especially in developing nations. The Bank's main role is to help raise living standards and promote sustainable development in developing countries.

Today, the World Bank Group comprises four bodies: the International Bank for Reconstruction and Development (IBRD), the International Finance Corporation (IFC), the International Development Association (IDA) and the Multilateral Investment Guarantee Agency (MIGA).

The Group offers loans, advice and a wide range of resources geared to the needs of over 100 developing countries or countries in transition. The Bank is the world's largest supplier of development aid, with some US\$20 billion in new loans every year. The Bank also plays a vital co-ordinating role with a host of other organizations, governments, multilateral agencies and private firms: it ensures that the sums lent are used as efficiently as possible with a view to helping the recipient countries' development programs take shape.

Funds from loans are used to support a wide variety of projects in such fields as energy, agriculture, transportation, the environment, health care and education, with the general objective being to improve living standards in the recipient countries. The main goal is to make the world's poorest countries less poor. To that end, the Bank pays special attention to the development of rural regions and the role of women in development.

From 1947 to December 31, 1994, the GATT was the forum for eight rounds



- and Slovak Federal Republic would cease to exist on December 31, 1992, and that the Czech Republic and the Slovak Republic, as successor States, would apply for membership in the United Nations. Following the receipt of its application, the Security Council, on January 8, 1993, recommended to the General Assembly that the Czech Republic be admitted to United Nations membership. The Czech Republic was thus admitted on January 19 as a Member State.
- 3 Egypt and Syria were original Members of the United Nations from October 24, 1945. Following a plebiscite on February 21, 1958, the United Arab Republic was established by a union of Egypt and Syria and continued as a single Member. On October 13, 1961, Syria, having resumed its status as an independent State, resumed its separate membership in the United Nations. On September 2, 1971, the United Arab Republic changed its name to the Arab Republic of Egypt.
- 4 The Federal Republic of Germany and the German Democratic Republic were admitted to membership in the United Nations on September 18, 1973.

  Through the accession of the German Democratic Republic to the Federal Republic of Germany, effective from October 3, 1990, the two German States have united to form one sovereign State.

- 10 The General Assembly decided on April 8, 1993, to admit to United Nations membership the State being provisionally referred to for all purposes within the United Nations as "The former Yugoslav Republic of Macedonia" pending settlement of the difference that had arisen over its name.
- 11 Tanganyika was a Member of the United Nations from December 14, 1961, and Zanzibar was a Member from December 16, 1963. Following the ratification on April 26, 1964, of Articles of Union between Tanganyika and Zanzibar, the United Republic of Tanganyika and Zanzibar continued as a single Member, changing its name to the United Republic of Tanzania on November 1, 1964.
- 12 Yemen was admitted to membership in the United Nations on September 30, 1947, and Democratic Yemen on December 14, 1967. On May 22, 1990, the two countries merged and have since been represented as one Member with the name "Yemen."

## Universal Declaration of Human Rights



Whereas recognition of the inherent dignity and of the equal and inalienable rights of all members of the human family is the foundation of freedom, justice and peace in the world,

Whereas disregard and contempt for human rights have resulted in barbarous acts which have outraged the conscience of mankind, and the advent of a world in which human beings shall enjoy freedom of speech and belief and freedom from fear and want has been proclaimed as the highest aspiration of the common people,

Whereas it is essential, if man is not to be compelled to have recourse, as a last resort, to rebellion against tyranny and oppression, that human rights should be protected by the rule of law,

Whereas it is essential to promote the development of friendly relations between nations,

Whereas the peoples of the United Nations have in the Charter re-affirmed their faith in fundamental human rights, in the dignity and worth of the human person and in the equal rights of men and women and have determined to promote social progress and better standards of life in larger freedom,

Whereas Member States have pledged themselves to achieve, in co-operation with the United Nations, the promotion of universal respect for and observance of human rights and fundamental freedoms,

Whereas a common understanding of these rights and freedoms is of the greatest importance for the full realization of this pledge,

Now, Therefore the General Assembly proclaims this Universal Declaration of Human Rights as a common standard of achievement for all peoples and all nations, to the end that every individual and every organ of society, keeping this Declaration constantly in mind, shall strive by teaching and education to promote respect for these rights and freedoms and by progressive measures, national and international, to secure their universal and effective recognition and observance, both among the peoples of Member States themselves and among the peoples of territories under their jurisdiction.

. Article 1

All human beings are born free and equal in dignity and rights. They are endowed with reason and conscience and should act towards one another in a spirit of brotherhood.

. Article 2

- 1 Everyone is entitled to all the rights and freedoms set forth in this Declaration, without distinction of any kind, such as race, colour, sex, language, religion, political or other opinion, national or social origin, property, birth or other status.
- 2 Furthermore, no distinction shall be made on the basis of the political, jurisdictional or international status of the country or territory to which a person belongs, whether it be independent, trust, non-self-governing or under any other limitation of sovereignty.

Article 3

Everyone has the right to life, liberty and security of person.

Article 4

No one shall be held in slavery or servitude; slavery and the slave trade shall be prohibited in all their forms.

Article 5

No one shall be subjected to torture or to cruel, inhuman or degrading treatment or punishment.

Article 6

Everyone has the right to recognition everywhere as a person before the law.

Article 7

All are equal before the law and are entitled without any discrimination to equal protection of the law. All are entitled to equal protection against any discrimination in violation of this Declaration and against any incitement to such discrimination.

. Article 8

Everyone has the right to an effective remedy by the competent national tribunals for acts violating the fundamental rights granted him by the constitution or by law. . Article 9

No one shall be subjected to arbitrary arrest, detention or exile.

Article 10

Everyone is entitled in full equality to a fair and public hearing by an independent and impartial tribunal, in the determination of his rights and obligations and of any criminal charge against him.

Article 11

- 1 Everyone charged with a penal offence has the right to be presumed innocent until proved guilty according to law in a public trial at which he has had all the guarantees necessary for his defence.
- No one shall be held guilty of any penal offence on account of any act or omission which did not constitute a penal offence, under national or international law, at the time when it was committed. Nor shall a heavier penalty be imposed than the one that was applicable at the time the penal offence was committed.

Article 12

No one shall be subjected to arbitrary interference with his privacy, family, home or correspondence, nor to attacks upon his honour and reputation. Everyone has the right to the protection of the law against such interference or attacks.

Article 13

- 1 Everyone has the right to freedom of movement and residence within the borders of each state.
- 2 Everyone has the right to leave any country, including his own, and to return to his country.

Article 14

- Everyone has the right to seek and to enjoy in other countries asylum from persecution.
  - This right may not be invoked in the case of prosecutions genuinely arising from non-political crimes or from acts contrary to the purposes and principles of the United Nations.

Article 15

- 1 Everyone has the right to a nationality.
- No one shall be arbitrarily deprived of his nationality nor denied the right to change his nationality.

. Article 16

- Men and women of full age, without any limitation due to race, nationality or religion, have the right to marry and to found a family. They are entitled to equal rights as to marriage, during marriage and at its dissolution.
- 2 Marriage shall be entered into only with the free and full consent of the intending spouses.
- 3 The family is the natural and fundamental group unit of society and is entitled to protection by society and the State.

Article 17

- 1 Everyone has the right to own property alone as well as in association with others.
- 2 No one shall be arbitrarily deprived of his property.

Article 18

Everyone has the right to freedom of thought, conscience and religion; this right includes freedom to change his religion or belief, and freedom, either alone or in community with others and in public or private, to manifest his religion or belief in teaching, practice, worship and observance.

Article 19

Everyone has the right to freedom of opinion and expression; this right includes freedom to hold opinions without interference and to seek, receive and impart information and ideas through any media and regardless of frontiers.

Article 20

- 1 Everyone has the right to freedom of peaceful assembly and association.
- 2 No one may be compelled to belong to an association.

Aticle 21

- 1 Everyone has the right to take part in the government of his country, directly or through freely chosen representatives.
- 2 Everyone has the right of equal access to public service in his country.
- 3 The will of the people shall be the basis of the authority of government; this will shall be expressed in periodic and genuine elections which shall be by universal and equal suffrage and shall be held by secret vote or by equivalent free voting procedures.

Article 22

Everyone, as a member of society, has the right to social security and is entitled to realization, through national effort and international co-operation and in accordance with the organization and resources of each State, of the economic, social and cultural rights indispensable for his dignity and the free development of his personality.

Article 23

- 1 Everyone has the right to work, to free choice of employment, to just and favourable conditions of work and to protection against unemployment.
- 2 Everyone, without any discrimination, has the right to equal pay for equal work.
- 3 Everyone who works has the right to just and favourable remuneration ensuring for himself and his family an existence worthy of human dignity, and supplemented, if necessary, by other means of social protection.
- Everyone has the right to form and to join trade unions for the protection of his interests.

. Article 24

Everyone has the right to rest and leisure, including reasonable limitation of working hours and periodic holidays with pay.

. Article 25

- Everyone has the right to a standard of living adequate for the health and well-being of himself and of his family, including food, clothing, housing and medical care and necessary social services, and the right to security in the event of unemployment, sickness, disability, widowhood, old age or other lack of livelihood in circumstances beyond his control.
- 2 Motherhood and childhood are entitled to special care and assistance. All children, whether born in or out of wedlock, shall enjoy the same social protection.



- 1 Everyone has the right to education. Education shall be free, at least in the elementary and fundamental stages. Elementary education shall be compulsory. Technical and professional education shall be made generally available and higher education shall be equally accessible to all on the basis of merit.
- 2 Education shall be directed to the full development of the human personality and to the strengthening of respect for human rights and fundamental freedoms. It shall promote understanding, tolerance and friendship among all nations, racial or religious groups, and shall further the activities of the United Nations for the maintenance of peace.
- 3 Parents have a prior right to choose the kind of education that shall be given to their children.

Article 27

- 1 Everyone has the right freely to participate in the cultural life of the community, to enjoy the arts and to share in scientific advancement and its benefits.
- 2 Everyone has the right to the protection of the moral and material interests resulting from any scientific, literary or artistic production of which he is the author.

Article 28

Everyone is entitled to a social and international order in which the rights and freedoms set forth in this Declaration can be fully realized.

Article 29

- Everyone has duties to the community in which alone the free and full development of his personality is possible.
- 2 In the exercise of his rights and freedoms, everyone shall be subject only to such limitations as are determined by law solely for the purpose of securing due recognition and respect for the rights and freedoms of others and of meeting the just requirements of morality, public order and the general welfare in a democratic society.
- 3 These rights and freedoms may in no case be exercised contrary to the purposes and principles of the United Nations.

Article 30

Nothing in this Declaration may be interpreted as implying for any State, group or person any right to engage in any activity or to perform any act aimed at the destruction of any of the rights and freedoms set forth herein.



## Secretary-General Kofi Annan



he seventh Secretary-General of the United Nations, Kofi Annan is, of all those who have held the position, the one with the most experience in the organization. When appointed in December 1996 for a five-year term commencing in January 1997, Mr. Annan, who has spent more than 30 years at the UN, was Under-Secretary-General for Peacekeeping Operations.

Born on April 8, 1938, at Kumasi, Ghana, Mr. Annan is fluent in English, French and several African languages. After studying at the University of Sciences and Technologies in Kumasi, he received a degree in economics from Macalester College in St. Paul, Minnesota, in 1961. After a year at the Institut universitaire des hautes études internationales in Geneva, he began working for the

World Health Organization. A few years later, he went back to school and in 1972 obtained a master's degree in management from the Massachusetts Institute of Technology before joining the UN.

Mr. Annan has performed a wide range of duties in his career at the UN, becoming involved not only in management-administration, budgets, finance and personnel-but also in refugee problems and peacekeeping matters. He distinguished himself by leading a number of delicate diplomatic missions, including the negotiations to repatriate over 900 international civil servants and to liberate Western hostages in Iraq following that country's invasion of Kuwait in 1990, the development of the "oil for food" formula adopted in response to the humanitarian crisis in Iraq, and the supervision of the transition phase between the United Nations Protection Force (UNPROFOR) in the former Yugoslavia and NATO's Implementation Force (IFOR) following the signing of the Dayton peace accord in 1995.

## Deputy Secretary-General Louise Fréchette



orn in Montréal on July 16, 1946,
Louise Fréchette was appointed
to the post of Deputy SecretaryGeneral of the United Nations at the end
of February 1998, following the adoption
by the General Assembly of the program
of reforms proposed by Mr. Annan.
Ms. Fréchette has had a long career in
diplomacy, having held several important positions in Canada's Department
of Foreign Affairs and International
Trade, which she joined in 1971.

Among her many positions, she served as Canada's Ambassador to Argentina and Uruguay, Assistant Deputy Minister for Latin America and the Caribbean, and Assistant Deputy Minister for Economic Policy and Trade Competitiveness. In 1994, Ms. Fréchette was Canada's Ambassador to the United Nations in New York before being appointed in June 1995 as Canada's Deputy Minister of National Defence. She graduated from the Université de Montréal with a degree in history, and from the College of Europe in Bruges with a diploma in economic studies.

## **Boutros Boutros-Ghali** (Egypt)

January 1, 1992, to December 31, 1996

orn in Cairo on November 14, 1922, Boutros Boutros-Ghali is a lawyer and a career diplomat. After receiving a doctorate in international law from the Université de Paris in 1949, he taught international law and international relations at the University of Cairo until his appointment as Egypt's Minister of State for Foreign Affairs in 1977.

Heavily involved in international affairs, he had a hand in negotiating the Camp David accords signed by Egypt and Israel in 1979. He headed the Egyptian delegation to the UN General Assembly in 1979, 1982 and 1990. Before taking up his duties as UN Secretary-General on January 1, 1992, he also served as Vice-President of the Socialist International.

## Javier Pérez de Cuéllar (Peru)

January 1, 1982, to December 31, 1991

avier Pérez de Cuéllar was born in Lima on January 19, 1920. He joined the Peruvian Ministry of Foreign Affairs in 1940 and eventually made his way to the top, serving as Ambassador to Switzerland, the Soviet Union, Poland and Venezuela. In 1971 he was named Peru's Permanent Representative to the United Nations.

In 1973 and 1974 he represented his country on the Security Council, serving as President of the Council during the Cyprus crisis in July 1974. On September 18, 1975, he was named Special Representative of the Secretary-General in Cyprus, a post he held until December 1977. In 1979 he was appointed United Nations Under-Secretary-General for Special Political Affairs. In May 1981 he returned to Lima, where he remained until his appointment as UN Secretary-General in December of that year. He served two terms.

## Kurt Waldheim (Austria)

January 1, 1972, to December 31, 1981

orn in Sankt Andrä-Wörden, near Vienna, on December 21, 1918, Kurt Waldheim is a lawyer and career diplomat. After receiving a doctorate in law from the University of Vienna, he joined the diplomatic service in 1945 and was appointed the Permanent Observer for Austria to the United Nations in 1955, and then the head of the Austrian mission when Austria was admitted to the United Nations.

From 1956 to 1960, he represented Austria in Canada. He then returned to Vienna, where he served as Director-General for Political Affairs. In 1964, he was named Austria's Permanent Representative to the United Nations. From 1968 to 1970 he served as his country's Minister of Foreign Affairs before being re-appointed Austria's Representative to the UN. He held this post until he was named Secretary-General at the end of 1971. After his diplomatic career, he served as President of the Austrian Republic from 1986 to 1992.

# **U Thant**(Myanmar—formerly Burma) November 3, 1961, to December 31, 1971

January 22, 1909, U Thant worked in the field of education and for the government, where he served as Director of Broadcasting, before joining the diplomatic service. In the 1950s he worked in

the Prime Minister's office and headed

Burma's Economic and Social Board.

In the early 1960s, he represented his country at the UN. On November 3, 1961, he was appointed to fill the unexpired term of Dag Hammarskjöld, who had died in an air crash. One year later he

was appointed for a term of office ending in November 1966, and was subsequently re-elected for another term ending December 31, 1971. U Thant had to deal with an unprecedented number of serious international crises requiring deft handling, including African decolonization, the Cuban missile crisis in 1962, the Indo-Pakistani crisis in 1965, the Middle East war in 1967 and the Vietnam war. U Thant was also a writer, authoring a number of books including *The League of Nations* in 1933. He died in New York in 1974.

## **Dag Hammarskjöld** (Sweden)

April 7, 1953, to September 1961

orn on July 29, 1905, in Jonkoping, Sweden, Dag Hammarskjöld met with a tragic fate when he died in a plane crash in Zambia in September 1961. After receiving a doctorate in law and political science, he taught at the University of Stockholm before becoming Under-Secretary of the Finance Ministry and then Chairman of the Board of the National Bank of Sweden from 1941 to 1948.

Dag Hammarskjöld joined the Foreign Office in 1946 as a financial adviser. In 1950 he was appointed Minister of State. Later, he led his country's delegation to the General Assembly and, on April 7, 1953, was appointed Secretary-General of the United Nations. He was unanimously reelected for a second term on September 26, 1957. He was posthumously awarded the Nobel Peace Prize in 1961.

## **Trygve Halvdan Lie** (Norway)

February 1, 1946, to April 7, 1953

rygve Lie was born in Oslo on July 16, 1896. He was elected a member of the Norwegian Parliament in 1935, and served as Minister of Justice, Minister of Trade, and Minister of Supply and Shipping. When his country was invaded by Germany, he fled with his government to London and in 1941 became Foreign Minister for the Norwegian government in exile.

In 1945 he led his country's delegation to the San Francisco Conference, where the UN Charter was signed. There he chaired the commission responsible for drafting the Security Council provisions of the Charter. The following year, he led the Norwegian delegation to the first session of the General Assembly, held in London. It was there that he was elected the first Secretary-General of the United Nations. On November 1, 1950, his term of office was extended by three years, but in 1952 he submitted his resignation. He died on December 30, 1968, at the age of 72.

Central figure in the negotiations that led to the Law of the Sea Convention (1967–82). Proponent of the idea that the oceans belong to the "common heritage of mankind."

#### **Harry Black**

Served as Executive Director of UNICEF in the 1970s.

#### Lt.-Gen. E.L. Burns

Assembled and led the United Nations Emergency Force, which defused the Suez Crisis in 1956. Served as Chief of Staff for the United Nations Truce Supervision Organization.

#### **James Carney**

Helped launch an aid program for developing nations by producing over 200 films for the United Nations Conference on Human Settlements in 1976. Commissioner-General for the UN Pavilion at Expo 86 in Vancouver.

#### **Margaret Catley-Carlson**

Deputy Executive Director of Operations at UNICEF, with the rank of UN Under-Secretary-General (1981–83).

#### **Brock Chisholm**

First Director-General of the World Health Organization.

#### Rt. Hon. Joe Clark

Former Prime Minister and Secretary of State for External Affairs, served as Special Representative of the Secretary-General for Cyprus. Also played an important role in mobilizing international opinion against apartheid in South Africa.

#### Justice Jules Deschênes

Chaired the Commission of Inquiry on Romania (1989–91). Served as a consultant for the UN Centre for Social Development and Humanitarian Affairs in Vienna (1983–85). Judge on the international tribunals investigating war crimes committed in the former Yugoslavia and Rwanda.

#### **Elizabeth Dowdeswell**

Canada's Permanent Representative to the World Meteorological Organization. Executive Director of the UN Environment Programme in 1992. A world expert on climate.

#### William Epstein

Secretary of the United Nations
Disarmament Commission (1952–72).
Director of the Department for
Disarmament Affairs (1954–72).
Played an important role in numerous
negotiating sessions leading to the
signing of several arms control
treaties, including the Partial Test
Ban Treaty (1963) and the Biological
Weapons Convention (1972).

#### Col. Don Ethell

Commanded the Canadian contingent serving under the United Nations Disengagement Observer

Force in the Middle East. Helped bring about large-scale prisoner of war exchanges between Syria and Israel. Called out of retirement to lead Canadian personnel taking part in the European Co-operation Commission's observer mission in the former Yugoslavia.

#### **Ron Gould**

Organized the UN mission to Nicaragua (1989). Led a fact-finding mission to Cambodia to help plan and organize the 1991 elections. Directed the UN's Electoral Assistance Division in Mozambique (1994) and took part in the UN's pre-electoral mission to Tanzania (1995).

#### John Peters Humphrey

Organized the Human Rights Division of the UN Secretariat. Wrote the first draft of the Universal Declaration of Human Rights and oversaw the debates on the Declaration in the General Assembly.

#### **Paul Ignatieff**

Worked for UNICEF throughout the world. Served as UNICEF representative in Japan, then as Director of its Geneva office.

#### Philippe Kirsch

Legal Adviser, Department of Foreign Affairs and International Trade. Deputy Ambassador to the UN (1988–92). Chaired the Special Working Group on Peacekeeping. Chaired the UN's Judicial Commission (1982) and the drafting committees of several international human rights conventions. In 1998, chaired the Committee of the Whole of the Conference on the

Treaty of Rome establishing the International Criminal Court, a first in international human rights law.

#### **Stephen Lewis**

Canada's Ambassador to the United Nations (1984–88). Chaired the committee that designed the UN's five-year program for African economic recovery. Secretary-General's special adviser on Africa (1986–91). Deputy Director (external relations) for UNICEF in 1995. Member of the advisory group for the Fourth World Conference on Women (1995).

### Maj.-Gen. Lewis MacKenzie

Participated in seven peace missions throughout the world. Chief of Staff of the United Nations Protection Force (UNPROFOR) in the former Yugoslavia in 1992.

### Elisabeth Mann-Borgese

Expert on law of the sea. Received the UNEP Sasakawa Environment Prize in 1987.

#### Lucien Michaud

Chair of the Council of the United Nations University since 1995.

#### **Tamar Oppenheimer**

Former Secretary-General of the UN Conference on the Environment (1972), first Executive Director of UNEP, Co-ordinator of the UN's Office for Emergency Operations in Africa (1985–86), and Secretary-General of UNCTAD (1992). Also chaired the World Federation of United Nations Associations (WFUNA) and the 1992 Earth Summit in Rio.

#### **Gerald Trant**

Executive Director of the World Food Council in 1986.

#### **Harry Winsor**

Joined FAO in 1946. Organized the first regional fisheries development project in the West Indies. Was the first Director of Operations (Fisheries) at the FAO (1968–74), and FAO Senior Director (1974–79).

## **United Nations Association in Canada**

As a large-scale international organization, the United Nations may seem very distant and inaccessible to the general public. Although it is not a world government, it faces a challenge familiar to democratic governments: staying in touch with its constituents.

To narrow the gap between the UN and ordinary citizens, over the years a network of voluntary UN associations has grown up in 80 countries.

One of the most active is the United Nations Association in Canada (UNA-Canada). From its small national head-quarters in Ottawa and 15 branches across the country, the 15 000-member organization works year-round to promote Canadian understanding of the UN and support for its cause.

The essence of the task is communication. UNA-Canada is a national clearing house for information about the UN. Among other things, it fields public and media inquiries, publishes a newsletter and other material, and operates a Web site. It also keeps Canadian industry up to date on UN-related business opportunities.

Locally and nationally, the Association is a tireless proponent of international co-operation, marshalling public and government support for UN action on such issues as landmines, human rights, food security, and the financial crisis caused by non-payment of UN dues on the part of some members.

The national office organizes annual events, including gala dinners that combine fund-raising with promotion by featuring UN officials as keynote speakers. Each year, the Association awards the

Pearson Peace Medal for distinguished service in support of human rights and other international causes.

With the UN turning 54 years old in 1999, UNA-Canada is focussing special attention on youth. Says Executive Director Harry Qualman, "People who can remember when and why the UN came into being are gradually passing from the scene. We have to guard against a generation gap in understanding."

UNA-Canada's youth programs include the following:

- support, through its branches, for model UN Assemblies in which high school and university students take the part of member states in the General Assembly and the Security Council;
- operation of an internship program funded by the Department of Foreign Affairs and International Trade, which places recent university graduates in UN and UN-related offices abroad; and
- a regular poll of Canadians about their UN views. ("Support has stayed high over the years," says Mr. Qualman.
   "We take some credit for that.")
