## HOLLAND ISSUES HER ULTIMATUM

**Demands that Venezuela Revoke Be-  
fore Nov. 1st Decree Issued  
May 14th Last.**

### COURTEOUSLY FRAMED

(Special News Service)  
THE HAGUE, Monday. — Hol-  
land's notes to Venezuela contain  
one point which appears practically  
an ultimatum. Holland demands of  
Venezuela the revocation before Nov-  
ember 1st of the decree issued by  
President Castro on May 14 last  
which resulted in the practical sup-  
pression of Caracas trade. This de-  
cree made obligatory the trans ship-  
ment of all goods from and to Mar-  
acaibo and other ports in Western  
Venezuela and Porto Cabello instead  
of Willemstad as previously had been  
the custom. This demand, however,  
President Castro on May 14 last is  
framed in courteous and mild lan-  
guage.

### GOT ONE MONTH EACH

house. The steamship was bound for Cork, Ireland, and had proceeded as far as Point LeGarde, when the crew struck, refusing to work the vessel further, claiming that she was unseaworthy. On receipt of a mes-  
sage from the captain explaining the situation, seven warrants were issued and Chief Crawford, assisted by  
Officers Savoy and Fleming, went down to the steamship in a tug and brought the crew to town. The names of the men are as follows:—

**PIETERMARITZBURG, Monday.**— Apparently there is fresh trouble in part of Zululand. Colonel Duncan Mackenzie, commandant of the Colony's forces, has left hurriedly for Dundee, accompanied by Colonel Wilson, with field artillery, officers and men. The Natal police have been called in from out stations with orders to proceed immediately to Melmoth and join the force despatched there on July 27. On the arrival of the second force 200 men will be there. They will proceed to N'Kandha, the reputed storm centre.  
It is impossible to say whether this latest move has any bearing on the reported serious unrest mentioned in the Natal Government's despatches to the Colonial Office in July. The authorities are reticent.

With a companion Miss Hall was picking tomatoes in her father's garden while in an adjoining field Allen was waiting with his gun for a fox that had been raiding his father's chickens. Firing of waiting for the fox, Allen said that he crept up to the stone wall separating him from his sister and pointing the gun at her commanded her to throw up her hands.

Mr. A. B. Leonard, merchant of Matapedia, is a personal friend of Sir Wilfrid Laurier for whom he has an undeviating admiration. He loves to recall the many struggles for the nation of the great premier.

Mr. Bouchard and four court-stationers were once boys together in the little village of Athabasca. There was a common enemy, a friendly school that lived in the town and the young Wilfrid at that time, according to Mr. Bouchard, was a youth of frail physique with a tendency towards consumption. Despite his physical weakness, however, he was a prodigious student, being seldom seen in his spare hours without some abstruse volume in his hands over which he would pore, unmindful of the flight of time. His ambition then, as now, was to carve his name deeply upon the tablets of Canadian history as a law-giver and a statesman.

Of this ambition he would often speak when in the company of his favorite companions and those who listened to his profound reasoning, even at that early age were not surprised to learn in the after years that the studious weaking of Athabasca had reached by his own efforts the highest office in the gift of the people of Canada.

By a strange caprice of fate he was defeated in his first attempt to win political honors, by the brother of Mr. Bouchard, who was the candidate of the opposition. The next election, however, told a different story when young Laurier was elected by a splendid majority.

Mr. Bouchard is enthusiastic in his praise of the curacy manner and sterling character of Sir Wilfrid, going as far as to call him the greatest statesman on the American continent. Only recently he received from the premier an urgent invitation to visit him at his home. The words he used were "Bouchard, my old friend, I wish to see you before I die."

An enthusiastic meeting of Campbellton citizens was held in the Campbellton Club rooms last evening to hear Mr. Clinch of the Fish, Forest and Game Protective Association discourse on the aims and objects of the association.

His Honor Judge McIntyre was chosen chairman and H. B. Anselow, secretary of the meeting. His Honor briefly stated the object of the meeting and introduced Mr. Clinch.

Mr. Clinch in a clear and concise manner stated the object of the Association, the object of the Association was to work for the protection of the forest and streams in the province of New Brunswick. He stated that in 1902 one hundred and thirty-three thousand eight hundred and fifty-five persons visited Maine to shoot or fish. In 1908 this number had increased to 250,000 while in 1907 it was nearly 400,000. When you consider that each one of these people spend on an average \$100 you can realize what that means to the state. During financial panics Maine is prosperous. Its young men stay at home and many new industries have been established by sportsmen, who, visiting their country in search of game, saw its natural resources and took advantage of them.

The object of the association was to conserve and protect the river fishing. The speaker spoke of the blocking of rivers with dams, and the dumping of saw dust in such streams, and stated that the association had already done good work on the St. John river. The matter of forest protection against fires was also referred to. In reference to the big game Mr. Clinch stated that with the exception of remote parts of British Columbia in New Brunswick had the best moose hunting territory in the world. This fact we should advertise, and besides the protection of the game, this was one of the objects of the association.

In closing he strongly advised the forming of an association. Mr. W. A. Mott said that he had listened with pleasure and profit to the remarks of Mr. Clinch and he moved that an association be formed and that A. McG. McDonald be the president. Carried unanimously. Mr. McDonald thanked the meeting for the honor conferred on him and would do all he could to further the work.

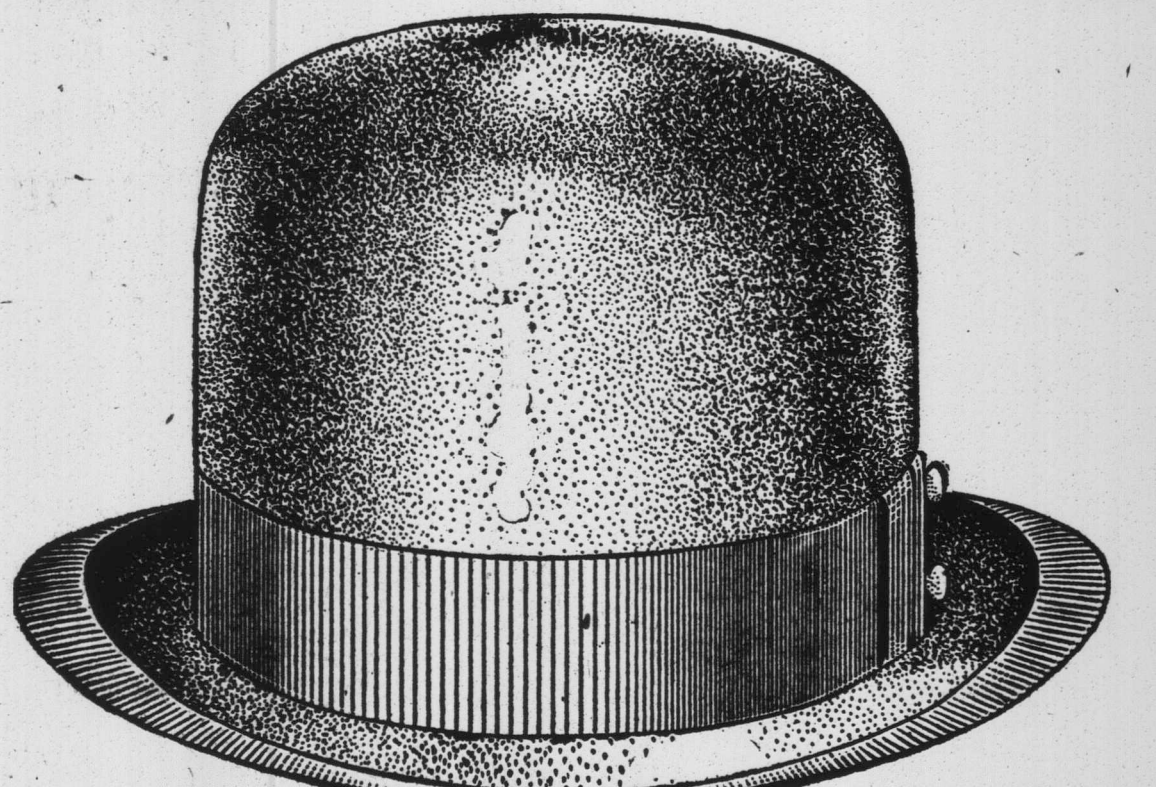

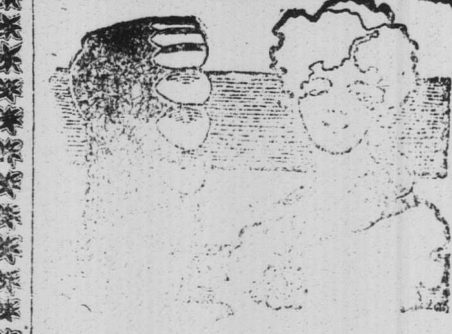
