Murdree's Bar, Cal., Sept. 1857.

Glorious country this, for women.

14th. What are the prospects for a man of family in the mines?

First rate prospects of having none on his hands in a short time.

15th. What kind of business pays well?

All kinds, if you can get the money; credit a man, and ten to one he will lick you if you don't him. Very good country for business; very good indeed!

16th. What branches of business are mostly followed?

Drinking whiskey and loafing.

17th. Are the people who have settled permanently, satisfied?

Perfectly satisfied, that if they were back where they came from, they never would be such fools as to leave.

18th. How are the laws regarded and enforced?

According to circumstances. If the people want a show, they hang some poor devil on suspicion, for an example, and demonstrate to all the world, "and the rest of mankind," that all law emanates from the people. It is generally enforced with a rope over a limb.

19th. Is a man generally safe travelling through the country?

It is stated that the Lord Mayor of Dublin has received an invitation from Her Majesty to be present at the coronation of the marriage between the Princess Royal and the Prince of Prussia.

FIRE IN PRINCESS STREET.—Yesterday afternoon a fire broke out on the premises of Mr. Dunn, Cabinet Maker, &c., in Princess Street. The flames were discovered in the upper story, and fortunately were confined to that part of the building. The Engine of No. 6 Company, being on the spot almost simultaneously with the first alarm of fire, poured on the devouring element a stream of water sufficient to daunt the fiercest flame, and with the assistance which at that hour of the day was promptly at hand, the fire was speedily subdued before very great damage had been done.—[Leader.]

ANARCHY IN MEXICO.—The Romish hierarchy, appear to be now, as they have been all along, the Chief Engineers of the whole movement, which has for its grand object the annihilation of Comofort, for the unpardonable sin of secularizing the ecclesiastical estates, a measure with which he initiated his administration, and which will be long remembered as the distinguishing act of his public policy.—[Boston Traveller.]

General Walker is a modest man—very. He has stated the amount to which he has been damaged by the two arrests at San Juan del Sud and Punta Arenas; and that amount is \$140,000. Now, we cannot but think that, in the event of the little filibuster being allowed that amount of damages, he will make a good thing of his two seasons, as all precedent shows that he is not very apt to disburse any large proportion of his funds for the relief of the poor and suffering, who may be connected with him. So we must estimate General Walker's private damage at \$140,000, and think it a high price for the individual.

A curious lawsuit is going on just now in Berlin. A rich banker of that city, who is ill of the small pox, has had two actions brought against him, one by his barber, and the other by his upholsterer, who claim damages, because he communicated the malady to them. They demand compensation for the doctor's expenses, and the time they have lost. According to the Prussian law, the banker was bound to hang up outside his door a notice with the words, "There is a person here ill of the small pox."

# European Intelligence.

## ARRIVAL OF THE STEAMER CANADA AT HALIFAX.

### Improvement of the Money Market—Attempt to Assassinate Louis Napoleon.

The steamship *Canada* sailed from Liverpool on 16th inst., and called off Cork on the following day for the purpose of taking on board the mails and 66 passengers of the steamship *Ariel*, which had to put back to Cork in distress. She proceeded about noon the same day and reached Halifax at 4 o'clock on Thursday morning.

The Agent of the Associated Press is indebted to A. L. Holley, Esq., one of *Ariel's* passengers, who came in the *Canada*, for the subjoined particulars relative to that disaster:—

"*Ariel*, with 96 passengers, mails, and heavy freight, left Bremen on Dec. 27th, and was on the 31st. Experienced strong westerly gales which gradually increased until January 6th, when at 9 p. m., in lat. 50 N., lon. 29 W., broke starboard shaft just outside ship. Hove to under dray and storm sail till morning. On 7th found port wheel could be worked. Ship was then put about East at 8 knots. Shipped several tremendous seas and broke fore-yard—was again laid to till morning of 9th; succeeded in sighting Cape Clear on morning of the 14th, and reached Queenstown about-noon of next day.

Ship *Oxford*, of Freeport, Maine, from Lehigh for Boston, was abandoned at sea in November, in a very leaky condition.—Capt. Minott and crew were picked up and taken to Gibraltar by American ship *Mary* and *Mertha*.

As he and the *Empress* were entering the Italian Opera about a quarter past nine the explosion of three hollow projectiles was heard, and it was soon ascertained that by these the Emperor's Aid de-Camp and footman were merely wounded, one of the carriage horses killed, the carriage itself much broken, and a projectile of some kind passed through the Emperor's hat. Five other persons, including two soldiers, were killed, and 60 wounded—11 of them dangerously.

The Emperor showed himself immediately after to the people, and was loudly cheered. He and the *Empress* staid at the Opera to the close, and when they left at midnight were enthusiastically cheered by the vast multitude which the report of what had occurred brought to the streets. Next day the Emperor and *Empress* drove round Paris in an open caiche, and the Emperor visited the wounded.

The assassins are Italians, and several arrests have been made, including the notorious Count Orsini and a Count Pierre.—The French Police had information of the plot from the Belgian Police, and a few minutes before the explosion an Italian was arrested near the theatre, on whom was found a grenade, a revolver, and a poison.

English funds were depressed in consequence of this.

The Bank of England has reduced its rate of interest to 5 per cent., and money can be had in the streets for good paper at 8½ to 4 per cent.

The Leviathan has at length been dragged to within about 6 feet of the end of the ways, and will be allowed to remain there until the next high tides.

Reform Meetings were being extensively held both in London and Province. Chartists were taking part in them.

Col. Inglis promoted to Major General, for gallant defence at Lucknow.

India.—India weekly mail from Bombay with dates to the 24th Dec. reached Alexandria. Nothing from Oude or Cawnpore, owing it is presumed to continued interruption of mail between Calcutta and Bombay. Garrison of Futtehpore, pressed by insurgents, have abandoned part of their entrenchments, and taken up another and more secure position.

A column from Delhi, under Col. Seaton, attacked a body of insurgents at Genowree, and defeated them, killing 150 and taking three guns out of four. Three British officers were killed, one wounded.

The insurgents in the neighbourhood of Jubbulpore were attacked on 25th Nov. without decisive result. Reinforcements were advancing to Jubbulpore.

The Rajah of Amjheer and his minister, had been tried and sentenced to death.—Minister hanged: sentence of Rajah awaits confirmation of Government of India: other executions also taken place.

The Punjab, Scinde and Bombay all quiet. No further Bheel depredations reported. Quiet prevails generally.

Bombay import market generally lower.—Cotton declined. Exchange 2s. 2½d.

Spain.—Bravo Murillo was elected President of lower Chamber of Cortes by majority of 6 over Ministerial candidate.

Despatch from Madrid of 4th, says Spanish Ministry have tendered their resignation in consequence of nomination of Bravo Murillo; resignation has not been accepted.—Cabinet will retain office if Queen shall consent to dissolve Cortes.

Madrid despatch, Friday, reports acceptance of Ministers' resignation and formation of new Cabinet.

Italy.—M. Mazzini had published an article of eight columns in the *Italia del Popolo* addressed to the men of action, and telling them that to conspire is not a right but a duty.

Russia.—The nobles of district of Nign Norgored following example of nobles of Lithuania and St. Petersburg, had asked

Emperor's permission to enfranchise their serfs. Emperor granted the request.

China.—Hong Kong correspondent of London Times under date Nov. 28th, says, Mr. Reed, American Commissioner, remained on board frigate *Minnesota*, carefully avoiding any entangling alliances. He says *Minnesota* from her great size, would prove almost useless for warlike purposes in China sea.

Same letter predicts that British would have possession of Canton before end of year, and that free and unrestricted intercourse with China would be demanded.

Loan for India.—Times says an impression seems to be entertained that amounts instead of being limited to 6 or 8 millions will be as much as 10 millions.

The Funds.—The Times City article says attempted assassination of Napoleon caused flatness of funds today. Stock exchange rate for advances remain at 3 per cent. At Bank to-day applications were rather more numerous.

Markets.—Consols 94 3/4. Bank rate reduced to 5 per cent.

Cotton quiet and dull.

Breadstuffs declined. Wheat 21 to 23; Flour 64; Corn 1s. 10d.

Sugar firm and improved. Coffee and Tea unaltered, but in fair demand.

Timber.—Yellow Pine, 16d to 20d; Red 14d to 15d; Spruce 16d to 17d; Birch, 16d to 20d; Deals, 27 10 to 28 10.

Freights.—Boston, 10s to 13s 6d; New York, 8s to 10s; Philadelphia, 15s; New Orleans.

Accident on the River.—On Wednesday night, 27th, as three gentlemen belonging to this city, viz. S. R. Thomson, Esq., barrister, and Messrs. D. Howard and F. Frith, were returning from Gagetown by the ice, the horses they were driving fell through at Beadley's Point, at the Western entrance to Bellisle Bay, and both of them were lost. Attempts were made to save the animals, but without success. It was after midnight when the accident happened, and in the morning the sleigh and harness were recovered. The ice at this point is always unsafe, owing to the current which runs into the Saint John River, and had they driven a little further out, the lives of all would have been lost. It was a narrow escape from instant death. The horses belonged to Mr. Stockford's Livery's Stables.—New Brunswick.

Gold Discoveries in New Brunswick.—Quite a sensation has been created among our citizens during the past few days in consequence of the reported discovery of gold in Fairy stream, above South Bay, a few miles from Carleton. Numbers have gone out to search for the precious metal, and it is said that small quantities of the real dust and a few little nuggets have been found.—Whether the precious metal is there in sufficient quantities to reward the searchers, remains to be seen.—[ib.]

From the United States.

Official and other advices received at Washington, render it more and more certain that Brigham Young intends to resist the Federal Government. It is believed that he can muster 8,000 men. His intrigues have extended into Texas and California, and men holding responsible positions there are said to be compromised. At the same time the losses and sufferings of the troops, now wintering in the mountains, are even worse than has been reported, the War Department not daring to publish its full advices. It seems now to be settled that Gen. Scott is to go to California to be ready for action there in case of emergency. Gen. Walker's men have been discharged by orders from Washington. Many of them are wandering about the city of Norfolk, destitute, poorly clad, and moneyless.

Gen. Walker has written a letter to the President, in which he declares his determination to proceed again to Nicaragua, and the President has caused peremptory orders to be issued to the Federal officers at the South, to stop all filibustering expeditions if possible.

Lord Napier gave a fete on Monday last in Washington in favor of the marriage of the Princess Royal, that was the most brilliant spectacle ever witnessed here. About 600 persons were present. The whole diplomatic corps in court costume were in attendance. A body of officers of the United States Army and Navy were also there, with Gen. Scott at their head in full uniform. The British Consuls at New York, Philadelphia, Baltimore and other places, attended, and many distinguished strangers, specially invited from distant cities. There was the richest display of female toilets yet seen in Washington, several of them having cost thousands of dollars.

The "friends and fellow-countrymen" who have so disgracefully elected T. D'Arcy McGee to a seat in the Canadian Parliament, for Montreal, are now, as might be expected, at complete loggerheads among themselves. This characteristic fracas results from an accusation for "treachery" brought against Mr. McGee by a Mr. Howard, and against Mr. Howard by Mr. McGee. We trust their differences will prosper; and further, that no man who loves either his country or character, will demean himself by accepting the legislative society of such a disreputable rebel and traitor to his country as McGee. He should be "away in Alabama with his banjo on his knee", assisting his old companion Mitchell to drill his slaves.—Fredericton Reporter.
