An Act to render the judgments of the late Provincial Court for the Inferior District of Saint Francis executory and for the Removal of the Records of the said Court into the Circuit Court at Sherbrooke.

B I L L.

An Act to render the judgments of the late Provincial Court for the Inferior District of Saint Francis executory, and for the Removal of the Records of the said Court into the Circuit Court at Sherbrooke.

WHEREAS by the Act passed in the Session held ^{Preamble.} in the fourth and fifth years of Her Majesty's Reign, intitled, "*An Act to provide for the more easy and expeditious administration of Justice in Civil Cases, and matters involving small pecuniary value, in that part of this Province heretofore Lower Canada,*" the late Provincial Court for the Inferior District of Saint Francis was abolished; and whereas by the said recited Act no provision was made for the removal of the records of the said late Provincial Court into the District Court thereby established or to render the judgments theretofore rendered in the said late Provincial Court executory in the said District Court; and whereas no provision was made by the Act passed in the seventh year of Her Majesty's Reign, and intitled "*An Act to repeal certain Acts and Ordinances therein mentioned, and to make better provision for the administration of Justice in Lower Canada,*" for the removal of the records of the said late Provincial Court into the Court of Queen's Bench at the Inferior Terms thereof for the said District of Saint Francis by the said last cited Act established, or for rendering executory the judgments of the said late Provincial Court; in consequence whereof the said judgments of the said late Provincial Court have remained unexecuted or it hath been necessary to have them declared executory by other judgments obtained at great cost; for remedy whereof, Be it enacted, &c.,

That the Registers, Muniments, Records, Official Acts, and Papers and other proceedings of the said late Provincial Court shall immediately after the passing of this Act be transmitted into and make part of the Records, Muniments and other judicial proceedings of "The Circuit Court" for the Sherbrooke Circuit at the Town of Sherbrooke in the District of Saint Francis, and that the judgments of the said late Provincial Court shall and may be executed as if they were judgments of the said Circuit Court, and the Clerk of the said Circuit Court for the said Sherbrooke Circuit shall accordingly issue execution under the said judgments, and ulterior proceedings shall be had thereupon, as if the said judgments were judgments of the said Circuit Court under the laws now in force.
