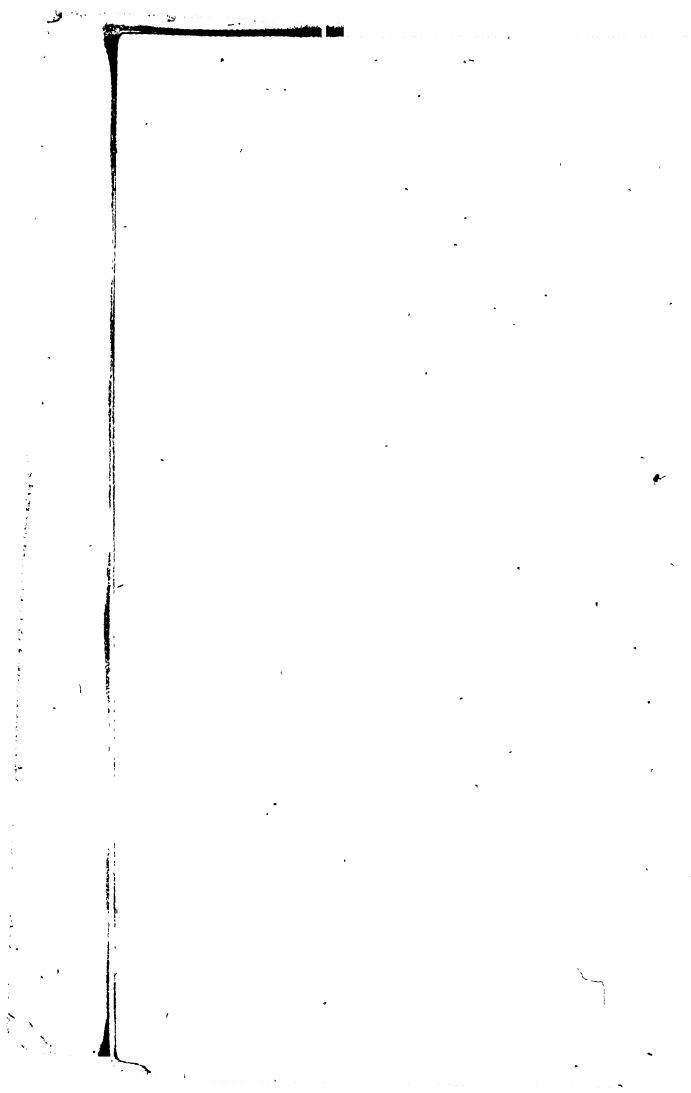
P R E F A C E .

ALLAN, Hon. George William. [*York.*]

S. of the late Hon. W. Allan, of Moss Park, Toronto, for many years a Member of the Legislative Council of U. C., and a Member of the Executive Council during the governments of Sir F. B. Head and Sir G. Arthur. B. at Toronto, 9th January, 1822. Educated at Upper Canada College. M. in 1846 W. Louisa Maude, third dau. of Sir J. B. Robinson, Bart., late Chief Justice of U. C., she died at Rome in 1852. M. a second time, Adelaide Harriet, dau. of the Revd. T. Schreiber formerly of Bradnell Lodge, Essex, England. Has been President of the Canadian Institute and the Mechanics' Institute, Toronto. Is President of the Bank of Upper Canada ; member of the Senate of University of Trinity College and of the Council of the Canadian Institute, and is a Director of the British America Assurance Company. Returned to Legislative Council in Nov. 1858.—*Moss Park, Toronto.*

Hon. G. W. Allan, 2869. *C. E. Romain, 1456. [Retired.]*

ARCHAMBAULT, Hon. P. U. [*Repentigny.*]

Is a Member of the Board of Agriculture of Lower Canada, and a Major in the Militia. Has been Mayor of the Parish of L'Assomption. Elected to the L. C. in Nov. 1858.—*L'Assomption.*

ARMAND, Hon. Joseph F. [*Alma.*]

Returned to Legislative Council in Nov. 1858.—*Rivière des Prairies, C. E.*

Hon. J. F. Armand, 1883. *Ashley Hibbard, 1078.*

ARMSTRONG, Hon. G. M., J. P. [*L. M.*]

Sat for Berthier from 1841 to 1851. Appointed to the L. C. 5th Feb., 1855. Is a Commissioner of Small Causes.—*Berthier en haut, C. E.*

BABY, Hon. François. [*Stadacona.*]

S. of the late Hon. F. Baby, formerly a member of the Executive Council of L. C., and Adj. Genl. of Militia. Elected to the Leg. Council in 1861.—*St. Lewis St., Quebec.*
Hon. F. Baby, 2258. *T. Fournier, 958.*

BELLEAU, Hon. Sir Narcisse Fortunat, Kt., Q. C. [*L. M.*]

Has been Mayor of Quebec; called to the Bar of L. C., 26th Dec., 1832. M. Miss Gauvreau, dau. of the late L. Gauvreau, Esq., formerly a member of the L. C. Legislature. Was knighted by H. R. H. the Prince of Wales on the occasion of his visit to Canada, in 1860. Was speaker of the Legislative Council from 26th Nov., 1857, to 1st Aug., 1858, and from 7th Aug., 1858, to 20th March, 1862. Appointed Minister of Agriculture 27th March, 1862. Called to the Legislative Council 23rd Oct., 1852.—*St. Lewis St., Quebec.*

BLAIR, Hon. Adam J. Fergusson. [*Brock.*]

Is a Barrister at Law of U. C. and a Bencher of the Law Society. Sat for Waterloo, from Feb. 1849 to June 1854, and for Wellington, S. R., from the latter date to 1857. Elected to Leg. Council in 1860. Assumed the name of Blair after that of Fergusson on his succeeding to the Blair Estates, Scotland 1862.—*Guelph, C. W.*

BOULTON, Hon. George Strange. [*L. M.*]

Third S. of the late Hon. D'Arcy Boulton, formerly of the Middle Temple, London, and afterwards one of the Judges of the Court of Queen's Bench in Upper Canada, and grandson of the late Sir John Strange, formerly Master of the Rolls, England. The family is of some antiquity. (*See Burke's Landed Gentry.*) B. in 1797 in the State of New York.

Educated at Cornwall by the present Bishop of Toronto. M. firstly, in 1824 to Elizabeth, third dau. of the late Henry Boulton, Esq., of Geddington House, near Kettering, Northamptonshire, England, she died in 1836. Secondly, in 1840, Anna Maria, eldest dau. of the late J. Walton, Esq., of Schenectady, N. Y., and widow of N. F. Berk, Esq., of Albany. First returned to Parliament in the U. C. Legislature in 1820 for Durham, and sat for same county in several succeeding parliaments. Appointed to the Legislative Council in June 1847.—*Cobourg, C. W.*

CAMERON, Hon. Malcolm. [*St. Clair.*]

S. of the late Mr. Angus Cameron. B. on the 25th of April, 1808. M. in Scotland, in 1833, his cousin, Miss McGregor. Sat in the U. C. Legislature for Lanark, from 1836 to the Union, and from that time until Dec. 1847, for the same place; for Kent, from April 1848 to Oct. 1851, and for Huron, from Dec. 1851 to June 1854, when he was defeated; for Lambton, from Jan. 1858 until 1860, when he was returned for L. C. division of St. Clair. Was Asst. Com. of Public Works from March 1848 to Feb. 1850. President Ex. Council from Oct. 1851 to Aug. 1853. Minister of Agriculture from Nov. 1852 to Aug. 1853, and Postmaster Genl. from the latter date to Sept. 1854.—*Sarnia, C. W.*

CAMPBELL, Hon. Alexander, Q. C. [*Cataraqui.*]

Is a Barrister at Law of U. C., a Q. C. and a Bencher of the Law Society. Elected to the Legislative Council in Nov. 1858.

CHRISTIE, Hon. David. [*Erie.*]

Born in Scotland. Is a member of the Senate of the University of Toronto. Sat for Wentworth, from 1851 to 1854, and for Brant, E. R., from March 1855 to Oct. 1858, when he resigned, and was elected to Leg. Council.—*Paris, C. W.*

CRAWFORD, Hon. George, J. P. [*St. Lawrence.*]

Sat for Brockville, from 1851 to 1857. Elected to the Leg. Council 2nd Nov., 1858. Has been President of the Brockville and Ottawa Railway Company.—*Brockville, C. W.*

Hon. G. Crawford. *Dr. Brouse.*

DEBEAUJEU, Hon. George René Saveuse. [*L. M.*]

Is a Seigneur of Lower Canada. Appointed to the Leg. Council 21st Nov., 1848.—*Coteau Landing, C. E.*

DESSAULLES, Hon. Louis A., J. P. [*Rougemont.*]

S. of the Hon. Jean Dessaulles, M. L. C. of Lower Canada, and of M. R. Papineau, his wife, sister of Honorable L. J. Papineau. B. at St. Hyacinthe, on the 31st Jan. 1819. E. at the colleges of Montreal and St. Hyacinthe. M. Miss Z. Thompson of the latter place. Is a large proprietor and a seignior. First returned to Parliament for the division of Rougemont, 12th Oct., 1856.—*St. Hyacinthe. 26 Berri st., Montreal.*

DICKSON, Hon. W. H. [L. M.]

Is a Barrister at Law of U. C. Appointed to L. C. 8th February, 1855.—*Niagara, C. W.*

DUCHESNAY, Hon. Elzear J., J. P. [*Lauzon.*]

Is an Advocate of L. C., and a commissioner of small causes. Returned to Legislative Council 4th November, 1856, by acclamation. *Ste. Marie de la Beauce, C. E.*

DUCHESNAY, Hon. Antoine Juchereau, J. P. [*La Salle.*]

Is a Seignior of L. C., and Colonel in the Militia. Elected to the Legislative Council 2nd November, 1858. *Ste. Catherine, Fossambault.*

FERRIER, Hon. James, J. P. [L. M.]

Is President of the University of McGill College, a Member of the Senate of Victoria College, Cobourg, a Director of the Grand Trunk Railway, and of the Bank of British North America, President of the Canada Sunday School Union, and of the Montreal Oratorio Society, Vice-President of the French Canadian Missionary Society and of the Montreal Auxiliary Bible Society. Appointed to the Legislative Council 27th May, 1847.—*Montreal, C. E.*

FERGUSON, Hon. Adam. [L. M.]

Has been President of the Agricultural Society of U. C. Appointed to the Legislative Council 9th June, 1841.—*Waterdown, C. W.*

FERRIE, Hon. Adam, J. P. [L. M.]

Appointed to the Legislative Council 9th June, 1841.—*Hamilton, C. W.*

FOSTER, Hon. Asa B., J. P. [*Bedford.*]

Sat for Shefford, from 1858 to 1860, when he resigned and was elected for the L. C. division of Bedford.—*Frost Village, C. E.*

GUÉVREMONT, Hon. J. B. [*Saurel.*]

Sat for Richelieu from 1854 to 1857. Elected to the Legislative Council 2nd November, 1858.—*Sorel, C. E.*

GOODHUE, Hon. George Jervis. [*L. M.*]

S. of the late Dr. Josiah Goodhue of Hadly, Mass., U. S. B. at Putney, Vt., U. S., 1st Augt., 1799. Educated at Amherst, Mass., U. S. Came to Canada in 1820. M. in 1831 to Louisa, dau. of Capt. John Mathews, of the Royal Artillery. Appointed to the Legislative Council in 1842.—*London, C. W.*

GORDON, Hon. James. [*L. M.*]

Appointed to the Legislative Council 4th November, 1845.—*Toronto, C. W.*

HARWOOD, Hon. R. U. [*Rigaud.*]

Born in England. Is a Seigneur and large mill owner, of Lower Canada. Sat for Vaudreuil from 1857 to 1860, when he resigned, and was returned for Legislative Council division of Rigaud.—*Vaudreuil, C. E.*

HAMILTON, Hon. John. [*L. M.*]

Is one of the Trustees of the University of Queen's College, Kingston. Appointed to the Legislative Council 9th June, 1841.—*Kingston, C. W.*

HAMILTON, Hon. John, J. P. [*Inkermann.*]

S. of the late Col. G. Hamilton, of Hawkesbury, C. W. Judge of the District Court and Chairman of the Quarter Sessions, who died in 1837. Is Warden of Prescott and Russell, and Mayor of Hawkesbury. Elected to L. C. in 1860.—*Hawkesbury, C. W.*

JEFFREY, Hon. Andrew. [*Newcastle.*]

Is a Merchant. Elected to Legislative Council in 1860.—*Cobourg, C. W.*

Hon. A. Jeffrey. *J. S. Smith.*

KNOWLTON, Hon. Paul H. [*L. M.*]

Has been Mayor of Knowlton, C. E., and Warden of Brome. Is Colonel in the Militia. Appointed to the L. C. 9th June, 1841.—*Knowlton, C. E.*

LESLIE, Hon. James, J. P. [*L. M.*]

Is a Wholesale Merchant. Sat for Vercheres from 1841 to March 1848. Was President of the Executive Council from March, 1848, to September, 1848, and Provincial Secretary from September, 1848, to October, 1851. Appointed to the Legislative Council 23rd May, 1848.—*Montreal, C. E.*

LATERRIÈRE, Hon. M. P. de S., M. D., J. P. [*Laurentides.*]
Sat for Saguenay from January, 1845 to 1854. Elected
to the Legislative Council 2nd March, 1857.—*Eboulements,*
C. E.

Hon. M. P. de S. Laterrière, 2554. *A. Gagnon*, 1134.

LACOSTE, Hon. Louis, N. P. [*Montarville.*]

Sat for Chambly from October, 1843 to 1861, when he
resigned, and was elected for L. C. Division of Montarville.
Is a Colonel in the Militia.—*Boucherville, C. E.*

MACNAB, Bart., Hon. Sir Allan Napier, Q. C. [*Western.*]

S. of Allan MacNab, Esq., an officer in the British army.
B. at Niagara in 1798. Served in the British army and
navy during the war of 1812. Called to the Bar of U. C.
in 1825. M. 1st. in 1821, Elizabeth, dau. of Lieut. D.
Brooke, she died in 1825; 2nd. in 1831, Mary, eldest dau.
of Mr. Sheriff Stuart, of the Johnstown district, she died
in 1846, by these he had three daughters and one son, the
latter died when only thirteen years of age, of the former
Ann Jane m. John L. Davenport, Esq., Deputy Commissary
General, Sophia m. Right Hon. Viscount Bury, M. P., and
Mary Stuart m. John G. Daly, Esq., Barrister, &c., s. of

lative Assembly previous to the Union, and again of the
United Provinces from Nov. 1844 to Feb. 1848. Adjutant
General of Militia in 1846, and Premier and President
of Executive Council and Minister of Agriculture from Sept.
1854 to May 1856, when he resigned. Returned to L. C. in
1860.—*Dundurn Castle, Hamilton, C. W.*

MATHESON, Hon. Roderick. [*L. M.*]

The only surviving s. of John Matheson, Esq., by Flora
Mackae, his wife. Descended from an ancient Scottish
family. B. in Ross-shire, Scotland. Educated in Inverness

and Canada. Served as Lieut. and Paymaster in the late Glengarry Light Infantry during the war of 1812, was present at the actions of York, Sackett's Harbor, Cross Roads, Fort George, Lundy's Lane and Fort Erie, and was wounded at Sackett's Harbour. M. in 1830, Anna, dau. of Revd. J. Russell, Minister of Gairloch, Ross-shire, Scotland. Is Colonel commanding No. 1 Military District, U. C., and Chief of the Matheson clan. Appointed to the Legislative Council in 1847.—*Perth, C. W.*

MORRIS, Hon. James. [L. M.]

S. of the late Alex. Morris, Esq., of Montreal. B. at Paisley in Scotland in 1790.

In notice of Hon. Roderick Matheson, add: "His great grandfather, Dugall Matheson, of Balmacara, Loch Alsh, Rosshire, Scotland, Chief of the Clan, (killed in the action of Glenshiel, Glenelg, on 10th June, 1719,) married the daughter of Mackenzie, of Dachmalnack; their eldest son, Roderick, married the daughter of Kenneth Mackenzie, and Mary, daughter of Mackenzie, of Applecross, Roderick's eldest son, John married Flora, daughter of Donald MacRae, of Strath Conan; the Honorable Roderick is the only surviving son of John, so in direct line of descent from his great grandfather, who was the Chief of the Clan, he, Roderick, is the Chief of the Clan.
