An Act to amend the Act 14 and 15 Vict., cap. 96,  
to facilitate the performance of certain duties of  
Justices of the Peace.

WHEREAS the provisions of the eleventh section of the Act passed Preamble.  
in the session held in the fourteenth and fifteenth years of Her  
Majesty's Reign, and intituled "*An Act to facilitate the performance of* 14 & 15 V. c.  
"*the duties of Justices of the Peace out of Sessions, with respect to* 96.  
5 "*persons charged with indictable offences,*" have been found in some  
cases to operate unjustly; And it is expedient to repeal the same and to  
make other provisions instead thereof; Therefore Her Majesty, &c.,  
enacts as follows:

I. The said eleventh section of the Act cited in the preamble of Section 11  
10 this Act, shall be and is hereby repealed. repealed.
