ARTICLES OF CONSTITUTION.

VICTORIA, B. C. - - - - MAY 15, 1894.

1. The following residents of Victoria, B. C.: Hewitt Bostock, Meredith Jones, F. R. C. S., Ernest V. Bodwell, Arthur H. Scaife and Archer Martin, and Warburton Pike of Saturna Island, B. C., together with such others as may be selected as hereinafter provided, hereby constitute and form themselves into an association known as the BADMINTON CLUB, the headquarters of which shall be in the City of Victoria, B. C.

2. The entire management of the Club, its property and effects, are hereby vested in the hands of a Committee consisting of the six persons mentioned in Article 1, in trust for the members; the Committee shall elect its own officers. *



3. The object of the said Club is to secure a convenient and agreeable place of meeting for men connected with each other by a common bond of literary, sporting and personal acquaintance.

4. Special attention shall be devoted by the Committee to the literary aspect of the Club, and such measures shall be taken as will insure (a) the completeness of the reading-room generally; (b) the gradual acquirement of such works as relate to the history, fauna and flora of British Columbia; (c) the obtaining of reliable information with regard to the game of the province, and the best methods of preserving and hunting it.

5. The said Committee shall hold office for two years. Subsequent Committees shall hold office for one year. At the end of two years the present committee shall retire, and new members be elected, half by the retiring Committee and half by the ordinary members; the retiring members shall be eligible for re-election.



6. In case of the death, continued absence, or retirement of any member of the Committee his place may be filled by the majority of the whole Committee, which shall also have the power to request and enforce the retirement of any of its members by a majority of votes.

7. The Committee shall meet on the first Tuesday in each month at 5 p.m. The President, if he be present, shall take the chair, but the Chairman shall not vote except on a tie when he shall decide the motion.

8. The Committee is hereby empowered to select and admit 74 members, of whom 45 shall be resident members, and 29 non-resident members.

9. Members shall be divided into two classes :
(a) ORDINARY : consisting of resident and non-resident, elected by the Committee ; resident members being such as reside within a radius of ten miles from the post-office of Victoria ; non-resident, such as reside outside that radius ; no one shall be admitted as an ordinary member who has not resided in British Columbia for a continuous period of six months immediately preceding his admission.

CONSTITUTION.

(b) INTRODUCED: consisting of (1) ~~Officers of Her Majesty's Regular Forces, and the Canadian Militia on active service in British Columbia; such may be admitted by the Committee for 21 days, after which the introduction may be extended, on application, from month to month, the applicant paying in advance the regular monthly subscription of resident members \$2,~~ and (2) friends of ordinary members, resident elsewhere than in British Columbia, who may be introduced for a period not exceeding fifteen days, and on application to the Committee the introduction may be extended from month to month for a further period not exceeding three months, upon payment of a fee of \$5 for each month or portion of a month, and such persons shall be introduced members for the period for which they are introduced, provided always that the privileges of all introduced members shall be personal only, that members introducing friends shall be responsible for any indebtedness of whatever nature the latter may incur, and that no person shall again be introduced until a period of six months shall have elapsed since his last introduction.

10. Each ordinary member shall sign the register kept for that purpose, as soon after his admission to the Club as possible.

11. A register of introduced members shall be kept, showing the full name, residence, period of introduction and introducer's name.

12. No introduced member shall have the right to introduce nor bring any person into the Club.

13. No member shall introduce nor bring into the Club any person residing within twenty miles from the post office of Victoria, but he may introduce a resident of the province, outside that district, for a period of not more than seven days in each year.

14. Any person posted as being indebted to the Club shall not be entitled to introduce a member thereto.

15. A resident member who is about to reside out of the said radius of ten miles for a period of not less than three whole months, may, provided he beforehand notify the Secretary in writing of his departure, be placed on the non-resident list and pay the dues of a non-resident during the period of his absence.

16. A non-resident member who comes to reside within the said radius for a period of more than three continuous months shall at the expiration of that period be deemed a resident member and pay the dues of such.

17. There shall be no entrance fee to the Club.

18. All subscriptions shall be payable in advance.

19. The subscription for resident members shall be at the rate of \$5 a month for the first six months, and \$3 a month afterwards, payable quarterly.

20. The subscription for non-resident members shall be \$5 a quarter.

21. Subscriptions must be paid when they fall due. Failing payment within one month, the name of the member in arrears will be posted, and if his subscription be not paid at the end of the month next following, his name will be removed from the list of members, and he will thereby cease to enjoy the privileges of the Club.

22. No accounts of any description shall be kept in the name of members, who shall pay for everything as they order it, in cash, to the Steward.

23. No member of the Club, while serving as a Committee-man, shall be directly concerned in supplying any stores to the Association.

24. Any member whose subscription is paid shall be at liberty to withdraw from the Club on notifying the Committee in writing to that effect. Any member who withdraws or is expelled as hereinafter provided shall forfeit all right to, or claim upon the Club, its property or effects.

25. In case the conduct of any member, either in or out of the Club, shall, in the opinion of the Committee, be injurious to the character or interests of the Club, the Committee shall be empowered to recommend such member to resign; provided that no such recommendation shall be sent to any member unless the same shall have been agreed to by two-thirds of the members of the whole Committee, at a meeting of the Committee specially summoned for that purpose, and if such member

do not resign within the space of ten days from the notification of such recommendation of the Committee, it shall be the duty of the Committee to expel him. Provided also, that if the Committeemen present at such meeting are unanimously of opinion that the offence of such member is of so grave a character as in the interest of the Club to warrant his immediate expulsion, the Committee at such meeting are hereby empowered forthwith to expel him from the Club.

26. Any of these articles may be amended or changed by a majority of the whole Committee, one week's notice in writing of the proposed change having been given to each member of the Committee by mailing the same prepaid to his last known place of address.



BY-LAWS.

1. The Club shall be open every day from 10 a. m. until 1:30 a. m., except on Sundays, when it shall close at midnight.

2. No dogs shall be admitted to any part of the premises, nor in the outside hall.

Dogs brought in the premises must be immediately chained up in the place provided for that purpose.

3. No games shall be allowed in the Club on Sundays. No games at cards, except whist, shall be permitted in the Club; the limit of stakes shall be as follows: 25 cent points, and \$1 on the rubber.

4. The address of the Club shall not be used for any advertisement.

5. No notice nor advertisement shall be posted up nor published in the Club, except such as are countersigned by the Secretary, and sanctioned by the Committee.

7. Political and religious questions must not be discussed in the club.

8. Strangers calling on members must see them in the hall, or in the card room if it be not occupied nor required for use.

9. If any member shall procure the admission of any stranger to the Club, the Steward and other servants are strictly ordered to draw the attention of such member to this rule, and to report the same forthwith to the Secretary or to one of the Committee. Should a member infringe this rule a second time he shall, in the discretion of the Committee, be liable to expulsion from the Club.
