WHEREAS in consequence of the large number of Shareholders Preamble.
 in the Quebec Building Society, exceeding six hundred, it is
 expedient to amend the Act which was passed in the twelfth year of
 Her Majesty's Reign, intituled, "*An Act to encourage the establishment* 12th Vict. ch.
 5 "*of Building Societies in Lower Canada* as far as regards the said So- 57.
 ciety;" Be it therefore enacted, &c.

That so much of the seventh Section of the said Act as enacts that no Part of sect. 7
 Rule shall be altered, rescinded, or repealed, unless at a General Meet- of the said Act
