THE GOVERNMENT AND THE CANADIAN PACIFIC

Mr. Verous Smith, the Chief of the Short Line Survey, is in the city, and he reports that the entire survey will be completed this month, and that about the beginning of February the plans will be ready for Parliament. The proposed line will shorten the distance from Montreal to Halifax by about 32 miles.
