WHEREAS it has been represented to the Legislature of this Preamble. Province that the Venerable Isaac Hellmuth, D.D., Archdeacon of Huron, is engaged in erecting and establishing a school on a block of land bounded on the north by Grosvenor-street, on the south by St. 5 James-street, on the east by Waterloo-street, and on the west by Wellington-street, in the City of London, for the purpose of providing a classical, scientific and commercial education for the sons of gentlemen, under the title of "The London Collegiate Institute; whereas it would tend greatly to advance and extend the usefulness of 10 the said school and promote the purposes for which it is being established that it should be incorporated; Therefore, Her Majesty, by and with the advice and consent of the Legislative Council and Assembly of Canada, enacts as follows:—
