

# JOURNAL

OF THE

# LEGISLATIVE COUNCIL.

### COUNCIL CHAMBER,

WEDNESDAY, February 5th, 1834.

In pursuance of the foregoing Proclamation, His Majesty's Council met.

PRESENT:

The Hon. Chief Justice, Jarvis, President; George Wright, Ambrose Lane, The Honorables Charles Worrell, John Brecken, John S. Smith.

THE Honorables John Brecken and J. S. Smith having been appointed Councillors, took their seats at the Board accordingly.

His Excellency the Lieutenant Governor having come to the Council Chamber, and being seated, the Gentleman Usher of the Black Rod received His Excellency's commands to desire the immediate attendance of the House of Assembly, in the Council Chamber:

The House of Assembly, with their Speaker, having attended accordingly— His Excellency was pleased to open the Session with the following Speech, viz:—

Mr. President, and Gentlemen of His Majesty's Council;

Mr. Speaker, and Gentlemen of the House of Assembly;

I have assembled you in your Legislative capacity at as early a period of the year as circumstances would admit of—and I rely with confidence that, in the execution of the important duties which devolve upon you, the furtherance of the Public Good, and the advancement of the Colony, will be assiduously sought by you.

Since I last met you in General Assembly, I have received a Despatch transmitting two Orders in Council signifying His Majesty's Assent to several Acts passed in the year 1829, and I shall avail myself of an early moment to lay copies of them before you.

Under the Act of the Legislature of the last Session, I caused a Census of the Island to be taken, a copy of which I have directed to be laid before you; and it will be satisfactory to you to observe the steady increase of population that has taken place of nearly one third since the year 1827.

In my visit during the Summer of such parts of the Country as I could conveniently do, I was gratified in noticing the progressive improvement and comfort that appeared to prevail—and I anticipate with pleasure, at a future day, to see the good that will result to our Peasantry from a sober, steady, and persevering industry.

Mr. Speaker, and Gentlemen of the House of Assembly;

The Accounts of the past year shall be laid before you with little delay.

I regret to observe that the Revenue has not been so productive the last year as the preceding one; its fluctuation must necessarily be looked for, and that circumstance will, no doubt, have its influence with you, in making your Appropriations for the service of the present year.

I think it necessary to inform you, that owing to some unavoidable and unforeseen cause, a larger amount of work has been performed on the new Wharf in Charlotte-Town than was contemplated in the estimates of last year.

I shall desire the Papers to be laid before you, and recommend you to vote such further sum as, under the circumstances, you may think the Contractors entitled to.

Mr. President, and Gentlemen of His Majesty's Council;

Mr. Speaker, and Gentlemen of the House of Assembly;

Resume your official duties, and, guided by an impartial and honorable desire to the fulfilment of them, uphold the character of the Country, and your own credit.

The Speech being ended, His Excellency was pleased to retire, and the House of Assembly having withdrawn, the President reported His Excellency's Speech, which being read by the Clerk—

Resolved—That an humble Address be presented to His Excellency the Lieutenant Governor, to return His Excellency the thanks of this House for his Speech delivered this day;

Ordered, that the Honorables Charles Worrell, John Brecken and J. S. Smith, be a Committee to prepare a Draft pursuant to the above Resolution.

On motion, Ordered, that the Honorables George Wright and Ambrose Lane be a Committee to revise the Journals of this House each day.

On motion, Ordered, that the Honorables Charles Worrell and J. S. Smith be a Committee to examine into, and report upon such Laws as are near expiring.

On motion, Ordered, that the Rev. Louis C. Jenkins be appointed Chaplain, and that he be requested to attend the Council to-morrow at One o'clock, and each succeeding day during the Session, for the purpose of reading Prayers,

His Excellency the Lieutenant Governor requiring the personal attendance of J. P. Collins, Esquire, the Clerk of the Council, Mr. John Ogle Nantes was appointed to act as Clerk during the present Session, and having taken the Oath of Allegiance and also the Oath of Office, took his Seat accordingly.

Adjourned until 1 o'clock to-morrow.

To His Excellency Lieutenant-Colonel ABETAS WILLIAM YOUNG Lieutenant-Governor, and Commander in Chief in and over His Majesty's Island Prince Edward, and its Dependencies, Chancellor, Vice-Admiral, and Ordinary of the same, &c. &c.

The Humble Address of His Majesty's Council.

May it please your Excellency,

We His Majesty's dutiful and loyal Subjects, the Members of His Majesty's Council, in our Legislative capacity assembled, beg leave to thank your Excellency for your Speech, delivered at the opening of this Session of the Colonial Parliament. We also beg leave to assure your Excellency, that the advancement of the Public good will be the unceasing object of our deliberations.

We shall receive with satisfaction copies of the two Orders in Council alluded to by your Excellency.

We are much gratified to learn that the Population of the Island is so much on the increase; and the progressive improvement noticed by your Excellency in your visit to the country affords us much pleasure. We sincerely trust that your anticipations as to the prosperity of the Country and comfort of the People generally may be fully realized.

We further assure your Excellency, that in resuming our official duties, we shall be actuated by an impartial and honorable desire to uphold the character of the country and thereby our own credit.

On motion, Ordered, that the said Address be presented to His Excellency by the whole House.

Ordered, that a Committee consisting of the Honorables Charles Worrell and John S. Smith do wait upon His Excellency the Lieutenant Governor, to know at what time His Excellency will be pleased to receive the Address of this House.

The Hon. the *Chief Justice*, from the joint Committee of both Houses appointed to correspond with the Colony Agent, produced the Correspondence had subsequent to the last Session of the General Assembly—which was ordered to lie on the Table.

The Hon. Charles Worrell, from the Committee appointed to wait upon His Excellency the Lieutenant Governor to know at what time His Excellency will be pleased to receive the Address of this House—reported, that His Excellency had been pleased to say, that he would receive the Address at Government House, to-morrow, at 12 o'clock.

Adjourned until half past 11 o'clock to-morrow.

Whereas, the Governor of His Majesty's Island of Prince Edward, with the Council and Assembly of the said Island, did pass Nineteen Acts, in the Months of March and April last, which Acts have been transmitted, intituled as follows, viz:--

"An Act to regulate the laying out and altering of Highways, and to provide a mode of obtaining Compensation for those who may thereby be injured, and to cause those who are benefited thereby to contribute towards their formation."

"An Act for the Security of Navigation, and for preserving all Ships, Vessels and Goods, which may be found on Shore Wrecked or Stranded upon the Coasts of this Island, and for Punishing Persons who shall steal Shipwrecked Goods, and for the relief of persons suffering loss thereby."

"An Act for keeping clean the Streets of Charlotte-Town, and for removing Obstructions therefrom."

"An Act to amend an Act made and passed in the Ninth year of His present Majesty's Reign, intituled 'An Act for Establishing the Standard Weight of Grain and Pulse, and for appointing proper Officers for Measuring and Weighing the same."

"An Act for the appointment of Limits and Rules for the Jail of Charlotte-Town."

"An Act to alter and amend an Act, made and passed in the 31st year of the Reign of His late Majesty, intituled 'An Act for compelling persons owning Lands adjoining each other to make their respective parts or proportion of the Fence between them, and for empowering the Grand Jury to nominate Fence Viewers."

"An Act for encouraging the Fisheries by granting Bounties."

"An Act to regulate the size of Barrels and enfore the Inspection of such Pickled Fish as may be exported from Prince Edward Island."

"An Act to regulate the Introduction of Passengers in Vessels arriving in this Island."

"An Act for the Establishment of an Academy in Charlotte-Town."

"An Act to amend an Act intituled An Act to render perpetual an Act intituled An Act to enable the Justices of the Supreme Court of Judicature to issue Commissions for examining Witnesses out of this Island."

"An Act in further amendment of an Act made and passed in the Sixth year of the present King, initialed An Act to regulate the performance of Statute Labour on the Highways, and to suspend an Act made and passed in the Thirty-fifth year of the late King, initialed An Act to alter and amend the High Road Laws."

"An Act to indemnify the Treasurer of this Island, and all other persons concerned, in paying certain Monies on Warrants issued since the last Session of the General Assembly.'

And after some time spent therein, the President reported, that the Committee had agreed to the same, with the following Amendments, viz:-

The Hon. George Wright, from the Committee appointed to meet the Committee of the House of Assembly on the subject matter of the last Conference, having gone to the Conference, and returned, reported the substance thereof.

On motion, the House resolved itself into a Committee of the whole, on the Bill intituled "An Act for ascertaining and establishing the Boundary Lines of "Counties and Townships, and for regulating the Duty of Surveyors,"

In the Title, line 3-After the word "Townships," insert the words "and parts of Townships." line 4-After the word "Surveyors," insert the words "and to repeal a certain

"Act therein mentioned."

Ordered, that the report of the Committee be received, and that the Amendments be engrossed.

On motion, the said Bill was read a third time with the Amendments, and passed; and ordered to be sent down to the House of Assembly for their concurrence.

On motion, the Bill intituled "An Act to repeal certain Acts therein "mentioned,,' was read a third time, and passed.

Ordered, that a Message be sent down to the House of Assembly, acquainting them therewith.

On motion, the Bill intituled "An Act for appropriating certain Monies "therein mentioned for the year of Our Lord One Thousand Eight Hundred and "Thirty-four," was read a second time.

Adjourned until 11 o'clock to-morrow.

Ordered, that a Message be sent down to the House of Assembly, acquainting them therewith.

Whereupon the Committee went to the Conference, and having returned, reported the substance thereof.

On motion, the Bill intituled "An Act in further amendment of an Act "passed in the Tenth year of His late Majesty's Reign, intituled An Act to regulate "the laying out and altering of Highways, and to provide a mode of obtaining Com-"pensation for those who may thereby be injured, and to cause those who are "benefited thereby to contribute towards their formation," was read a third time, and passed; and ordered to be sent down to the House of Assembly.

His Excellency the Lieutenant Governor having come to the Council Chamber, and being seated—the Gentleman Usher of the Black Rod received His Excellency's commands to desire the immediate attendance of the House of Assembly in the Council Chamber.

The House of Assembly, with their Speaker, having attended accordingly,

His Excellency was pleased to assent to the following Bills, intituled,

I. An Act for the Encouragement of Education.

II. An Act for the Summary Trial of Common Assaults and Batteries.

111. An Act for regulating the Toll for the Manufacture of Oatmeal and Pearl Barley; and to amend an Act ascertaining the Toll to be taken at Grist Mills.

IV. An Act for establishing the Size and Quality of Fish Barrels and Tierces, and for regulating the weight of Fish the same shall contain.

V. An Act for the appointment of Sheep Reeves, and to restrain Rams from being at large at improper Seasons, and to repeal the Acts formerly passed for that purpose.

VI. An Act relating to Costs, in Cases of Penalties recoverable before Justices of the Peace.

VII. An Act to enable the Supreme Court to give Costs in Cases of Certiorari.

VIII. An Act for the more effectual Punishment of Offenders, by enabling the Supreme Court to add Hard Labour to the Sentence of Imprisonment.

IX. An Act for the regulation of the Jails in King's and Prince Counties.

X. An Act for the better preventing Accidents by Fire within the Town of Charlotte-Town.

XI. An Act to repeal certain Acts therein mentioned.

XII. An Act for continuing the General Assembly in case of the Death or Demise of His Majesty, his Heirs and Successors.

XIII. An Act to regulate the Conveyance of the Mails by a Steam Vessel, and to repeal an Act formerly passed for that purpose.

XIV. An Act authorizing Collectors of Impost to appoint Deputies.

XV. An Act for ascertaining and establishing the Boundary Lines of Counties and Townships and parts of Townships, and for regulating the Duty of Surveyors, and to repeal a certain Act therein mentioned.

XVI. An Act in further amendment of an Act passed in the Tenth year of His late Majesty's Reign, intituled "An Act to regulate the laying out and altering of Highways, and to provide a mode of obtaining Compensation for those who may thereby be injured, and to cause those who are benefited thereby to contribute towards their formation."

XVII. An Act to suspend for one year a certain part of an Act passed in the Third year of His present Majesty's Reign, authorizing a further issue of Treasury Notes to the amount of Five Thousand Pounds.

XVIII. An Act for the better Conveyance of the Mails in the Winter Season.

XIX. An Act to continue an Ad-valorem Duty on all Goods, Wares, and Merchandise imported into this Island, with certain exceptions.

XX. An Act to continue for one year an Act levying a Duly on Tobacco and Tea.

XXI. An Act for continuing for one year an Act imposing an additional Duty on Wines and Spirituous Liquors.

XXII. An Act for levying a Light Duty on all Vessels clearing out at any of the Custom Houses in this Island.

XXIII. An Act for appropriating certain monies therein mentioned, for the service of the year of Our Lord One Thousand Eight Hundred and Thirty-four.

His Excellency was then pleased to close the Session with the following Speech, viz:---

Mr. President, and Gentlemen of His Majesly's Council:

Mr. Speaker, and Genilemen of the House of Assembly:

Having concluded your Legislative labours, it only remains for me to express my earnest hope that you carry with you to your retirement the pleasurable feeling of having faithfully discharged the duties that have been confided to you.

Mr. Speaker, and Gentlemen of the House of Assembly:

I thank you for the Supplies you have voted for the service of the year—their application to the purposes for which they have been entrusted to me, I shall conscientiously endeavour to fulfil.

Mr. President, and Gentleman of His Majesty's Connail:

Mr. Speaker, and Gentlemen of the House of Assembly:

With peculiar satisfaction I notice the continuance of your desire to promote the advancement of Education; it is a matter of such infinite consequence to the future prosperity of the Colony, that liberality in fostering this most important object cannot be too much encouraged.

In taking leave of you for the present Session, I would recommend to you to exert all the influence you may possess, by instilling into the minds of those in whose Districts you severally reside, the beneficial effects of moral and sober habits, essential to the general welfare, and also to themselves, as being the primary means of insuring, under the favour of Providence, health and happiness, and a reasonable hope of acquiring a competence for their declining years.

After which, the President of the Council, by His Excellency's command, declared the General Assembly to be prorogued until Wednesday the 7th day of May next.
