Those Liberal-Conservatives who remained home on the 11th inst., and unconditionally allowed the Grits to march majestically, rendered a service to Mr. L. H. Davies which he little expected. It was only once in his life that such an opportunity to display his untruthfulness presented itself, and Mr. Davies made the most of it. As might be expected, he hastened to inform that receipt of Grit truth, the Toronto Globe, that the so-called Liberals of this Province had won a great victory, knowing as well as any man could know that such a statement was untrue.

Seven members of the Council were elected on Thursday, and six are held over until 1889. Out of the thirteen members of the Legislative Council eleven are now Liberals.

No careful analysis of the above telegram is required to show that it contains several distinct and vital falsehoods—(1) the Grits did not carry the entire Province; (2) the Grits do not hold eleven of the thirteen seats, because Messrs. Crow, Nicholson, Martin, Kichham (non-abolitionists) hold seats; and it is not yet finally determined whether or not Messrs. Campbell and Owen are defeated.

It was quite becoming that Mr. Davies' false telegram should receive editorial notice in the Globe. Any false coloring the despatch required could be readily supplied by that notoriously unreliable newspaper. What more likely, therefore, could happen than a leading article, based upon Mr. Davies' false telegram, setting forth that, in P. E. Island, the Liberal party had scored another victory! It also overlooked the correct report it received, and adopted the misleading telegram of Hon. L. H. Davies, by stating editorially that "in all the seven districts the Liberals were victorious. In the Legislative Council, as it will be composed when next it meets, there will be eleven Liberals to two Conservatives." Bravo, Mr. Davies! We quoted last week from the extracts of the speech reported in Canadian exchanges that came to hand, and no word of Ontario appeared, as it was well understood Mr. Blake intended his speech for the Dominion, and not specially for Ontario. The Patriot quotes yesterday an extract from the fuller report that has since come to hand, and endeavors to assure the farmers here that they are quite safe from Mr. Blake's socialistic schemes. Why does the Patriot not publish the whole speech? Any one who reads it carefully can see that he spoke as the leader of the Grit party in Canada. The speech was addressed to the workingmen of the Dominion, and of course they do not all reside in Ontario. He was describing how the present Dominion tariff was oppressing the workingmen all over Canada, and robbing the Dominion of its resources. Seven members of the Council were elected on Thursday, and six are held over until 1889. Out of the thirteen members of the Legislative Council eleven are now Liberals.

If the result has any bearing upon Dominion politics, we might also point out that Mr. Martin's majority would almost turn the scale in Queen's County without the hundreds of Liberal-Conservatives who did not vote. In the first District of King's County the Opposition did not display great confidence in their strength when they were content with a Liberal-Conservative who merely opposed abolishing the Council; and the Second District of King's is solid for the party of progress in the Dominion, and of economy in local affairs. In Prince County it will be found the ledger and sectional influences, so unscrupulously wielded by the Grits in the recent contest, will go unheeded at the ballot boxes.

While we approve of Mr. Davies' choice in sending his despatch to the Dominion, we fail to see any consistency in its rejecting over the continuance of our second chamber.

Both Mr. Blake and the Globe have declared war upon the Senate, and yet they unite with the Grits in this Province in perpetuating an infinitely more useless institution. Such conduct is, however, only a piece with the tactics of Mr. Blake who, to obtain votes, is weeping hypocritically over the grave of the man he once characterized as a red-handed murderer; while Mr. Davies keeps monkeying after the votes of the men who believe the Government did their duty in allowing the law to take its course. It would be strange indeed if the electors of any portion of the Dominion could allow themselves to place any confidence in such untruthful and inconsistent place-hunters.
