











NOTHING THAT MAY RESTRAIN CANCELLATION OF CHARTER

Attorney-General Upheld in Proceedings Against Recreation Club—Time to Wind Up Given.

As soon as an order in council can be prepared and passed, the Toronto Junction Recreation Club's charter will be revoked by the attorney-general as a result of the decision of Justice Anglin yesterday in refusing to grant the application of the club to restrain the attorney-general from such cancellation.

A sufficient time to wind up the affairs of the club may be granted, and the club will be permitted to continue its operations for a short period or other illegal business will be transacted in the meantime, otherwise the cancellation will be given immediate effect.

The contention of E. F. H. Johnston, K.C., for the club, was that the attorney-general had, by entering an action against the club, deprived himself of the right to exercise his power until the case was decided.

To this Justice Anglin said: "That the court has not jurisdiction to command or restrain the crown or its officers is established by many authorities. For the exercise of the powers of the crown, the attorney-general is answerable and responsible to the crown alone. He owes no duty to the Toronto Junction Club."

"No precedent has been cited for the granting of such an injunction on the application of a subject defendant, the many suits against the crown or its officers have been maintained by the attorney-general in England and her colonies. Such actions are in fact the suits of His Majesty instituted by his law officer, the attorney-general, and it is not therefore surprising that the research of the learned counsel for the defendants has unearthed no instance of any such anomalous order of injunction which he now asks, by His Majesty, that the instrumentality of this court, would restrain himself in the exercise of functions of his executive government."

Not for Him to Advise. Mr. Johnston had further suggested that the court recommend the attorney-general to postpone the return of the crown's prerogative until a decision had been rendered in the case before the court. To this Justice Anglin replied:

"While I have no doubt that the attorney-general would pay due regard to any proper expression of judicial opinion, I must decline to assume the role of judicial adviser on the propriety or impropriety of any course which he sees fit to take in such matters."

CITY GRANTS \$1000

Toward Scholastic Reception-Roof Garden Scheme Killed.

Mayor Urquhart thought that \$1000 would not be too much to spend on the Scholastic reception, when the controllers talked the matter over yesterday. Aid Fleming said the city had gotten ten times that amount in advertising. The grant passed.

The Majestic Theatre was given permission to erect a porch over the sidewalk.

Fire Commissioner Chambers withdrew the application of his assistant, Commissioner Fleming recommended that \$1500 be paid the Naamith Company for the Moss Park property, and it was adopted.

The Kew Beach and Berkeley-street fire station proposals were passed.

Mr. Fleming recommended that two lots in Broadway-avenue to St. John's Presbyterian Church for \$1400, 75 cents a year, and they were set for taxes. Another lot on Frizzell-avenue was sold to G. R. Henderson for \$200.

Another Building for the Burnard District.

Plans were filed yesterday with the property commissioner for a new six-story warehouse, 50 feet x 125 feet, for the slaughter in the east-end for Mr. John W. Cowan. In this building, as designed by Architect F. H. Cockburn & Rea, the wholesale milliners, who hope to be in possession by the first day of December. The work of construction has been awarded to Mr. John McLeod of Kingston, Ont., who started a large force of men at work yesterday morning.

ELECTIONS AT YEAR'S END

DECEMBER OR JANUARY

Activity of Liberal Organization Indicates Appeal to People Before Session.

There is good reason to believe that the Dominion general elections will not be held until December or January. It is almost a certainty that they will be held before another session of parliament. A circular recently issued from the Ontario Liberal headquarters in Toronto urges careful scrutiny by Liberals of the voters' lists under course of preparation. These lists will not be finally revised in some municipalities until September or October, and as the law requires that they shall elapse from the preparation of the lists until the nomination, it is obvious that the nominations will be thrown into the latter part of December or the first of January. The late Sir Oliver Mowat once conducted a very successful campaign in midwinter, and it is urged by many that Christmas is about the proper time, as the voters make up their minds during that festive season. The Liberal Party recently issued calls attention to the fact that any election which may be held either for the Dominion or for the Ontario legislature before the end of the year will be held upon the voters' lists now under course of preparation.

The Liberal Party is sending out a large quantity of campaign literature, using the members' trunks to various parts of the province, where it is to be kept under lock and key until the word goes out that the fight is on. They are expecting this word shortly after the prorogation of the house.

Out of the 88 Ontario constituencies only 30 have no candidates in the field. The Liberals have nominated 42 and the Conservatives 40. Thirty constituencies have both candidates facing each other ready for the fray. As soon as the house rises the call will go for nominating conventions to convene.
