Another Will Case Before the Court

Appeal—A Sheep Deal—A Question Under a Label Action.

The Court of Appeal was occupied yesterday with the important case of May v. Logie.

The amount involved in this case is not very large, but upon its decision rests the continuance of a number of other cases, involving a vast amount of property.

The plaintiff represents the heirs of William Edgemoor, deceased, and the defendant the widow and executrix of what is contended is Edgemoor's will, and the action is brought to recover possession of certain land in Mimico.

The plaintiff in question, which the defendant says conveyed a good title to the widow, are: "It is my will that, as to all my estate, both real and personal, my wife, Elizabeth, and I hereby appoint my said wife, Elizabeth, to be executrix of this will."

Mr. Justice Meredith held that the widow took the real estate in fee simple, and dismissed the action, with costs. Judgment was reserved.

The next case, Harris v. Bank of Toronto, was not of such tremendous magnitude, but is still of public importance.

The Bank of Toronto had a judgment against Mr. Harris, and sought to enforce it by possession of the Divisional Court, overruling the decision of the trial judge.

Mr. Harris had not an interest in the sheep which could be seized by the sheriff under an execution. The trial judge, however, held that the sheep were not the property of Harris, but of the bank, and that the bank was entitled to possession of them.
