In the House of Commons on Tues. day, Attorney-General Clarke, of Manitoba, was examined at some length in regard to the litel case. The House cannot try Riel for mur-der, but after satisfactory evidence it pusite he cannot sit among its mem-bers. To this end the examination is now being held, and when finished a motion will doubtless be passed to that effect. Mr. Clarke's evidence awas conclusive on the following im-portant points:--That Riel had signed the Parliamentary roll; that he was elected for Provencher; that a first under indictment for murder, and eluding the search of the officers who hold warrants for his arrest; that a bench warrant was issued in Manitoba last fall for his arrest; and that Mr. 8 Clarke had tried, but failed, in his efforts to have him arrested. Before it he House adjourned, a motion was passed ordering Riel to attend in his place to day. Should he do so, the poficers of justice will doubtless arrest the House will decide that he be ex-pelled from Parliament. 

It is undonbtedly the pretiset homestead in the country, surrounded by all the comforts and Inx-uries that mocay can purchase, indica-ting a refined taste on the part of the proprietor and his family, which is not usual among the cattle ranches of Texas. Captain King has an enclosed pasture of 20000 carting the pasture of the proprietor and his family, which is not ting a refined taste on the part of the propristor and his family, which is not usual among the cattle ranches of Texas. Captain King has an enclosed pasture of 70,000 acres of land in Nences and Duval Counties. The entire stock held by him at the present time is 50,000 head of cattle, 20,000 head of sheep, and 10,000 head of horses. He overstocked his en-closed pasture to such an extent last fall that he was compelled to turn a great many out ' on the range' again, although he sent 4,000 head for their hides and tallow. He disposes annually of about 8,000 head of cattle, either by sale or slaughter, netwithstanding which his stock is steadily on the increase. If the shipping of stock is commenced at Cor-pus Christi he will probably find a mar-ket for some of them. He has recently purchased another ranch in Cameron County, on which he has 10,000 more of cattle, and attached to which is about 10,000 acres of land."

10,000 acres of land." PUBLIC ACCOUNTS.—The Public Ac-counts of the Dominion for 1872-73 were published on Tuesday. They show the total receipts for the year, chargeable to Consolidated Fund, to have been \$20,913.-469, against an expenditure of \$19,174,-647, giving a surplus of revenue over ex-penditure of \$1,638,822. The income of 1872-73 exceeds that 1871.72 by \$98,656. and the expenditure, that of the same year, by \$1,585,179. Under the head of Loans, the account shows receipts \$4,153-193, and expenditure, \$2,907,232. Open accounts receipts amount to \$8,386,642. against payments, \$13,305,369. The gross totals therefore are, receipts, \$33.-305,305; expenditure, \$55,287,250.
