GIGANTIC ESTABLISHMENT OF MESSRS. S. DAVIS & SONS.

Astonishing Increase in Business—Three Hundred Skilled Workmen Employed.

A few months ago we published a description of the magnificent structure erected and about to be completed by Messrs. S. Davis & Sons, Montreal. Since that time the premises described have been completed by them, and a large addition made there, the colossal premises being too small. Owing to the wonderful increase of their business, which assumed such extraordinary and vast proportions within this past year, they were compelled to look to foreign markets to increase their staff, as it was found, after months of advertising for first-class cigarmakers, impossible to obtain the required help in this country, therefore by necessitating the importation of foreign labor. With their usual enterprise Messrs. Davis & Sons sent one of their junior members of the firm—Mr. M. E. Davis—to Europe to obtain the necessary help, while he was in Europe he was doing about 300 skilled workmen having arrived a few weeks ago. Notwithstanding this large additional increase they are, as yet behind orders, but hope soon to be able to fill all orders promptly. In justice to Messrs. Davis & Sons we should inform the public through our columns of a wrong impression that was created, attributable to an error in the Associated Press despatches, which stated that a strike had taken place amongst their imported workmen, owing to Messrs. Davis & Sons not carrying out the agreement made with them.
