An Act to amend the Act respecting mortgages and sales of personal property in Upper Canada.

THEREAS it is expedient to amend the Act respecting mortgages Preamble. and sales of personal property in Upper Canada, in the manner hereinafter provided; Therefore Her Majesty, &c., enacts as follows:

I. So much of the fifth section of the Act passed in the twentieth Such mortvear of Her Majesty's reign, intituled, An Act to amend the statutes of gages and sales to be this Province respecting mortgages and sales of personal property in registered, in Upper Canada, and to consolidate the same, as provides that where the certain cases, mortgager or bargainer is resident in Upper Canada, the instruments in the office of the Tawaship 10 mentioned in the preceding sections of the said Act shall be registered Clerk, instead in the office of the Clerk of the County Court of the County or Union of the County of Counties where the mortgager or bargainer shall reside at the time Clerk,—under of the execution thereof,-shall be repealed upon, from and after the first day of October, in the present year 1858, as regards all such instruments 15 to be registered on or after that day: And upon and after the said day every such instrument as aforesaid shall be registered in the office of the Clerk of the Township or united Townships, city, town or incorporated village, in which the mortgager or bargainer shall reside at the time of the execution of such instrument, whenever such mortgager or 20 bargainer is a resident in Upper Canada; and as regards all such instruments to be registered upon or after the said day, such Clerk and all other persons shall have the same rights, powers, duties and liabilities, and such registration or the omission thereof shall have the same effect, and the said Act shall be construed in the same manner, as if the said third 25 section thereof directed the registration thereof to be made as herein provided, and not in the office of the County Clerk.

II. The seventh section of the said Act shall apply only to cases Sect. 7 of the where the mortgage is registered in the office of the Clerk of a County said Act amended as to Court; and whenever the mortgage is registered as provided in the first goods remoso section of this Act, then in the event of the permanent removal of yed from the
goods and chattels so mortgaged from the Township or Union of Townwhere the ships, city, town, or incorporated village in which they were at the time mortgage is of the execution of such mortgage, to another Township or Union of registered. Townships, city, town, or incorporated village, before the payment and 35 discharge of such mortgage, a certified copy of such mortgage under the hand of the Clerk of the Township, Union of Townships, city, town or incorporated village in whose office it was first registered, and under the corporate seal of the municipality, and of the affidavits, documents and instruments relating thereto and filed in such office, shall be 40 filed with the Clerk of the Township, Union of Townships, city, town

or incorporated village to which such goods and chattels are removed, within two months from such removal, otherwise the said goods and chattels shall be liable to seizure and sale in execution, and in such case such mortgage shall be null and void as against subsequent purchasers and mortgagees for valuable consideration, as if never executed. 5

III. The copy of any mortgage registered under the first section of this Act, and the statement of account and affidavits, required by the eighth section of the said Act to be again filed within the period therein mentioned in order to preserve the mortgage, shall be filed in the office of the Clerk of the Township, Union of Townships, city, town or incorporated village, wherein the goods and chattels mortgaged are then situate, with the same effect, and under the same penalty for not filing them, as provided in the said section with respect to mortgages registered in the office of the Clerk of a County Court.

IV. The certificate of the Clerk of the Township, or Union of Town-15 ships, city, town or incorporated village in whose office any instrument or document is fyled under this Act, and the seal of the municipality, shall have the same effect, with regard to any such instrument or document or any copy thereof, as by the ninth section of the said Act is given to the certificate of the Clerk of the County Court under the seal 20 of the Court, with regard to instruments or documents fyled in his effice or any copy thereof.
