TO THE GRAND WORTHY PATRIARCH AND THE MEMBERS OF THE GRAND DIVISION OF NOVA SCOTIA.

At the last annual session of the Grand Division P.G.W.A. Barratt submitted the following question,-" Has the G.W.P., either by himself or Deputy, the right to ask for the chair of a Subordinate Division,and when so asked for, is the Worthy Patriarch bound to give it to

The foregoing question was, by vote of the Grand Division, referred to the undersigned Committee, with instructions to furnish a reply

thereto. Our answer is as follows:

We do not find, in the "book of Constitutions," or in the duties imposed upon Grand Officers, any recognition of such a right; nor can we imagine any advantage that would result from conferring such a right upon a G.W.P. or his Deputy. The B. B. lays down the form for receiving the G.W.P. or his Deputy when "visiting" a Subordinate Division; and in these instructions we find that he is to be conducted to the chair of the P.W.P. as a "post of honour." Of course when either of these officers visits a Division for the purpose of installing officers, he occupies the Worthy Petriarch's chair. But the question proposed can have no reference to such a case—for the installing officer has entered the Division Room invited by the statement of the W.P., that "the Division are ready to receive him," to perform the duty already stated by the Grand Conductor.

The rights of Subordinate Divisions are just as sacred as are those of either the Grand Divisions or the National Division. And if a Subordinate Division should violate its obligations to the Grand Division, or the G.W.P., or his Deputy, our Constitution furnishes appropriate checks; and just because the G.D. has all the power necessary for enforcing its authority, we should icalously guard against any usurpation of power not plainly authorized by the Constitution and rules of our Order. We, therefore, answer the question of P.G.W.A. Barratt, by saying that neither the G.W.P. nor his Deputy has the right to ask for the chair of a Subordinate Division.

DIVISIONS NOT WORKING.

The Divisions not working are:—Morning Star, No. 38, June Rose, No. 125, Ohio, No. 150, Hope, No. 154, Brilliant Star, No. 183, Star of Hope, No. 190, Halls Harbour, No. 201, Alexandra, No. 216, Macleod, No. 272,—9.

Several of these Divisions would resume operations without delay if they had suitable halls in which to hold their meetings. Being deprived of holding their sessions in school buildings is the cause of their suspending work for the present. We have in this jurisdiction a number of apparently influential opponents to the progress of temperance who hold office as School Trustees.

WORKING DIVISIONS.

In the jurisdiction there are 173 subordinate Divisions supposed to be in working order.

FINANCES.

The receipts of this Office to 17th inst., amount to \$663.96\frac{1}{2}, which sum was paid to the Grand Treasurer. Of the amount named, 247.97\frac{1}{2} were received on account of Agency Fund.

DIVISION INCORPORATED.

The Incorporation Papers of Rechab Division, No. 119, were filed in the Provincial Secretary's Office on November 29, 1367.

AGENCY.

Brothers Barratt and Beattie have been constantly employed by the Agency Committee, as Agents and Lecturers, since the annual meeting. The amounts received by them in the shape of collections and donations have been small.

By the Grand Treasurer's financial statement, it will be seen that during the quarter, \$100—half of the sum appropriated at the annual meeting—were paid from the General to the Agency Fund. The last named fund has also drawn upon the former to the extent of \$125.49½—which with the sum of \$21.34 advanced previous to the last session, make the whole amount borrowed from the General fund by the Agency department—\$147.03½.

The Agency Committee have issued an Appeal to the Order on the subject of the work committed to their supervision. The response made to their Circular is referred to in their report. There is a probability of a respectable amount being received in aid of the fund before the April Session.

TAX FROM SUBORDINATE DIVISIONS.

A few years since the Constitution of Grand Divisions specified that the Subordinate Divisions pay—cents quarterly to their Grand Division, except on such members as were suspended, or over twelve months in arrears for dues. Many Divisions having taken what was supposed to be an unfair advantage of the exceptional clause of the law, and the revenues of Grand Divisions being considerably reduced thereby, the National Division amended the Constitution so that the per capita could be exacted on all members on the Financial Scribe's

books, leaving it to Grand Divisions to fix the amount to be paid. Rule eleven of this Grand Division provides that—

"Every Subordinate Division shall pay to the Grand Division the sum of six cents per quarter for each member on the Financial Scribe's books."

As many Divisions considered it a hardship to pay the per capita on members who were suspended, and over twelve months in arrears, the National Division was induced, in the year 1866, to amend the Code of Laws of Subordinates with the view of giving them the privilege of expelling members as soon as they were six months in arrears for dues.

A large number of our Subordinates report a certain number of members as suspended, deduct the same from the whole number and pay tax on the balance; others again pay tax on a lesser number than the balance—for instance a Division has—

Leaving 25 to be accounted for, even if they were exempt from paying on suspended members, which the rule does not now allow. In such a case the Grand Division would lose tax on 35 members, amounting to \$2.10.

without stating whether they were suspended or expelled.

As members can now be dealt with at the expiration of six months, Divisions should discipline them in order to pay tax on the whole number on the roll.

I bring this subject to your notice with the view of receiving definite instructions as to whether, in future,—commencing with the term ending March 31st, 1868, the Grand Scribe shall exact six cents per capita on the whole number of members returned on the books of Financial Scribes, or that Divisions be exempt from paying on suspended members, or members over twelve menths in arrears.

I also wish instructions as to whether new Divisions should pay the tax when they are organized during the last month of a quarterly

Definite instructions to the Grand Scribe on the points referred to, will tend to prevent misunderstanding between the Grand and Subordinate Divisions.

DECEASED MEMBERS.

It again becomes my painful duty to announce the demise of members of this body, two of whom have passed away since the annual meeting held in October last

P.G.W.A. Bro. Lawrence E. VanBuskirk, M. D., died at his resi-

dence in Dartmouth on the 6th November, 1867, aged 68 years. Our deceased Brother at an early period of his life connected himself with the temperance movement in Kings County. He was one of the Charter in members of Maytlower Division, No. 9, which was instituted in Halifax; on 9th February, 1845, and at the time of his death was a member of the Atheneum Division. On the 31st January, 1849, he was initiated a member of this body, at the quarterly meeting held in Liverpool; and on the 25th of October, in the same year, he was elected to the office of Grand Worthy Associate—at the annual meeting held in Yarmouth. He became a member of the National Division on 15th June, 1854.

In connecting himself with our organization at the time he did, he took a noble stand—one which reflected honor upon him as a man, he having much opposition to contend against in reference to temperance principles. He loved the Order, and, in accordance with one of his latest wishes, was consigned to the tomb as a Son of Temperance.

P.W.P. John Blenkhorn, of Rescue Division, No. 199, died at his residence, Advocate, Cumberland County, on 21st November, 1867, at the age of 66 years. He was an enterprising, useful, honest, and benevolent man. He attended the annual meeting of this body hele in Halifax in October last, and within twenty days after the close of the Session he departed this life. He became a member of the Grand Division on 27th July, 1864.

NEW DIVISIONS.

Since the annual session of this body, four Divisions have been organized, with good prospects of adding to the number before our next quarterly meeting.

From the cursory view we have taken of the field and its products, we learn much that is fitted to encourage, and we learn that there is much to be done,—"there remaineth very much land to be possessed." How cheering to the veterans who have borne the heat and burden of the day to find our principles so firmly fixed in the public mind. How encouraging to those who have entered our ranks but lately, to see the mists steadily giving away before the rising sun.—Thus are the hopes of the earnest strengthened, the doubting confirmed; and we are all led to adopt as our motto "Trust in God and do the right."

How are the necessities of the situation fitted to inspire every lover of our race, with a longing desire to do something to mitigate the evil fitted to inspire the high resolve to labour yet more faith ully for our cause, for our brethren of mankind.

Of the means at hand which we are privileged to use, we may note the following:—

THE DIVISION ROOM.

If, to wield its proper influence, home should be a happy place, how necessary it is that all contentions and heartburnings should be entirely excluded from our weekly Divisional meetings. If the young of our land are to flock to our halls and cause like doves to their windows, then the peace and security of our temperance arks must be made abundantly manifest. The peace which pervades our halls must be a pure, powerful and active principle, not like the calm of the Dead Sea, the effect and the evidence of a curse; but operating on the nature of mankind as it is, and combining the social, the intellectual and the moral parts of that

nature in active and yet happy harmony. Let our aged brethren be grave without being gloomy; wise, without stip formality; considerate without censorionsness. Let the young brothers be apt and active without being intrusive or impertment—intelligent without being dictatorial, impressible without being inconstant; and let our female friends throw over all the mantle of kindness and charity. Then our Division Rooms will be the place of resort, and will be a power in the land, the influence of which shall be irresistable. Experience has taught us how important to our cause is the

AGENCY OF OUR ORDER.

And indeed how could we expect it to be otherwise. The living voice of the living agent is the method appointed by high heaven, whereby to disseminate the holiest principles, and shall any one of the virtues, a part of those very principles, be expected to prove an exception? Verily no. The kind reception given to our agents—Brothers Barratt and Beattie—the fruits of their labours and the very general interest manifested in this branch of our efforts, by the Order generally—all combine to teach us that to continue to strengthen—to enlarge this branch of the service is not only a duty, but an absolute necessity.

BANDS OF HOPE.

Those nurseries of our Order are rising up, and from their ranks we may expect a higher type of Sons of Temperance. Those who have been engaged in conducting those bands deserve our highest commendation; but we doubt not they esteem their reward sufficient;—theirs is indeed a labor of love. If we expect to redeem our Province from the liquor traffic, we must exert ourselves to gain and keep the loving hearts of the children.

THE PRESS.

All experience leads to the conclusion that without the aid of the Press, the success of any movement affecting the public mind is extremely doubtful. This Grand body has in years gone by attended to this matter as their means permitted. The Abstainer may be considered as part of the inheritance which carnest men who have passed away, have bequeathed to us. The character of that paper has, I believe, never stood so high as it does this moment. Yet its circulation is not equal to our present wants. The multiplication of Temperance papers in this Province is certainly doubtful policy on the part of Temperance men. One paper reflecting the sentiments and talents of Temperance advocates, is surely enough—at least until the circulation is extended much beyond the present limit. The paper in its present shape is a good family newspaper. The best modes of cultivating garden and field, with general news and topics of common interest are wisely interwoven with sound temperance literature. But it is especially because the "temperance party" require a "party paper," and because as such its circulation is quite unequal to the wants of "the party," that those remarks are submitted to this Grand Division. What course shall we adopt to give more extended knowledge of our objects to those who are not of us, and to gather together the somewhat scattered forces of those who are with us, -is a subject worthy of deep consideration at this time.

Whether it is practicable to give gratuitous circulation of the paper through the remote parts of the Province; whether a whole or a half sheet could not be afforded to distribute by the Lady Visitors of our Order, or whether "our party" shall step forth into the arena of politics, and as far as temperance is concerned, in these changing times demand for this Province legal enactments equal to present wants, and with a view to future well-being. Is it not plain that if "our party" is to be respected, our "party paper" must be both feared and beloved? Can it be either the one or the other in an extended sense under present circulation?

PROBERTION.

Perhaps in quarterly Sessions of this body we express opinions rather than arrive at decisions. Still it must be evident that public opinion on this point is nearly, if not altogether abreast of us. As leaders in the Temperance reform are we not called upon to take some step in advance?

Brethren, allow me to submit those remarks as a substitute for a quarterly report. I trust our deliberations may be characterized by zeal tempered with wisdom, and may result in great and lasting good.

May purity guide us to honest conclusions.

BROTHER BEATTIE'S REPORT.

REPORT OF MISSION UNDER AGENCY COMMITTEE GRAND DIVISION, COMMENCING NOVEMBER 9, 1867, ENDING JANUARY 22, 1868.

Worthy Brothers,—During the interval that has clapsed since Annual Session, I have, under your direction, passed through the Counties of Lunenburg and Queens, the District of Shelburne, and visited portions of Halifax, Hants and Annapolis. I have, during that period, travelled 808 miles, addressed 39 public meetings, visited and addressed 19 Divisions, and collected for Agency Fund \$37.09.

The collections have been small, especially so in localities visited where other organizations occupied the ground; and I would respectfully submit to you the propriety, in future, of visiting only those localities where our Order is established, or where there is a prospect of unfolding our standard. Not only have the collections been small, but the donations have likewise been few, small, and far between. This arises partly, I believe, from a scarcity of the circulating medium, but I fear also from the want of a heartfelt interest in the work.

It is with pleasure I report that a number of the Divisions visited have cheerfully complied with the request to contribute monthly to the Agency Fund; and in some others a weekly collection is taken for the same object. There appears to be a general desire for the continuation of Agency effort.

In the Counties through which I have passed, organization has reached its extreme limit—almost every locality visited being occupied by one or other of the branches of the temperance tree; and in not a few both Orders are established.

Revisiting a locality after an absence of years, affords the opportunity of contrasting the present with the past. There is no doubt on my mind that, during the interval, temperance principles have made decided progress, evidenced by the increase of societies and the interest manifested in them. This is especially true of Lunenburg. is much to encourage, there is not a little to sadden. Although there wrought an almost entire change in our membership-comparatively Four years have few of those who were then active are now working. called home by the Great Patriarch, have finished their work and fallen Some have been at their post; but a large number have withdrawn; disheartened and discouraged, they have ceased effort and their places are now filled by a much younger class of members. May they be more faithful than their fathers.

Nearly all the Divisions visited were active. Some, amid great discouragements, upholding our principles with firmness and zeal, looking for better days; and there can be no doubt that under the operation of the School Law, there will be in a short time, in many localities, a better instructed membership.

I have again to express the obligations I owe to the Grand Scribe for prompt attention to all matters pertaining to Agency; and also to the numerous friends who have lightened labour by kind attention.
