GRAVE CHARGES AGAINST HON. J. M. GIBSON.

It will be remembered that a couple of years or so ago Hon. J. M. Gibson, at that time Commissioner of Crown Lands, rendered a decision in the case of the famous Sullivan Island. The case was a somewhat complex one, as the interests of several parties were involved, patents for the property having been issued by both Dominion and Ontario governments. One of the claimants was a Mrs. Johnston, whose rights were looked after by her father, Mr. Robert Gerrie, of Winnipeg. In last Saturday's Winnipeg Telegram Mr. Gerrie addressed an open letter, two columns in length, to Hon. E. J. Davis, present Commissioner of Crown Lands, in which he charges that his predecessor, Hon. J. M. Gibson, was guilty of a scandalous perversion of justice in favor of certain mining rings. The ex-commissioner is charged with ignoring the decision of the courts and setting his judgment at defiance. Mr. Gerrie seems to establish the fact that his daughter was charged with a one-third interest in the property. But the serious accusation brought by Mr. Gerrie against Attorney-General Gibson is that he was acting as a judge in a case in which the firm of Gibson & Osborne, of which he is a member, was one of the claimants. Mr. Gerrie makes this charge against Hon. Mr. Gibson in the following unqualified language:
