

HISTORICAL MEMORANDA.

On the 10th March, 1875, 111 members of Zion Church withdrew from that fellowship, for the purpose of forming a new Congregational Church under the pastoral care of the Rev. J. F. Stevenson. LL B., one of the joint-pastors of Zion Church. On Sunday, March 14th, 1875, after an appropriate service conducted by Mr. Stevenson, the church was duly organized, and Mr. Stevenson was unanimously chosen Pastor. At the same time the Church, by formal Resolution of the united brotherhood, received the name of "Emmanuel Church," and all present rising, the Pastor read the following declaration, which was assented to as the covenant or basis of union:—

"We, whose names have now been read, do hereby in humble dependence on Almighty God the Father, His Son Jesus Christ Our Saviour, and the Holy Ghost the Comforter, organize ourselves into a Christian Church of the Faith and Order commonly styled "Congregational" or "Independent." And we further pledge ourselves with the help of God, to do all that within us lies, as a church, to secure the great ends for which the Head of the Church ordained that His faithful followers should, while on earth, be banded together in holy brotherhood. And we do severally as members of this church solemnly promise to be loyal to our obligations to sustain the work and interests of the body now organized, and to do our best to promote the spiritual welfare of each other."

As the Church possessed no local habitation of its own, the public services on the Lord's Day were held in the Montreal Gymnasium Building; and on week-evenings, in the Lecture Room of Erskine Church. In the month of June, 1875, ground was broken for the erection of a new church-edifice, on a site occupying the corner of Stanley street, and facing St. Catherine street. On April 15th, 1876, the corner stone was laid by the

Pastor, assisted by Rev. Dr. Wilkes. On January 14th and 15th, 1877, the building was opened for Divine Worship with special Dedicatory Services.

In September, 1886, Dr. Stevenson resigned the Pastorate, on receiving a call to the Brixton Independent Church, London; and amid many tokens of respect, both from the church and the general community, he left for England, at the beginning of November, 1886.

On May 25th, 1887, the church extended a unanimous call to Rev. F. H. Marling to assume the Pastorate, which call he accepted, and entered upon the duties of his office on Sunday, September 4th, 1887.

On March 28th, 1889, Mr. Marling tendered his resignation of the Pastorate; which resignation was ultimately accepted, and his official connection with the Church terminated, amid many tokens of high regard and esteem for Mr. Marling, on June 15th, 1889.

PROCEEDINGS OF THE ANNUAL MEETING.

The Annual Meeting of the members of the Church was held on the evening of January 20th, 1890, in the Lecture-Room of the Church.

- 1. The Acting-Pastor, Rev. Dr. Cornish, occupied the Chair and conducted the devotional services. Mr. Leet was appointed Minute-Secretary of the meeting.
- 2. The Report of the Board of Trustees, together with the Treasurer's Statement, was read; and, on motion, received and adopted.
- 3. The Church re-elected by ballot the following retiring members to serve on the Board of Trustees:—Messrs. Linton, Wilson and Walker.
- 4. The Church Secretary presented the Report of the Church Board for 1889, which was received and adopted.
- 5. The Rev. Dr. Cornish was re-elected Church Secretary, the Church at the same time expressing its cordial thanks to him for his services during another year.
- 6. On the question of the mode of appointing brethren to serve on the Church Board, it was Resolved:—That a committee of nomination be appointed by the Chair. Whereupon, Messrs. Henry Lyman, Walker and Hollis were nominated the said Committee; and they presented the following nomination of brethren to serve for the current year:—Messrs. H. Sanders, S. P. Leet, C. Gurd, J. B. Learmont, Hy. Fry, Jun., A. Birks, E. S. Sharpe, W. S. Russell and Ed. Hollis. On motion, the nomination was received and adopted.
- 7. The Report of the Ladies' Aid Society was read and received, the Church recording its high appreciation of the value of the manifold work done, and tendering its thanks for the same.
- 8. The Young Ladies' Missionary Society's Report, including that of the Chinese School, was read and cordially accepted.

9. The Report of the Sunday School Committee was read, and received and adopted, and the Office bearers and Committee for 1890 were appointed.

10. The Report of the Committee on Psalmody was read. It reported satisfactorily on the regular attendance and progress of the members of the Choir, under the care of Mr. Reyner as

Organist and Choir Master.

vith thanks to the members of the Choir; and the following were re appointed as the Committee on Psalmody:—Messrs. C. Gurd (Convener), J. B. Learmont, C. R. Black, S. J. Andres, Jabez Jones, F. Scholes, and Wm. B. Blackader.

12. The Acting-Pastor and Messrs. Alexander and Jamieson were appointed the Committee on the use of the Church Building.

13. Mr. Wm. B. Blackader presented the Report for the third year of the Debt Fund Committee, which showed that \$870 had been raised in 1889. The debt is now \$18,450.

14. On motion, the above Report was received and adopted, with the cordial thanks of the Church to the Committee, and especially to Mr. Blackader.

15. The Report of the Young People's Association was read and received.

16. Mr. W. T. Russell, on behalf of the Christian Endeavour Society, recently organized, reported progress.

17. *Ordered*:—That the question of whether the deficiency in the Sunday-School account should be paid by the Church be referred to the Trustees for consideration and action.

18. On motion, it was *Resolved*:—That a Year Book for 1890 be printed, containing the Reports and Accounts now presented, and other customary information, under the care of the Church Secretary.

19. On motion, the above minutes were taken as read and confirmed.

After the Doxology, and prayer by Mr. Hague, the meeting adjourned.

REPORT OF CHURCH BOARD FOR 1889.

The Report now to be presented by your Board, is the fourteenth in the history of this Church; a short period in the life of public institutions, yet with us it has been marked by many changes, arising from death and removals on the part of members and Office bearers and Pastors. To say that as a Church we have suffered no detriment from these changes would be hardly correct; still, it is matter for thankfulness that we have been brought through another year in peace and harmony, with "no root of bitterness springing up" to cause trouble and division, and that we stand together on the threshold of another year in mutual confidence and regard, and cherishing the hope that the future has good things in store for us. Let us only be loyal to Christ our Master and to one another, and true to our own convictions of duty and responsibility, and all will be well with us; and we shall fill the position and do the work which fifteen years ago we looked forward to with so many bright and confident anticipations.

The losses by death in our membership during the year have been only two. On January 9th, Mr. Alfred Savage; and on February 13th, Mr. Gordon Kingan, passed to their rest and reward, both after an illness of great length and suffering, but borne with exemplary patience. The death of Mr. Savage, was referred to in the last Annual Report, together with the resolution adopted by the Church, testifying to the worth of his character and example, and to the value of his long services to the Mother-Church, as well as this, in the office of Deacon.

The most noteworthy event to us in the year now reported, was the resignation of our honoured Pastor, the Rev. F. H. Marling, which he tendered by a letter bearing date March 28th, and proposed that his period of service should close at the end of May or June. It is not necessary to report here with fulness of detail the steps that were taken in consequence of this unex-

pected event, but the following extract from the Pastor's letter will explain his position:—"You will readily understand that all the reasons for this conclusion cannot be given; and that to state part of them would produce an erroneous impression. I must ask you therefore simply to accept my assurance, especially in view of all which this step involves to me, that my action is deliberate and disinterested, and that to my own mind the path seems clear."

After a careful consideration of this letter, the Deacons reported it to the Church with the recommendation; that, "As the Pastor's resignation has come as a surprise to us; and as it constitutes a grave crisis for the Church, requiring the exercise of the most prayerful and deliberate circumspection and judgment; it be referred to a Committee of the Church, consisting of the Deacons, the Board of Trustees, and the elected members of the Church Board, for their most careful consideration, and report and recommendation thereupon." The committee so appointed sought an interview with the Pastor, in order to ascertain whether or no his resignation was final; and on his courteous assurance that it was, they felt that they had no other alternative before them than to recommend that it be accepted, with all proper expression on the part of the Church, of the very high appreciation in which his character and faithful services were held by every one among us. This recommendation was received and adopted; and the following resolution was unanimously passed :-

"That in accepting the resignation of our esteemed Pastor, the Rev. F. H. Marling, we desire to place on record our deep regret that any causes should exist among us which have led him to this important step; and to express our high appreciation of his faithful and self-denying services during the period of his pastorate. In every department of his work, he has recognized the responsibilities that have devolved upon him, and has manifested a cheerful self-sacrifice in discharging them. Especially has this been seen in his pastoral oversight of the flock committed to his charge, and in his desire to strengthen and extend the influence of the Sunday School by his interest therein, and

" by his conduct of a large and appreciative Bible-class, in addition to his other duties on the Lord's Day.

"Nor should we fail to make special mention of his constant "efforts to promote the temporal as well as the spiritual interests "of the Church, by his anxiety to see the debt reduced, and by his liberal contributions to that and all other pecuniary objects."

"We beg to assure him, that in leaving us he will carry with him our profound respect for his high Christian character, and our grateful remembrance of the many good qualities of mind and heart displayed by him in his intercourse with us; and our devout wishes that his future, as his past has been, may be one of honour and usefulness and happiness in the service of Christ and of His Church.

"Ordered further:—That the Church Secretary have the above resolution fairly engrossed for presentation to Mr. "Marling."

It was subsequently arranged that the Pastor's resignation should take effect on June 15th, and that a social farewell-meeting of the Church and Congregation should be held; and, further, in recognition of the cordial relations, which had happily subsisted between Mr. Marling and his ministerial brethren, that the Protestant Ministers of the city and neighbourhood should be invited to be present, and take part in this meeting.

These arrangements were duly carried into effect, the meeting being well attended, and shewing in what high esteem Mr. Marling was held by his Ministerial brethren, as well as by all who knew him in Montreal.

The Committee on Pastorate and Supplies was enlarged by the addition thereto of Messrs. William Blackader, B. B. Stevenson, Alfred Grafton and W. D. Lighthall. Dr. Cornish was appointed Convener of the Committee; and also, for legal and other necessary purposes, Acting Pastor during the vacancy in the Pastorate.

This committee has carefully attended to the important business entrusted to it, holding regular monthly meetings, which have been well attended, and presenting monthly reports of its proceedings to the Church. For the supply of the pulpit during most of the summer, the Church is under large obligations to Rev. Principal Barbour, for his valuable services, which he cheerfully supplemented by other Pastoral work, when such was needed. He has also delivered the Preparatory Lecture during the autumn and winter months, for which gratuitous service the Church has placed on record a special vote of thanks to him.

The Pulpit-supplies since the month of August have been obtained partly from the ranks of our own Ministers in Canada, and partly from the United States. The Board cannot report that up to the present time any definite progress has been made towards a final settlement. At the Church meeting held on October 30th, the Church, on recommendation of the Committee, resolved to invite six gentlemen, ministers of churches in England and Scotland, whose names in various ways had been submitted to them, to supply the pulpit, each for one month, beginning with the month of December. The invitations were accordingly sent, with the result that four accepted, viz :- Revds. C. A. Lyon, late of Rugby, for December; W. H. Pulsford, M.A., Dumfries, for April; J. P. Noble, Dundee, for May; and W. T. Clarkson, B.A. Edgbaston, for June. Mr. Lyon has duly kept his appointment and has returned to England, having won the high regard and esteem of many among us. The names of gentlemen in the United States have also been sought and obtained. In this way, much thought and labour have been expended, and all that we can do is to wait with patience, leaving the issue in the hands of the great Head and Guide of His Church.

During the summer, the Church-Secretary visited England, and returned home on September 3rd. Mr. Duff was appointed Acting-Church Secretary in his absence, and discharged the duties of the office with his wonted zeal and efficiency.

In this connection, the Board deem it proper to state that they have under consideration the question of appointing an Assistant Church Secretary, partly to relieve Dr. Cornish of some of the duties devolving upon him; but, mainly, that some one may be under his guidance and training to fill the office when a successor to him shall be found necessary.

Mr. Duff having tendered his resignation of the office of Deacon, in order to introduce certain changes in that office, his resignation was conditionally accepted, with the thanks of the Church for his past services.

Whereupon, on the recommendation of the Pastor and Deacons, steps were taken for the election of new Deacons to fill existing vacancies, which however did not result in an election. Whereupon, resolutions were introduced for effecting important changes both in the tenure of the office and in the mode of appointment thereto. After much discussion, the matter of the careful-examination of the Bye-Laws and Regulations of the Church, with a view to such revision as may be found necessary, was referred to the Church Board. A committee of the Board has presented its report, which has been received for further consideration and action thereupon, after which a Report will be presented to the Church by the Board.

The Home and Foreign Missionary meetings were duly held. On February 17th, the Pastor preached on Home Missions; and on the 24th, the Rev. Dr. Judson Smith, of the American Board, on Foreign Missions.

In the last Annual Report, reference was made to the important question of the introduction of a new Hymn and Tune Book, for use in the Public Services of the Lord's Day. The Church Board, to whom the matter was remitted, reported finally, recommending the adoption of Dr. Allan's books, which recommendation was concurred in, and the change took effect in the month of May.

Messrs. Duff and Leet, with Mr. Hague as alternate for Mr. Duff, were appointed delegates to the meetings of the Union held in Brantford. Mr. Hague and Mr. Leet duly kept their appointment, and reported thereupon on their return.

The question of improving the attendance and enhancing the interest of the week-evening service, has, on recommendation of the Board, had the careful attention of a committee of the Church, appointed for this purpose. The committee has reported to the Church certain important changes, by which it is hoped the

desired end will be secured. Whilst the Prayer-meeting is not in itself an end, it may be made a valuable means to an end, nor can it be neglected with impunity.

Mr. William B. Blackader, as Treasurer of the Debt Fund, reported in February, that \$1,053.88 had been raised during the previous year; making the total of \$7,096.69, which had been raised during the past 3 years of the existence of the Committee. The cordial thanks of the Church were deservedly tendered to Mr. Blackader and his colleagues, for this valuable service rendered by them in the reduction of the debt on the building.

It will devolve on the Committee on Psalmody to report on the gratifying progress which has been made by the Choir, under the care of our Organist and Choir-Master, Mr. Horace W. Reyner,

in the service of Song on the Lord's Day.

The Reports of the Sunday-School, the Ladies' Aid, the Young People's Association, the Young Ladies' Missionary Society, and our other organizations for good work, will be presented by their proper Committees; and they well deserve attention telling, as they do, of much self-denying thought and sacrifice and effort on the part of those engaged in them. It is an encouraging fact, that recently a Society of Young People's Christian Endeavour has been established, and it is much to be desired that it be energetically sustained and encouraged by all interested in the welfare of the young people of the Church and Congregation.

The Governors of the Protestant Hospital for the Insane have sought the co-operation of the Church in the completion and future management of that Institution. This Church, in common with others in the city, was asked to contribute \$400.00, by annual payments of \$80.00, for 5 years; such payment entitling the Church to send a representative on the Board of management annually, without any further contribution. The Church acceded to this request, and by a special collection on the second Sunday in December, which collection is to be taken up on that day annually, raised the first instalment of \$80.00. The Church-Secretary has, for the present, been appointed representative on the Board of Management.

Our motto at the end of this fifteenth year of our life as a Church, may well be "Hitherto hath the Lord helped us"; and from our experience of His goodness and faithfulness in the past, we will trust Him now and through all the future with a firmer faith, and serve Him with a more fervent devotion and love. Let us by His help and guidance do this, and all will be well with us.

TRUSTEES' REPORT.

Your Trustees in presenting their Annu'l Report for the year 1889, are happy to be able to state, that, notwithstanding the fact that the Church has been without a Pastor for more than half the year, the income has about kept pace with the expenditure, and there is a balance in the hands of the Treasurer, of \$197.06.

There is, however, included in the receipts, a refund from the city of special taxes erroneously collected, \$475.05.

The Treasurer's Statement, presented herewith, gives full details of the receipts and expenditures during the year.

The Church-building has been well maintained. Special ex penditure, chiefly in re-pointing the outside walls, and altering the choir seats, has amounted to \$163.85.

The rate of interest on the mortgage, held by the Estate H. B. Smith, has been reduced during the year to 5 per cert.

The committee in charge of 'Debt Fund," have enabled the Treasurer to pay a further sum of \$1,050, on account of the mortgage due to the College.

The mortgage debt is now as follows:-

The annual interest charge is now \$1,057 per annum.

REPORT OF SUNDAY SCHOOL.

The year 1889 opened with the roll as follows:—Officers, 4; Teachers, 18; Scholars, 201; Total 223.

Average attendance first half year, 145.

The attendance during the past year has not been equal to the former year, the difference is mainly attributed to the falling off in attendance of one of the most important classes of the school, viz:—The Pastor's Bible Class.

Last year the class had an attendance varying from 12 to 44: after the resignation of the Rev. Mr. Marling, as Pastor of the Church, which took effect, June 15th, the attendance was much reduced in numbers.

The class has been regularly held, but with diminished numbers. The thanks of your committee are due to the students of the Congregational College, and others, for filling the place of leaders during the latter half of the year. Last Summer, six children were sent to the Murray Bay Convalescent Home. The difference between expenditure and collections made for the purpose, was placed to the debit of general fund account.

Meetings of the Helping Hand Society have been regularly held, and have been well attended. The personel has changed, many of the older boys having gone to fill situations which interferes with their attendance on Saturday mornings, but new members have taken their places.

A carpenter has been engaged to instruct the members in the use of tools. The sale of their work realized \$51, which was donated to the Day Nursery.

We have never known a year when sickness has been so prevalent among the scholars, but happily it has not been of a se rious character; it is matter for thankfulness that only one death has occurred, viz.—That of Samuel Cromwell Thomson, one of the

scholars of the Primary class, which took place last August. He was much attached to the School and his Teachers. He has frequently been known to express regret if anything interfered with his attendance at the School.

An instructive entertainment was given to the scholars of the School on December 13th, being a Lantern Exhibition and a Lecture, entitled "Ben Hur." Teachers and scholars of the School were admitted free. The tickets sold paid the cost incurred and a small balance was carried over to the credit of the general fund account.

It has been decided by the Teachers to give an Afternoon Tea to the scholars of the School, during the month of February next. It has also been decided to ask the scholars to give an entertainment to a number of poor families at Easter.

Your Committee have pleasure in alluding to the interest of the scholars in benevolent work; it may not be out of place here to mention the efforts of two Teachers in the School, desirous of practically instructing their scholars in doing good as a means of getting good. Two deserving families were selected who needed

assistance, to whom thanksgiving dinners were to be sent. The girls and boys of the two classes cheerfully co-operated with their teachers, each scholar contributing some article of food; one of these classes sent also a New Year's dinner to every destitute family, and the other class mentioned have decided to clothe a little girl. In addition to those already mentioned, another teacher and her class of little boys sent a Christmas dinner to a family who would not have had one, but for their thoughtfulness. Their kind acts were gratefully appreciated by the families alluded to, and the scholars have experienced that pleasure which results from trying to make others happy.

Your Committee wish to tender their thanks to Miss Wilkes and Miss MacPhie and Master Arch. Duff, for their kind assistance in connection with the musical part of our services.

When the new Hymn Books were introduced into the Church, after due consideration your committee decided to introduce Dr. Allon's Book, called Children's Worship, containing as it did many old familiar Hymns as well as many new ones suited to the want of the School.

In last Annual Report your Committee suggested the purchase of a piano in place of renting one, the cost of rental including insurance and risk of owner was \$4.00 per month, or \$48.00 per annum. The piano now in the School has been purchased for \$100.00, this amount has yet to be paid.

The Library has been under the direction of Mr. W. H. Black. It is gratifying to report that the books have been very much in demand by the scholars.

A Christmas service was held on Sunday, 22nd December, when a special sermon to the Scholars of the School was preached by the Rev. Mr. Lyon, late of Rugby, England. The Annual Christmas offering was taken up on Sunday, December 29th, for the Day Nursery, which amounted to \$41.41.

The year just closed has been one of change. The removal from the city and by death of esteemed friends who were connected with our Church and the temporary absence of others from the city, and other causes, have diminished our numbers during the latter part of the year.

Your Committee allude with regret to the small number attending the Adult Bible Class; they recommend that special effort be made to induce the attendance of young men and women who are not connected with the School.

The Chinese Class, although it assembles with its teachers for the opening exercises of the School, is not included in the numbers of the School. We cannot allow the opportunity to pass without allusion to the earnest and good work done by those connected with this effort. It may be mentioned that one of the teachers of the school parted with a number of her class, so that they might become teachers of this interesting class.

In closing, your Committee wish to place on record their appreciation of the good work done in connection with the School by the Rev. Mr. Marling, when pastor of the Church, in organizing and maintaining a large Bible Class. Mr. Marling was always found at his post. Your Committee wish gratefully to bear testimony to his personal attachment to the School and to his liberal pecuniary and personal support of all efforts connected with the School.

REPORT OF THE DEBT FUND COMMITTEE.

Since the last Annual Meeting there has been collected on account of the Debt Fund the sum of \$870.46.

THIRTEENTH ANNUAL REPORT OF THE LADIES' AID SOCIETY.

In presenting our Annual Report, we do so with great pleasure, as our work has gone on as successfully as formerly, and we have every reason to hope for a blessing.

We have held seventeen meetings, with an average attendance of ten; and very pleasant and profitable were the hours spent in our comfortable parlour, working for others.

Our only wish is that more of the ladies of our Church would take the opportunity thus afforded of identifying themselves with the work of our Society.

Our first work this year was for the "Diet Dispensary," in providing articles of clothing to be given away to the sick poor, than which there certainly can be no better nor more needful work.

This Fall our sympathies were again aroused by an appeal from the nurses connected with the "Diet Dispensary," for the babies of the poor, who alas, are not born like the lambs, with their clothes ready made, and accordingly we prepared four sets of everything necessary to a baby's comfort, and sent them to the Dispensary on the 25th of November.

It was time now to turn our attention to our usual Christmas offering to two of our Ministers in the country, who are not overburdened by this world's goods.

After some correspondence with our ubiquitous friend, Mr. Hall, we settled upon two families to whom it seemed that help would be opportune, one in Ontario and one in Quebec.

The response to our public appeal was both prompt and liberal, and we were enabled to send on the 17th of December, two valuable cases of articles, that so far as we knew were most necessary for the comfort of those to whom they were sent.

Letters have been received from both families, expressing their gratitude and hearty thanks. We quote from one:—"We feel that we cannot fully express to the Ladies' Aid Society, all the gratitude which we feel, for the thoughtful kindness bestowed upon us at this season, and above all to our Heavenly Father for His goodness to us. Bur are we not told, 'it is more blessed to give than to receive,' and those who scatter seeds of kindness, never fail to reap an abundant harvest."

After some consideration it was decided to unite the prayer and working meetings, faith and works literally going hand in hand, and we feel sure that the earnest prayers that have risen from that band of godly women, have been both heard and answered.

Not long since, the Rev. S. Massey interested us in the Protestant Insane Hospital, and we have pledged ourselves to furnish two rooms at a probable cost of fifty dollars, and we

trust that the Church will not be slow in backing us, as this as yet to be accomplished. We intend also working for individual families among the poor, and shall therefore continue our weekly meetings.

Various collections have been made through the Church for charitable purposes, viz:—Industrial Rooms, Young Women's Christian Association, Sheltering Home, Woman's Board of Foreign Missions, etc., mention of which will be found in the Treasurer's Report.

Several Church Socials have been arranged for by our Society, and we have much pleasure in acknowledging the kindness of Messrs. Willis in sending piano free of charge upon these occasions. We wish also to thank Messrs. James Linton, Wm. MacLachlan, and Wm. McDougall, for valuable donations, and the Williams Sewing Machine Co., for the use of a machine for the year.

On the whole we feel that we have passed a most successful year; but sincerely trust that before another has rolled away, we shall have a legitimate head in the shape of a Pastor's wife, without whom we feel like a ship without a rudder.

Dr. Moffat once said that an unmarried missionary was like a boat being roared by one oar, it just spun round and round, and unless a change takes place shortly, we fear we shall be in like condition.

In April, travelling-rugs were presented to two members of the graduating class of the Congregational College, previous to their going forth as Foreign missionaries—Mr. Lee to Africa and Mr. Pedley to Japan.

The Chinese class has had a successful year's work, as will be seen from its report.

The Society lost a faithful friend and counsellor in the departure of Rev. Mr. Marling. We miss his ever ready and active sympathy in our work. One of his kindly acts before leaving the city was to give us several volumes; these formed the nucleus of a mission library, which is steadily increasing and will, we trust, prove a source of great enjoyment.

We would take this opportunity of publicly thanking Mr. Hague for his much-appreciated gift of a handsome bookcase—also the ladies who kindly gave books and money for the library fund.

While feeling deeply grateful for all past favours, may we be permitted to ask for still further assistance? Books of reference, or magazines for the library will be gladly received.

Before closing, we would cordially invite every young lady in the church to join us. The attendance this year has been a great improvement on that of the past; there is still room for many more.

Your presence will be an inspiration to us and we may be of mutual benefit to one another.

REPORT OF CHINESE SUNDAY SCHOOL.

The Chinese Sunday School of Emmanuel Church is now just five years old, having been organized in November, 1884.

In the spring, one pupil went to Quebec, to open the first Chinese laundry in that city, and in September, three returned to China. Lately, however, three new-comers have joined, so that we now number twelve Chinese and twelve teachers—in

all, twenty-four.

Many complaints, from both teachers and Chinese, of the early hour, led to a change from half-past nine to three in the afternoon. Several teachers were thus lost to us, as they are engaged in the Sunday School at the same hour, so it became necessary to fill their places with new recruits. Our thanks are due to those who have acted as substitutes during the absence of regular teachers; also to Mr. Charles Gurd, who has kindly lent a piano for our use from December till June.

The progress is encouraging. The Ten Commandments, the Lord's Prayer, hymns, and Bible verses are being taught, in

addition to lessons in reading and writing.

A correspondence with Miss Harriet Carter, of Boston, who is the leader in Chinese work in that city, and who has often aided us by advice, led to our sending to San Francisco for a little book called "Bible Questions and Answers," which gives in seventy questions the whole Plan of Salvation, the answers being texts of Scripture. A great advantage is that we have this book also in Chinese, and one of the pupils reads aloud the lesson for the day, so that all hear in their own tongue what we have been trying to explain.

The expense of this work has never been large, and was always borne by the teachers; but as it became necessary to supply a number of books, etc., help was asked from the Sunday School, which promptly responded with a donation of \$15. Our

REPORT OF THE YOUNG PEOPLE'S ASSOCIATION.

It is with pleasure I have to report another prosperous year for this Association.

Eight meetings have been held since the last Annual Meeting of the Church, and though few in number, have been exceptionally good, the papers we have had the pleasure of listening to have always been interesting and instructive.

One meeting was held in the form of a debate between our Association and the Calvary ChurchYoung Men's Literary Society, at which there was a very large attendance of members of both congregations, and great interest was manifested in the speeches.

Finding that too much work devolved upon the officers of the Society in providing programmes for the various meetings, this season a different committee, composed of two men and two ladies, is chosen for each meeting, this gives each member a greater interest in the welfare of the Association and secures a better programme by creating a healthy rivalry between the committees.

The meetings are held in the houses of members of the Congregation or in the Church-parlor, those held in the former are generally more successful, being more homelike and social in their aspect.

The work of decorating the Church for the Christmas and

Thanksgiving services, was intrusted this year to our Society,

special contributions being made for it.

A subscription-list was opened at the last meeting to defray the current expenses of the Association, which last year were kindly borne by some of the officers, and such expenses as the decorations, etc., mentioned before; the sum of \$20 has already been subscribed.

The Association, though perhaps not as large in numbers as it might be, is still in a very flourishing condition and an important factor of the Church; it brings the young people of the Congregation together in social intercourse, trains them in the work of committees and stimulates them in the field of literary research, while behind all this it exerts a christian influence towards better and nobler aims in life.

At the Annual Meeting held on Tuesday, 5th November, 1889, the following officers were elected for the season 1889-90.


