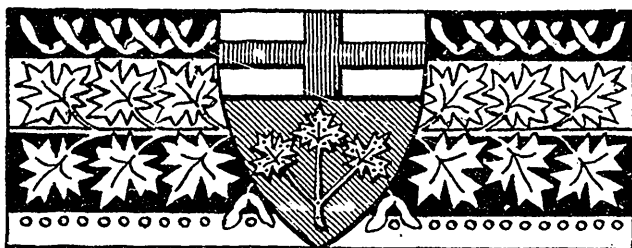

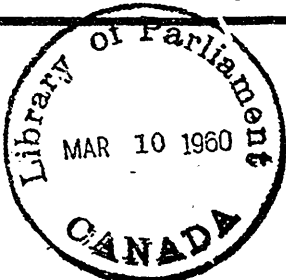

Clan Baty.

AMONG the Scottish Border Clans of olden time was that of Bat—or Baty—represented by the modern families of Beatson and Beaty, who inhabited the valley of the Esk in Dumfries, in the 15th and 16th centuries. The name is a diminutive of Bartholemew, and in early records is variously spelled Bat, Bette, Baty, Baytie, Batie, Baetie, Baittie, and Baitty; in modern times it appears as Beattie in Scotland and Beaty or Beatty in Ireland, while at all times it appears in the form of Beatison or Beatson, with variations of spelling. In 1458 King James II. granted lands in Roxburgh to John Beatisoun, and others in the same locality to his brother Nicholas Batisoun, as rewards for services rendered. Robert Batysoune also received a grant of lands, apparently for participating in the same services. Half a century later the clan seems to have fallen upon evil days, being, with many other border clans, sufferers from an English invasion, and the victims also of much rough usage from their own compatriots; and about the middle of the 16th century they became broken. It was probably about this time that some of the name crossed over and settled in the north parts of Ireland, where their descendants still continue. From this latter section of the clan are derived some of the families of Beaty and Beatty, settled in Ontario, and of whom some members have attained considerable prominence in this province.*

The Macdonells OF GLENGARRY (A.E.L.)

IT has always been well known that the principal families of the Clan Macdonell of Glengarry, in Canada, were of near kin to the chiefs of that clan, but it has been difficult to show the actual connection of some branches, in consequence of, firstly, in a general way, the confusion occasioned by the attempts of the Stuarts to recover their lost throne, and secondly, in particular, the loss of family papers on two occasions when dwelling houses of principal persons of the family in Canada were burnt down. These difficulties have chiefly concerned the branches of Leek, Ardnabee, Aberchalder and Collachie, those of Scotus and Greenfield being much better known, though even of the latter, Greenfield, two genealogies, materially different, have appeared in print. It is probable that the best information which has been, or perhaps can be, procured on this subject, will appear in the third volume of "*Clan Donald*," now in preparation, and likely to be published some time next year. In the meantime, as the subject is one of interest to many of our readers, we give the result of such enquiries as have been made to the present time.

All the families referred to appear to derive descent from

Donald Macdonell, 8th Chief, who died 2nd Feby 1645, aged over 100 years, who had issue, viz. :

1.—Angus, or Æneas, slain in a fight between the Macdonalds and the Mackenzies, cir. 1603.

2.—Alexander, Alastair Dearg, d.v.p., father of Æneas, 9th Chief, who was created Lord Macdonell and Arros, and d.s.p.

3.—Donald, of Scotus, or Scothouse, father of Ranald, or Reginald, 10th Chief, of whom below.

4.—John, the elder, or Ian Mor, from whom the families of Ardnabee, “all of whom emigrated to America.”*

5.—John, the younger, or Ian Og, “whose descendants also went to America.”

Ian Mor is said to have been father of Alexander, who was father of John of Leek, Allan of Collachie, or Cullaquhy, and Alexander of Aberchalder, from each of whom descent is traced in *Ontarian Families*. But there must have been at least one generation intervening, even though, as is probable, Ian Mor was born late in the life of his father, who lived to a great age.

Ranald, or Reginald, 10th Chief, had issue,

1.—Alastair Dhu, 11th Chief, who led the Clan at Killiecrankie, and in 1715 was created a peer by K. James II., after his abdication. His line failed in 1868.

2.—Angus, or Æneas, of Scotus, who had issue,

1*a*.—Donald, whose descendant Æneas-Ranald became 19th Chief on failure of the elder line in 1868.

2*a*.—John, of Crowlin, father of John of Scotus, who was an adherent of Prince Charles Stuart in 1845, and afterwards went to America, finally settling in Canada (U. E. L.), and from whom descent is traced in *Ontarian Families*. He was known as “Spanish John.” His present representative is John-Alexander Macdonell, M.D., of Port Arthur.

3.—John, father of 1*a*—Donald, of Lochgarry, a noted adherent of P. Charles, with whom he escaped to France after Culloden, and became a Colonel in the French service; his descendants subsequently returned to Scotland; and 2*a*—Angus, of Greenfield, ancestor of that branch, of which the representative is John-Alexander Macdonell, Q.C., of Alexandria.

Stewart of Douro.



Sir William Stewart, brother of Sir Alexander Stewart, created Baron of Garlies in 1607, and Earl of Galloway in 1623, was a Captain in the army and served in Ireland, where he acquired estates, in which he was succeeded by his nephew

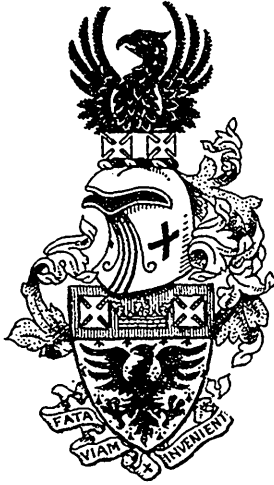

Susanna, dau. of Robert Sanderson second son of Robert Sanderson Bishop of Lincoln, and had issue, of whom

Bittern at the affair on the Peiho River and the attack on the Taku forts (medal); commanded H.M.S. Ariadne, which brought the Prince of Wales to Canada in 1860; also H.M.S. Achilles in the Channel fleet when she was first put in commission.

1.—Elizabeth, m. to Robert Riddell, of Glen Riddell, Scotland, who settled in Co. Oxford, Upper Canada, for which county he was M.L.A. 1844. He afterwards returned to Scotland. Had issue, several sons and daus., of whom the eldest son is Robert-VanSittart Riddell, Colonel R.E.
