

## An Act to Incorporate "The City of "Kingston Water Works Company."

WHEREAS the supplying of the City Preamble. of Kingston with Water would be of great public advantage, and whereas the City of Kingston, under their Common 5 Seal, and Francis Manning Hill, William Ford, Junior, Thomas Weeks Robinson. John Richardson Forsyth, George Baxter, Archibald John Macdonell, William Allan Geddes, Thomas Kirkpatrick, Stephen Al-10 dritch Irons, John Quiggin, George Alexander Cumming, Horatio Yates, and John

- Mowat, inhabitants of said City of Kingston, have, by their petitions, prayed that the said Francis Manning Hill, William Ford, Junior,
- 15 Thomas Weeks Robinson, John Richardson Forsyth, George Baxter, Archibald John Macdonell, Willian Allan Geddes, Thomas Kirkpatrick, Stephen Aldritch Irons, John Quiggin, George Alexander Cumming, Ho-
- 20 ratio Yates, and John Mowat, and others who may become associated with them in the undertaking may be Incorporated under the style and title of " The City of Kingston "Water Works Company," the better to en-

and all such persons as shall hereafter become Stockholders of the said Company, shall be, and are hereby ordained, constituted and declared to be a body corporate and politic in law, in fact and in name, by 5 the style and title of " The City of Kingston "Water Works Company," and by that name and style, their assigns or successors. shall and may have continued succession, and shall and may be capable in law of suing 10 and being sued, pleading and being impleaded, answering and being answered unto, defending and being defended in all Courts and places whatsoever, and that they and their assigns or successors, may have a 15 Common Seal, and may change and alter the same at pleasure, and shall and may have power to purchase lands, tenements, and hereditaments, for them and their assigns and successors, for the use of the said 20 Water Works, and also to sell any of the said lands, tenements and hereditaments, to be purchased for the purpose aforesaid, and any person or persons, bodies politic or corporate, may give, grant, sell, bargain, or convey 25 to the Company, any lands, tenements or hereditaments, for the purposes aforesaid, and the same may re-purchase from the said Company, provided always that the said lands, tenements and hereditaments to be 30 holden by the said Corporation, shall be held for the purposes and business of the said Water Works Company, in constructing their necessary works, and for no other purposes whatsoever, and that they shall not 35 exceed at any time the yearly value of five hundred pounds currency, over and above the value of the works thereon erected.

Company may raise £10,000 for constructing Water Works. II. And be it enacted, That the said Company of Proprietors may raise and contribute 40 among themselves, such sum as shall not exceed the sum of ten thousand pounds currency, in shares of twelve pounds ten shillings currency each, and the money so raised shall be appropropriated to the pur-45 pose of constructing, completing, and maintaining the said Water Works, and to the purposes of this Act, and to no other object or purpose whatsoever.

- III. And be it enacted, That within one General Mect-5 month after the passing of this Act, a Gen- ing when to eral Meeting of the Proprietors, for carrying this Act into effect, shall be held at such place in the City of Kingston as the majority
- 10 of such proprietors shall appoint, to choose nine persons being Proprietors in the said undertaking, as Directors, of whom any three or more shall be a Committee for managing the affairs of the Company, and in the
- 15 event of there not being nine Proprietors or Shareholders in the Company, then, and in that case, the number of Directors shall be limited to the number of Proprietors or Shareholders, each being the owner of at
- 20 least ten shares of the stock of the said Company, held in his own name and right.

IV. And be it enacted, That the Direc- Period during tors so chosen shall serve until the first which Direct-Monday in the month of May, one thousand office.

- 25 eight hundred and fifty, and shall immediately after their election at their first meeting choose out of their number a President and Vice-President who shall hold their offices respectively during the same period
- 30 for which the said Directors shall have been elected as aforesaid, and shall thereupon commence the business and operations of the said Corporation, and general meetings of the Proprietors or Shareholders shall be
- 35 held annually for the purpose of electing Directors as aforesaid on the first Monday in the month of May in each year, at which meeting the Directors of the then past vear shall exhibit a full and unreserved state-
- 40 ment of the affairs of the Corporation, and of the funds, property and debts due to and from the said Company, which said statement shall be certified by the President under his hand and seal; and in the event of

there being no meeting of Shareholders or Proprietors in consequence of the said Shareholders or Proprietors neglecting to attend in conformity with the requirements of this Act, then and in that case the Direc- 5 tors of the previous year shall continue and remain in office until an election shall take place at a future meeting of the said Shareholders or Proprietors, and such Directors subsequently elected or remaining in office 10 shall at their first meeting after such election or the period named in this Act for holding such annual meeting, choose out of their number a President and Vice-President who shall hold their offices respectively for 15 the then ensuing twelve months, or until such subsequent election at a future meeting of the said Shareholders or Proprietors as the case may be, and it shall be lawful for the said Directors, from time to time, in case 20 of death, resignation, absence from the Province or removal of the persons so chosen to be President or Vice-President or Director, or either of them to choose in their or his stead from among them, the said Directors. 25 another person or persons to be President or Vice-President, or from amongst the other Shareholders or Proprietors another person or persons to be Director or Directors respectively, to continue in office until the next 30 annual meeting as aforesaid.

Shareholders may vote by proxy, &c.

V. And be it enacted, That Stockholders or Proprietors may vote by proxy or in person, and all elections shall be ballot, and each Stockholder or Proprietor shall have 35 one vote; provided always that each Stockholder or Proprietor holding more than three shares shall have one vote for every three shares held by such Stockholder or Proprietor.

VI. And be it enacted, That the Directors or Committee thereof shall and may have the power to appoint such officers and other persons as may appear to them necessary for carrying on the business of the said

Corporation, with such salaries and allowances to each as shall seem meet and advisable, and also shall and may have the power

- 5 to make and prescribe and alter such Bylaws, Rules, Regulations and Ordinances as shall appear to them proper and needful touching the well ordering of the said Corporation, the management and disposition of its
- 10 stock, property, estate and effects, and also shall and may have the power to declare yearly or half-yearly dividends out of the profits of the said business as they may deem expedient: Provided always, that such By- Proviso.
- 15 laws, Rules, Regulations and Ordinances, shall be in no wise inconsistent with the true intent and meaning of this Act, and the powers hereby granted, nor repugnant to the laws of the Province.
- VII. And be it enacted, That the stock of Stock assess-20 the said Company shall be assignable and able under re-transferable according to such rules, and Board of Disubject to such restrictions and regulations rectors. as the Board of Directors shall from time to
- 25 time make and establish, and shall be considered as personal property: Provided Proviso. also, that such transfer be entered and registered in a book or books, kept for that purpose for the said Company.
- VIII. And be it enacted, That it shall and Corporation 30may be lawful to and for the said Corpora- may break up, &c. streets, &c. tion, after three days' notice in writing to the and lay down City Clerk of the City of Kingston, to break &c. up, dig and trench so much and so many of
- 35 the streets, squares, and public places of the said City of Kingston, commencing at the works of the said Corporation, and running through the said City of Kingston, as will be necessary for laying the mains and pipes to
- 40 conduct the water to and from the works of the said Corporation to the consumers thereof, doing no unnecessary damage in the premises, and taking care, as far as may be, to preserve a free and uninterrupted passage through the

said streets, squares and public places. while the work is in progress, and making such openings in such parts of the said streets, squares, and public places, as may be requisite for the construction of such works. 5 and laying such mains and pipes therein with the permission of the City Council of the said City of Kingston; and also placing guards and fences, and taking all such necessary precautions for the prevention of accidents 10 to passengers and others, which might be occasioned by such openings, as such City Council shall at any time order or require: also finishing the work, and replacing the said streets, squares and public places in as 15 good a condition as before the commencement of the work, without any unnecessary delay; and also to break up, dig and trench such roads, streets, and places in the immediate vicinity of the said City of Kingston as 20 may be necessary for laying the mains and pipes aforesaid, and for constructing the said works, doing no unnecessary damage in the premises, and taking all necessary precautions for the prevention of accidents to pas- 25 sengers or others, during the progress of such works, and in case of the neglect of any of the duties herein provided, as aforesaid, the said Corporation shall be subject to such fine not exceed-30 ing Five Pounds currency, for every day such neglect shall continue, to be recovered by information in Her Majesty's Court of Queen's Bench, on behalf of Her Majesty, Her Heirs and Successors for the public uses 35 of the Province, as the said Court may order or impose, over and above such damages as may be recovered against the said Corporation in any Civil Action.

Consequences of neglect on the part of the Company.

IX. And be it enacted, That in case the 40 said Corporation shall open or break up any street, square, or public place in the said City, and shall neglect to keep the passage of the said street, square, or public place, as far as may be, free and uninter-45

rupted, or to place guards or fences. or to take any necessary precaution for the prevention of accidents, to passengers or others, or to close and replace the squares, or public places, 5 said streets,

without unnecessary delay, as hereinbefore provided, the City Surveyor, under the direction of the City Council of the said City of Kingston, shall cause the duty so neg-

- 10 lected to be forthwith performed, and the expense thereof, shall be defrayed by the said Corporation on demand of the City Surveyor, from the Cashier, or Treasurer, or any Director of the said Corporation, or in de-
- 15 fault of such payment, the amount of the said claim, shall and may be recovered from the said Corporation, at the suit of the said City of Kingston, in an action of debt in any Court of competent jurisdiction.
- X. And be it enacted, That the said Cor- The Company 20 poration shall be held and obliged to make, for construct erect, construct, repair, and keep in good order, at the charges and expense of the City of Kingston, in such parts of the City
- 25 of Kingston as may be fixed upon by the City Council thereof such number of good and sufficient fire plugs as may be found necessary by the said City Council for the purposos of supplying fire engines, and of
- 30 giving such other assistance as may be useful and necessary for extinguishing fires, and preventing the communication thereof: Pro- Proviso. vided always, that the said Water Works Company shall not be compelled to make,
- 35 erect, or construct any fire plugs as aforementioned in any part of the City of Kingston, where they have not made or constructed pipes for conveying water.

XI. And be it enacted, That if any per-Penalty on 40 son or persons, shall lay, or cause to be laid, ring water any pipe or main, to communicate with any without the pipe or main belonging to the said Corpora-Directors or tion, or any way obtain or use the water with- their officers. out the consent of the Board of Directors, or

their officer appointed to grant such consent, he or they shall forfeit or pay to the said Corporation the sum of twenty-five pounds, and also a further sum of one pound for each day such pipe shall so remain, which said 5 sum, together with costs of suit in that behalf incurred, may be recovered by civil action in any Court of Law in this Province, having jurisdiction competent for the same.

Penalty on persons damaging pipes or other works, &c.

XII. And be it enacted, That if any per- 10 son or persons shall wilfully or maliciously break up, pull down, or damage, injure, put out of order, or destroy any main, pipes, engine, water house, pipe, plug, or other work, or apparatus, appurtenances, or de-15 pendencies thereof; or any matter or thing already made and provided, or which shall be made and provided for the purposes aforesaid; or any of the materials used and provided for the same, or ordered to be erected. 20 laid down, or belonging to the said Company, or shall in any wise, wilfully do any other injury or damage, for the purpose of obstructing, hindering, or embarrassing the construction, completion, maintaining, or repairing of 25 the said works, or shall cause or procure the same to be done, or who shall bathe, or wash, or cleanse any cloth, wool, leather, skins, animals, or any noisome or offensive thing, or cast, throw, or put any filth, dirt, or 30 any noisome or offensive thing, or cause, permit or suffer the water of any sink, sewer, or drain to run, or be conveyed into, or cause any other annoyance to be done to the water within any reservoirs, cisterns, ponds, courses 35 or fountains, from which the water to supply the said City is to be conveyed, or by wrongfully or improperly wasting the water; every such person or persons shall be guilty of a misdemeanor, and on conviction thereof, 40 . the Court before whom such persons shall be tried and convicted, shall have power and authority to condemn such person to pay a penalty not exceeding five pounds, currency, or to be confined in the Common Gaol of 45

the District for a space of time, not exceeding three months, as to such Court may seem meet.

XIII. And be it enacted, That the sub- subscriptions 5 scriptions for shares in the Capital Stock of made before the said Company or to the undertaking for Act, good and carrying out which the said Company is valid incorporated, shall be good and valid and binding on the Shareholders whether made 10 before or after the passing of this Act; and the several persons who have subscribed or may hereafter subscribe for shares in the said undertaking or Company, shall and they are hereby required to pay the sum or sums 15 of money by them respectively subscribed, or such part or portions thereof as shall from time to time be called for by the Directors of the said Company under and by virtue of the nowers and directions of this Act to such m person or persons and at such times and places as shall be directed or required by the Directors; and in case any person or persons shall neglect or refuse to pay the same at the time and in manner required for 25 that purpose, it shall be lawful for the Directors to cause the same to be sued for and recovered in any Court of Law in this Province having jurisdiction in civil cases to the amount, and in any such action, whether for 30 the subscriptions already made or hereafter to be made, it shall not be necessary to set forth the special matter in the declaration. but it shall be sufficient to allege that the defendant is the holder of one or more shares 35 in the Stock, (stating the number of shares) and is indebted to the Company in the sum to which the calls in arrear may amount; and in any such action it shall be sufficient to

maintain the same, that the signature of the 40 defendant to some book or paper by which it shall appear that such defendant subscribed for a share or a certain number of shares of the Stock of the said Company or undertaking be proved by one witness, whether 45 in the employ of the Company or not, and

that the number of calls in arrear have been made, and the suit may be brought in the corporate name of the Company.

Instalments not to exceed a or rtain amount.

XIV. And be it enacted, That no instalment 10 be paid on account of the shares 5 in the Stock of the said Company shall exceed two pounds ten shillings currency on each share, and notice thereof shall be given by advertising in one or more of the newspapers published in the said City of Kings- 10 ton, at least two weeks before such instalment shall be called for: Provided always, that no instalment shall be called for except after the lapse of a fortnight from the time when the last instrument was called for, and if any 15 person or persons shall neglect or refuse to pay his or their share of such money to be so paid in as aforesaid at the time or place fixed and appointed by the Directors, such person or persons so neglecting or refusing 20 may be sued as aforesaid, or at the option of the Directors shall thereby incur forfeiture of not more than ten nor less than five per cent. on the amount of his or their respective share or shares; and if such person or 25 persons shall refuse or neglect to pay their portion of the instalments demanded for the space of two calender months after the time fixed for the payment thereof, then and in that case such person or persons shall forfeit 30 his or their respective share or shares upon which former instalments shall have been paid, and such share or shares shall be sold by order of the Directors, by public auction, and the proceeds of the sale, after deducting 35 costs and the forfeiture above mentioned, shall be paid over to such defaulter, and the President or Manager of the Company shall have power to transfer the stock to the purchaser or purchasers thereof; Provided al- 40 ways, that no advantage shall be taken of the forfeiture of any share or shares, unless the same shall be declared to be forfeited at some general or special meeting of the Shareholders, assembled at any time after such 45

Act not to affect private water works, or to bind the Legislature.

Accounting clause.

XVIII. And be it enacted, That in case the present limits of the City of Kingston be enlarged by any Act to be passed in the present or any future Session of the Parlia- 20 ment of this Province, it shall be lawful for the said Company to extend their operations over any such enlarged limits or the future liberties of the said city, and the provisions of this Act shall in all respects be applica- 25 ble to any such enlarged limits or liberties in the same manner and to the same effect as they are made applicable to the present limits of the City of Kingston.

XIX. And be it enacted, That nothing in 30 this Act contained, shall extend, or be construed to extend to prevent any person or persons, body politic or corporate from constructing any works for the supply of water to his, or their own premises, or to prevent 35 the Legislature of this Province, at any time hereafter, altering, modifying or repealing the powers, privileges or authorities hereinbefore granted to the said Corporation.

XX. And be it enacted, That the penal-40 ties by this Act imposed, appertaining to Her Majesty, Her Heirs and Successors, shall be reserved for the public uses of the

Province, and for the support of the Government thereof; and the due application of the same shall be accounted for to Her Majesty, Her Heirs and Successors, through the 5 Lords' Commissioners of Her Majesty's Treasury, for the time being, in such manner and form as Her Majesty, Her Heirs and Successors shall be pleased to direct.

XXI. And be it enacted, That nothing Reservation of 10 herein contained shall affect, or be construed Rights. to affect, in any manner or way whatsoever, the rights of Her Majesty, Her Heirs and Successors, or of any person or persons, or of any bodies politic, corporate or collegiate, 15 such only excepted as are herein mentioned.

XXII. And be it enacted, That the Water Water Works Works hereinbefore mentioned, shall be in edwithin three operation within three years from the passing years. of this Act, in default thereof, the privileges 20 and advantages granted by this Act to the said Company shall cease, and be of no effect.

XXIII. And be it enacted, That when-Interpretation ever the word person or persons is used in clause. 25 this Act, it shall be taken to comprehend a

body politic or corporate, or its lawful agent or agents, as well as an individual; and every word importing the singular number shall, when necessary, be deemed to extend to 30 several persons or things, and every word importing the masculine gender shall, when necessary, extend to a female as well as a male.

XXIV. And be it enacted, That this Act be Public Act. 35 and is hereby declared to be a Public Act, and that the same may be construed as such in Her Majesty's Courts in this Province.

XXV. And be it enacted, That this Act Duration of shall be and remain in force for fifty years the Act. 40 and no longer.
