

An Act to incorporate the Lay Association of the Presbyterian Church of Canada, in connection with the Church of Scotland, at Montreal.

WHEREAS an Association under the name of the Lay Association Preamble.

of the Presbyterian Church of Canada, in connection with the
Church of Scotland, was formed at Montreal in the year of our Lord
one thousand eight hundred and forty-five, for the purposes of affording
5 assistance to poor or small congregations of the said Church in the payment of their Clergy and in the erection of Churches, and of rendering
assistance to young men studying the ministry, and of publishing missionary records, pamphlets or magazines respecting the Church of
Scotland and the said Church, and is governed by a constitution which
10 has received the assent of the Members of the said Association: and
whereas the said Association have prayed by Petition that they may be
incorporated, and it is expedient to grant such prayer: Therefore, Her
Majesty, by and with the advice and consent of the Legislative Council
and Assembly of Canada, enacts as follows:—

- 15 1. John Greenshields, John Smith, William Edmondstone, Alexander Incorporation Morris, W. Christie, G. Templeton, T. A. Gibson, J. Kerigan, Archibald Ferguson and John L. Morris, and all other persons who are now or shall hereafter, under the provisions of the said constitution of the Association become members thereof, are hereby declared to be a body 20 corporate and politic, by the name of "The Lay Association of the Presbyterian Church of Canada, in connection with the Church of Scotland, at Montreal," with all the rights and powers, which under Rights and the Interpretation Act, vest in a Corporation.
- 2. The personal property of the said Association, shall become the Transfer of 25 property of the Corporation hereby created, and is vested in such Corporation.
- 3. The objects of the Corporation hereby created, are those men-Objects and tioned in the Preamble to this Aot, and the Constitution already constitution. adopted by the said Association, shall remain in force, but may be 30 added to, amended or repealed in the manner and subject to the conditions therein at any time contained.
- 4. Until Directors shall be elected, according to the By-laws of the Officers. Corporation, the present officers of the Association shall be those of the Corporation, but the members of the said Corporation for the time 35 being or the majority of them, shall have power to appoint a Board of not less than five nor more than seven Directors or Managers for the admi-Directors. nistration of the property and affairs of the Corporation; and all of-Powers. ficers so appointed, shall have the right to exercise such other powers and authorities for the due management and administration of the affairs 40 of the Corporation, as may be conferred upon them by the By-laws of the said Corporation.
 - 5. The said Corporation shall at all times when required by the Return to Go-Governor, make a full return of all property held by it, with such details vernment and other information as the Governor may require.
- 45 6. This Act shall be deemed a public Act.
