The M... E... Grand High Priest delivered the following address:

\* COMPANIONS: We meet to-day in our Ninth Annual Communication. Those of us who were active in the organization of Grand Chapter, can scarcely realize that that number of years have passed since we first met for that purpose. To me, to many of you, it must seem but the work of yesterday, and yet of those who were present on that occasion and who were in our first list of office bearers, Companions B. Lester Peters, James McNichol, T. Nisbet Robertson, and Samuel McKean have passed away, while in the present year another Companion who was then with us. Companion Edwin J. Wetmore, is enrolled among the dead. Companion Wetmore was the seconder of the resolution which in the convention of 1887 declared the establishment of a Grand Chapter in this Province desirable. Although he had not filled any office in Grand Chapter, he was, as all know, one of the most active Masons in this jurisdiction. He was one of the original members of Union Chapter and served as its First Principal, and was a long time its Scribe E., and for many years worked earnestly in its interests. It was, however, in the work of our craft generally that Companion Wetmore was best known. He had served in Grand Lodge in several capacities, including those of Deputy Grand Master and Grand Secretary, and his Masonic life went back to the days of the old Provincial Grand Lodge under English registry. Esteemed by us all for his many virtues, his kindness of heart, his moderation of temper, and his lenient judgment of the motives of men, he will be long kindly remembered in this jurisdiction and in this community. He had well discharged important civic duties, and had won the respect of all who were associated with him. Another Royal Arch Companion who has gone from us in the past year, was Henry Duffell, who, although not active in the Grand Chapter, was one of the best known and most active Masons in the jurisdiction, and who had filled several offices of distinction in Craft Masonry, and whose counsel and judgment as a ruler, and whose skill as a ritualist, were ever available.

The reports of the Grand Secretary and Grand Treasurer fully exhibit the business of the year. It has not been less prosperous than the average of its predecessors. Speaking generally, our receipts are equal to our expenditures, but we will be wise to husband our resources. We have made a trifling gain in membership. Our reports, it will be recollected, are up to 31st December, 1895. In the current year there has been, I think, something more of activity thas in the preceding year.

I have been a fairly constant visitor at the Chapters within the City of Saint John, and they all have had work to do, and in most cases it has

been done well. I do most sincerely hope, however, that all the office bearers of all our Chapters will use their power and their influence to prevent any innovations in the methods of conferring the degrees which will have the effect of lessening the moral influence of our symbolism upon the minds and hearts of the candidates. The appeal should be to his intellect and moral nature; not to his fear or to his sense of physical inconvenience.

With all of our sister jurisdictions with whom we are on terms of intimacy our relations are most cordial. Since our last annual meeting I have had a letter from the Grand Scribe E. of the Grand Chapter of Scotland in regard to a matter referred to in my address of last year. He says that nothing stands in the way of the existence of the most cordial friendship between the two Grand Chapters but failure on our part to admit the right of the Mount Lebanon Chapter at Chatham, which still holds of the Scottish authority, to exist within this jurisdiction. But I am quite sure that it would not be in the general interest of Royal Arch Masonry in this Province, as it would not be consistent with the dignity of this Grand Chapter, to admit in this Province of any outside jurisdiction. In order, if possible, to have the matter settled, I recently made a visit to the Mount Lebanon Chapter. The Companions called a special meeting in order to meet me, and received me in the true Masonic spirit, and we thoroughly discussed the whole situation. I think I was able to relieve some natural misapprehensions which existed upon their minds in regard to the general question, and we talked over the matter, and parted with expressions of good will. I will make no predictions, but I am confident that before this year expires we shall have the full assistance and co-operation of our Chatham Companions, and the attendance of their representatives at our next annual convocation.

I have no matter of special importance to bring before Grand Chapter, but in the performance of the simplest duties, if done faithfully and peacefully, there is pleasure.






