To Editor of Church Chronicle.

REV. AND DEAR SIR,—At the last meeting of the Synod a committee was appointed by the Bishop in accordance with the following resolution:—Moved by S. B. Harman, Esq., seconded by Col. Armstron s, that a select committee of 15 members be appointed to consider the report and bill submitted to this Synod, and report at the next session of this Synod, and if they report in tavor of the incorporation of the Synod and Church Society, that they shall report a bill for that purpose, which shall stand first in the order of the day after routine business.

My present object is to call attention to the fact, that although the period for the re-assembling of Synod is drawing near this committee has not yet been called

together.

The subject which the committee is to consider is a grave one. involving issues of great importance, not to be arrived at hastily, and not likely to be encompassed

at one meeting.

There are many circumstances connected with the condition and wants of the Dincese which suggest the present as an auspicious time to inaugurate a more vigorous management of our church affairs. The question is, (and that question is already before us) whether the Church Society shall in future be managed as

heretofore, or whether it shall be engrafted into the Synod and become one or-This question should certainly be answered before we enter upon the detail of arrangement for the future working of the Society. And the members of the Church generally ought to know what the committee purposes to recommend, in order that they may come prepared to give a calm and deliberate verdict.

In any case judgment in so important a matter should not go by default.

CONFIRMATION.

On Wednesday, the 28th ult., the Right Reverend the Bishop of Toronto held a confirmation at Weston. His Lordship was met at the church by the Rev. Mr. Johnson, the incumbent, and the Rev. C. Badgley, B.A., Head Muster of the Trinity College Grammar School, recently established in that prosperous village. Morning prayer having been said at an early hour, the Bishop directed Mr. Badgley to read the litany, and the Incumbent read the anti-communion service, when his Lordship preached a discourse principally designed for the candidates for the holy rite, who numbered 23, and were chiefly composed of pupils in the school,

After the confirmation the Bishop affectionately addressed the candidates, and dismissed them, and the highly respectable congregation which filled the church, with the Episcopal benediction. The singing and responding was particularly good. It is gratifying to find that the school is likely to prove successful—the attendance has gone on to increase since its commencement. It now numbers 25

fine intelligent boys, and six more will enter after the Easter vacation.

ST. GEORGE'S CHURCH, TORONTO.

Early in February last every pew-holder in the above church received a vary able printed paper, entitled "A Statement in relation to St. George's Church Debt due the Bank of Upper Canada, for the payment of which Vice Charcellor

Spragge is liable."

This statement came upon the congregation like a thunder-clap, as arrangements had been made years ago to pay this debt. Ample funds had been provided, through a building society, to do so; and no mention having been made of it at the vestry meetings for eight years, and no demand for its payment having been made during that time, the congregation had no idea that such a debt existed.

They were confirmed in this opinion by the fact that of late years this was not included in the debts enumerated by the churchwardens in their annual reports to the congregation, who being ignorant of the existence of this debt had reported nothing but the debt contracted in the erection of the school house, still amount-

ing to \$4,300.

However, at a vestry meeting, called by the Rector and attended by some thirtyfour members, resolutions were passed almost unanimously, authorizing the Rector and churchwardens to mortgage the school house and parsonage (if necessary) for the paying off this debt. This was acting in a truly Christian spirit; for in addition to the fact, that those who were interested in securing the payment of the debt had forfeited their legal claim on the congregation by not urging its payment for eight years, the congregation had, during that time, been greatly weakened by having two congregations, (those of St. John's and St. Stephen's) formed out of what, when the payment of this debt was last pressed upon them, constituted the congregation of St. George's.

But, rather than allow Mr. Spragge to suffer, the vestry assumed the heavy responsibility, although their school house debt was apparently quite enough for them to manage. The next thing to be done was to meet it; and, at the suggestion of some very zealous members of the congregation, another vestry meeting was called for the 26th of February, and at it a subscription was commenced to pay off the debt in six months. This has been very happily effected in less than .

three months; for on the 19th of March the sum of \$3,000 was paid to the solicitor of the Bank of Upper Canada, and a discharge of all claim against St. George's Church was obtained, covering also a release of all the lands held by the bank, as security for the payment of the debt. In effecting this most desirable object those members of the vestry, who exerted themselves and taxed their means (many of them to the very utmost) to carry this measure out to completion, were greatly aided by a widow lady of this city, who was anxious to release a lot of land belonging to her, and which was in Chancery in consequence of this debt; and at the same time to serve Vice Chancellor Spragge, who was held for the debt. This case is mentioned, at length, to show some of our country friends, who complain that the members of the city churches do very little for the Church, that some of the city churches, at least, have as much as they can do to meet their own liabilities.
