THE vote in the House of Commons on Mr. Bechard's bill to repeal the Insolvency Act, was certainly unexpected, and will create no little surprise throughout the country. The wisdom of such action is questionable. There is no doubt that the Act of 1875 opened the way for the perpetration of fraud, but this is not a sufficient excuse for the repeal of the Act without providing a remedy, eceived in the Commons. for in any case, where a trader is determined to make money, honestly if he can, but at all hazards to make it, there are no serious obstacles in the way should he make up his mind to act dishonestly. It is greatly to be regretted that the House did not accept the bill prepared by the Committee who had the Insolvency matter under their consideration, and which was introduced by Mr. Colby. 
