Why should a prohibitory law partake of a fragmentary sectional character, such as is imposed upon the city of Toronto and the county of York to decide each for itself upon the question of capital punishment?

It is not competent to Halton county to say that stealing is a capital crime and to the county of Wentworth to say that it is not.

Why then should the liquor dealers of the latter county be left in the enjoyment of a lucrative privilege that is denied their peers across the imaginary line which divides the two municipalities? No reason, good or indifferent, can be assigned for this invidious distinction.

In addition to being unfair, inadequate, and inconsistent with the national principle, local option is burdenously expensive. Of course no fair-minded person will hold the workmen responsible for the outbreak, but the attitude of popular movements are always eager to associate them with the always eager followers, who if not hostile at least indifferent to the success of those who have the cause at heart.

The fine art of courtship is apparently not understood by those gentlemen who are promoting the union of Parkdale with this fair city. There is a lack of coyness about their approaches that is calculated to repel. When Bismarck was asked why the Germans did not carry Paris by assault, he replied that he proposed to let the Parisians fry in their own fat. As the Parisians were about that time very thin from starvation, there was a refined cruelty about this cynicism that he should be sorry to see applied to our Parkdale friends. But we do think that they might profitably be left to their own devices. If annexation is a good thing for them they will see it, soon or late, and will come into camp of their own volition. There was one bright spot in his otherwise dark record. He had spared the judiciary, and had seemed to take pride in being able to say that, though he was compelled to yield to the importunities of faction in all other departments, his care in the appointments of judges had proved that regard for the interest and honor of the country was not the ruling principle in his own heart.

He had even won the applause of all good citizens by promoting to the bench an eminent lawyer of the opposite party. But now it seems the judiciary has gone with the senate and every other part of the minister's least into the common fund of corruption.

Judicial appointments are beginning to be used not merely as rewards for unscrupulous politicians, but as a means of direct bribery for the purchase of votes. The special motive for the appointment of Mr. Kee was too probably the hope of propitiating a powerful church.

That appointment, however, though not commensurate with professional distinction, was not the highest order, was perfectly respectable. But the last appointment, the political motive of which is unmistakable, is pronounced by the whole nation, excepting the warmest political friends of Sir John Macdonald, in itself improper and unwelcome to the people for the bench and to shake their confidence in the administration of public justice. This is done in a legal, while in England things are taking the very opposite course, and judges are now generally appointed for professional merit.

It is to be regretted that the success of the labor demonstration in Hamilton should have been marred by the misconduct of a few roughs upon the sidewalk, who attempted to raid the washes house of a defenceless Chinese laundryman, and otherwise misconducted themselves. Of course no fair-minded person will hold the workmen responsible for the outbreak, but the attitude of popular movements are always eager to associate them with the always eager followers, who if not hostile at least indifferent to the success of those who have the cause at heart.

The fine art of courtship is apparently not understood by those gentlemen who are promoting the union of Parkdale with this fair city. There is a lack of coyness about their approaches that is calculated to repel. When Bismarck was asked why the Germans did not carry Paris by assault, he replied that he proposed to let the Parisians fry in their own fat. As the Parisians were about that time very thin from starvation, there was a refined cruelty about this cynicism that he should be sorry to see applied to our Parkdale friends. But we do think that they might profitably be left to their own devices. If annexation is a good thing for them they will see it, soon or late, and will come into camp of their own volition. If it be not a good thing for them, they had better stay out. The more they are coaxed, coddled and constrained, the longer will the desired consummation be delayed.

The Hamilton Spectator would like to know how the farmers of Canada would benefit by the free admission of Kansas wheat at 40 cents per bushel. While the free trade organs remain solemnly silent, as they always do when this question is asked, we seize the opportunity to remark that such a change might benefit the Canadian bakers, who charge as much for loaves of bread as in any other country.

It is alleged that Mr. Fenton says he has discovered that he cannot prosecute parties who but upon the recent boat race, but that he can prosecute the stakeholder. Capt. Dillon says he could not and did not hold the stakes, and that is the cause of the whole trouble. We throw out this suggestion to Capt. Dillon's counsel in a purely philanthropic spirit.

The young ladies of Newark, N.J., have registered a vow in the registry office that they will not kiss or be kissed by any young man who uses tobacco in any shape or form. We are of the opinion that the agitation will end in smoke, and that the right man can kiss the right girl if he chooses.

The reformer Pembroke Observer demands fair if not kindly treatment for Judge O'Connor, such as he has not received, and will be very much surprised if he does not prove himself the superior of two or three individuals who now hilariously and politically grace the Canadian bench.

In Coleridge's amusing verified account of "the devil's walk," which is too good to be regarded as a serious satire, the poet says that "saul cloths," shook hands with the league for so doing, and was not afraid of outrageous demands. The president of the Castle Island Irish League was equally reckless. He shook hands with the lord lieutenant and was expected to lead the league for so doing. "What good lord Greave freely used to call 'shaking hands over the bloody chasm,' is out of fashion at Castle Island.
