## PRESBYTERIAN CHURCH IN CANADA,

TORONTO, 29th, 30th AND 31st MARCH, 1881.

At Toronto, and within the Deacons' Court Room of Knox Church there, on Tuesday, the 29th day of March, 1881, at 2 o'clock in the afternoon, the Home Mission Committee (Western Section) of the Presbyterian Church in Canada, met and was constituted with prayer. Rev. W. Cochrane, D.D., Convener. The Committee continued in session till 1 p.m. on Thursday 31st March.

#### STATE OF THE FUND.

There was laid on the table and read a report from the Treasurer showing the state of the fund at this date, as follows:

Receipts from 1st May to 28th March	\$22,820.00

After consideration the following resolution was adopted, on motion of Mr. J. M. King:—

The Committee having passed the claims for the last half-year, find that it will take fully \$35,000, the amount previously stated, to meet the expenditure of that year. They learn from the Treasurer that \$22,820 have been contributed to the fund up to date, and that therefore over \$12,000 must yet be received in order to enable the committee to equalize the income and the expenditure. From the number of congregations which have not reported, the committee are hopeful that this amount will be reached before the close of the financial year. The committee, however, urge Presbyteries to use the utmost diligence in securing, prior to 30th April, a contribution from every congregation and mission station to this important fund.

The committee further agreed to continue for the ensuing halfyear the grants made in October last to the supplemented congregations and mission stations in Ontario and Quebec at the same rate as for the past six months, except in those cases where changes have been specially made at this meeting. #### LAKE SUPERIOR.

#### SAULT STE. MARIE.

A report was laid on the table from Mr. Gallagher, missionary in this field, the substance of which the Convener was asked to embody in the annual report of the committee to the General Assembly.

#### PRINCE ARTHUR'S LANDING.

There was submitted an interesting report from Mr. Jas. Herald, missionary at Prince Arthur's Landing and Fort William.

There was also read a letter from the managers asking that Mr. Herald be re-appointed for a year, and that the grant from the committee be increased from \$250 to \$350 per annum. It was agreed to comply with the request, and Mr. Herald was accordingly reengaged for a year from this date, the grant from the committee being at the rate of \$350 per annum from October last.

#### BRITISH COLUMBIA.

A letter was laid on the table and read from Mr. R. Jamieson of New Westminster, giving a report of the congregation there, which it was agreed to embody in the annual report to the General Assembly.

#### MANITOBA PRESBYTERY.

#### PRINCE ALBERT, N. W. T.

A letter was laid on the table from Mr. J. Sieveright, giving an interesting and encouraging report of Prince Albert and the adjoining stations. Mr. Sieveright's expenses from Ontario to the field amounted to \$162.50, which had been paid.

#### EDMONTON, N. W. T.

Owing to ill health Mr. J. Duncan had been unable to proceed to Edmonton and had spent the winter in Prince Albert assisting Mr. Sieveright. As he was now returning to Manitoba at the request of the Presbytery, his appointment to Edmonton was cancelled.

Mr. A. B. Baird, M.A., was appointed to Edmonton for three years at a salary of \$900 per annum, and travelling expenses to the field, with the understanding that the people contribute at least \$300 of the salary during the first year.

#### APPOINTMENT OF MR. D. STALKER.

Mr. D. Stalker, one of the graduating class of Knox College, Toronto, was appointed to Manitoba Presbytery for six months,—his permanent appointment for three years at the salary fixed by the General Assembly for missionaries in Manitoba to take place after his being licensed.

#### CLAIM OF PROFESSOR HART.

It was agreed to pay a claim of \$19.80, being expenses incurred by Prof. Hart in connection with services rendered the mission field.

#### MR. W. D. RUSSELL'S CLAIM.

In accordance with the instructions of the committee at the meeting in October last, the Presbytery of Manitoba reported that the amount due Mr. Russell for services in the Greenwood field was \$68.75. It was agreed to pay this amount in full of Mr. Russell's claim.

#### REV. C. B. PITBLADO.

Mr. C. B. Pitblado's report of his visit to Manitoba and the North-west was laid on the table. The Convener intimated that he had, in accordance with the instructions of the committee, sent Mr. Pitblado \$150 on behalf of his expenses in the North-west, which sum Mr. Pitblado had returned to the Home Mission fund, with the request that it should be expended on mission work in the North-west. The committee resolved to put on record their appreciation of the valuable and gratuitous services rendered by Mr. Pitblado, and instructed the Secretary to convey to him the cordial thanks of the Committee.

## PROPOSED NEW REGULATIONS.

The sub-committee appointed in October last to consider the terms on which the services of the missionaries to Manitoba, whose terms of engagement have expired, should be retained, with a view to a more efficient and economical working of this rapidly growing field, presented a report containing the following regulations, which the committee recommended the General Assembly to adopt:

- 1. That congregations in Manitoba, having settled pastors, and not self-sustaining, be placed on a list, distinct from stations supplied by missionaries, to be called the list of Supplemented Congregations; that a minimum contribution of \$450 towards the salary of the minister be necessary in order to entitle any congregation to be placed on this list, and that, in view of the greater cost of living in Manitoba compared with Ontario and Quebec, the committee have power, if it sees fit, to supplement the salaries of Ministers labouring in these congregations up to \$850 per annum.
- That the committee hereafter simply make grants to the fields, and that the list of labourers to be employed by the Presbytery in supplying these fields, be revised at the semi-annual meetings of the Home Mission committee; with the understanding that the committee are only liable for the amount of the grant to the field, except in the case of those missionaries directly appointed by this committee, whose term of service has not expired.
- 3. That the distinction hitherto made in the remuneration of married and unmarried missionaries be done away, and that \$800 be the salary of missionaries to be hereafter sent to Manitoba, during the period of their direct appointment by the Committee, unless in cases in which the great distance from Winnipeg would render a larger salary necessary; with the understanding that the amount promised by the field to which the Missionary is appointed be regarded as a part of the salary named.
- 4. That a semi-annual grant be made to the Presbytery of Manitoba for exploring and giving temporary supply in new districts, the details of the expenditure to be submitted to this Committee.

#### REV. G. RODDICK.

A letter was read from Mr. G. Roddick, Grand Valley, in relation to his being employed as a missionary in the Presbytery of Manitoba. The letter was referred to the Presbytery, with instructions to report at next meeting of the Committee.

### GRANTS MADE TO THE PRESBYTERY.

After consideration the committee agreed to recommend the General Assembly to appoint a Superintendent of Missions for Manitoba and the North-west.

## MISCELLANEOUS.

#### GRANTS FROM BRITISH CHURCHES.

The Convener reported that he had received and suitably acknowledged a grant of £150 stg. from the Free Church of Scotland, and £100 stg. from the Presbyterian Church of Ireland. The report was received.

## REMIT ANENT OPENING AND CLOSING OF COLLEGES.

The committee considered the remit from the General Assembly as to a proposed change in the time of opening and closing the sessions of the Theological Institutions of the Church. It was unanimously resolved to recommend that the college sessions extend from the beginning of November to the end of April.

## SPECIAL APPEAL TO THE CHURCHES IN BRITAIN.

On the report of a sub-committee appointed to consider the matter it was resolved to make the following representation to the General Assembly:—

The committee are convinced that, owing to the vast extent of the Mission field, especially in the North-West, the work will not only tax to the utmost the liberality of the church in Canada, but will present, beyond all that we can do in the immediate future, opportunities of very great value and claims which are almost irresistible, which we shall be unable to meet. On this account and, further, from the fact that a large number of the immigrants to the North-West are coming directly from Great Britain and Ireland, the committee respectfully suggest to the Assembly the propriety, and even the necessity, of having the magnitude and needs of the North-West mission work brought fully before the churches in Great Britain and Ireland; and for this purpose, that a deputation be sent to their Assemblies, in the hope that the liberality of these churches will thus be still further extended on behalf of a work which has such strong claims upon their sympathy.

#### PLACE OF NEXT MEETING.

It was agreed to hold the October meeting of the committee in the lecture room of St. Andrew's Church, Toronto.

#### EXECUTIVE SUB-COMMITTEE.
