**An Act to enable Owen J. Devlin to be admitted to practise as a Notary.**

**W**HEREAS it is expedient to grant the prayer of the petition of Owen Joseph Devlin, who hath prayed that he may be admitted as a Notary Public in Lower Canada, on the conditions hereinafter mentioned; Therefore Her Majesty, &c., enacts as follows : Preamble.

- 5 I. The said Owen J. Devlin may be admitted to practise as a Notary Public in Lower Canada, if otherwise duly qualified, as soon as he shall have completed the term of study required by law for that purpose, reckoning from the day the said Owen J. Devlin began the study of the law with a Barrister, Advocate, Attorney or Solicitor; and it shall be the  
 10 duty of any Board of Notaries in Lower Canada to consider the time he shall have served under articles of Clerkship with any Barrister, Advocate, Attorney or Solicitor as if he had served the same time with a Notary, and to that effect such articles of clerkship and all certificates from the Council of any section of the Bar of Lower Canada, or from any Barris-  
 15 ter, Advocate, Attorney or Solicitor, shall be considered as having the same effect as if such articles of Clerkship had been entered into with a Notary, and such certificate had emanated from a Board of Notaries or from a Notary.
- O. J. Devlin may reckon the time he studied with an Advocate as time served with a Notary, and be admitted accordingly.

II. This Act shall be deemed a public Act.
