## BILL.

An Act to amend chapter 128 of the Consolidated Statutes for Upper Canada, intituled, "An Act respecting the Administration of Justice in the unorganized tracts."

**H**ER MAJESTY, by and with the advice and consent of the Legislative Council and Assembly of Canada, enacts as follows:

1. The following words shall be read as, and shall be, a sub-section to and immediately following the ninetieth section of the said Act, namely :
1. The Governor in Council may also appoint a Registrar of Deeds in the Judicial District of Nipissing, who shall register all deeds and other conveyances and agreements relating to lands situate in any part of the said Judicial District and laid out and surveyed by the Crown ; the said Registrar shall keep his office in a place to be named for that purpose in his commission, or at such other place as may be appointed for that purpose, from time to time, by the Governor in Council, and his duties shall be the same as the duties of other Registrars under the Register Laws of Upper Canada ; his fees shall be the same as those appointed by the Consolidated Statutes for Upper Canada, respecting the registration of deeds, wills, judgments, decrees in Chancery, and other instruments, or the Governor in Council may order an annual salary not exceeding *eight hundred dollars*, to be paid to the said Registrar out of the Consolidated Revenue Fund of this Province, in lieu of such fees, which fees shall in such case be paid into such Revenue.
