An Act to annex the County of Dorchester to the Judicial District of Quebec.

WHEREAS the Act passed in the twentieth year of Her Majesty's Preamble.
reign, intituled, "*An Act to amend the Judicature Acts of Lower Canada,*" has the effect of rendering the administration of Justice in the County of Dorchester less easy and more expensive to the inhabitants thereof than it was before the passing of the said Act: And whereas it is expedient to remedy this inconvenience; Therefore Her Majesty, &c., enacts as follows:

I. The County of Dorchester shall, from and after the passing of this Act, cease to form part of the Judicial District of Beauce, and shall be annexed to the Judicial District of Quebec, anything in the said first above mentioned Act, or in the Schedule annexed to the said Act, to the contrary notwithstanding; and the said first mentioned Act as amended shall apply to the Judicial Districts of Quebec and Beauce as so enlarged or diminished hereby, to all intents and purposes as though this Act and the first mentioned Act formed but one and the same Act.

II. This Act shall be deemed to be a public Act.
