An Act to grant certain Lots on Water Street, in the Town of Cornwall, to the Municipality thereof.

WHEREAS lots numbers Ten and Eleven, on the north side of Water Street, in the said Town of Cornwall, were by the original survey set apart for market lots; and subsequently an Act was passed by the Legislature of Upper Canada, authorising the Magistrates to build a market-house on the said lots, and embodying regulations therefor; and in accordance with the said Act, the Magistrates did build a market-house, and suitable arrangements were made for its being used as such: And whereas, in 1834, an Act was passed by the said Legislature, incorporating the said Town, and transferring all the powers of the Magistrates, in reference thereto, to the Board of Police: And whereas the Mayor and Town Council of the said Town of Cornwall, have prayed for the grant to them of the said town lots, in perpetuity, to be held for general town purposes; and it is expedient that the prayer should be granted; Therefore Her Majesty, &c., enacts as follows:

Preamble.

- 15 I. The said lots, numbers Ten and Eleven on the north side of Water Street, in the said Town of Cornwall, shall be and are hereby granted to and vested in the Town Council of Cornwall, for the Corporation of the said Town, and to be held for general Town purposes, and for no other use or purpose whatsoever.
- 20 II. This Act shall be deemed a public Act.

The said lots vested in the Town Council for Town purposes only.
