




Interference in Elections. The Hon. Mr. Dorion on Tuesday brought under the notice of the House of Commons some revelations of a most scandalous character, in which it was proved that the Hon. Mr. Langevin, one of the members of the Government, had directly inter-fered in the election for the County of Charlevoix, last summer. The facts as stated in documents and let-ters duly certified and signed, are as follows:--Mr. Cimon, who first an-nounced his intention for run for the County of Chicoutimi, afterwards changed his mind, and became a candidate for Charlevoix. Mr. Trem-blay, an opponent of the Govern-ment, ran against him, and being the more popular of the two he defeated the Government nommee, and is now sitting member for Charlevoix. The Hon.
