The Grand Scribe read the following Report from the G. W. P.

In consequence of business and other engagements the G. W. P. regrets his inability to be present with his Brothers, the Representatives on the present occasion.

It is, however, with the most lively satisfaction that he congratulates this body on the increasing prosperity of our Order, and to give thanks to our Father in Heaven for the measure of peace and harmony that pervades the whole of our jurisdiction.

Under the protecting and fostering care of the Great Patriarch above, our Principles of Love, Purity, and Fidelity have gone, and are going on in their peaceful march—triumphing over opposition, and drawing into our fold many who in days gone by looked upon these principles with suspicion; but who, having judged the tree by its fruits, see these christian graces are realities; and that the practical working of our Order for the amelioration and advancement of those of our fellow-men who join our ranks are in accordance with the principles of Him "who went about continually doing good."

To us is committed the important duty of legislating for this organization, which, if we may be permitted to judge of the future by the past, is destined to exert a moral power, and an influence over mankind, second only to that of the religion of

our blessed Redeemer.

I have to report that the progress of our cause since the Annual Session in October last is highly gratifying. Something like thirteen new Divisions have been instituted in various parts of the Province—while the resuscitation and revival of several, supposed beyond recovery, is cause of much thankfulness.

In Halifax County I have had the pleasure of instituting three new divisions, one at Ingraham River, another at Indian Harbor,

and the third at the Richmond Depot, and was ably assisted by our G.W.A. Murray—the Grand Scribe—by Brother Barratt, P. R. Foster, Clark, Williams and others.

I beg further to report that to Brother P.G.W.F. Avard Longley, Esq., are we mainly indebted for the formation of the "Richmond Division." To him also are the travelling public under obligation for the determined stand he has taken for the removal of those dens along our Railway lines, East and West, and libelled as "Refreshment Saloons" !!!

The Bonds of the Grand Scribe and those of the Grand Trea-

surer-duly executed-are now in my possession.

You will learn with satisfaction that the Bands of Hope are on the increase. Our satisfaction will be the greater, if these auxilliaries are worked by those in charge of these important agencies for good, in such manner, as will redound to the well being of those committed to their care.

So far as I am aware, there will be no appeal cases to be adjudicated upon during this Session; this speaks well for the harmony and order prevailing among our Brotherhood—conclusively showing that our principles are better understood as we

advance in our onward and upward march.

The Committee appointed at the Annual Session to prepare an address to Sir Fenwick Williams of Kars, on his assuming the Government of this Province, have performed that duty. The Grand Officers and Past Grand Officers resident in this city had the honor of presenting it to His Excellency. The Gommittee were most graciously and cordially received—were highly delighted with their reception—but a thousand fold more so were they gratified with His Excellency's reply to their address.

The Committee to whom was given in charge to bring the subject of "An Asylum for Inchriates," before the Legislature

will doubtless attend to that duty at the proper time.

The Circular with Petition appended, and forwarded to each Division for signature—will, it is hoped, be taken in hand with a hearty good will, and every effort made to have it largely and respectably signed, and forwarded at an early day to the Grand Scribe, or the Representatives of the Counties in which the Petitioners reside.

I regret to report the Resignation as D. G. W. P. of our worthy Brother Wm. Bryden of New Era Division at Liverpool. Our brother's health has been delicate for some time, and he has seen it to be his duty to resign that office. Let us hope our brother may long be spared to his friends, and to our cause, and that he may in the future, as in the past, be a faithful and loving brother, and friend.

I have to report the care and attention of the Deputies generally throughout this jurisdiction—some of whom, however, have been somewhat negligent, and others remiss in the discharge

of their important duties.

To D.G. W.P. Brother T. M. King, our present Grand Conductor, and Brother W. C. Bill, of Billtown. Cornwallis, King's County, I owe "honorable mention" for their careful, active and energetic advocacy of the interests of our Order in their several localities; and to others doubtless will the same meed of praise be due when their several reports come to hand. To Brother Bill is mainly attributable the organization of three of the thirteen new Divisions above mentioned. And I would here specially direct the attention of all our Deputies—Divisional and County, to the zeal displayed by these worthy Brothers, as shewing the result of perseverance, and the effect of well-directed personal effort. It is this that does the work. Where individual effort is judiciously directed, success will almost invariably follow. Let us have more of it!

#### HALIFAX COUNTY.

Of the Divisions in Halifax County, D.G.W.P.P.R. Foster writes encouragingly of those in the western section. "Morning Star" "Ingraham" and "Marathon"—all in the Margaret's Bay district, are doing remarkably well. The "Band of Hope" in connection with "Morning Star" has doubled in numbers since its organization. "Rising Sun" in Middle Musquodoboit is in a healthy state, and flourishing; meetings well attended and business done in a harmonious manner, and with friendly feelings towards each other-so says our D. G. W. P. Francis All the City Divisions work on amid much to discourage, and keep about their own as regards numbers; the Division Room is better attended than for sometime past. All now admit lady visitors-although old Chebucto No. 7, has not as yet initiated any visitors of their own. "Day Spring," at Dartmouth, is improving that community; and "Richmond" at the Depot bids fair to be active and vigilant in the fight against our common foe. All are adding to their membership. Financial matters should receive careful and prompt attention. Auditing and Financial Committees should be "instant in season."

Deputy J. M Forrest of Tangier writes: "The Order in this jurisdiction looks prosperous at present. "Tangier Division has quite revived and is in good working order." "Champion" is still going on in the even tonor of its way, increasing slowly."

## HANT'S COUNTY.

At Windsor "Avon" is not frozen up—but alive and active, getting along swimmingly." Our Rev. brother, D. G. W. P. J. McLeod writes:—"Our division is in better working order than it ever has been; at no period has there been a deeper interest in, or a better attendance on our meetings; we have admitted 20 lady visitors, and hope before the end of the quarter the number will be doubled."

Brethren must excuse me for again urging upon their attention the claims of the Agency Fund, and the necessity of sustaining it by donations from Divisions and contributions from individuals.

ADDRESS TO GENERAL WILLIAMS.

In accordance with the resolution passed at the Annual Session, an address congratulating General Sir William Fenwick Williams, of Kars, Bart, on his assuming the Government of this Province, was duly prepared and presented to His Excellency on the 4th day of December last. The brethren who waited on our distinguished countryman were most cordially received and much gratified with their reception.

#### DECEASED MEMBER.

It is with much sorrow I have to announce the death of a brother with whom I have had official intercourse for a period extending over nine years—D. G. W. P. Abrah in Vanbuskirk of Aylesford. After an illness of several months our lamented brother died on 24th November, 1865, in the 55th year of his age. He was initiated into this Grand Division on April 26, 1854. In the illness and subsequent death of the brother our Order has sustained a loss; as had he been spared the Divisions over which he had supervision would not have been allowed to cease operations. Abraham Vanbuskirk was active in the cause—a faithful Son of Temperance, and an excellent man.

#### VARIOUS MATTERS.

In accordance with instructions given at the Annual Meeting, a circular, with copy of petition to the Legislature asking the separation of the liquor from other traffic embodied therein, was issued to the subordinate Divisions urging them to have said petition circulated and signed. So far as I can learn, the matter is being attended to by most of the Divisions.

I have to call the attention of Deputies and other officers to a matter which occasions difficulty and annoyance at times. Returns are sometimes sent in without either name, number, date, signatures, or an accompanying letter from the officers forwarding them. This makes it difficult to ascertain what Divisions they come from. I would urge deputies or other officers forwarding wins and monies to always enclose a letter stating the name of the Division whose returns are sent; also how mones are to be appropriated when more than the amount of per capita tax is sent. A little attention to this suggestion will prevent both annoyance and trouble.

I cannot close this Report without mentioning the fact that our worthy brother William Bryden, of Liverpool, County Deputy for Queen's, in consequence of the delicate state of his health, has found it necessary to return his commission to the Grand Worthy Patriarch. We have had, and still have fuithful and attentive De-

- 1. The Committee on state of the Order beg to report that having acquainted themselves, so far as in their power, with the present position and working of the Order, have pleasure in congratulating the Grand Division that the institution of the Sons of Temperance in this Province has secured for itself a standing in which it commands the respectful consideration of all classes of society; the love and veneration of a multitude who, themselves, or whose friends, have been rescued from inchriety and ruin through its influence, and is generally recognized as one of the social powers of the land.
- 2. The successes of the past quarter, compared with other periods, afford an occasion for thankfulness and encouragement. Taking into the cnumeration the Division proposed to be organized before this date, at Cow Bay, and that to be organized this evening at Vogler's Cove, as many have been instituted during the last quarter as during the last Divisional year; while the number resuscitated and the number of languishing ones revived during the quarter, compare favorably with those of the past year. We are cheered by the aunouncement that the Order in this Province never occupied a better position. And this progress which it has made, the impetus it has received, the attitude it at present assumes, and the facilities it enjoys, all point to gratifying success in the future.

3. The Agency is prosecuting a much desired and highly pleasing work, and, in the opinion of your committee, should be encouraged by hearty co-operation and liberal pecuniary support. In view of the small amounts ordinarily collected at the meetings held by the Grand Division Agents, your committee would suggest, that, in addition to the passing of contribution boxes, and

might be resorted to for the accomplishment of that end.

4. The Abstainer, your Committee recognizes as an auxiliary in the work which the Order places before itself, which has not been cared for sufficiently, and whose value can scarcely be over-estimated. The cause cannot afford its discontinuance. Its successful operation can be secured only by a generous and interested support.

5. That the office of Chairman of the Railway Board is occupied by a firm and consistent friend of the Order, and that the Lieut. Governor of the Province is a friend of Temperance, are facts which give great gratification because of their present results, and

also for their future promise.

6. With such facilities and encouragements as the Order enjoys, your Committee look hopefully forward to the achievements that may be attained by petitioning the Legislature for a divorce of liquor selling from other traffic in our Province. The value of such a result and its importance to the cause should influence every Division to employ the most carnest efforts to have the petition for this object extensively circulated and numerously signed.

7. Your Committee submit that earnestness and persistency in effort, with trust in God, are demands of the hour, on the friends of the Order. The present rampant attitude of intemperance requires this; past successes warrant it; and future promise encourages it. Our cause is in the ascendant. May it remain so till it

triumphs!

## APPENDIX.

#### BROTHER R. M. BARRATT'S REPORT.

Report of Mission under the appointment of the Agency Committee of Grand Division, between November 1, 1865, and January 16, 1866.

Worthy Brothers:-

In presenting this my first Report for the present year, I am happy to have it in my power to bear testimony to the general prosperity of the Divisions I have visited, and also to the extension of the Order, and consequently the advancement of the Temperance cause, as manifested in the institution of new and the

resuscitating of old Divisions.

While I have uniformly refrained from interfering with other organizations or intrenching upon ground occupied by them, I have endeavored to use every honest and manly effort for the extension of our noble and beloved Order, well knowing its value both as a moral and intellectual institution, and in the spirit which all its teachings dictate, have always sought to use the opportunities afforded for the dissemination of Temperance truth alike in localities where no Divisions existed, as well as those in which our Order has an existence.

Of the Divisions visited I regret having to report "Welsford" at Shubenacadie in a very low state, if not entirely dead. I met with the Division at the close of my first meeting in that place on the 13th of November; but few members were present, which was accounted for by the very unpleasant weather. From those present I experienced much kindness, the Division not only contributing \$4.00 to the Agency Fund, but also providing for my expenses while there. Since that time, however, there have been but few meetings, and no officers had been chosen up to the time of my last visit on the 11th inst.; all the energy of even those whom we counted as leading members has been thrown into the arena of Templarism, and although I was informed that the Division had changed their place of meeting and hired a room in company with the "Good Templars," yet, what was very significant to my mind as regards the brothers to whom I have alluded, (although the Division is so much the senior), the blank in my printed notice announcing the place of meeting was filled up with "Lodge Room," thus ignoring the Division altogether, although the meeting was under our management, and appointed mainly out of regard for the Division. I have been particular in alluding to this special case as an unhappy illustration of the way by which, in too many instances, brothers are led to forget their off repeated and solemn obligations to seek to advance the interests of the Order. It would not serve any good purpose were I to refer to other circumstances which have transpired, manifesting, at least, an unwise hostility to us as an institution, as those have not very seriously affected our prosperity.

For statistical information I beg to refer to the accompanying tables, and trust that these will be found sufficiently plain and comprehensive. The small amount received in support of the Agency, will, I trust, induce our Divisions to put forth more efforts financially if they wish to see this branch of our work sustained.

# ADDRESS TO SIR WILLIAM FENWICK WILLIAMS, Bart., Lieutenant-Governor of Nova Scotia, &c.

Reference having been made in the Reports of the G. W. P. and G. S., to the Address presented to the Lieut. Governor, the following is copied from *The Abstainer* of December 6, 1865.—[G. S.]

At the Annual Meet ng of the Grand Division, held in this city in October last, it was unanimously agreed that an Address be prepared and presented to General Sir William Fenwick Williams on his arrival at Halifax to assume the Government of Nova Scotia, and P. G. W. P's. Dr. Cramp, McMurray, Christie, and McRobert, and P. W. P. W. N. Rudolf appointed to prepare the same

Accordingly, on Monday afternoon, the 4th inst., a deputation waited upon His Excellency at Government House, at three

o'clock, viz. :--

The Grand Worthy Patriarch having introduced the Brethren named, addressed His Excellency in substance as follows:—

We wait upon your Excellency, on this occasion, to congratulate you on your arrival in this your native land, and on your Excellency's appointment to the honorable office of Governor of Nova Scotia. In offering our congratulations to your Excellency, let us assure you that the thousands of total abstainers throughout our Province give you a sincere and hearty welcome to the land of your nativity. In the discharge of those duties pertaining to the high position our beloved Queen has called you, be assured your Excellency has the sincere prayers of all good men throughout the land. We all pray that your administration of the affairs of this Province will be conducive to the well being of the people, pleasant to your Excellency, and receive the commendation of our beloved Sovereign.

The G. W. P. then called upon the Grand Scribe, who read the following

ADDRESS.

To His Excellency SIR WILLIAM FERWICK WILLIAMS, Bart., K. C. B., Licutenant Governor and Commander-in-Chief of the Province of Nova Scotia, its dependencies, &c.

MAY IT PLEASE YOUR EXCELLENCY:

The Grand Division of the Sons of Temperance of Nova Scotia, as British subjects cherishing towards our Queen and Government the most devoted loyalty, and towards your Excellency sentiments of sincere respect in ramembrance of the distinguished qualities by which your Excellency has hitherto adorned high and honourable positions, beg to present their hearty congrafulations on your arrival as the Lieutenant Governor of this Province.

They trust that your Excellency's administration may be distinguished by many advantages to the people of Nova Scotia, not only in material prosperity, but also in the progress of know-

ledge, virtue and religion.

To free our country from the demoralizing and ruinous vice of intemperance is the object of the enterprise in which the Sons of Temperance are engaged. Your Excellency has had extensive opportunities of observing the baneful effects of this vice in many parts of the world and among all classes—that it is the fruitful parent of misery, disease and crime—that it is one of the greatest barriers to human progress—that it unfits man for rational enjoyment in this world, and deprives him of the hope of happiness in the next—and it is no less certain, that notwithstanding the enlightenment of the present age, thousands are annually plunged in hopeless degradation by indulgence in habits of intemperance.

In their efforts to save their fellow-men from this great evil, the Sons of Temperance depend chiefly on moral suasion, and the influence of example. They have also repeatedly sought the interference of the Legislature, both for the enactment of efficient legal restraints on the liquor traffic while it is permitted to exist, and for its ultimate prohibition except for medicinal, mechanical or other useful purposes, regarding such prohibition of the traffic in strong drink as necessary for the effectual protection of society. Your Excellency may be informed that the Order of the Sons of Temperance was founded in 1842. It is now established in Great Britain, in all the Provinces of British America and Australia, as well as in the United States. The Grand Division of Nova Scotia was established in the year 1848. It now comprises within its jurisdiction one hundred and twenty

Subordinate Divisions, numbering over six thousand members, and four thousand lady visitors, all solemnly pledged to abstain from the use of intoxicating drinks as a beverage, and to promote, to the utmost of their power, the spread of Temperance. Connected with this Order are persons of all ranks in society, including many of the military who have been stationed in this garrison during the last few years, to whom the organization has

proved of immeasurable benefit.

In conclusion, the Grand Division vontures to express the hope that your Excellency may be pleased to regard their aims and efforts with favour, and that they may receive from your Excellency such countenance as will tend to sustain them in their labours to promote the virtue and happiness of their fellowmen—and they pray Almighty God to bless your Excellency with all spiritual blessings, and so to guide you in the discharge of public duty, that your Administration may prove greatly beneficial to this your own, your native land.

His Excellency then read the following

#### REPLY.

HALIFAX, DECEMBER 4th, 1865.

To the Grand Division of the Sons of Temperance of Nova Scotia:

Gentlemen.—I thank you in the name of Her Gracious Majesty the Queen, for the sincere expressions of loyalty and devotion to Her Crown and Government, with which you have opened this address; and I beg to add on my part unfeigned sentiments of gratitude and pride towards the members of your Society, for the favorable view you take of my past career,—as well as your prayers for my future success in the administration of the Government cutrusted me by our Sovereign.

I heartily agree with you in every sentiment embodied in this address, as they bear on the debasing and ruinous results of intemperance, carrying as they do, blighted hopes, grief, and degradation into the bosom of private families, as well as punishment and disgrace into the ranks of an army celebrated as it is—amongst the bravest hosts of other nations—for valor, combined

with kind social disposition and a generous spirit.

Who has not witnessed in civil life the dire effects of intemperance, and seen the once cherished members of the family circle,—perchance the centre of it,—prowling through the streets,

shrinking, as it were, from himself, and shunned by his former friends and acquaintances; and in the military career look at the healthy well cared-for young soldier, full of pride and hope,see him enter upon a course of intemperance, and trace him to the military prison where he passes his best days under the jailor's discipline, thus throwing on his comrades the weight of those duties for which he is paid to perform; and the scene does not close here, as intemperance sours his temper, undermines his health and the sentiments of military honor, he passes from one scene of crime to another, and the last glimpse of this man is on the scaffold, where he forfeits his life for the murder of his officer, whom he had sworn to defend.

Now, my friends, this is a sad but truthful picture, a picture rendered still darker by our conviction that no laws of coercion can stay the mischief. All attempts in this direction have only led to the creation of the double evil of hypocrisy and intemperance, and it is to such societies as yours that we must look for a remedy; increase, therefore, your numbers, rally round each other, and by your christian-like and patriotic example, impress on others that sentiment which you have so well advocated in

vour address.

You appeal to my enlarged experience in the momentous subjects now before us; if I could consistently dwell on that experience you could more fully estimate the sincerity of my wishes. and indeed, the depths of my desire that you should succeed in your well-directed efforts.

After reading the Reply, His Excellency entered into conversation with the Deputation, who were very much gratified with

the reception they met with.

A pleasing incident of the occasion, which transpired after the Address and Reply were read, was that the day on which the Deputation waited upon him was His Excellency's Sixty-fifth birth-day.
