The Deputy Grand Master then appointed G. Rep. Partridge, Warden, pro. tem, and Rep. On motion of Rep. Yale, seconded by Rep. Box, the Lodge then closed in Grand Lodge Degree, and opened in the Scarlet Degree, for the benefit of all Scarlet Degree Brothers.

The reading of the Minutes of last Session of the Grand Lodge held at St. Catherines, was dispensed with, and on motion adopted as printed.

The Deputy Grand Master then appointed, with the approval of the Grand Lodge, the following Committees, viz :

On Milage and per Diem.—Reps. T. Browne, James Marquand and Henry Sewell.

On the State of the Order.—Reps. T. Healey, A. Humphrey, and A. A. Towns.

On motion, the Address of Grand Master Dolson was read by the Grand Secretary, as follows:

By the continued favor of the Grand Master of the Universe, we are once more permitted to meet in Annual Session, and it becomes the duty of each and every one of us, to return Him thanks for the many blessings and privileges we have enjoyed during the year that has just passed away.

It affords me much pleasure to meet the members and representatives of our Grand Lodge in this beautiful town, and I hope, while surrounded by the consecrated walls of this newly fitted up Lodge Room, our deliberations may be conducted in a spirit of harmony and brotherly love, and that the meeting of this Grand Lodge may produce something that will be beneficial to our jurisdiction, and our coming together at this time will not be altogether in vain.

The time has already come when the grand luminary of day, from the moment he leaps from the Atlantic wave, which lashes the rough coast of New England, till he laves his burning brow in the placid waters of the Pacific, ceases not to shire on and illumine the towers and minarets of the beautiful temples of Odd Fellowship; and at these annual gatherings it becomes our duty to cast a retrospective glance at the past, and see if our Order is exercising that great and benevolent influence, which we, as its members, claim and desire.

During the forty-three years since we were first instituted on this Continent, through many vicissitudes has our Brotherhood passed, and how 'nobly has it out-rode every storm; how valiantly surmounted every difficulty, and how manfully met and discomfitted every foe. The hot blast of calumy has passed over it, but it remains unscathed; the fierce and relentless opposition of ignorance has essayed the overthrow of our principles, but in vain; we have lived down all opposition, and find our Order still continues to disseminate the principles of Friendship, Love and Truth, to visit the rick, relieve the distressed, educate the orphar_ and bury the dead. What effect the disorganization now at work in the

United States, will have upon our Order, it will be difficult for any one at present to foretell, but it is to be hoped that the lowering clouds which now overspreads that nation, momentarily threatening to burst and scatter destruction and dissolation in their midst, will be speedily dispelled, and the time soon come when they shall beat their swords into plough-shares and their spears into pruninghooks; when they shall not lift up sword against one another nor learn war any An activate from the state.

An extract from the address of the Grand Master of the State of Indiana,

"The troubles which exist and threaten the disruption of our glorious Union, has given rise to numerous surmises in the minds of our Brethern as to the effects of these troubles on the unity of our Institution, and upon the perpetuity of the one Grand Legislative head of the Order as it now exists, composed of representatives from all the grand bodies on this Continent. The significancy of these questions at this time, and in view of future events, can neither be doubted or evaded. Many anxious minds desire some alleviation of their fears for our unity, and some encouragement to their hopes that the Order may pass unscathed through this trying vicissitude. My counsel is that we do nothing and say nothing calculated to engender dissention or fruitless discussion in our now united and fraternal Order. Let the potsherd strive with the potsherds of the earth; but let us, as an Order, with all lowliness and meekness, with long suffering forbearing one another in love, endeavor to keep the unity of the spirit in the bond of peace. Let us rely upon the freedom of our institution and its principles from al! political bias, upon its universal fraternity that would make us all under God benefactors and all mankind objects of our benefaction and regard, to save our cherished Order from disruption and dissension. Though love of family, of party, or of country is a natural and beautiful sentiment and holds us to obligations of a peculiar character that should never be disregarded ; yet we must not stop with these, we must not array them in direct conflict with other and more comprehensive duties. Let us never lose sight of what we teach respecting our benevolent enterprise, that all men are one family; that there is but one country the earth ; but one nation, the human family."

The limited field of the jurisdiction of our Grand Lodge has not furnished during the past year many topics on which it is necessary that I should address ciples of Odd Fellowship are getting too well understood, and too rigidly practiced in the several lodges to call for the frequent interference of official authority, and it gives me much pleasure in stating that no interference on my part has been necessary during the past year, and I believe, for the first time in The many years, there are no appeals before this grand body.

The report of our worthy Grand Secretary will give you full detailed information as to the condition of our Order in the various Lodges. From the reports which I have received from the D. D. G. M's. I find that the Order has not increased to be better, which is very important to the existence of a Lodge. Ontario Lodge, I fear, will have to surrender from the mere want of energy among its members. In December last I received an application for a dispensation for a to de be to be located in the town of Stratford, and from the recommendations of Brother McLean, of St. Mary's, I granted the request, and it will be

necessary for this Grand Lodge at this time either to confirm or set aside myaction. In January last, while taking an official tour among the Lodges, I had much pleasure in proceeding to Stratford and instituting Avon Lodge, No. 41, which has since continued to work and their reports show that they have not been idle, and I here take the opportunity of returning thanks to those Brothers from London and St. Mary's, who were present on that evening, and also Brother Bingham, of Brantford, and the Grand Secretary ; they all being good and efficent members, enabled me to conduct the whole proceedings in a becoming and satisfactory manner.

The official tour taken by me may appear to some to have been unnecessary, but it was a duty which I considered I was called upon to perform, which, however, I did not undertake until I had consulted all the D. D. G. M's. in our jurisdiction, as to the propirety of such a visit; they all having approved of my intentions, I proceeded in January last and visited all the Lodges, excepting Brock and Ontario, and I must say that I found everything as well as could be expected. I had the pleasure of installing the officers of Forest City and Chatham Lodges in public, but would here recommend that, in future, public installments do not take place oftener then about once in five years. I went to Amherstburg and made an effort to revive Rose Lodge, and supposed I had succeeded, 'for nine members signed a petition requesting to be reorganized, I immediately granted the request, and installed their principal officers and left them, under the full conviction that they would work and try to make themselves into a prosperous Lodge as they once were, but I have not heard from them to this day, and I now believe that all future effort there will be in vain. The expenses connected with this visit will not draw very heavy on the receipts of this Grand Lodge, as they will be mostly met from the sale of blanks, which I furnished to the different Lodges for the purpose of introducing a uniform mode of working, realizing therefrom the sum of thirty-eight dollars, the printing of which cost eleven dollars and fifty cents.

Another great inducement I had for making the official visit was that I might personally present before each Lodge the necessity of disposing of the Charter question. I felt as though the finds of our Grand Lodge were not sufficient to allow any money to be taken from them for that purpose, and I am glad to say when it was properly laid before the Lodges, that they have liberally responded, and in most cases informing me if what they gave was not sufficient they were ready at any time to pay their share to make up the balance.

I have great pleasure in stating that Brother Peel furnished the design for Charter, which he freely and voluntarily offered to do, at the last session of our Grand Lodge, which was unanimously apporved of by your committee. It certainly was a very beautiful design and highly spoken of by all who have seen it, and reflects great credit upon Brother Peel as an artist, and certainly must have cost him many hours of anxious thought and labor, and I was in hopes that this Grand Lodge would be in a position to tender to Brother Peel some testimonial of their appreciation for hivvaluable services. From the moment I saw the design, I was more convinced of the necessity of making a personal appeal to the Lodges, in order that so beautiful a piece of workmanship might be properly lithographed. The whole cost of which will be \$161.25, including expenses, &c., for which I have received from Lodges \$127, making nearly enough to cover all without using the \$50 appropriated by this Grand Lodge at the last session.

The lithographed copies are now in the possession and at the disposal of this Grand Lodge, together with the estimates I received for the lithography and all communications connected therewith.

According to notice a resolution will be in order at this meeting, altering our Constitution so as to allow lodges that choose to meet semi-monthly. My opinion is that it might be desirable in some localities, but I am sure it would not do for the Lodge of which I have the honor of being a member.

We will probably have a full report from our worthy Grand Representative, which may bring up some question upon which it will be necessary for you to act, in order that your next representative may be prepared and enabled thereby to sustain your views. I believe there is a strong disposition to have the secret work somewhat changed, and a committee has been appointed for that purpose; in my opinion a change, in some respects, would be beneficial, and fully believe that the matter is in competent hands to report on.

Permit me, in conclusion, to tender to the members of this Grand Lodge my singere thanks for the honorable position they assigned to me one year ago, for I assure you it was with many misgivings and doubts in regard to my ability that I accepted the trust which was then confided in me, and in agam resuming my position as a private in the fanks among you I shall labor with increased zeal, and be at all times ready and willing to advance the interest of our order, and thus may we all co-operate in the great mission of Odd Fellowship, and hasten the period when mang-shall hall his brother-man with fraternal greetings; when wickedness and falschood shall be driven from the earth, and the race of Adam form a universal family, acknowledging the God of the Universe as their Father, and every child of man as a brother; when, in short, one law shall bind all nations, tongues and kindreds of the earth, and that law shall be the law of Universal Brotherhood.

The Returns of Forest City, Union, Gore, Samaritan, Chatham, Imperial, Eureka and Erie Lodges, are correct.

Avon Lodge reports no W. and O. Fund; St. Mary's is deficient in percentage 89cts; Ontario Lodge Report does not give names withdrawn.

Rond Eau Report for 1860 is without Seal.

Brock Lodge Report for 1860 is signed by current Officers instead of Past Officers, and is without Lodge Seal; and the Report of same Lodge for June 1861 does not give names of expelled members.

Elgin Lodge overpaid percentage \$3.23.

Your Committee would recommend that the Grand Secretary insert, hereafter in the Return Forms, before sending them out, the words "In good standing," after the words "Past Grands," and erase the word "Other," and insert the word "Totall" before the words "Members in good standing; insert the word "General" before the words "Funds in Treasury;" interline or in sert the words "W. and O. Fund in Treasury;" at bottom of all reports; prefix the word "General" to the words "Funds in Treasury;" and annex the word "Insected" to the words "Funds in Treasury;" and annex tistical reports, when filled and published, may show exactly the amount, and position of each Fund. We further recommend that whenever new blanks are printed, the above alterations be properly made in them.

BY-LAW GRAND LODGE OF UNITED STATES.

ARTICLE X.—Annual returns shall be made by each State, District or Territorial Grand Lodge or Grand Encampment, in which they shall give the names of Grand Officers, number of Lodges, and the aggregate number of members in good standing in all Subordinate Lodges, and the aggregate number of Initiations, of reinstatements, rejections, suspensions and cause, expulsions and cause, admissions by card, withdrawals by card, of brothers relieved, of widowed families relieved, deaths, amount expended for relief of brothers, amount expended for education of orphans, amount paid for burying the dead, and the whole amount of receipts; forms for which shall be furnished by this Grand Lodge. Said returns shall be made to the Grand Corresponding and Recording Secretary at least one month previous to the annual meeting of this body, and shall be accompanied with the dues thereon, in money current at par in the place where the meeting of this body is held. And in default of such returns being made and the dues thereon paid within ten days prior to the annual meeting of this body, the Representatives from such delinquent Grand Lodges or Grand Encampments shall not be admitted to a sect in such annual meeting.

The Committee on Mileage and per Diem then made a Report, which, on motion of Rep. Box, seconded by Rep. Bingham, was referred back to await the Report of the Committee on Finance.

The Report of the Grand Representative of the Grand Lodge of United States for 1859 and 1860, was then submitted, and on motion of Rep. Sewell, seconded by Rep. Fitzsimmons, those parts referring to proposed amendments in the Constitution and By-Laws of the Grand Lodge of the United States, were referred to the Committee on the State of the Order.

On motion of Rep. Yale, seconded by Rep. Wigmore, Grand Master Dolson, Grand Secretary Read and Grand Rep. Partridge, were appointed a Committee to abridge the Report of Grand Rep. Partridge, for printing in the Journal of Proceedings of this Grand Lodge.

Moved by Rep. Bingham, and seconded by Rep. Box, that in consequence of the disorganized condition of Political, Religious, Benevolent and Social Institutions of the United States, it becomes this Grand Lodge to act with more than ordinary caution in the payment of its regular per centage to the Grand Lodge of the United States, and that the same be not forwarded until perfectly assured that the executive officers, and those having control of the funds, and other effects of the Grand Lodge of the United States, have no sympathy with the proposed dismemberment of that Grand Body, and unless such assurance can be obtained sconer, that the per centage be placed in the hands of Grand Rep. to be paid over by him at the next regular meeting of the Grand Lodge of the United States, when fully assured that our confidence will not be abused, nor our funds misappropriated.

Moved in amendment by Rep. Healey, and seconded by Rep. Friesman, that the motion proposed by Rep. Bingham, be referred to the Committee on the State of the Order-Carried.

The Grand Master, with the consent of the Grand Lodge, added name of Grand Rep. Partridge, to the Committee on the State of the Order.

The Committee on Laws of Subordinates, submitted the following Report: To the R. W. Grand Lodge of Canada West, I. O. O. F: We, your Committee on Laws of Subordinates, have carefully examined the

Laws laid before us, and ask leave to report as follows :-

We condemn the Preamble and Article 1st of Constitution of Elgin Lodge, No. 32, and recommend the use of the Constitution for Subordinates, as adopted by this Grand Lodge.

We cannot recommend any alteration at present, in the proportion of regular receipts set apart for the W. and O. Fund, as the requisite notice of Amendment has not been given.

We recommend, that the Amendments adopted by Imperial Lodge, No. 37, of its By-Laws, changing the scale of Initiation and Degree fees, be sanctioned by this Grand Lodge.

Your Committee are also of the opinion that the application of Rond Eau Lodge, No. 40, for a change in their night of meeting, from Friday to Saturday, should be granted.

Your Committee fully concur in the report of the Grand Secretary, in regard to the present state and future prospects of the Order, as set forth in said report, and would recommend the adoption of said report by this Grand Lodge.

In regard to a Resolution moved by Rep. Bingham, and seconded by Rep. Box, and refered to your Committee on the State of the Order, relative to the sending of the regular Per Centage to the Grand Lodge of the United States; your Committee fully concur in the view set forth in said resolution, and would recommend the adoption of the same.

In legard to the possible effect, that may result to our Order, from the present troubles in the United States; your Committee fully concur in that portion of the Grand Master's Address, which refers to this subject, and would recommend, that the counsel there given, be strictly adhered to.

In the report of the Committee on the State of the Order, at the last sitting of your Grand Body; your Committee find the following recommendation:

Viz: "Your Committee would also recommend, that the affairs of Rose Lodge, No. 28, be closed up if possible, and that a Committee be appointed for that purpose."

In regard to the above we would state, that subsequent to the recommendation of the Committee above refered to, an effort was made in January last, by our R. W. Grand Master, to re-organize said Lodge, which effort, he supposed had proved successful. Since which time, however, nothing has been heard from said Lodge. Your Committee are therefore of opinion, that all has been done in the premises, that can reasonably be expected, and we regret to say without avail.

Your Committee would recommend, that the action of the Grand Master, in granting a Dispensation to Avon Lodge, No. 41, be confirmed, and a Charter granted them.

In regard to the Charters now in possession of this Grand Lodge; your Committee would recommend that in consequence of the persevering efforts of Grand Master Dolson in obtaining them satisfactorily to this Grand Lodge, that he he allowed to fill the same, together with the Grand Screetary, and present to each Representative a copy of the Charter, for their respective Lodges.

With regard to a change in the secret work of the Order, as has been proposed by the Grand Lodge of the United States; your Committee not knowing wherein the change may consist, merely say, that, reposing full confidence in our Representative to that Body, we would allow him to use his own judgment on the question.

Your Committee feel that this Grand Lodge is deeply indebted to our respected Brother Peel, of Eureka Lodge, for the very chaste and beautiful design furnished by him for our Charter; and would recommend that some suitable Testimonial be presented to him, as an acknowledgement from this Grand Lodge, of his zeal for the good of the Order, as well as of his taste and skill as an artist.

Your Committee would also recommend; that the Grand Secretary be allowed some remuneration for his valuable services during the past year, as Secretary of this Grand Lodge.

With regard to amendments to the Constitution of the G. L. U. S., to be

acted upon at its next session ; we object to the adoption of No. 1, 2 and 3, as proposed. In regard to No. 3, we would recommend that the words four fifths, be inserted instead of the word "unanimous." We would recommend the adoption of No. 4. No. 5, we would favor, in the event of No, 4 being adopted, No. 6, we would favor, excepting the second part of the clause, with regard to the meeting of Grand Officers every six months. No. 7, we would approve.-No. 8, we would oppose. No. 9, we would favor providing No. 4 is adopted. No. 10, we would approve.

On motion duly passed, the Report on Mileage and Per Diem was adopted and ordered filed, and the Grand Secretary instructed to issue orders accordingly, on the Grand Treasurer, in favor of the Grand Officers and Representatives.

The Special Committee appointed to abridge the Report of the Grand Reps., reported their duty completed, and were duly discharged.

To the Right Worthy Grand Lodge of Canada West :

The undersigned, your Representative to the Right Worthy Grand Lodge of the United States of America, would respectfully submit the following Report of the proceedings of that Body during his term of office. On the nineteenth day of September, 1859, I attended the annual Communication held at the City of Baltimore.

By reference to the Grand Secretary's Report, I am informed that there were then, under the jurisdiction of the Grand Lodge of the United States, thirty-nine State and Territorial Grand Lodges, three thousand four hundred and twenty-five Subordinates, with a membership of one hundred and seventy-seven thousand seven hundred and eleven, which shows an increase during the past year of thirty-five Subordinate Lodges, and one thousand and eleven members.

By the same Report I find that there was, during the same year, eighteen thousand one hundred and thirty brothers relieved; two thousand six hundred and ninety-seven Widowed families assisted, -\$300,359 15 paid for the relief of brothers, \$51,454 00 paid to widowed families, \$13,555 72 for the education of Orphans, and \$45,227 74 expended in burying the dead.

The decisions made by the Most Worthy Grand Sire during the recess of the Grand Lodge, and confirmed by that body at the Session of 1859, were as follows:

When the holder of a Withdrawal card has, within a few months after its use, deposited the same in, and thereby become a member of another Lodge, the Lodge issuing such card has no right to annul it.

That it is competent for a State Grand Lodge to prescribe a By-law, that all applications for Visiting or Withdrawal cards, must be in person or in writing.

It is not competent for a Lodge or an Encampment to try a deceased member, or deprive his widow of the benefits allowed by the laws, her husband having been beneficial, and not under charge at the time of his decease.

If under the law authorizing public installations, any controversy arise between the Elective Grand Officer and a District Deputy Grand Master, as to which shall conduct such installation, the Elective Grand Officer, being superior in rank, shall have precedence.

The following decisions of the Grand Sire was reversed :--When a brother, living remote from his Lodge, sends to its Treasurer instead of its Secretary, his dues, and said Treasurer fails at next meeting of the Lodge to report the payment of the same, and before another meeting the brother dies, this Lodge cannot withhold the funeral benefits authorized by law, the Treasurer reporting and paying such dues to the Lodge at said second meeting. The Treasurer is an

agent of his Lodge, and the proper custodian of its funds, and to refuse bene fits under such circumstances, would not be consistant with the just and liberal

The Grand Lodge decided that when the law of the Lodge required payment of dues to the Secretary, a payment made to the Treasurer, who withholds it, does not bind the Lodge.

The following decisions were made by the Grand Lodge upon reports of Committees, to whom the subjects were referred. That when local laws require a majority of two-thirds present to be necessary to expel, that member excused from voting must be counted as present, and in fact as voting in the negative.

That when the By-laws of a Lodge limit the Candidates on a second ballot to the two highest on the first ballot, all votes cast for other Candidates on the second ballot are void.

That a Grand Lodge is not liable for the indebtedness of one of its defunct Subordinates, arising out of advances made by a Lodge in a Sister jurisdiction to one of its sick members, unless it appears that assets sufficient to discharge the debt belonging to the defunct Lodge, come into the Treasury of the Grand

That when a brother without the term pass-word shall apply for admission to his own Lodge, the Noble Graud shall, after he has been satisfied of the good standing of the brother, direct his admission.

None of the proposed amendments to the Constitution were adopted.

I also attended the Session for 1860, which commenced its sittings in the city of Nashville, Tennessee; on the 17th September. The R. W. Grand Sire was not present, and the chair was filled during the session by the R. W. Deputy Grand Sire, Edward H. Fitzhugh, of Vurginia. The debates were unusually lively, contested, and extended, and brought out, in full relief, the promptness, the perspicacity, firmness and courtesy which distinguished the presiding officer.

DECISIONS MADE.

The following decisions, applicable to the branch of the Order which I represent were made :

Where the Degrees are conferred by a regular. Degree Lodge, separate from the Subordinates, the application of the brother desiring the degree must be acted upon in his Subordinate Lodge by such members only as have taken the degree applied for. If the application is granted, a certificate of the fact is given to the applicant, which certificate being presented to the Degree Lodge, author-

It is not legal to ballot upon the application to have the Rebekah Degree conferred upon brothers' wives when objections are made. The Degree of Rebekah is conferred on the wives of scarlet members in good standing, as a matter

It is not competent for a Subordinate Encampment, or Lodge, to insert in its. Constitution a provision that a member who may draw a final card, shall have the privilege of depositing the same in said Lodge within a specified time, by a simple vote of the Lodge, instead of a ballot vote, as in the case of initiating members. ⁹ The laws of the Order clearly provide *the way* in which a person may regain membership upon card, and a Lodge granting a final card has no more power to depart from that way when the person holding that card seeks to

reunite with said Lodge, than upon the application of a stranger. But persons who, from no fault of their own, are illegally initiated, cannot be discharged from membership for that reason, but are entitled to all the rights enjoyed by other members of similar rank; and the same rule governs the case of an unworthy person, who may have been indvertently admitted.—Digest 307, Section 17.

The above decisions were made by the R. W. Grand Lodge upon reports of the Committee on the State of the Order, upon decisions of the M. W. Grand Sire, made during the recess of the Grand Lodge.

The following decisions, reported by the Committee on the State of the Order, were adopted:

The presiding or sitting N. G. of a Subordinate Lodge, has no right to sign an ennual or semi-annual report returning himself as a Past Grand, he not having previously passed the Noble Grand's chair.

Officers of Subordinate Lodges may confer the Degree of Rebekah upon widows of Odd Fellows in good standing, after application in open Lodge. The certificate of either the Recording Secretary or the Permanent or Finan-

The certificate of either the Recording Secretary or the Permanent or Financial Secretary of a Subordinate Lodge, under the seal of the Lodge, of the standing, etc., of a member thereof, is sufficient evidence for an Encampment to act upon—but that local legislation may make it exclusively the duty of either Secretary.

The following decisions of the Committee of Appeals were adopted :

No person, on being admitted to membership in this Order, thereby loses any rights he had in possession as a citizen. His right to protection by the civil anthorities is not impaired by becoming an Odd Fellow—the laws of the land and the courts which administer them, are the surest and most proper means by which justice can be attained; especially is this so in regard to civil contracts, frequent ly involving, as they do, long, intricate and conflicting accdunts; requiring close and patient scrutiny, and impartial investigation. This class of questions of difference should always be submitted to the legal institutions of the land, rather than be attempted to be adjudicated by any authorities within the Order.

This was a case in which a brother refused to permit his Lodge to interfere with his pecuniary transactions with another brother, and for that reason was expelled for contempt. He was restored to membership.—Appeal of P. G. Callin.

The Order does not, in every case, recognize the "legal representatives" of a brother deceased, as entitled to his benefits.—Appeal of P. G. Adams

A Treasurer of a Subordinate Lodge became pecuniarily involved by the accidents in business; he informed his Lodge of the fact, and made security to them which they accepted as satisfactory, and released his sureties. It then became unlawful to prefer charges against the delinquent brother for appropriating the funds of the Lodge to his own use.—Appeal of P. G. Seaman.

LEGISLATIVE BUSINESS.

Rep. Kennedy, of Southern New York, moved the following resolution, which was adopted :

Resolved, That the Legislative Committee be instructed to report such action, if any is required, to enable the Grand Secretaries of Grand Lodges to issue proper certificates to members of defunct Lodges, who are in good standing, to enable them to make application for membership in another Lodge.

The Legislative Committee having considered the subject matter, reported the following resolution, which was adopted: *Resolved*. That the resolution adopted by this Court L.

Resolved, That the resolution adopted by this Grand Lodge, to be found on page 3134 of the Revised Journal of the Annual Session of 1859, having reference to the authentication of all certificates and cards issued by State Grand Officers and officers of all Subordinate Lodges and Encampments, shall not be construed to apply to certificates signed by Grand Officers of State Jurisdictions to members of defunct Lodges, as heretofore provided.

On motion of Rep. Veitch, of Missouri, the Lodge adopted the following amendment proposed by him to Article X of the By-Laws, as follows:

Amend Article X of the By-Laws by adding thereto as follows: fault of such return being made and the dues thereton paid within ten days prior to the annual meeting of this body, the Representatives from such delinquent Grand Lodges or Encampments shall not be admitted to a seat in such annual meeting."

The following resolutions were adopted :

Resolved, That a Committee of three be appointed to report to the next session of this body a revision of the secret work of the Order, having in view th various suggestions to that effect submitted to this Grand Lodge at this and previous sessions.

Reps. Stuart, of the District of Columbia, Dwinelle, of Northern New York, and Nicholson, of Pennsylvania, were appointed such committee.

Resolved, That the Committee to whom was referred the subject of revising the work of the five degrees, bedirected to enquire and report upon the propriety o expediency of incorporating into the instructions required to be given in conferring degrees, the several emblems of our Order, and give emblems such a fixed language.

The following were unanimously adopted :

Resolved, That the thanks of this Grand Lodge are due and are hereby tendered to Grand Sire Samuel Craighead, for the very able, courteous and impartial manner in which he has performed the very arduous and responsible duties of his office.

Resolved, That P. G. Sire Samuel Craighead be requested to sit for his portrait, to be placed in the Hall of this Grand Lodge, and that the expenses incurred for the same be paid from the treasury of this Grand Lodge.

Resolved, That the thanks of this Grand Lodge' are due and they are hereby tendered to R. W. D. Grand Sire Fitzhugh, for the very able, courteous, dignified and impartial manner in which he has discharged the

fied and impartial manner in which he has discharged the unusually arduous duties of Grand Sire during the present term.

Resolved, That in consideration of these services, and of the services heretofore rendered this Grand Lodge, in all the departments of duty which he has been called upon to discharge and fill, the Grand Lodge recognize a debt of obligation, which they propose in part to discharge by tendering this acknowledgement; and the additional request, that he consent to sit for his portrait, to embellish our Grand Lodge; and that an engraved likeness be made to be inserted in the bound Journal, and that the Grand Secretary have the same carried into

CONSTITUTIONAL AMENDMENTS.

The following propositions for the amendment of the Constitution of the R. W. Grand Lodge, are pending for action at the next session:

By Rep. Prall, of Northern New York, seconded by Rep. White, of Northern New York, Rep. Taylor, of Pennsylvania, Rep. Hunt. of Texas, Rep. Garwood, of California, Rep. Veitch, of Missouri, and Rep. Clark, of Vermont:

Amend Article XIV, Clause 2 of the Constitution, by striking out the words "seventy-five" and inserting "twenty."

Proposed by Rep. Kenneday, of Southern New York, seconded by Reps. Dwinelle, of Northern New York, Escaville, of Maryland, and Starr, of Illinois:

Amend the Second Section of the Ninth Article of the Constitution so that it shall read as follows:

"SECTION 2. Every State, District, Territorial or Colonial Grand Lodge, or Grand Encampment, having under its jurisdiction one thousand or less members in good standing, shall be entilled to one vote in the Grand Lodge; every State, District, Territorial or Colonial Grand Lodge, or Grand Encampment, having under its jurisdiction over one thousand members in good standing, shall be entitled to two votes; and no State, District, Territorial or Colonial Grand Lodge or Grand Encampment, shall have more than one Grand Representative at the same time; Provided, however, that any Grand Lodge, or Grand Encampment, shall be entitled to as many Grand Representatives as it may have votes, on assuming the payment of the Mileage and Per Diem of the additional Grand Representatives."

Proposed by Rep. Thayer, of South Carolina, seconded by Reps. Lamberton, of Pennsylvania, Granniss, of Georgia, Burnham, of Maine, Krogman, of Massachussetts, and Dwinelle, of Northern New York :

1. This Grand Lodge shall meet biennially on the third Monday of September, at 9 o'clock, A. M., at such place as the Grand Lodge shall from time to to time determine. It may also meet on its own adjournments. It may also meet on the calls of the Grand Sire, of which the Grand Sire shall eause three months' notice to be given to the Representatives of the several State, District, Territorial and Colonial Grand Bodies, communicating to them the purpose for which the special meeting is called; and in no case shall any business be transacted at a special meeting, unless notice thereof has been given as above provided.

2. During the time intervening between the biennial sessions, there shall be a committee, of the Grand Sire, the Deputy Grand Sire, the Grand Secretary, and the Committee on Appeals appointed at the last preceding session, to whom appeals and applications for charters may be made, or any other business refered, not affecting the finance of the Grand Lodge, nor being of a legislative nature. Said committee shall hold semi-annual sessions, their actions being always subject to confirmation or reversal by the Grand Lodge at its next session.

3. Article IX and other Articles of the Constitution are hereby ordered to be formed in phraseology, so as not to conflict with this.

Both of these propositions were pending and acted upon at the session just past. The Grand Lodge patiently devoted a whole legislative day to their discussion in Committee of the Whole. It is conceded that some alteration of

the Constitution is imperatively demanded by the present and prospective condition of the finances of the Grand Lodge, which cannot now or hereafter sustain the present representation with an annual session.

The Grand Lodge received, at the hands of the city authorities of the city of Nashville, a public reception at the Capitol of the State, which was worthy the reputation of that city for a genial and graceful hospitality. The sessions of of the Grand Lodge were held in the hall of the House of Representatives, by invitation of that body. The Grand Lodge also visited in a body the residence of the late President James K: Polk, by invitation of Mrs. Polk, and were en-tertained by her with her accustomed grace and urbanity. They also, by invitation of the Odd Fellows of Nashville, visited the Hermitage, and tomb of Andrew Jackson, where a chair was presented to them, and some special exerckes had, which are explained by the following resolutions:

On motion of Past Grand Sire John A. Kennedy, the Grand Lodge

Resolved, That the hickory arm chair, presented through the M. W. Grand Sire, be accepted, and that the R. W. Grand Corresponding and Recording Secretary be instructed to have the following inscription placed, in a permanent form, on the chair : "Presented at the Hermitage to the Grand Lodge of the United States, I. O. O. F., by G. Rep. H. K. Walker, of Tennessee, on behalf of Dr. John Marshall Lawrence, a member of the family of the late Andrew Jackron, who constructed the chair with hickory withes grown upon the Hermitage estate, Nashville, September 20, 1860."

Rep. Mills, of Kentucky, moved the following resolutions. which were adopted: Resolved, unanimously, That this Grand Lodge hereby express the great pleasure derived from our visit to Mrs. James K. Polk, and tender to that estimable lady our unfeigned thanks for her very elegant, courteous and hospitable reception of this Grand Lodge.

OFFICERS ELECTED.

The following officers were elected for the ensuing two years, and duly installed:

BY-LAW ADOPTED.

The following by-law was adopted by the R. W. Grand Lodge :

Any propositions offered for reference to any Standing Committee of this Body, which shall require an entry in full upon the journal, shall be submitted in duplicate, either fn print or manuscript; and if in writing, they shall be on paper not less in size than half a page of foolscap.

A resolution substantially the same was adopted on the first day of the session, and the business of the session was transacted under it. It enables the Gaand Secretary to send to its appropriate committee at once, everything which is refered by the Grand Lodge; it protects him from annoyance, and from the loss of papers and documents.

Resolved, That the following matters be referred to the several Grand Jurisdictions for their consideration, and that they be requested to report their conclusions to this R. W. Grand Body at the next Annual Communication :

I.—The abolishment of the mileage and per diem to Grand Representatives. II.—The reduction of the present Representative tax of seventy-five dollars,

to its former amount, of twenty dollars for each Representative.

III.- Supplies such as cards, books, odes, etc., be furnished to Grand Bodies and Subordinates at cost price.

IV.— All deficiency in revenue to be yearly assessed upon the membership of the respective Grand Bodies.

In conclusion, I have in every respect endeavored to advance your interests, but in consequence of a custom of the Grand Lodge, of appointing only those Representatives who have for years occupied seats in the said Grand Lodge, on committees of any importance, I was unable to bring the same amount of influence to bear, I could wish. In closing the report of my stewardship, allow me kindly to thank the members of this Grand Body, for placing me in the position I have occupied, and hope that no act of mine has caused any member to regret the confidence they bestowed.
