Auxiliary to the Women's Foreign Missionary Society meets on the second Tuesday of each month at 8 o'clock p. m.

Weekly Prayer Meeting every Wednesday at 8 p. m. Mission Prayer Meeting in the Mission School every Thursday evening at 8 o'clock.

The Regular Business Meetings of the Sabbath School Association are held on the last Thursday of every month.

The Ordinance of Baptism is dispensed on the first Sabbath of every month, at the commencement of the morning service, and on the first Wednesday of every month at the commencement of the Prayer Meeting.

The Ordinance of the Lord's Supper is dispensed on the first Sabbath of March, June, September and December.

A Preparatory Service on the Friday immediately preceding each of the said Sabbaths at 8 p. m.

The Annual Meeting of the Congregation is held on the third Wednesday of January.

If not convenient to give on the last of the month, any other time will do.

Those wishing to subscribe by envelope, and who are not at present supplied can secure envelopes by applying to any of the members of the committee or to Mr. Warren, Church officer.

It is expected that as far as possible subscribers will give a definite sum every month, and if subscribers fall in arrears they will be notified of the same as often as the committee think it best.

The Treasurer's statement was read by Mr. James Dixon, Treasurer.

The report of the Session was read by the Session Clerk, Mr. James Ogilvie.

Moved by Mr. Ogilvie, seconded by Dr. Fraser, that the report of the Session be received and printed in the year book.—Carried.

The Secretary's and Treasurer's report of the Sunday School was read by Mr. W. J. Cunningham, who moved their adoption, seconded by Mr. J. A. Moffat.—Carried.

The report of the Mission Sunday School, with the Treasurer's statement was read by Mr. A. McPherson who moved their adoption, seconded by Dr. Fraser.—Carried.

* The report of the Missionary Association was read by the Secretary, Miss Rosa A. Baine, who moved its adoption, seconded by Mr. Givin.—Carried.

The report of the Young People's Society of Christian Endeavor was read by the president, Mr. D. A. Rowland, who also read the Treasurer's report and moved the adoption of both.—Carried.

Mr. Ogilvie, as treasurer of the Sunday School Building Committee, reported that the sum of \$231.50 had been collected.

Mr. Ogilvie stated that as Mr. Duncan Robertson had received a call to London, he wished to be released from his present charge

Dr. Fraser moved, seconded by Mr. James Ogilvie, that we as a congregation release Mr. Duncan Robertson as assistant pastor in accordance with his request, and that Mr. Robertson be thanked for the services rendered to the congregation and Mission School.—Carried unanimously.

Mr. Givin, as one who was appointed by the Sunday School to bring the matter of better building accommodation before the meeting, spoke for some time, but as the hour was late, the discussion was deferred to an adjourned meeting.

Mr. Ogilvie gave notice of motion to amend the Constitution so as to make three members present at a managers' meeting constitute a quorum, instead of five as at present.

Moved by Mr. McFadden, seconded by Mr. McPherson that this meeting stand adjourned until January 31st. Carried.

Minutes of Adjourned Annual Business Meeting of Knox Church, held Wednesday Evening, January 31st, 1894.

The meeting was opened with fifteen minutes of devotional exercises led by Dr. Fraser, after which Mr. James Dixon took the chair, and Mr. J. A. Moffat as secretary.

The chairman stated that the first item of business was the notice of motion given by Mr. James Ogilvie at the last meeting, when it was

Moved by Mr. Ogilvie, seconded by Mr. A. Richardson, that our Constitution be amended by making three managers instead of five form a quorum at a manager's meeting. After some discussion it was thought best not to amend the Constitution in this particular, and the motion was withdrawn.

The next item of business was the consideration of better School accomodation, when it was

Moved by Mr. J. A. Moffat, seconded by Mr. Wm. Givin, that, recognizing the immediate necessity of better School accomodation, therefore resolved, that the trustees be and are hereby authorized to negotiate a loan on the church property for a sum not exceeding \$4,000, and that a Building Committee be appointed with three representatives from the congregation session, managers and

Sunday School respectively, with full power to proceed at once with the necessary improvements.

Mr. Ogilvie asked the chairman to rule if this resolution was in order, when a former Building Committee had not reported and was still in existence.

The chairman answered that the resolution was out of order until the Committee had reported and had been discharged.

Mr. J. A. McNicol, as chairman of the Building Committee, reported that for the last six months the Committee had done nothing, and moved, seconded by Mr. W. H. McLaren, that the Committee, having failed to carry out the instructions of the congregation, they be now discharged.—Carried.

Moved in amendment to the original resolution by Mr. C. Arthur, seconded by Mr. James Ogilvie, that the whole Sunday School question be left over until the congregational meeting of 1895. This amendment was lost.

The vote on the original motion was taken by ballot, and the scrutineers, Messrs. W. J. Cunningham, Andrew Leitch and J. A. Melville reported that the vote cast was yeas, 141; nays, 42. The chairman declared the resolution carried.

Moved by Mr. John Madill, seconded by Mr. A. McPherson, that Dr. Fraser, Wm. Givin and W. H. McLaren be a committee to appear before the Presbytery to secure their sanction in connection with the loan.—Carried.

Moved by Mr. John Madill, seconded by Mr. J. A. Moffat, that Messrs. James Dixon, Captain Samuel Malcolmsen and J. A. Melville be members of the Sunday School Building Committee.—Carried.

Moved by Mr. W. H. McLaren, seconded by Mr. John Madill, that the Session be authorized to secure supply for the Mission, and report to a future meeting if a suitable person is found to take charge permanently.—Carried.

Moved by Mr. Andrew Leitch, seconded by Mr J. A. McNicol, that a hearty vote of thanks be tendered Miss Maggie Laird and Miss Annie Munro for their services as choir leader and organist respectively in the Mission School.—Carried.

A communication was read by the chairman from Miss Mary Allan asking that remuneration to the extent of \$150.00 a year be allowed her as soprano soloist in the choir.

Moved by Mr. Wm. Givin, seconded by Mr. _____, that Miss Mary Allan be engaged as soprano soloist in the choir at a salary of \$100.00 a year.

Moved in amendment by Mr. H. S. Wallace, seconded by Mr. Andrew Leitch, that this meeting does not wish to commit the congregation to any further expense in connection with the choir. Amendment was carried.

Moved by Mr. J. A. Moffat, seconded by Mr. James Ogilvie, that the money now in the hands of the previous Building Committee be handed over to the treasurer of the new Building Committee as soon as he is appointed.—Carried.

Dr. Fraser then pronounced the benediction, and the meeting adjourned.

FIFTIETH ANNUAL REPORT

OF THE

Managing Committee of Knox Church

FOR THE YEAR ENDING 31ST DECEMBER, 1898.

It is with great pleasure that your Managing Board present the Fiftieth Annual Report, shewing the entire property to be free from debt. It is particularly gratifying to have this state of affairs in this, our Jubilee Year.

We would respectfully draw the attention of the congregation to the fact that the envelope system of raising revenue is yielding less income year by year. For example: in the first full year of Dr. Fraser's pastorate the average envelope contribution per communicant was a little over 17 cents, while for the past year it was less than 11 cents. For this state of affairs we account partly by many of the younger members of our families failing to become contributors when they grow up, and by some who join by certificate neglecting to apply for sittings and getting envelopes, and thus becoming regular subscribers. The loose collections for 1886 were \$1,070.51, as against \$907.03 this year. The number of envelope subscribers for this year was 460, as against 464 last year. The average per Sunday was \$103.20, as against \$104.89 last year. The arrears at the close of the year were \$310.75.

We would suggest that notice be given to the managers by any member who is about to leave the church so that the seats may be allocated to others at once, and thus avoid having such seats unoccupied for months as is sometimes the case.

The managers whose term expires this year are Messrs. Dixon, McLaren and Gillespie.

FIFTY-SEVENTH ANNUAL REPORT

—OF—

KNOX CHURCH SABBATH SCHOOL

For the Year, Ending December 31st, 1893.

We are pleased to report to the congregation that our work has continued to progress favorably through the year. Our teachers have been faithful in their attendance—very few having been absent without either providing substitutes, or notifying the Superintendent before hand.

Our scholars have manifested unusual interest, as shown by their regular attendance, good order, attention and by their splendid liberality, as proved by the Treasurer's report, \$941.50 having been raised in the school during the past year: an average of \$17.94 per Sunday for the fifty-three Sundays of the year. Our attendance has fallen off slightly owing to the removal from the city of a number of our families, the decrease being 17. Our average attendance is 443, or a decrease of 25. The small average is largely owing to the fact that each year more are taking advantage of the holiday season, and for two months our school was a very small one indeed.

After paying for our Sunday School papers, and all other expenses in connection with the school, we have raised and allocated for Missions \$330.41. We have also added to our building fund \$618.08, as will be seen by the Treasurer's statement; the amount now held by the Sunday School, contributed by itself for this fund, is \$1335.38.

We regret to say that during the year four of our members have passed away: Miss Gracie Webster, of Miss McGregor's class; Mr. Wm. Gilchrist, of the Young Men's Bible Class; Winnie Simpson and Ernest Shaver, of the Infant Class.

Knox Church Misson Sabbath School.

I beg leave to present the Sixth Annual Report of our Mission Sabbath School.

There are on the roll at the present time 219 scholars and 29 teachers and officers, making a total of 248. The average attendance for the year has been 197. This is a little below the average attendance for last year, and is accounted for by the absence of a number of our teachers for a long term during the summer holidays and who have been unable to supply suitable substitutes.

During the year two of our boys have been removed suddenly by death. We are glad to be able to report that our School was never in a more prosperous position than at the present time, and never was it equipped with a more faithful and efficient staff of teachers.

We regret the contemplated removal from our Mission of Mr. Robertson, who has been our Superintendent for the greater part of the year, and express the hope that in his new field he will make as many friends and as few enemies as he has here; that he will be eminently successful in leading many from the darkness of sin into the glorious light of the gospel of our Lord and Master.

We also regret the loss of Mr. McRae, whose place we find very difficult to fill. These removals from time to time are a source of great discouragement to those who are left, but we trust that, as has been the case in the past, others will be raised up to fill these vacancies.

TWENTY-FIFTH ANNUAL REPORT

—OF THE—

Missionary Association of Knox Church.

The Mission Committee have again to report a falling off in the amount of the monthly collections as compared with last year, of \$82.65, but this is more than counter-balanced by the large amount raised for special purposes.

It is gratifying to note the steady and rapid increase from year to year of the congregation's givings to the schemes of the church. We have since the settlement over us of our present esteemed pastor, Dr. Fraser, made a considerable advance in our contributions to missions, as will be seen from the following figures: Total amount contributed in 1887, \$357.05; total amount contributed in 1893, \$2643.39, an increase of 2286.34. This surely indicates a growing sympathy with the great work of our church, and a deepening interest in the sphere of her Christian activities.

The subscribers to Dr. Robertson's fund for the support of a missionary at some point in the Northwest, have all, with one exception, paid their subscriptions, and the first year's demand of \$250.00 has already been remitted to the Mission Board. The Committee refer with special pleasure to the liberal collection obtained by the Sunday School at the Quarterly Service on the last Sunday of the year in aid of Mr. Fortune's work at Elkhorn, Manitoba. This collection, with donations from several classes, amounted to the handsome sum of \$73.53, showing how cheerfully our people will contribute to any worthy object when properly brought before them. Notwithstanding the liberality shown in those special collections, the Committee do not consider that they have done their duty

until they have brought before the congregation the fact that out of our large membership of 968 there are only 167 regular monthly subscribers to missions. Surely out of that large number we ought at least to have 500 regular subscribers to the mission fund. The Committee will not be satisfied until they have reached the heart, and aroused the conscience of the many who now appear to be utterly indifferent to their duty and responsibility in this respect, and are quite content to stand idly by and let the conscientious few do all the giving and maintain the credit of the congregation.

The Woman's Auxiliary and Mission Band are doing excellent work and cultivating a missionary spirit which, no doubt, will bear good fruit. In order to bring these two organizations into closer affiliation with the general Committee it is recommended that the presiding officers of each be made *ex officio* members thereof. The Committee also rejoice in the commendable liberality displayed by the congregation in the ample support given the Mission School in the north-end, the amount expended this year being larger than any previous year.

We close our report with a feeling of sincere thankfulness to God for the great measure of prosperity graciously bestowed on us during the past year, and we earnestly pray that the spirit of our Great Master who said "Go ye into all the world and preach the Gospel to every creature" may animate our hearts as a congregation and enable us to see more and more clearly the great importance of this field of Christian activity.

Two very successful socials have been held during the year, on February 28th and October 9th, the latter being the Fifth Anniversary of the organization of our Society.

Through the influence of the Missionary Committee the Society have adopted the two cent a week plan of raising money for Missions. Many interesting and profitable meetings have been held, which have done much to stimulate interest in this great cause. On November 20th a Missionary concert was held, from the proceeds of which books were bought for the Library.

The Visiting and Flower Committees have done

splendid work in visiting and taking flowers to the sick of the congregation; 1,174 visits have been made, and 632 bouquets distributed. The work of these two committees has been very much appreciated by those remembered in this way, and many expressions of gratitude have been received from time to time.

During the past year the work of the Relief Committee has been varied. As the opportunities presented themselves visits have been made in the interests of relief. Medicines and provisions were carried to those in need of them; over one hundred articles of clothing distributed; assistance given by paying rent; and contributing articles for the stocking of a small store; feeble and aged members have been brought to the communion services in a cab, and the sick cheered and comforted by the services of prayer and praise, forty-nine of which have been held in their homes.

We feel at the closing of the year we must thank our Heavenly Father for His great goodness to us as a Society for the success we have enjoyed, and for any opportunity we may have had to do good to any brother or sister.

CONSTITUTION
—OF—
KNOX CHURCH, HAMILTON.

1st.—The Church, Manse, Burying Ground, and any other Houses or Real Estate now belonging to or which may hereafter become the property of the Congregation, shall be held in trust by three members of the said Congregation, in full Communion, in accordance with a Deed of Trust—bearing date the Sixth Day of September, in the year of our Lord, One Thousand Eight Hundred and Fifty-six.

2nd.—The members in full Communion with the Congregation shall have the sole power of choosing a Minister or Pastor and Elders of said Congregation.

3rd.—The election of a Minister or Pastor shall take place at a meeting of the Members of the Congregation, which shall have been called from the Pulpit of the Church by the officiating minister on each of the two Sabbaths preceding such meeting. The majority of Members present shall determine the election.

4th.—The method of the election of the Elders shall be determined from time to time by the Session, as occasion may require, but the election shall be by the Members of the Congregation, and notice of meeting for such election shall be given as provided in Clause Third.

5th.—The constitutional duty of the Session to superintend the Spiritual affairs and watch over all the interests of the Congregation is recognized and reserved to them.

6th.—Nine managers shall be elected to take charge of the secular affairs of the Congregation, three of whom shall retire annually in rotation, but shall be eligible for re-election. In case of a vacancy occurring by resignation or otherwise, the Managers themselves shall fill the vacancy at their earliest convenience; and a Manager absenting himself from three successive regular meetings without leave shall cease to be a Manager.

7th.—The Managers shall elect their own Chairman, Treasurer and Secretary, hold regular meetings as often as their business may require, and may give notice of their meetings, either from the Pulpit on Sabbaths or by the Secretary to each Manager, when demanded by any three of them. Five Managers shall constitute a quorum. When the Managers shall themselves deem it necessary, or when requested to do so by seven or more Members of the Congregation in Full Standing, they shall with concurrence of the Session call a special meeting of the Congregation, stating

the object in the notice thereof; and no business shall be entertained at any Special Meeting excepting what is mentioned in the notice thereof. Should any Manager cease to be a member of the Congregation he shall cease to be a Manager. The Treasurer shall open an account with some regular Chartered Bank in the city, and deposit in his own name, as Treasurer of the Managing Committee, monies from time to time as may be convenient.

8th.—The use of the Church property for public and general purposes not connected with the Congregation shall be under the control of the Managers, with the concurrence of the Minister.

9th.—The whole revenues of the congregation from all sources shall be received and disbursed by the Managers in payment of Stipend, Salaries and other expenses, including such as may be required for preserving the property and providing for the dispensation of Divine Ordinances, but no repairs, improvements or alterations exceeding the sum of One Hundred Dollars shall be gone into without the consent of the Congregation. The "Poor Fund," however, shall be distributed by the Session, and contributions for Missionary and Benevolent purposes shall be distributed by the Association appointed for these special purposes.

10th.—The Members of the Congregation shall choose their Organist and Precentor, and fix their salaries, and in the discharge of their duties they shall be under the control of the Session.

11th.—The Managers shall have power to engage or dismiss, and regulate salary of any one who may act as Church Officer or Door Keeper; and appoint or pay such person or persons as may be required to keep the Church clean and comfortable.

12th.—The Managers shall be accountable to the Congregation for their acts, and shall, at each annual meeting in January, submit a full printed, audited, articulate statement of the Income and Expenditure of the preceding year—copies of which shall be distributed in the pews on the Sabbath before the Annual Meeting; and said Managers shall be regulated as to the proportion of revenue to be applied to any particular purpose by the instructions they may receive from the Congregation at any Special or Annual Meeting.

13.—A Committee, consisting of the Chairman, Secretary and Treasurer of the Managing Committee, two members of Session, the Secretary of the Sabbath School, and Secretaries of all the organizations in connection with the Congregation, shall annually arrange for the printing—in pamphlet form—of the reports of all the different organizations in connection with the Congregation, together with the list of office-bearers, members and adherents, with their residences; said pamphlet to be distributed to the Congregation as early as possible after the annual business meeting, and not later than March 1st. The Chairman of the Managers shall be Chairman of the said Committee.

14th.—The Managers or Trustees shall have no power to contract debt on property without the consent of the Congregation.

15th.—At each annual meeting the Congregation shall elect three Trustees and two Auditors to serve for one year.

16th.—The foregoing rules shall be in force until altered or amended, and no motion to alter or amend said rules shall be put unless due notice of such motion has been given at the annual meeting of the Congregation, and when notice of motion shall have been made, a special meeting of the Congregation shall be called to consider the same, not sooner than two weeks, nor later than two months after said annual meeting.

17th.—In the foregoing rules no one shall be held to be a member of the Congregation who is not in Full Communion with the same, and whose name does not appear on the Communion Roll of the said Congregation, and no others than members in Full Communion shall be allowed to vote at any Congregational meeting.
