DEMAND IS EXCELLENT

Backs of All Combines Broken

Market Conditions Better Than They Have Been for Years.

With the passing of last week the high prices and all sorts of combines have been all shot to smithereens in the markets of the city. Everything has come tumbling down at a great rate and it is now possible for a man working on a salary to put butter on his bread and cream in his coffee. Immense stocks have been turned over in the past seven days, some of the houses handling a scow of two each day and it is conceded all over town that prices and condition of trade in general is far better than it was a year or two years ago. The demand is excellent and the shipments to the creeks something enormous. The bulk of the stuff delayed at upper Lehigh is in and as was predicted a week or so ago in these columns some of it is in bad condition. One house had a ton of rhubarb arrive out of which he scarcely saved a hundred pounds, hauling the balance to the garbage pier and dumping it overboard after paying high freight including the hauling over the ice to upper Lehigh, duty and other costs of handling.

On one of the late boats a quantity of cabbage and cauliflower came in, the first of the season, ten crates of the former and five of the latter. It found a ready sale at 25 cents a pound by the crate for the cabbage and \$6 to \$7 a dozen for the cauliflower. Not all the rhubarb shipped has come in in bad condition. Some of it is excellent and has been jobbed at 25 cents by the box.

About the only line that has not been relieved is that of cream. There is no Highland to be had for love or money. There is a little Jersey on the market but the small cans have been exhausted and only the hotel size is procurable at present. Potatoes in almost twenty-four hours dropped from 17 to 7 cents and are now wholesaling at 6 1/2 and 7 with plenty in sight. Some of the spuds arrived in poor shape and a considerable sorting and consequent heavy shrinkage is necessary. Some varieties are badly sprouted and others are in perfect condition. New stock will begin arriving within a week. Eggs are also in abundance, though the delayed stock is much to the bad, shrinking on an average of four dozen to the case in candling. Fresh stock is going at \$12 and \$12.50 and retailing at 50 cents.

Quite a quantity of onions have arrived and they are going at 14 cents. There was enough of the old stock to have carried well into the season had they not sprouted so badly and gone bad occasioning a severe loss. Ham and bacon have dropped five cents and the demand is excellent. A week ago 3 1/2 was being asked and 2 1/2 is being quoted today. Another kitchen necessity that has been short for a long time is lard which is going at 25 today, a drop of seven cents in a week. NEW THEATRICAL PEOPLE ARRIVE IN DAWSON.

SAM LEVY COMMITTED
HIS THIRD ACT
John Kearns, an Old Offender, in Court This Morning
Must Await Trial in Upper Court

Steinfeld's Evidence Implicates Him in Every Deal Made.

At the conclusion of the preliminary hearing before Magistrate Wroughton yesterday evening of Sam Levy, charged with being implicated with Max Steinfeld in the robbery of Isaac Bros' warehouse, the prisoner was committed for trial before the territorial court at the next criminal session which sits next month, until which time he will be held without bail.

The strongest evidence against Levy was that of his self-confessed partner in crime, Max Steinfeld, who made a clean breast of the whole business, sparing neither himself or Levy.

Francis Corbett, the electrician, also gave evidence regarding his having sold a key to Steinfeld and Levy at 11 o'clock at night the latter part of April and of their taking it away and returning in half an hour with complaint that it did not fit and of him telling them to smoke the key, then try it in the lock and file down the places shown by marks in the black on the key. Witness loaned them a file and had vice to alter the key. They went away and later that night Levy returned the vice and file, stated that the key had been made to fit and paid Corbett 50 cents for it. Corbett identified the filed key and it fit in the padlock used by Isaac Bros on their warehouse door.

Isaac Isaacs testified to keeping two keys of the warehouse in his store, one on a key ring with other keys and the other in the money drawer. Both Steinfeld and Levy had frequently taken his bunch of keys and gone to the postoffice for him. Levy had lately been in his employ.

Henry Isaacs showed invoices for the goods recovered from merchants to whom they had been sold by Steinfeld.
Several other witnesses were examined, considerable of the testimony having no bearing on the charge against Levy.
Crown Prosecutor Pattullo at the conclusion of the hearing was well satisfied at the showing made against the prisoner and Mr. Hagel, K.C.,

FOUND DEAD IN CABIN

Lone Trapper Dies on Upper Pelly

J. D. Hamilton Who Left Dawson Last Season With Two Year's Outfit.

News has been received at the barracks of the finding by some Indians of the dead body of J. D. Hamilton in his cabin in the neighborhood of Pelly Forks 350 miles up that river from the mouth. The news comes from Sergeant Stillman located at Selkirk and says it was brought down the Pelly by a trapper named St. Laurent who is now on the way to Dawson with the dead man's effects.

J. D. Hamilton left Dawson last year for the headwaters of the Pelly taking provisions to last two years, his object being to engage in trapping. He was located far away from anyone else and was reported about four months ago among trappers, of that section as being sick. As all the trappers had agreed among themselves to meet occasionally at the Hudsons Bay Co.'s post to exchange experiences, uneasiness was created by Hamilton's favorite dog showing up at the post one day without his master. Uneasiness was abated, however, soon after by a report that Hamilton had moved further away and into a good beaver locality. Nothing was then thought of the matter until Indians reported finding his body in his cabin. Other trappers investigated and found death had occurred from natural causes.

The report to the police at Selkirk said that the dead man had a brother employed in the Dawson post office. Inquiry at the postoffice shows that W. R. Hamilton is employed at the postoffice as a dispatching clerk but he is no relation to the dead man. Another W. R. Hamilton is employed in the gold commissioner's office and it is possible that he may be the brother referred to.

Fatal Explosion
Pittsburg, Pa., May 26.—An explosion of gas in the 'Chartiers' coal and coke mine at Federal, Pa., today killed four men instantly, badly burned seven, and slightly injured a number of others. Several more are missing, and believed to be still in the mine. The mine is on fire, and it is feared that they will be burned to death or suffocated by the smoke.

TREADGOLD BLIGHT.

If the present dry weather continues for any considerable length of time a serious water famine on the creeks will become an absolute certainty. Already reports are being received which indicate that difficulties are appearing, and unless heavy rains set in very shortly the trouble bids fair to become greatly augmented.

Without an adequate water supply, mining operations will be sadly hampered, and a shrinkage in the output will necessarily result.

All the facts contribute toward substantiating the view that the water problem is the most serious issue before the people of the territory. Water bears the same relation to a placer mining camp that it does to an agricultural district.

With plentiful water at hand supplied to the miner at reasonable figures, operations would go forward throughout the entire summer season and upon a vastly enlarged scale.

Undoubtedly our morning contemporary would take occasion to remark that the Treadgold concession is designed to accomplish the purpose set forth above and that in opposing Treadgold the miners are combatting their own interests.

If Treadgold were out of the way and the belief thus dispelled that the government is determined to protect him and his associates against all comers, there would be small difficulty in enlisting legitimate capitalists in the work of supplying the miners with all the water needed for every purpose.

Treadgold need not turn his hand toward relieving the situation for the next four years and yet is in a position to bar anyone else from so doing.

There is no enterprise in the territory which offers more attractive inducements to capital, as a clear business proposition, than the establishment of a water supply. It would be like building a railroad into an already populated and productive district. The business is waiting the arrival of water and the miners have the money to pay a reasonable price for services rendered.

There is no reason why special privileges of tremendous value should be granted to the holders of a water right and particularly is there no cause for so doing, when it is remembered that private capital is ready to engage in the work of establishing a water system without asking for special privileges.

LIBERAL LEADER

Joe Martin Resigns Reins of Power

Vancouver, June 17.—I hereby place my resignation as leader of the Liberal party in the hands of the provincial executive.

This was the announcement today which caused a sensation at the meeting of the executive of the Liberal Association of British Columbia. Mr. Martin's avowed reason was to promote harmony and avoid friction in the party throughout the province.

He refused to discuss the matter further before leaving for Victoria by boat at 2 p. m.

John Oliver, Mr. Baxter and one or two others pulled very strongly for a convention, but were outvoted by the other members of the executive.

The plan, in brief, is that the party will go to the country without a provincial leader, and that no general convention will be called. The idea is that each riding hold a local convention, nominate candidates, and a caucus of the members elected will, after the election, choose a leader from amongst the elected members.

The meeting was pretty lively at times. Many local Liberals are much disappointed that no convention was called. They question the power of the executive to refuse a convention when it is requested by fourteen or fifteen associations, as is said to have been done.

The meeting was called at 11:30 a. m. Those present were as follows: Stuart Henderson, vice-president, in the chair; Wm. Sloan, T. S. Baxter, R. Hall, C. C. Brown, John Oliver, W. J. McMilligan, J. Sardine, Dr. Sinclair, H. G. Miller and Joseph Martin, by invitation; he not being a member of the executive.

It was decided that, looking to the imminence of the dissolution of the legislature and the short time available, it would be inadvisable to call a convention of the party, and Mr. Martin agreed with this view, and as there had been throughout the country a certain amount of feeling regarding the constitution of the last convention as not being representative, and as on that and other grounds, the action of the convention in electing Mr. Martin as leader of the Liberal party had been challenged, Mr. Martin told the executive that the best course under the circumstances seemed to be for him to place his resignation in the hands of the executive and make that body, which is more representative of the Liberal of the province, than any individual could be, responsible for immediate arrangements.

Mr. Martin immediately wrote his formal resignation as above quoted. It was moved and carried that Mr. Martin's voluntary resignation be accepted.

It was resolved that an appeal be made to the Liberals of the province to fall into line, and work together for the purpose of bringing into power a Liberal government.

Drowned in Lake. Peterboro, May 26.—Mr. W. A. Sanderson, a well-known jeweller of this town, went, together with his wife and family, on Saturday to Stony Lake to spend the holiday at his summer cottage there.

This morning Mr. Shortley received a telephone from Police Magistrate Dumble stating that Mr. Sanderson had gone out for a paddle in his canoe on Monday afternoon at 4 o'clock, and, not returning at his usual hour, Mrs. Sanderson became alarmed, and told the inhabitants of neighboring cottages of her husband's prolonged absence.

A search was at once made, and at 4 o'clock this morning Mr. Sanderson's canoe was discovered floating upside down. It is assumed that he is drowned, but there have been no developments for over 24 hours.

To Form Guard. London, May 30.—According to an agency despatch from Constantinople 150 Russian blue-jackets have been landed there to form a guard for the Russian embassy.

LIBERAL LEADER

Joe Martin Resigns Reins of Power

Vancouver, June 17.—I hereby place my resignation as leader of the Liberal party in the hands of the provincial executive.

This was the announcement today which caused a sensation at the meeting of the executive of the Liberal Association of British Columbia. Mr. Martin's avowed reason was to promote harmony and avoid friction in the party throughout the province.

He refused to discuss the matter further before leaving for Victoria by boat at 2 p. m.

John Oliver, Mr. Baxter and one or two others pulled very strongly for a convention, but were outvoted by the other members of the executive.

The plan, in brief, is that the party will go to the country without a provincial leader, and that no general convention will be called. The idea is that each riding hold a local convention, nominate candidates, and a caucus of the members elected will, after the election, choose a leader from amongst the elected members.

The meeting was pretty lively at times. Many local Liberals are much disappointed that no convention was called. They question the power of the executive to refuse a convention when it is requested by fourteen or fifteen associations, as is said to have been done.

The meeting was called at 11:30 a. m. Those present were as follows: Stuart Henderson, vice-president, in the chair; Wm. Sloan, T. S. Baxter, R. Hall, C. C. Brown, John Oliver, W. J. McMilligan, J. Sardine, Dr. Sinclair, H. G. Miller and Joseph Martin, by invitation; he not being a member of the executive.

It was decided that, looking to the imminence of the dissolution of the legislature and the short time available, it would be inadvisable to call a convention of the party, and Mr. Martin agreed with this view, and as there had been throughout the country a certain amount of feeling regarding the constitution of the last convention as not being representative, and as on that and other grounds, the action of the convention in electing Mr. Martin as leader of the Liberal party had been challenged, Mr. Martin told the executive that the best course under the circumstances seemed to be for him to place his resignation in the hands of the executive and make that body, which is more representative of the Liberal of the province, than any individual could be, responsible for immediate arrangements.

Mr. Martin immediately wrote his formal resignation as above quoted. It was moved and carried that Mr. Martin's voluntary resignation be accepted.

It was resolved that an appeal be made to the Liberals of the province to fall into line, and work together for the purpose of bringing into power a Liberal government.

Drowned in Lake. Peterboro, May 26.—Mr. W. A. Sanderson, a well-known jeweller of this town, went, together with his wife and family, on Saturday to Stony Lake to spend the holiday at his summer cottage there.

A search was at once made, and at 4 o'clock this morning Mr. Sanderson's canoe was discovered floating upside down. It is assumed that he is drowned, but there have been no developments for over 24 hours.

ERITS ARE DISCUSSED

of the Two Routes From Stewart to Duncan Much Agitated.

people interested in the Ditan great question now agitating their minds is as to which of the two routes from the Stewart to Duncan which will be selected by the government, which to build the road that has been decided.

Each route has many agitators and the controversy at times becomes very bitter owing to the fact that the building of the road will mean the fate of one or the other of the two villages at the terminus of the trails, Gordon's and Mayo landing. The general opinion is that which ever route is selected the other will thereafter be abandoned.

The routes have been viewed by A. H. Peterson, D. L. S., and also by J. C. Cutler, D. L. S., and their opinions are in the hands of the commissioner. Which is favored is not known, but it is thought Gordon's route is preferred. Within the next few days the Territorial Engineer, Thibedeau, will go over the land and make his report and then will be decided which route will be employed and active work will be begun immediately after. It is the office of Territorial Secretary Brown yesterday that a number of gentlemen waiting to see the commissioner were assembled. Several recently been over both the routes and for want of something to talk about the conversation directed toward the relative merits of the trail via Gordon and Mayo. Alex Macfarlane, who is something of an explorer himself and who recently made the trip over both the routes, was firm in his opinion that Mayo was the only route worth considering, but it even if it should be as it at present is laid-out. The trail is a wrong limit of the river; if it were on the other side it would be much better, the soil being hard and dry. It was admitted that the Mayo route as now run was miles longer than the other, and it was insisted that even with a handicap it was preferable on account of its much better condition and freedom from hills. Two miles were saved by taking the other side of the river, Alex says, and he does not know for he tramped it, but he knows of it. One of the gentlemen present, an engineer, took issue with Alex and told him he was talking through his hat, but the latter would not be made to believe it.

The road that will be put in this year will be the best that can be made, so that freight interruption from the landing and the mines will be a thing of the past. At present it is necessary that all freight be taken in midwinter over the snow, which things as absolute necessities in the way of provisions being taken in during the warm weather on account of the expense attached to the movement of heavy machinery, upon which the future of the country so much depends, is an absolute impossibility. The road will be completed and ready for use before the beginning of cold weather. This

LABANIANS ARE STILL FIGHTING

Albanians, May 31.—In spite of Turkish assurances there appears to be a prospect of further fighting in Albania. Many of the most influential Albanians have taken to the hills, while the Albanians of Louma, who are considered to be particularly fierce warriors, are reported to be determined to resist any advance on their stronghold. Forty Christians were held up a few days ago near Gornar, and one was killed. It is impossible not to be struck with the contempt shown openly even by the Albanian yokels for the Turkish representatives of law and order. Pasha informs me that it is proposed to exile to Asia Minor 103 Albanians from Macedonia, mostly the most obstinate and substantial merchants selected as being the most dangerous of the 300 long suspected ringleaders who were recently arrested. Though the idea of exile is not unexpected that the Albanians will permit the execution of Pasha's proposal, nor that it can be effected if it is permitted, since the real ringleaders have been arrested in avoiding Turkish prisons, and are either occupying the mountains or living in safety on the other side of the

GREENS FAVOR TURKEY

Bulgaria, May 31.—Accounts in the Constantinople papers of Greek zeal in behalf of the Turkish cause produced the bitterest feeling in Bulgaria. To the terror prevailing

among the Bulgarians in Macedonia, large numbers have abandoned the Bulgarian church and joined the Greek patriarchate. A converse process occurred in 1897, when the Greeks suffered a similar proscription and the exarchate gained many adherents.

APPREHENSION IN AUSTRIA-HUNGARY

Vienna, May 31.—Mr. Chamberlain's proposals have caused astonishment, not unmixd with apprehension, in Austria-Hungary. As long as it was possible to represent his Birmingham speech as a manoeuvre, inspired by personal ambition and by a desire to steal a march on the premier, Austrian politicians affected to attribute to it the secondary importance attaching to an electioneering manifesto, but now their tone is changed. Chamberlain is still regarded as a schemer, but it is remembered that his schemes have an unpleasant way of fitting themselves to circumstances, which, if not actually existent, are already casting their shadows before.

There Are Others.

Seattle, June 4.—Forced to work in dance halls and to give her earnings to a man whom she has only known three weeks, 18-year-old Laura Roff was released from such a life last night when she was arrested in the Arcade dance hall, along with her male companion, by Detective Barber. For several days the father and brother of the girl, living in Shelton, have been in the city on her track, but it was not until yesterday that any definite news of her whereabouts was obtained.

Laura Roff, in company with an older sister, left her home in Shelton six weeks ago to go to work in Seattle. They worked a while in a private family, and the older sister fell sick and went to the Wayside Mission. When she had been there about a week, Laura Roff met Frank Bloomer, who claims to be a printer, and was persuaded to live with him and go to work in the dance halls. She did so, and gave up to him, she says, everything she earned. She went from one dance hall to another, living the while on Fifth avenue and Yester way.

The girl, tired of the life and tried to leave, and on one occasion went away, but was made to come back. Once, she says, Bloomer struck her in the face. During all this time Laura, together with the man, visited her sister, claiming she had been married.

When the father, S. M. Roff, heard of his daughter's case, he came down to Seattle, with his son, and laid the matter before the police and the prosecuting attorney.

It was learned that the couple had been living on Fifth avenue. On one of their trips to the Wayside Mission they came across Laura's brother, and quieted him by saying they were married, and giving him their address. The young man informed the police, and when the place was visited the couple had flown.

When arrested, Laura Roff was engaged in trying to procure dances and drinks, while Bloomer was hanging around in the crowd, watching her. Bloomer was locked up in the city jail and the girl was taken in care by the police matron. The Roff girl said last night she had intended going back to her father, and was glad she had been given a chance to break away from Bloomer.

Bloomer is a San Francisco man, having come to Seattle in 1898. He is said to be a worthless kind of fellow, and to have a wife from whom he has separated. A serious charge may be placed against him.

Some International Happenings

News was brought by the steamer Tartar that as a result of the unexpected Russian activity in both Manchuria and Korea, the Japanese are eager to hasten the inevitable. Many of the Japanese journals brought by the steamer state that unless Russia recedes—and little hope is held by the vernacular press that such will occur—war is inevitable.

Vernacular Japanese papers publish alarming stories to the effect that several army divisions have been mobilized, reserves are being prepared, and the naval headquarters has received rush orders to have all preparations made, as a result of the Russian activity in Korea. News is also given of secret dispatches regarding the situation, which have been passing between Great Britain and China regarding the Anglo-Japanese treaty. One message quoted is that proper measures will be taken by Great Britain regarding the Straits Settlements in the event of war. Other measures quoted apply to Britain's aid in the event of hostilities.

While it is considered in the Orient that the majority of the powers, with the exception of Japan, are accepting Russia's statement that the evacuation of Manchuria will take place, the Japanese government is preparing for resort to war. This fact is no longer masked, nor is the great amount of preparations and massing of fleets and soldiers by Russia done with any covertness. It is admitted that both Japan and Russia are preparing for conflict. The feeling against Russia in Japan is constantly growing, and any trivial incident at this moment might precipitate war between these bitter enemies.

Russian action in Korea is firing the Japanese even more than the activity in Manchuria. Gradually Russia has been bearing down Japanese prestige in Korea, and within the past few months scores of actions have been directed against Japanese industry in Korea—Russia having sternly secured control of the Korean government. Each race is now confronting the other, goaded to the extreme, and a shot, a riot, a conflict between the meanest representatives of Russia or Japan at this time would doubtless enrage the populace and war would be inevitable.

The latest news regarding Russian action in Korea shows that thirty thousand Chinese are engaged in timber cutting for Russian concessionaires on the Yalu river, and the Russian forces have been sent to protect them. Enormous quantities of coal are also said to have been shipped from Port Arthur to the Yalu.

BUILDING BARRACKS

More than five hundred Russian

troops have entered Wiju and constructed barracks, taken in stores, and made preparations for permanent occupation. About ten Japanese residents there have been subjected to severe restrictions. Their chattels have been closely inspected and Russian soldiers follow them whenever they go outside. The exchange of letters has been almost prohibited.

A number of Russian soldiers, computed at six hundred, have entered Kai Chingdo and occupied several towns and villages. The Russian troops have blockaded Ton Mankon and Yungchihwan. The local governors asked the Russian commanders the reason for the dispatch of these troops, but the Russians stated that the object was to furnish protection for timber felling, and vouchsafed no further explanation.

Some Japanese residents at Wiju have had a dispute with Russian soldiers and have been severely injured. It is reported that three persons injured, the recovery of one is doubtful.

VIOLATED TREATY.

A telegram from Seoul states that the Japanese and British ministers have jointly sent a warning to the Korean government, stating that the intrusion of Russian troops into Korean territory constitutes a violation of the treaty stipulations, and further that Korea should quickly open negotiations with Russia and demand the withdrawal of the troops, as the independence of Korea may be endangered if she allows the incident to pass unnoticed.

CONSTRUCTING FORTS.

Prince Ching has received an urgent telegram to the effect that 14,000 Russian troops, with sixteen field pieces, have suddenly appeared on the banks of the Liao river, and that the construction of forts has been commenced at Tien Chuangtai. Another telegram from Pekin states that 60 large number of Russian troops have entered Newchwang and occupied the forts at the mouth of Liao river, and are also going to capture the forts at Tien Chuangtai, and that 14,000 Russian troops have been quartered between Port Arthur and Yinkow.

A Tientsin telegram, under date 10th of May, states that it is clear by reports from various sources that the Russians have been making preparations for emergencies by strengthening the position at Newchwang, Liaoho and other points. Thirty Russian men of war are at Port Arthur.

The Russian troops at Tieling, Liaoyung and Yinkow have been ordered to make preparations for emergencies. They are going to proceed in the direction of Feng Huang-cheng and Chiu Liencheng, and a portion of the commissariat corps has already been dispatched. Foreigners,

even traders, are prevented from travelling.

MANY RUSSIAN TROOPS.—Ten Norwegian steamers have been engaged in the carriage of several thousands of the Russian troops to the shores of the Yalu river, and other coasts of North China. The Volunteer fleet has also been engaged in the carriage of troops.

Russia has ordered from the Shingawa Confectionery Company, the Fugetsudo and the Kobayashi Confectionery shops in Tokyo, several hundred tons of biscuits.

The Russian volunteer fleet of steamers and other Russian chartered steamers have been dispatched to the Yalu from Port Arthur with Russian troops on board. The number of the Russian troops dispatched to Ching-Lien-Cheng already amounts to five thousand, and unusually active preparations are being made.

KOREA PREPARING.

The Korean government has given instructions to the local garrisons at Pingyang to defend the Korean boundary.

The Korean government has received advice from the commander of the garrisons at Wiju stating that about fifty Russians have come to Lin Yung-go, on the bank of the Yalu river, and have begun the purchase of land and houses. The Korean court has applied to the Russian minister in Seoul to stop the Russians from doing so, on the ground that their act constitutes a violation of the treaty.

The Russians have been carrying out various undertakings at Liaoyung, which is an important point on the way to Wiju via Feng Huang-cheng. There are three hundred houses, ten rows of barracks and twelve hospitals in course of construction outside the southern gate. This place is now a rendezvous of the Russian troops. At present there are about fifteen thousand soldiers inside the gate and twenty thousand outside the castle.

It is estimated that there are about six thousand Russian troops at Feng Huang-cheng, and the Russian troops scattered about in Manchuria are supposed to consist of ten thousand in Mukden, twenty thousand in Kirin and forty thousand in Amur. The Asahi's Pekin correspondent reports that the following numbers of Russian troops are now in Shinkiang province: About 300 foot soldiers

at Mukden, 100 artillerymen and 800 cavalry at Liaoyung, 100 artillerymen and 5,000 infantry, and cavalry at Feng Huang-cheng, 100 artillery and 100 infantry and cavalry at Tieling, and 200 infantry and cavalry at Newchwang. The number of the Russians at Kaiping is not known.

Governor-General Alexieff has promulgated the law of siege in Kirin province and has issued at the same time a strict order prohibiting foreigners from moving about therein.

Prince Ching has asked the Russian charge d'affaires for definite information when Russia would evacuate Manchuria. A reply was promised on the return of M. Lessar, who is ill, to Pekin.

Heroic Policemen.

New York, May 26.—Prompt and heroic work by two policemen, one of whom was so badly burned that he was crazed by the pain, saved the lives of several women and children, who had been caught in a burning building in Fulton street, Brooklyn, at an early hour today. When the police and firemen reached the scene women and children were at the windows of the building calling for help. Policeman James F. Haven entered the building and on the top floor found Mrs. Howard Murray unconscious. He carried her to a window and she succumbed, having been burned about the face and hands. The pain from the burns crazed him and he had to be placed in a strait-jacket at the hospital. In the meantime policemen and firemen had rescued the other women and children, who were asleep when the fire broke out.

At the hospital it was said Haven could not live. Policemen McAuley and Cook were also seriously burned, and will probably be disfigured for life.

The title to 9 Caribou gulch was settled yesterday by the placing on record a document by which F. P. Martin relinquishes all his alleged right and title to the ground. A protest was on the docket and it was thought, recourse would have to be had to the courts in order to decide who the rightful owner was, but the relinquishment of Martin settled the matter and the case was dismissed. John Ferry was the other party to the suit, he becoming interested in the ground by reason of a purchase made from Edward Herring. He, however, had neglected to record the bill of sale and when the claim was relocated by Martin on account of the representation work not having been sworn in time he found it impossible to record his bill of sale and thus establish his interest in the ground. It is thought some sort of a compromise was arranged and Martin withdrew by signing a relinquishment in writing. Upon the latter document being placed on record the bill of sale from Herring to Ferry was accepted and also placed on record.

SMALL DEBTS

Court Presided Over by the Hon. Charles Macdonald

A short session of the small debts court was held this morning which in the absence of Mr. Justice Macaulay, was presided over by Clerk of the Court Macdonald, the cases disposed of being tried by the consent of all parties interested. The first case to come up was that of Dr. Bourke against Williams, an action on a promissory note for \$50. Judgment for plaintiff in the amount prayed for. HIS SECOND APPEARANCE

There are still several new arrivals who have been interviewed by the police who have explained to them that Dawson may not prove congenial to them and that they had better move on.

Lynch is about 25 years of age and has about him a sort of jailbird look not unlike that of the notorious Kid West. He will be required to move on as soon as his sentence expires.

Dances Stopped

Regina, May 26.—Considerable annoyance to officials has been recently caused on the eight Indian reserves presided over by Mr. W. M. Graham, agent on reserves comprised in the Elk-Hills agency. Since the passing of the act about two years ago forbidding the sun dances, give-away dances and the like, there was no attempt to evade the law until last March, when a sort of agitator among the Indians arrived on Piapot's reserve and sought to, defy the law by an audacious technical point. He started "etree dances" at which nothing was given away but a supper. The first one was given on March 14th, and was quickly followed by a series of others of a similar kind, at which the Indians appeared in all their paint and the squaws in all their finery. The matter was getting serious. Mr. Graham took alarm and began proceedings against Etchease, the man who had started the dances, charging him with a breach of the Indian act. The magistrate decided to send the case for trial, and Etchease was charged before Judge Richardson and a jury, when Mr. Fred Jones put up an able defence on the point indicated. The accused, however, was found guilty and sentenced to three months imprisonment. Another Indian named Shave Tail, who had followed the example set by Etchease and organized a dance so recently as the 16th of the month, was charged with enticing the Indians to dances, and was also found guilty, but recommended to mercy and liberated after a severe reprimand by the judge.

J. J. Hill Will Help

The Pacific steamship and railway transportation interests will cooperate with the management of the Louisiana Purchase Exposition to make the Asiatic participation at St. Louis in 1904 a great success. John Barrett, commissioner general of the World's Fair, has just returned from Seattle, where he held a conference with President C. J. Hill on this subject. Mr. Barrett laid before President Hill the direct advantage of his active assistance and the effect of such help on the size and character of Asiatic exhibits. After careful consideration, Mr. Hill gave assurance that the systems would do everything possible in rates and space to facilitate the bringing of these Oriental exhibits to St. Louis. As the countries of Asia with which Mr. Barrett negotiated will expend \$3,000,000 at the exposition, the significance of this favorable action can be appreciated. It will also have a bearing on the Lewis and Clark exposition, because, as Mr. Barrett says, the larger and better the foreign display at St. Louis, the greater the portion thereof that can be brought to Portland in 1905. President Hill agrees with Commissioner Barrett that the promised representation of Asia's products and resources at St. Louis will mark the beginning of a new era in the expansion of transpacific trade, and is of even more interest to this section than to any other part of the United States.—The Commercial West.

The territorial court sitting en banc will convene on Tuesday, the 23rd, and remain in session the 24th and the 25th for the purpose of giving judgment in the case of McGraw vs McConnell, Anthony vs Ellis and that of Envidson vs Gosselin and Boyes. The latter is the outcome of the well known mandamus proceeding brought by the plaintiff to compel the gold commissioner's office to issue to him as grant for a certain mining claim which he had staked and which the office had refused him. The action was originally tried before Mr. Justice Craig who decided in favor of the plaintiff, issuing the writ of mandamus prayed for. The government appealed and the result of the case will be watched with much interest. The argument in one or two cases will also be heard before adjournment.

AGAIN THE DEFENDANT

Lovett Gulch Miner is Much in Court

Hillside Owned by Elmer Middlecoff is Protested by Esther Rose Stranger.

Elmer Middlecoff, the man who has had so many lawsuits over the upper half of 3 Lovett gulch, is again the defendant in an action that was filed yesterday, his opponent in this instance being a woman. Her name possesses an euphony by which one might conjure up visions of surpassing beauty. It is Esther Rose Stranger and she alleges she is a free miner and has been one for some time. She also claims to be the recorded owner of the fractional hillside claim adjoining the lower half, left limit, of creek claim No. 1 below discovery on Lovett gulch. Middlecoff likewise has a grant covering the same ground held by Miss Stranger which she alleges is wholly void for a number of reasons which she proceeds to give. It is claimed that when Middlecoff staked the ground he did not mark out or locate the claim in accordance with the regulations; that he did not apply for entry in accordance with the regulations; that he abandoned the hillside location by staking the creek subsequently.

In spite of all these gross errors committed by Middlecoff it appears that he has been in possession of the ground for some time and has been and is now working it to a substantial profit. The plaintiff alleges that he has taken out quite a considerable quantity of gold dust and that if he is not at once restrained she will be irreparably damaged.

The relief that is desired is quite exhaustive and comprises several things. First an injunction is demanded, then a receiver is desired and the court is asked to make a declaration that the ground is hers and cancel the grant held by the defendant. That done an accounting of all the dust that has been taken from the claim is demanded, the costs of the action and such other relief as the court may see fit to exact.
