Town and County News.

BOARD OF SCHOOL TRUSTEES.—The regular meeting of this Board was not held last evening from want of a quorum.

RUNAWAY.—This (Tuesday) forenoon the horse which Rev. Father Sherlock was driving got frightened at something while crossing the bridge at Allap's Mills and ran off. Mr. Sherlock was thrown out, and received some injuries, but we have been unable to learn their nature or extent. He was conveyed to his residence, and the horse was caught before he ran far.

ERIN ITEMS.—Our correspondent says: On Friday last Mr. J. S. Walker, of Erin Village, was thrown from his gig and sustained pretty serious injuries about the face and neck. On Saturday Mr. Johnson and his family were on a visit to his father-in-law's, Mr. Colin McMillan, 5th Line, Erin, and, on leaving, Mr. and Mrs. Johnson, another lady and three children, got into the buggy. The horse being young and spirited became frightened and ran away, throwing them all out, all of whom received more or less injury. Mr. Johnson was very badly hurt and one of the children dangerously injured. Dr. McNaughton was called immediately, and gave them all the relief he could.

LOCAL AND OTHER ITEMS. SERIOUS ACCIDENT.—A young man by the name of Thomas Pillow, an employee in Tilt's shoe factory, Brampton, accidentally fell from a third story window of the Exchange Hall, on Monday evening, and received such injuries that he was not expected to live till morning.

THE Dominion Telegraph Company have opened an office at Aurora, Ontario. They have also just completed stringing a third wire from Toronto to Hamilton in order to meet the rapidly increasing business between these two points. The Company also intend increasing their facilities by stringing extra wires on their trunk lines in other directions radiating from Hamilton to Toronto.

ATTEMPTED BURGLARY IN GALT.—An attempt at burglary was made in Galt between Sunday night and Monday morning. The office of Durand & Phillips, barristers, was entered, and an attempt made to force open the safe by powder. The only damage done was the blackening of papers and books in the safe. The burglars were probably frightened off by Stewart's mill hands coming to work at that hour. No clue to the depredaters as yet.

THE BEARING TREE IN APPLIES.—Take notice from the tree in 1872, and do the same in 1873, and you will get fruit in alternate years. 2. If you want fruit in the year 1873, you must plant a tree in the last of July, leaving three or four buds that would come out in 1873, you would force out the next year's buds and gain one year. 3. If you remove all the blossoms on one-half of your tree in the bearing year you will have fruit on that half the next year. These things have been done successfully. I have now in bearing the Victoria apple of the old year produced in this way; next year the seasons of the last year will bear on the regular year.—S. A. S., in Tilton's Journal of Agriculture.

THE PRICE OF MEAT IN BRITAIN.—The high price of butcher's meat continues to excite great attention and discussion in England. The main complaint seems to come from the country butchers, who in many cases have ceased to purchase on account of the extortion of the hold-ers of the stock. A meeting was held on Sunday's dinner for 29 years until the previous Sunday. The butchers have resolved in several places to close their shops for fourteen days.

A GENTLE HINT.—The following truthful remarks from the Buffalo Express are recommended for consideration: "When an editor has collected his thoughts as well as his scraps, and is ready to go to work, in comes somebody to scatter both, and talks or rustles his papers, and makes him feel very much like swearing. All business is suspended until quiet is restored by the return of the interrupted editor. If editors are not saints they certainly would swear under such circumstances, but they smile and smile—but meditate murder while they smile. If people would only consider that editors have work to do, that their work requires profound stillness, and that very few writers or readers can either write or read unless they are entirely alone they would not think an editorial sanctum so proper a place to spend their leisure hours in."

A list of pensions granted by the British Government during the last year has been published. Amongst others we notice one of £100 to Mrs. Helen Lemon, in consideration of the literary services of her late husband, Mr. Mark Lemon, and one of £100 to the Rev. H. A. Serivins, in recognition of his services in connection with biblical criticism. Generally the literary pensions are granted to people of who have never before. Three granddaughters of Dr. Robertson, the historian, receive £250 each, and a daughter of Dr. Southwell Smith £30.

ALBANY PAPERS quite remark that the pestilence of small-pox is parading their streets. One patient was marched through the streets to the almshouse, a distance of a mile and a half. Another took a hack and removed himself from one house to another. Meanwhile the Albany citizen fears to sit at his front door.

Melancholy Accident.

A WOMAN BURNED TO DEATH.

We regret to state that an accident of the most melancholy character occurred in town this (Tuesday) morning, by which the wife of Mr. Joseph Rainer, piano manufacturer, was burned to death. Mr. Rainer lives in a new frame house, on the east side of the river, near the railway bridge. It seems from what we could learn that shortly after 8 o'clock she was preparing to do some washing, and her children had gone out to the river for water. She must have been in the act of putting on the washing boiler when her clothes caught fire, for when found the boiler was lying beside her, and the covers of the stove were off. How her clothes caught fire, or whether after they were ignited she was seized with a fit, or the shock rendered her incapable of effort, will never be known, for not a soul was in the house or around at the time. It is, however, supposed that she must have fallen by the side of the stove immediately after her clothes were on fire, and that she lay helpless while the flames spread over her body, doing their terrible and fatal work. Some little time must have elapsed before the return of her little girls, and they, poor things, as soon as they witnessed the awful sight of their mother's scorched and burned corpse, gave the alarm, when some of the neighbours rushed in. Part of her clothing was still burning on their entrance. They at once dashed water on her and tore the clothing off, but life was quite extinct. The house was full of smoke which came pouring out of the door, and it was this that gave occasion to the alarm of fire, which drew the crowd to the house. The body of the unfortunate woman was at once removed to another room. It presented a most painful sight. The face was burned almost beyond recognition, her hair was completely burned off, in fact the whole body was scorched and burned in a terrible manner.

Dr. Herod was early on the spot, but life was extinct long before his arrival. He does not consider it necessary to hold an inquest, the cause of death being so apparent, and the fact of its being accidental being so well established. The deceased was in delicate health, and subject to sick spells, but we believe was not subject to fits. The supposition, therefore, is that when her clothing took fire, she became paralyzed with fear, and died without being able to make the slightest effort to save herself. The shock to her unfortunate husband and family was a terrible one, and they have the heartfelt sympathy of the community in their sore and sudden bereavement. The neighbours willingly gave their assistance in performing the necessary duties to the dead, and in relieving the family of these sad offices, and gradually the crowd dispersed, leaving them alone in their great sorrow, to mourn over the scorched remains of the unfortunate wife and mother.

Base Ball Notes.

THE INTERNATIONAL MATCH, ETC. A telegram reached Guelph on Monday night that the match played in Baltimore on that day between the Baltimore and the First Nine of the Guelph Maple Leaf Club resulted in a victory for the former. The score stood 25 for Baltimore, and 5 for the Guelph Club.

The Guelph Nine play with the Philadelphia Athletics to-morrow. The Athletics of London defeated the Dauntless of Toronto, on Saturday by a score of 29 to 27.

From the N. Y. Tribune of yesterday. The exciting contests in the championship arena during the past week will be succeeded by more first-class games this week, the visits of the Boston Red Stockings, the champion Athletics, and the champion club of Canada to this city, presenting opportunities for very attractive displays. The Canadian Champions the Maple Leaf Club, of Guelph, will visit this city on Thursday to play with the Mutuals. The Athletics will play with the Atlantics on Friday, and the Mutuals on Saturday. The Mutuals sustained their fourth defeat at Boston at the hands of the Red Stockings, on Saturday, by a score of 9 to 3, and the Athletics again defeated the Baltimore nine at Philadelphia by a score of 15 to 6.

There are now only four professional stock company nines in the country—the Athletic, Baltimore, Boston and Mutual clubs. The other contesting nines are co-operative clubs, which play their games by gate money, these include the Atlantic, Cleveland, Eckford, Mansfield and National clubs. The games played by the disbanded Olympic and Troy nines are to be thrown out by the championship committee.

INTERNATIONAL BRIDGE.—The Buffalo Commercial Advertiser says: "On Saturday, July 13, the coffer-dam for abutment No. 6 of the International Bridge was sunk to its position in thirty-three feet of water. This dam in shape and plan, Otto Meyer, of New York. The iron spans having been constructed some time ago, the utmost nicety was required in placing the novel structure in position. The difficult task has been successfully performed, and, as was to have been expected, Cap. Meyer received the enthusiastic congratulations of the Grand Trunk and Great Western railway officers on the occasion. The despatch which existed by reason of the discouraging state of affairs in connection with the construction of the bridge last summer, has now given place to pleasing anticipations, and all looks favourable. Two more piers—Nos. 4 and 5—are to be built without delay, and it is hoped that the bridge will be finished before next winter."

A Royal Birth.

London, Aug. 13, 6 a. m.—Princess Helena, wife of Prince Christian, has been delivered of a daughter.

The representatives of the London press entertained Mr. Stanley at the Garrick Club last night.

The Daily News discredits the disquieting rumors about the progress of the Arbitration at Geneva.

Dublin, Aug. 12.—The anniversary of the relief of Londonderry was celebrated in this city to-day. There was no disturbance.

Geneva, Aug. 12.—One of the most extensive cotton factories in this city was destroyed to-night by fire. The loss is estimated at ten million francs. Eight hundred operatives were thrown out of employment.

New York, Aug. 12.—The reception of Mr. Wm. Johnson, M. P. of Belfast, at the Cooper's Institute, by the Orange Societies of New York, to-night was a grand success. The hall was crowded, and the stage was decorated with flags, the Union Jack occupying the place of honour in compliment to the guest. Prof. Chapman introduced Mr. Johnston and John G. Bond presided. A gold maltese cross was presented to Mr. Johnston.

New York, Aug. 13.—A London special says that the Times says with regard to the reference in the royal speech to the East African coast slave trade, that it is the most significant part of the speech, and, we suppose, it is not an error to connect this announcement with the recent discovery of Dr. Livingstone, and the despatches to the Foreign Office, brought by Stanley, from the great traveller.

London, Aug. 12.—The Royal Yacht Squadron Regatta was brought to a conclusion on Saturday. The Challenge Cup, presented by the Prince of Wales, was won by Ewing's schooner-yacht Gwendolin. At one time during the race Ashbury's yacht Livonia was three miles ahead of all the others, and undoubtedly would have won the cup had not her progress been stopped by the carrying away of her maintopmast.

Geneva, Aug. 12.—Mr. Cohen, the English barrister, who drew up the report for the Crown on the subject of the American claims for losses sustained by the Mercantile Marine of the United States, has been summoned here from London. This gives rise to the conjecture that a decision has been rendered by the board upon the general question of England's responsibility for direct losses claimed by America, and that Mr. Cohen is called in to assist the British counsel in arguing upon the amount of damages to be assessed by the board. One of the many reports current here concerning the proceedings of the Board's present position on the arbitration is, that after the cases of the two governments were presented, the counsel on either side went into a lengthy discussion regarding England's responsibility, the argument being mainly upon the question whether the British authorities had exercised due diligence to prevent the Confederate cruisers from escaping out of British ports, and whether any such responsibility as American claims followed upon the permission to the said cruisers to take coal at British stations.

Sir Roundell Palmer opened the discussion on these points. He spoke at great length in support of the positions taken in the British case.

Messrs. Waite, Everts and Cushing replied, the latter closing the argument on behalf of the United States. In his summing up, Mr. Cushing strongly urged the point that the same diligence upon the part of the British authorities which afterwards served to detain the Confederate rams, would have been equally effective in preventing the escape of cruisers, had it been exercised.

AN UNTIMELY END.—The body of a young man named Bolton has been discovered in the Canal, near the locks, and started on foot saying that the deceased, at the Prince of Wales Saloon, Queen street, on Wednesday evening, by Coroner Kerr. The following facts have been elicited. The young man attended Mr. Patterson's meeting at Newport, on Tuesday evening, in company with Mr. Ovey, who resides at the Locks. At Newport he drank several times, and became so much under the influence of liquor that he desired to go home with Mr. Ovey and remain till morning. On arriving at Ovey's house he changed his mind, and concluded to go to his own home, and started on foot saying that the walk would do him good. He left Ovey's about half-past one o'clock Wednesday morning, and that was the last he was seen alive, as the evidence so far goes to show. Dr. Henwood examined the body and found no marks of violence upon it. The jury desiring to procure, if possible, further evidence, adjourned until last evening, when Mr. Dealtry, of Newport, attended, and from his evidence it was apparent that the deceased had drunk considerable whiskey at Newport. The jury returned a verdict that the deceased was accidentally drowned. The deceased, we understand, was one of the best swimmers in town. Young men may learn a profitable lesson from this most unfortunate event.—Brantford Courier.

Riel to the Rescue.

(From the Globe.)

The Ministerialists seem determined to make use of any agency, however invidious or dishonourable, to stave off the crushing defeat which they see clearly in the distance—and see with a measure of alarm that cannot be hidden by abundant boasting. After stealing private documents, falsifying records, inventing malicious accusations, and raising the howl of "disloyalty," they have resorted to a desperate expedient to carry a North-West constituency. At what would these immauculate loyalists stick? After all their loud professions of devotion to the Queen and country, they have determined to bring out the rebel "ex-President" for the District of Provencher. It is not unnatural that they should seek such congenial company. The man who "shot Scott" will undoubtedly make an obedient tool in Parliament. But what will Governor Archibald do? Will he again ferretly grasp the blood-stained hand of the candidate of the "Party of Union and Progress"? Or will he make one earnest effort to settle the vexed question of jurisdiction, when he has within his power the man who committed that "most foul and dreadful murder"?

Riel is already said to be "buzzing around," from one French parish to another. The time has certainly come when the officers of the law in Manitoba should take energetic steps to secure an administration of justice in this standing outrage.

"Mr." Riel, then, is to be a Ministerial candidate for Provencher. How will Mr. Howe like this intelligence? Will he send up from his New Jersey retreat another "wailing cry of a loyalist" or will he forthwith, in the extremity of his rejoicing, issue imperative orders to Fort Garry to "haul down that flag," in order that it may not offend the susceptibilities of the promising young candidate?

The situation is rendered somewhat complex by a report in the Toronto Tory organ that the Hon. Attorney-General Clarke intends to contest Provencher with "Mr." Riel. This establishes the fact of the murderer's candidature; it also demonstrates that the bitter personal quarrel between Mr. Clarke and Mr. Royal, the fugleman of Sir George in that quarter, is still in existence, in spite of the disturbance of Tory peace of mind in Manitoba. WHEREAS there is no interest in arrears.
And whereas the Corporation of the County of Wellington hath not in the municipal year contracted any debts or loans over and above the sum required for its ordinary expenditure, including the said sum of twenty thousand dollars, except twenty thousand dollars.
And whereas a copy of this by-law hath been duly published according to law, Therefore the Corporation of the County of Wellington, in pursuance of the powers in it in that behalf vested and in and to the effect set forth as follows: That the Wardens of the said County for the time being, be, and he is hereby authorized, empowered, and required for the purposes aforesaid, to issue in due form of law the sum of twenty thousand dollars in debentures of the said Corporation of the said County in sums of not less than one hundred dollars each, payable in twelve years at farthest from the day on which this by-law is appointed to take effect, at the office of the Treasurer of the said County, and that every such debenture shall bear interest at the rate of five per centum per annum from the date of its issue, payable half yearly at the said office, and shall be signed by the Warden, and countersigned by the Treasurer for the time being of the said County, and shall have attached thereto coupons for the payment of said interest, and the said Warden is hereby authorized to negotiate and dispose of.

AND BE IT ENACTED that, for the purpose of forming a sinking fund for the payment of said debentures and interest, an equal special rate of one-fourth of a mill in the dollar be levied on all other rates be raised, levied, and collected in each year upon all rateable property in the said County during the continuance of the said debentures.
AND BE IT ENACTED that, the proceeds of the said debentures shall be applied and apportioned to the several purposes hereinafter mentioned, in the amounts and proportion aforesaid, the grants of the said local municipalities to be paid to the Treasurers thereof respectively, to be applied by them strictly to the purposes aforesaid, and an account of such application to be returned by each Reeve to the Council of the said County, at the next December Session of this Council.
No person lending money upon or purchasing said Debentures shall be bound to see to the application of the proceeds thereof.
AND BE IT ENACTED that, this By-law shall take effect upon, from and after the first day of October, in the year of our Lord one thousand eight hundred and seventy-two.

The above is a true copy of a proposed By-law to be taken into consideration by the Municipality of the County of Wellington, at the Court House, in the Town of Guelph, in the said County, on the first day of October, 1872, at the hour of two o'clock in the afternoon, at which time and place the members of the Council are hereby required to attend for the purpose aforesaid.
