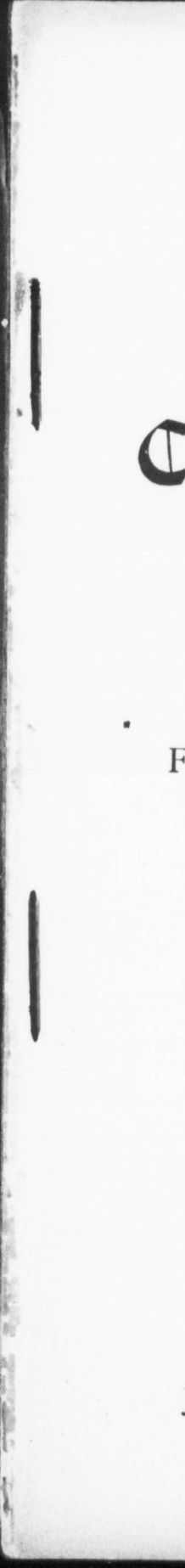
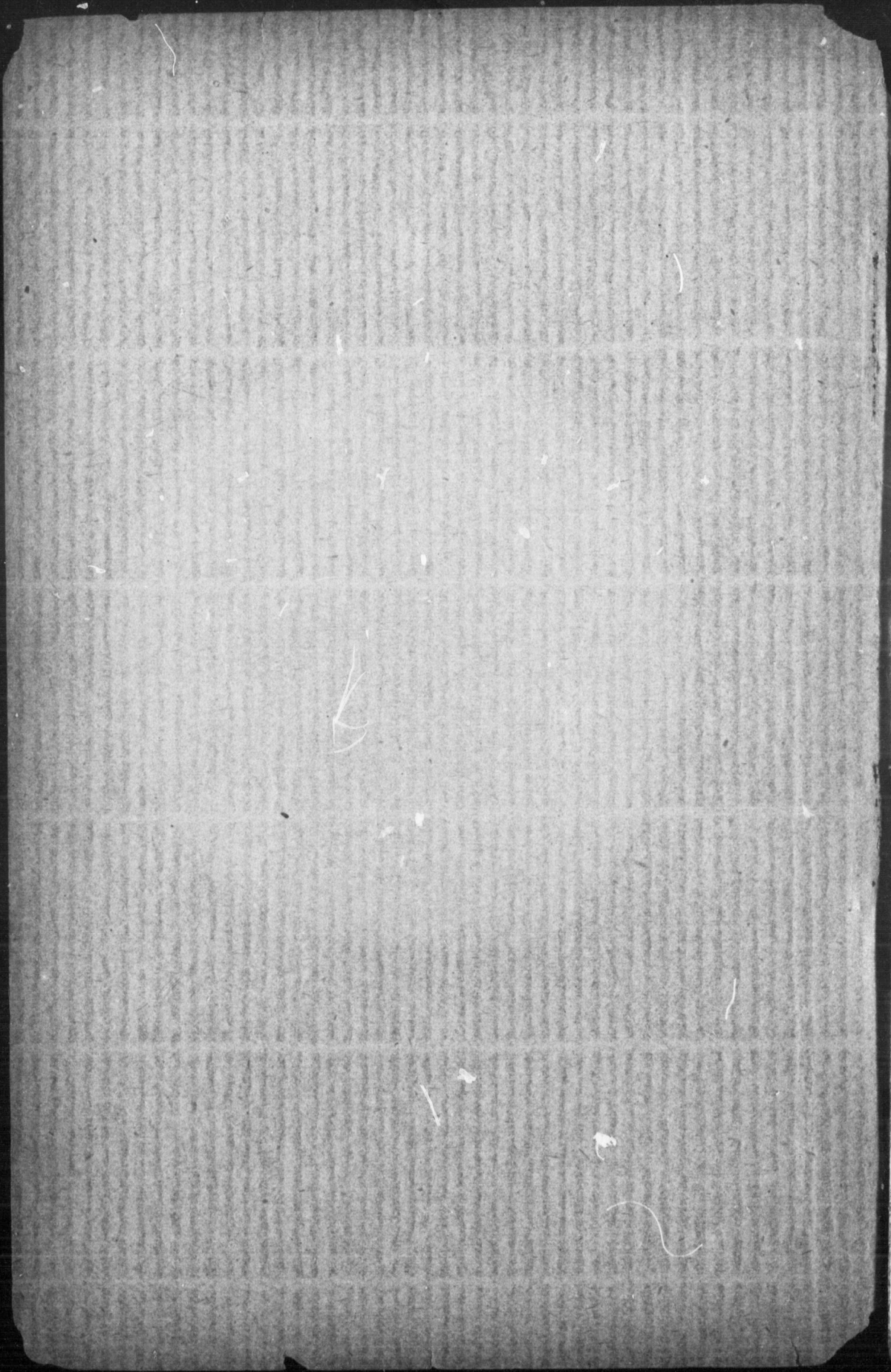

SYNOPSIS OF MINUTES OF THE ANNUAL MEETING OF THE CONGREGATION.

The annual meeting of the congregation was held on the evening of January 12, and was largely attended.

Before commencing the business devotional exercises were conducted by the Rev. Dr. McTavish, who then announced his intention of vacating the chair, upon which Mr. R. Donald was requested to preside, and the Secretary of the Managers was appointed Secretary for the evening.

The report of the Session for the past year was presented by Dr. McTavish, and the Session Treasurer's statement was also submitted.

The adoption of the annual report of the Managers was moved by Mr. Donald, seconded by Mr. Petry and carried.

Abstracts of the results of the work carried on during the year by the various organizations connected with the church were read and a motion was carried for their adoption.

The following gentlemen were elected to act on the Board of Managers during the next two years, viz., Messrs. C. B. Petry, G. H. Meldrum, W. D. Wilson, L. M. Livingston, Jas. Hedley, Geo. Denoon, C. J. Peter, D. Bain.

Votes of thanks to the Board of Managers for the efficient manner in which they have conducted the financial affairs of the congregation; to the members of the choir and auditors for valuable services rendered during the year, and to the ladies of the church for providing the excellent entertainment which preceded the meeting this evening, were unanimously passed.

A motion by Mr. Paton, seconded by Mr. T. A. Stephens, to have the annual printed report of the congregation contain information of precisely the same nature as it contained last year was negatived, and an amendment moved by Mr. Petry, and seconded by Mr. Geo. Anderson, to the effect that the report contain the same information as was given last year, with the exception that the amounts contributed by the members to the church and various missionary schemes be omitted, was carried.

Messrs. Theron Gibson and Peter McCulloch were appointed auditors for the ensuing year.

REPORT OF THE SESSION FOR 1890.

As a Session we express with gratitude our belief that the year just closed has, in several ways, been one of special blessing and interest to the congregation. During the month of March last a few special services were held, in which the pastor was assisted by the Hon. and Rev. R. Moreton of Hamilton. The interest became so manifest that the Session decided to invite the Rev. Wm. Meikle, B.A.—a licentiate of our Church engaged in evangelistic work—to help the minister in continuing the meetings. These services were held continuously for upwards of three weeks, and, we believe, with blessed results. Not only were many unconverted persons led to a definite decision for Christ, but also a large number of professing Christians received a spiritual quickening that has deepened their interest in Divine Truth and increased their usefulness in Christ's service.

During the year we have also had the pleasure of seeing an earnest desire of our hearts realized, viz., in having a representative of our own in the Foreign field. The amount necessary for the support of a missionary in the Foreign field having been volunteered, Mr. Norman H. Russell, B.A., a child of this congregation and a son of one of its first elders, was chosen by us, accepted by the Foreign Mission Committee, and ordained and designated to the work in Central India on the 22nd of September. He has reached his destination in safety, and has entered with bright hopes and high courage upon his great life work for the Master. It is pleasing to remember that while we are having the Gospel preached in our Church at home, our representative is holding forth the Word of Life to the heathen of India.

The various departments of the congregation's work, as reported to the Session from month to month, appear to be in a prosperous condition. The Sabbath Schools and Bible Classes, with their devoted officers and teachers, are increasing in attendance, and, we believe, in spiritual power. A considerable number from these schools and classes publicly confessed their faith in Christ during the year. A very marked step in advance has been taken in the work of the Elizabeth St. Mission.

The property has been purchased from Cooke's Church, and the building will probably be altered and enlarged at an early date to suit the needs of our growing work in that district. The work there never appears to have been more prosperous than at present. This is largely due, under the blessing of God, to the self-sacrificing zeal and earnestness of our devoted fellow-member and missionary, Mr. John Forster, and to his band of noble fellow-workers.

The congregational prayer meeting has been fairly well attended—as prayer meetings go—but as a Session we cannot help expressing the hope that this “spiritual pulse of the Church's life” may be strengthened by the presence and sympathy of many whose faces are never seen there. Without prayer there cannot be power, and whatever else it does a Church can never do its real work without spiritual power. To all our members we would say, “Forsake not the assembling of yourselves together as the manner of some is.”

The Young People's Society of Christian Endeavour is perhaps the most encouraging part of our Church work. The meetings for prayer at the close of the Sabbath evening service have increased until the capacity of the lecture room is taxed to hold all who come. The clear evidence of real spiritual interest among so many of our young people is an augury of future blessing.

The number of members received into Church fellowship during the year was 115; of these 67 were admitted on profession of faith, and 48 by certificate. After deducting removals by certificate and otherwise we have a net increase of 46, making the present membership of the Church 526.

The Sacrament of Baptism was administered to 18 children and 5 adults. The Lord's Supper was dispensed five times during the year, and these were all seasons of refreshing and comfort.

Our Session has suffered during the year by the removal of the Rev. Wm. Burns from our midst. He was always wise in counsel, generous in liberality, and was ready to sacrifice his own comfort for the welfare of the congregation. The departure of himself and his family has been to us a loss indeed, but as that is never lost which a friend receives, we will the more cheerfully bear

it and congratulate Bloor St. Church on this valuable accession to their strength. Another valued member has been removed from us by the hand of death. In the month of October Mr. John G. Campbell, our oldest and one of our most beloved members, was called home to his well earned rest and to his blessed reward. He was a loving and cheerful Christian, and a most helpful and sympathetic office-bearer, and his kindly, genial face is missed by many in the congregation. Other old and esteemed members, such as Mrs. A. S. Thomson, Mrs. Esson and Mrs. Thomas Mair, have also been taken away by death, but leave behind them the blessed heritage of a saintly memory.

To make up for the losses our Session sustained, four new members, Dr. D. J. Gibb Wishart, Frank B. Allan, James P. Donald and Robert Crow, were elected by the congregation and ordained and inducted on the 4th of January, 1891.

We are deeply sensible of our indebtedness to the Choir and its leaders for the assistance they have rendered in the service of praise, and to the Ladies' Aid Society for the invaluable help they have given in relieving the sick and needy. Compared with our possibilities our actualities appear very small indeed, but may we not believe that He who hath begun a good work in us will perform it until the day of Jesus Christ, and look forward to spiritual blessings far above what we have hitherto asked or even thought.

ANNUAL REPORT OF THE MANAGERS
FOR 1890.

The Managers have pleasure in submitting herewith their Annual Report for the year just closed.

At the beginning of the year there was a balance at the credit of Ordinary Revenue account of \$28.85, but owing to increased expenditure—the details of which will be seen from the Treasurer's statement—representing a total outlay, for Congregational purposes, of \$6,651 as against \$6,318 in 1889, the year has closed with a deficit of \$351.62.

To provide for this deficiency and meet the ordinary current expenses of the ensuing year the Managers estimate that the sum of \$123 per week will be required. There are at present 205 regular contributors by envelope giving weekly the sum of \$93.35, and the anticipated average loose collection is \$20 per week, so that, in order to place the Managers in a position to meet the estimated expenses for the year without making special appeals to the Congregation, the regular offerings will require to be augmented by the sum of \$10 weekly. A very small increase of, say, five or ten cents weekly from each contributor will accomplish this, and the Managers would urge upon the members of the Congregation the necessity that exists for an immediate effort in this direction.

In this connection it might be well to remind the members of the Congregation that when the responsibility of providing for the expenses of the Sabbath School and Mission was assumed by the Managers, they expected that those who had been in the habit of contributing specially towards these objects would continue to do so, by increasing their weekly envelope givings. As this was not done, however, the Managers have the greater confidence that the present appeal will be productive of the desired results.

The Managers have pleasure in congratulating the Congregation on a further reduction of the Mortgage Debt. Although the promised payments on account have not quite reached expectations, still with the saving in interest already effected, amounting for the year to \$120, another payment of £350 has been made, thereby reducing the total liability in this connection to £4,300, and leaving a small balance of \$16.58 to be carried forward to next year.

The average weekly collections by envelopes and loose contributions for the years 1889 and 1890 were as follows:

Stephens, diploma; Lloyd Knechtel, diploma. No other school in Canada did as well. A goodly number of our scholars are again going up for examination which will take place shortly.

From the School there have been several additions to the membership of the Church, and there are now twenty-six pupils who are Church members.

A weekly meeting of the teachers held after the prayer meeting for the study of the lesson conducted by our esteemed Pastor has proved very helpful and profitable.

REPORT OF THE CENTRAL PRESBYTERIAN CHURCH MISSIONARY ASSOCIATION.

The Missionary Association have much pleasure in presenting their Annual Report for the year 1890, a year which is of special interest to us both as a congregation and as an association.

In our last year's report a hope was expressed that we would soon be enabled to send a missionary of our own out to the foreign field. We feel that it is indeed a cause for great thankfulness to our Heavenly Father that He has, in the past year, both sent us a young man whose heart seems to be thoroughly in the work, and that He has put it into the hearts of so many of our people to contribute so liberally for his support. A very pleasant and interesting farewell meeting for Mr. Russell was held on the evening of October 22nd, a few days previous to his departure for India, where we are happy to say he has arrived in safety, a letter having been received from him at Port Said.

It is very gratifying for your Committee to note that, notwithstanding the amount contributed for Mr. Russell's support, the total amount contributed for missionary objects has not been diminished, and we trust that this year will bring a considerable increase over last year.

The Committee would respectfully beg to call the attention of the congregation to the fact that out of 285 heads of families and single persons not connected with any family in the Church, only 185 contribute anything towards missionary objects. This is not as it ought to be at all, and we would commend those who do not participate in the glorious work of spreading the Gospel to the prayers of the people that their eyes may be opened that they may see what a great privilege they are missing. What does it mean to be a member of the Church of Christ? Does it simply mean to come to church once or twice a week and listen to a sermon? We hardly think that anyone would be satisfied with that definition. A true member will take part in every branch of the work by presence, prayer and paying out to the full extent of what God has blessed him with, so that His treasury may be full to overflowing. There is not a single member of the church who is earn-

REPORT OF LADIES' AID SOCIETY.

In presenting the tenth Annual Report of the Ladies' Aid Society, we desire to record our gratitude to God for having enabled us to do even a little towards ministering to the wants of His poor.

During the year 1890, seventeen meetings have been held with an average attendance of fifteen.

Fifteen families have been materially assisted. Food, money, coal and wood have been distributed when re-

quired, and in some cases medicine has been supplied. Large quantities of cast-off clothing generously supplied by members of the congregation have also been given away. One woman and her child were kept for two weeks at the Hillcrest Convalescent Home at the expense of the Society. Upwards of 130 articles of clothing as well as some quilts have been made and sent to the Elizabeth Street Mission, where they are sold at a small charge. In addition to the above articles, two text quilts were made for the use of the Nursing-at-Home Mission.

We regret having to record the death of Mrs. Esson, for many years a regular contributor to our funds.

We cannot close this report without thanking the many friends who have so substantially aided us by the handsome collections given in the church, as well as by private subscriptions. We would specially mention also the kind donations of our old friends and staunch supporters, Messrs. Donald and Spence, who are always ready and willing to help us.

We now enter cheerfully upon a new year, feeling assured that we will be assisted in the good work of the future as we have been in that of the past.

REPORT OF CENTRAL CHURCH AUXILIARY
OF THE WOMAN'S FOREIGN MISSION-
ARY SOCIETY, 1890.

The year 1890 marks the close of the first decade of our Auxiliary, and we are met once more, through the mercy and loving kindness of our Heavenly Father, to look over the work we have been allowed to accomplish in His name, and to determine to go forward into another season with hearts more earnestly impressed with the desire to do what we can to assist our missionaries in foreign lands and at home.

During the past year the Society held 10 meetings, with an average attendance of 17 members. There are now on the roll 82 members; 57 of whom belong to the General Society; 8 to the Auxiliary; and 17 are life members—3 new names having been added. Through the kindness

and liberality of one of our members, we have been enabled to make two of the Foreign Missionaries life members of the Woman's Foreign Missionary Society—Miss Blackadder, of Trinidad, and Mrs. Gibson, of Demerara, widow of our late missionary there.

There has been no special effort made to increase our funds which amount to \$251.80 for the year. In October the usual thankoffering meeting was held when we realized the sum of \$79.65. Each contribution was accompanied with an appropriate text of scripture.

We regret to state that numerically and financially we are not so strong as we would desire, yet we have much cause for thankfulness that to many the meetings have been a time of encouragement, and we will remember that it is only by each individual realizing her responsibility for the success of the work that true and grand results can follow.

For kindly advice and supplies of tracts, we would again thank our warm friend, Mr. J. K. Macdonald.

YOUNG PEOPLE'S SOCIETY OF CHRISTIAN ENDEAVOUR.

The Society was formed in the month of November, 1889, with a view of interesting the young men in the spiritual work of the Church. Twelve young men pledged themselves to become active members.

Not long after this the young ladies formed a similar society. These meetings increased in interest, and every one who attended was benefited by it. On September 3rd, 1890, these meetings were united under the name of the Young People's Society of Christian Endeavour.

The weekly meetings are held on Sunday evening after service in the lecture room. An active member—previously appointed by the prayer meeting—comes, takes charge of the meeting, and after a few remarks on a given topic, leaves it to the other members to discuss. As every active member pledges himself to take part, no time is lost, and the meeting is always very interesting.

The last Sunday of each month we have a consecration meeting, at which every active member by experience or verse of Scripture testifies to his faith in Christ and his endeavour to be more like Him.

Besides the regular officers we have:—

A Prayer Meeting Committee who select the topics for the year and the leaders of the different meetings, and are responsible for any defect in the prayer meeting.

A Lookout Committee who solicit and propose new members, and see that the active members fulfil their pledge, especially that of taking part in the meetings.

A Social Committee who welcome strangers to our Society, and in every way endeavour to increase the

friendliness of the members, and have the arranging of socials of which the Society has three or four in the course of a year.

A Missionary Committee to receive voluntary contributions for the support of our missionary, Mr. Russell, etc.

Through our Society over \$120 dollars have already been paid in and more is promised for the support of our missionary.

We are now interested in Cottage Prayer Meetings; every Tuesday evening three meetings are held in different parts of the mission district. Five or six members attend each, and as the work increases in interest to the Society it is expected more will be started, as there are other houses open to us if we will only go to them. On the same evening three of our members conduct the boys' brigade in the mission hall.

Since organizing, our Society has increased over six-fold, as we have now over seventy active and twelve associate members, besides those who have left the city, and three who have gone to the mission field. With our present staff of officers we intend to make our influence felt in the present year, that the congregation may see that we are in earnest in our endeavour of winning souls for Christ, and in strengthening and encouraging the weak and diffident.

REPORT OF THE ELIZABETH ST. MISSION.

During the past year the work in the Mission has been going steadily on, and we are thankful to God for the many indications of good resulting from the work. This is the fifth annual report of this Mission and the progress during the five years has been very encouraging, and with the increased advantages this year we hope to carry on the work better and more thoroughly.

Owing to Mr. John Forster's earnest labours, the meetings this year have been well attended. The Sabbath school roll shows 175 scholars and 26 teachers and officers, and an average attendance of 97 scholars and 21 teachers.

In order to retain the larger scholars a Junior Bible Class for girls has been organized, and we hope that before long there will be one for boys also. The Sunday evening service has been very well attended, there being an average attendance of about 70, and much good has resulted from them. The Band of Hope has been very popular among the children, between 50 and 60 attending regularly once a week. The Boys' Brigade, which was started last year, has been resumed, and though not so encouraging we hope for better results. Collections for the year, \$115.31.

Reports of the other organizations in connection with the Mission will be found elsewhere.

Much credit is due Mr. Forster for his untiring labours during the summer months and also to the tract distributors who, by visiting and in other ways, have attracted many to the meetings.

We would like to thank those who have so kindly helped us in our work, the Ladies' Aid Society, Mrs. Carlyle, Queen St., and others. But above all our Heavenly Father for His abounding blessings.

THE PENNY BANK ASSOCIATION FIFTH
ANNUAL REPORT.

In presenting the fifth annual report of The Penny Bank Association, we are glad to be able to congratulate the directors upon the fact that the Association has attained that financial standing which has been its aim since its organization.

We commenced the year's business on January 1, 1890, with \$1,522.21 due depositors; we received in deposits during the year \$2,291.59, and we allowed interest to the amount of \$52.99, making a total of \$3,866.79; out of this sum we paid withdrawals to the amount of \$2,530.54, leaving a balance on hand due depositors of \$1,336.25. Our assets to meet this sum amounted to \$1,390.08, which gives us a surplus of \$53.83 over all liability. The expenses of running the bank for the year amounted to \$21.10.

The balance due depositors is not as large this year as it was the previous year. This is owing to a number of depositors who had been with us for a long time, and had saved from \$50 to \$100, withdrawing it, and, we trust, put it to good use.

The President looks after the affairs of the bank with a true, fatherly care, and it is due to his judicious management of the funds of the bank that our surplus is so large. And we can especially thank Mr. J. W. McIntosh, the Assistant Secretary, for his services during the Secretary's absence through the summer months. Our Mr. A. I. Forster, the Treasurer, is always faithful in the discharge of his duty. And our staff, we truly wish to thank for the ability they have shown in the management of the bank's affairs.

The Girls' Sewing Class in connection with the Elizabeth Street Mission, having been reorganized at the beginning of November, reports an average attendance of 19. Largest attendance at any meeting 29; smallest attendance at any meeting 8.
