BILL.

An Act to repeal so much of the 32nd Geo. III, Cap. 8, as applies to the appointment of the Keepers of Court Houses in the several Counties in Canada West, and to vest the same in the County Councils.

WHEREAS it is expedient that the nomination and appointment of the Keepers of the Court Houses in the different Counties in Upper Canada, now exercised by the Sheriffs, should be vested in the County Councils respectively; Be it therefore enacted, &c., Preamble.

That so much of the Act of the Parliament of Upper Canada, passed in the 32nd year of the Reign of His late Majesty King George the Third, and intituled, "*An Act for building a Gaol and Court House in every District within this Province, and for altering the names of the said Districts,*" as relates to the nomination, appointment, removal and discharge of the Keepers of Court-Houses in Upper Canada, be and the same is hereby repealed. Part of Act of U. C. 32 G. 3, c. 8, repealed.

II. And be it enacted, That from and after the passing of this Act, the nomination and appointment, removal and discharge of the Keepers of Court Houses in Upper Canada, shall be and is hereby vested in the County Councils respectively. Appointment vested in County Councils.
