An Act to repeal so much of the Act respecting Mutual Insurance Companies in Upper Canada, as authorizes Members thereof to vote by proxy.

WHEREAS great mischief has arisen from the provision in the Act respecting Mutual Insurance Companies in Upper Canada, which enables Members of such Companies to vote by proxy, and it is expedient to prevent such mischief for the future; Therefore Her Majesty enacts

5 as follows:—

1. So much of the fortieth section, or of any other part of the Act respecting Mutual Insurance Companies (chapter fifty-two of the Consolidated Statutes for Upper Canada), as authorizes Members of Mutual Insurance Companies to vote by proxy at elections of Directors, or on
10 any other occasion when the votes of such Members are to be given, is hereby repealed; and after the passing of this Act, the votes of such Members shall not be given otherwise than in person.

vote in person
and not by
proxy
