PROGRESSIVES IN A. O. U. W. ADOPTED NEW RATE SCALE AFTER LONG BITTER FIGHT

Result of Sweeping Victory Over Insurgents Means Doubling of Rates and Financial Success to Organization—Grand Lodge Officers Re-Elected With James McEwing Grand Master Workman.

At 10 o'clock last night the thirty-fifth annual convention of the Ancient Order of United Workmen came to an end, having accomplished the vital business of setting the rate of assessment of members at a scale which insures the financial future of the order.

At the evening session of the A. O. U. W. convention on Wednesday, several members of the order who were not delegates to the convention and had no right to vote, but who had secured the white convention badges and pinned them to their coats, gained admittance to the convention.

The insurgents, led by the Guelph division, vigorously opposed the re-election of Grand Master Workman James McEwing, who received a huge majority in the balloting for grand officers positions. The other officers elected were: Major J. J. Craig of Pergusa, past grand master Workman; grand foreman, W. C. Michel, K.C., of Belleville; grand overseer, J. MILITANTS BURN LADY WHITE'S HOME

Suffragettes' Latest Outrage Was to Cause Twenty Thousand Dollars' Damage to House at Eghat, Owned by Widow of Defender of Ladysmith.

LONDON, March 20.—(Copyrighted.)—The latest outrage of the suffragettes is to burn down the house of Eghat, 20 miles from London, belonging to Lady White, widow of Sir Geo. White, the heroic defender of Ladysmith. The damage amounts to \$20,000. Nothing remained unburned except some outer walls. It has been occupied for a long time as Lady White's home. She is now in a hospital and is unable to leave her bed.

There is abundant evidence that the crime was the deliberate work of the militants. At the rear of the house were found sheets of paper bearing such inscriptions as "votes for women," "Stop torturing our sisters." Other evidence shows the militants before starting the blaze saturated the staircase with oil and opened the windows in order to make a good draught. A short time before the fire was discovered, two women were noticed by the police cycling from the direction of the house, but so far all efforts to trace them have failed.

At the resumed trial of Olive Hocker, in whose studio the suffragettes' arsenal was discovered last week, the prosecution read a letter from Mrs. Pankhurst to the prisoner, which she described as being openly and avowedly a meeting of lawlessness and outrage. Another letter addressed to Olive and signed Dickie, was dated "U.S.A., January 4, 1913." It read: "I have had one or two attacks of nerves about you, thinking you might get into prison. Olive, you simply must not tell I get home, do you hear. Incidentally your mummy doesn't want it."

MOTHER CHARGES TEACHER WITH CRUELTY

Says Her Daughter Was Ill-Treated at Park School—Principal Denies Story and Lays Counter-Charge of Assault on Teacher by Mrs. John Brymer.

The attack of a mother upon a public school teacher has led to a charge of assault being laid by the school authorities against the parent of a girl pupil and a countercharge being made against the teacher of cruelty to a nine-year-old girl. The matter was to have been brought up in the police court before Magistrate Kingsford yesterday afternoon, but as the counsel for the board of education could not be present, the case has been postponed until next Thursday.

When Mrs. Brymer made serious charges against the school staff, the mother stated that her nine-year-old daughter Jenny was most brutally treated. She stated that another daughter, Lizzie, who is a pupil in one of the other classes, was passing Miss Richardson's class room on Monday morning, when she heard her sister shrieking in the cloak room. She rushed in and found Jenny on the floor with the teacher on top of her and beating her across the body. Lizzie ran out of the school to her home, which is only a short distance away, to tell her mother.

Mrs. Brymer states that on arriving at the school, she found her daughter on the cloak room floor in a hysterical and exhausted condition and vomiting. The teacher in the meantime still struggling with the child. She pushed Miss Richardson away from the child, and in so doing knocked her against Miss Suttle, one of the other teachers. That was as far as the assault on her part was concerned, she declared.

The mother says that the reason of the severe punishment was because her daughter happened to speak to another pupil. She further states that it is the second time this year that her daughter has been so roughly handled that she has been taken with vomiting spells. The daughter is now afraid to attend school.

An absolute denial of the mother's statements was given The World last night by Principal Byfield of Park School. Not only does he declare that there is not a word of truth in Mrs. Brymer's story, but charges her with making a vicious and wholly unwarranted attack on a young lady teacher. According to the version given by Principal Byfield, Jenny Brymer was discovered to be showing the results of a lesson to one of the other pupils. The teacher on seeing this ordered her to go into the cloak-room. This girl refused to do so and Miss Richardson, who was in the room, called Clerk Pratt, rising from his chair.

WIDOW CHARGED WITH KILLING ADMIRAL

Mrs. Joseph G. Eaton Arrested After It Became Known That Her Husband Had Died of Arsenic Poisoning—Second Poisoning Episode in Experience of Family.

Special to The Toronto World. BINGHAM, Mass., March 20.—Rear Admiral Joseph G. Eaton, U. S. N., retired, died of poisoning and his widow is charged with murder. She was today arrested, arraigned, pleaded not guilty and held for trial March 28. She is now in Plymouth Jail.

Admiral Eaton died in his bed on March 8, at the home in Norwell, where he lived with his wife, her mother, Mrs. George Harrison, and his step-daughter, Dorothy Ainsworth. The death was unexpected and due to the other members of the family said to an attack of indigestion which followed a two hearty meal of roast pork.

The authorities have known for 10 days that the rear admiral died of arsenical poisoning. In a formal statement the district attorney stated: "Admiral Eaton did not die a natural death. This fact was communicated to me on March 10 by Professor Whitney in a preliminary verbal report, and has been known to the office ever since that time. We have been unable thus far to ascertain where the poison was procured."

Open Court-Room. After the district attorney made his announcement the court-room where the secret inquest had been going on was thrown open. First came Deputy Sheriff Condon, then Mrs. Eaton, State Officer Scott, Mr. Geogan and last, District Attorney Barker.

Mrs. Eaton was wearing the black mourning veil that she wore at the funeral of the admiral. Her color was high, but she did not appear the least bit nervous, nor was there any vestige of a tear. She was entirely composed. "Jennie May Eaton," called Clerk Pratt, rising from his chair.

ASQUITH CABINET MAY BE UPSET BY LIBEL

Revelations of Speculation by Ministers in American Marconi Stock Cause a Sensation—Explanations Not Satisfactory, For Public Wants Officials Above Suspicion.

LONDON, March 20.—(Copyright.)—The Paris Matin libel suit is causing the most profound agitation in ministerial circles, where it is feared that in certain eventualities it may involve the existence of the Asquith cabinet, to say nothing of the future careers of Attorney-General Isaacs and Chancellor of the Exchequer Lloyd George.

A distinctly disagreeable impression was caused by Attorney-General Rufus Isaacs' admission in the suit against the Exchequer, Lloyd George and the chief whip, now Lord Murray, who resigned some months ago, to take a position in Lord Cowdray's Mexican enterprise.

Lost on Deal. It is true that the American company had nothing to do with the English company, which made the much discussed contract with the English Government, and it is also true that the stock was purchased at a premium and not at bottom prices, so that the attorney-general lost on the transaction. But it is felt that the minister should not have touched any Marconi stock in view of the negotiations of the English Marconi company with the post-office, especially as the attorney-general's brother was conducting those negotiations.

The positive, unqualified denial uttered in the house of commons by Lloyd George and Isaacs that they ever had any dealing direct or indirect with Marconi stock, tho they referred only to the English company as being alone concerned with the post-office contract, are now reprinted, and they certainly appear to lack candor in view of the attorney-general's admission.

Certain Unionist papers, notably The Morning Post, argue that the so-called standers on the ministers were after all not without justification, and the whole episode is far too useful for party purposes to be allowed to go unutilized.

Affects Libel Suit. The revelation may seriously affect the decision of the criminal libel suit which Isaacs, in conjunction with Postmaster-General Samuel, is bringing against Cecil Chesterton, the editor of The Eye Witness, who has been roundly abused by the ministers of gross personal corruption.

Experience has shown in the last few years that any Liberal who sues for libel before a London special jury gets merely a contemptuous verdict or none, and with the 10,000 share transaction admitted, tho it affords support to Chesterton's allegations, it is quite probable that Isaacs and Samuel may fall to obtain a verdict—a result which might be disastrous to the government.

Former Tory Member. Even some supreme court judges fall at times to take as severe a view of libel as the Liberals do against Tories. Justice Darling, who presided

SHOCKING CHARGE MADE AGAINST WILSON

American Ambassador to Mexico Knew That Madero and Suarez Were to Be Murdered and Refused to Intercede—Diaz Backed by British Capital.

SAN FRANCISCO, Cal., March 20.—Felix Diaz was backed by Sir Whitman Peckson and English capital to the extent of \$1,000,000 in his recent revolution against the Madero administration, is the statement made by Col. Manuel Bliche Alcalde, personal friend of the former president, an officer in the army and editor of The New Era, a newspaper in Mexico City. Col. Alcalde arrived in this city on the steamer Asapalco today in company with his brother, Capt. Johnin Alcalde, his wife and two small children. All were refugees from Mexico. Col. Alcalde himself being under death sentence. He makes a shocking charge against the American ambassador, "Ambassador Wilson of the United States informed myself and Mrs. Madero, the widow of the former president the morning before he was murdered that the proposed revolution would be killed inside of 24 hours. He said it was the best for the republic and refused to intercede," declared Col. Alcalde.

Became Mysterical. "Mrs. Madero's behavior became hysterical. She refused to leave the embassy and she demanded justice in the name of civilization and the Christian world, but your ambassador refused to listen further."

President Madero at this time was in prison at the National Palace. That night he was taken from his room in company with Vice-President Suarez by his guards and escorted to the palace stable in rear of the mansion. A captain of the 20th Battalion committed murder. He used a dirk. President Madero was stabbed to his death and Vice-President Suarez was choked to death.

Their bodies were then placed in an automobile under the presence of their

Parliamentarians at Ottawa Do Not Consider Situation Much Clearer—Some Conservative Members Regard Premier as Too Magnanimous For Success of Party Ends—Rogers the "Man Behind," Says Liberal Organ.

OTTAWA, March 20.—In the opinion of members of the house still in the city the manifesto issued last night with the authority of the prime minister has not greatly altered the situation. The government has all along been face to face with a dilemma of closure or dissolution, and has always and steadfastly maintained that the latter alternative was out of the question.

The Liberals, greatly emboldened by the success of their hold-up during the fortnight ending last Saturday night, are proclaiming that closure cannot be forced thru unless the speaker arrogates to himself powers not at present conferred on him by the rules of the house. They are prepared to go to great lengths unless restrained by the unmistakable public opinion of the country.

Borden's Restraining Hand.

The Conservatives, who were boldest in the battle during the two weeks' struggle, frankly admit that the prime minister may in the end prevent them from carrying out the program virtually agreed upon for passing closure thru the house, in spite of all protests from the opposition. They are even complaining of Mr. Borden's pacific counsels of last Saturday night, which undoubtedly prevented a disgraceful scene of violence.

Mr. Borden, seen at his office today, has no comment to make upon the letter of Arthur Hawkes, published in this morning's World. He said there was no objection to Mr. Hawkes making public the prime minister's reply, which was to the effect that Mr. Borden had publicly stated his position on many occasions, and saw no reason why he should be called upon to restate them by letter.

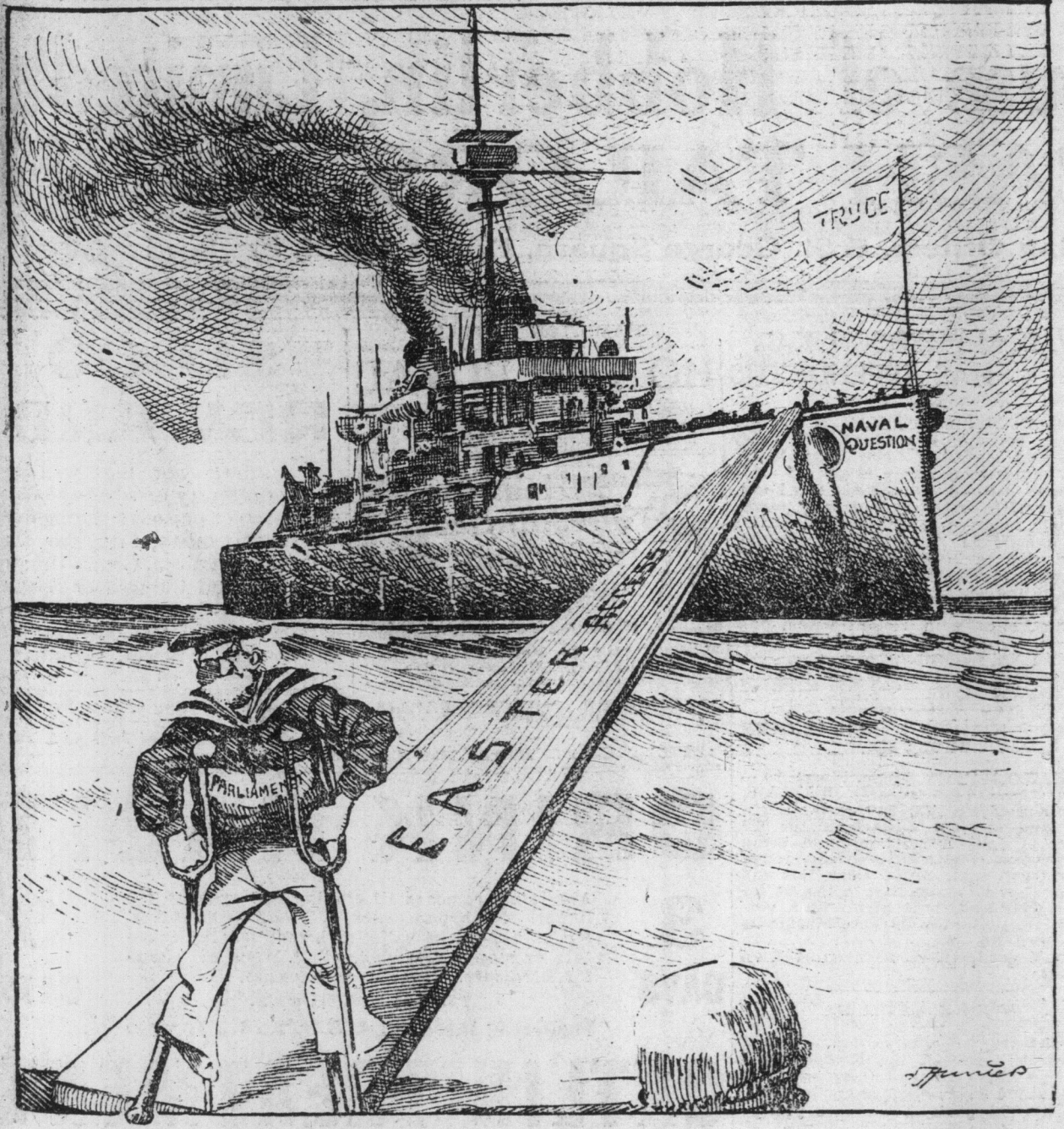

ROUTE OF HYDROGRAPHERS AGREE UPON

Southern Line Endorsed at Enthusiastic Conference of Municipalities Held at St. Thomas.

ST. THOMAS, March 20.—(Can. Press.)—That it is the opinion of the southern route of the hydro-electric line, is by far the most preferable.

That the question of the route or points where the line should touch should be left in the hands of the Hydro-Electric Commission, who naturally will ascertain the views of the different municipalities interested, and run the line where it will be of the most service to such municipality, and that each district on the southern route be requested to procure all necessary facts and data that would naturally assist the commission in arriving at a conclusion.

The above resolution was unanimously passed at a meeting of representatives from all the municipalities along the shore of Lake Erie at a meeting held here this afternoon, after an animated discussion. It was brought out by the speakers that there was a population of 57,601 along the southern route, against a population of 28,408 along the proposed northern route. The assessed valuation of the southern route is \$22,243,496, while that of the northern route is only \$20,353,494.

FORMER PRESIDENT OF HARVARD OFFERED BRITISH AMBASSADORSHIP

WASHINGTON, D.C., March 20.—Charles W. Elliot, president emeritus of Harvard, has been offered the ambassadorship to the court of St. James. The World is able to state this on high authority.

President Elliot has had the offer under consideration for several days, according to The World's informant, and the only obstacle in the way of his accepting the post is his age. President Elliot believes he is too far advanced in years to actively engage in public life. He will inform the president in a few days of his decision.

COL. MEEKING'S BODY EXHUMED GREAT SENSATION IN LONDON

He Died Suddenly Last Year and Relatives Have Been Unsatisfied as to the Real Cause of His Demise.

Satisfied as to the real cause of death, which the attending physician had certified as due to heart failure, Meeeking left a personal estate, net value \$3,121,535, besides real estate and settled property of considerable value. In 1843 Col. Meeeking married Lady Adelaide Tower, grand-daughter of the first Lord Brownlow. She died in 1903 and four years later the colonel married a French lady, Sybille Dedens de Piensien, Countess de Coligny. EIGHT HOUR DAY FOR ALL MINERS

Hon. W. H. Hearst Introduced Far-Reaching Bill to Legislature Yesterday.

RESULT OF AN ENQUIRY

Legislation Will Not Apply to Those Not Working Underground.

Hon. W. H. Hearst, minister of lands, forests and mines, introduced a bill yesterday in the legislature which means that no miner shall be allowed to remain underground in any mine for more than eight hours a day. This legislation, which was given its first reading, embraces the recommendations made by Commissioner Price, who was appointed by the government to investigate conditions in all the mines of the province. Mr. Hearst, in reply to a question by Mr. Rowell, stated that the bill covers the entire mining industry, save that of iron, of the province, and will make an eight-hour-day compulsory upon all employers and operatives. The reason for the exception of the iron mines would be given later.

The bill says, in part: "No workman shall remain or be allowed to remain underground in any mine for more than eight hours in any consecutive 24 hours, which eight hours, where the employer obtains from the inspector's certificate that the means and methods in use at the mine of getting to and from the place of work are proper and satisfactory shall be reckoned from the time of arriving at such place of work until the time of leaving such place, otherwise such eight hours shall be reckoned from the time of leaving the surface until the time of returning to the surface, or, in such other way as the inspector may direct."

The Saturday shift may work longer hours for the purpose of avoiding work on Sunday or changing shift at the end of each week, or giving any of the men a part holiday.

The eight-hour-day will not apply to shift bosses, pump men, or persons engaged solely in surveying or measuring, nor will it apply in cases of emergency, where life or property is in imminent danger, or in cases of repair work, or in any mine where the number of men working in the shift does not exceed six.

The bill gives the lieutenant-governor in council the right to suspend the operation of the eight-hour day in the event of a great emergency or grave economic disturbance, to such an extent as he deems fit.

GETS \$40 A WEEK FAMILY STARVED

Morris Ainsky Went to Jail Rather Than Supply Food.

HE LIVED WELL HIMSELF

Ate Meat While Wife and Children Had Bread and Water.

An owner of property worth over five thousand dollars, and whose income as a partner in the Canada Steel Company would bring him more than forty dollars a week, Morris Ainsky of 183 West Adelaide street, goes to prison rather than support his wife and three children. On his refusal to give his wife \$8 a week, he was given a six months' jail term by Commissioner Starr yesterday.

According to the story told by the man's wife, the family have been forced to live in two rooms with but scant furniture, and for 2 years past have lived on bread and water. The wife and children have been dressed in rags and have not even been provided with underclothing during the severe winter weather. Ainsky himself had the habit of bringing meat and other articles of food into the dwelling and taunting his family by having them watch him eat while they had only bread and water.

Commissioner Starr, after sending the husband down, advised the wife to apply for alimony.

RECORD NAVIGATION ON ST. LAWRENCE.

BROCKVILLE, March 20.—(Special)—The ice broke in the river sufficiently today to enable the steamer Biglow to resume her trips between here and Morrisstown, which marks the opening of navigation on this portion of the St. Lawrence. The boat ran up to Feb. 8, so that the ice bridge, which then formed, kept her out of commission less than six weeks, which establishes a new record.

HOUSES BURNED AT ST. KITT'S.

ST. CATHARINES, March 20.—(Special)—Two new houses on Niagara street, near the northern boundary of the city, were completely destroyed by fire from an unknown cause this afternoon. The loss is placed at \$300, partially covered by insurance. The houses were owned by George Anderson, whose father a few weeks ago was kicked to death by a horse.

W. D. McPHERSON, K.C., HAS APPENDICITIS

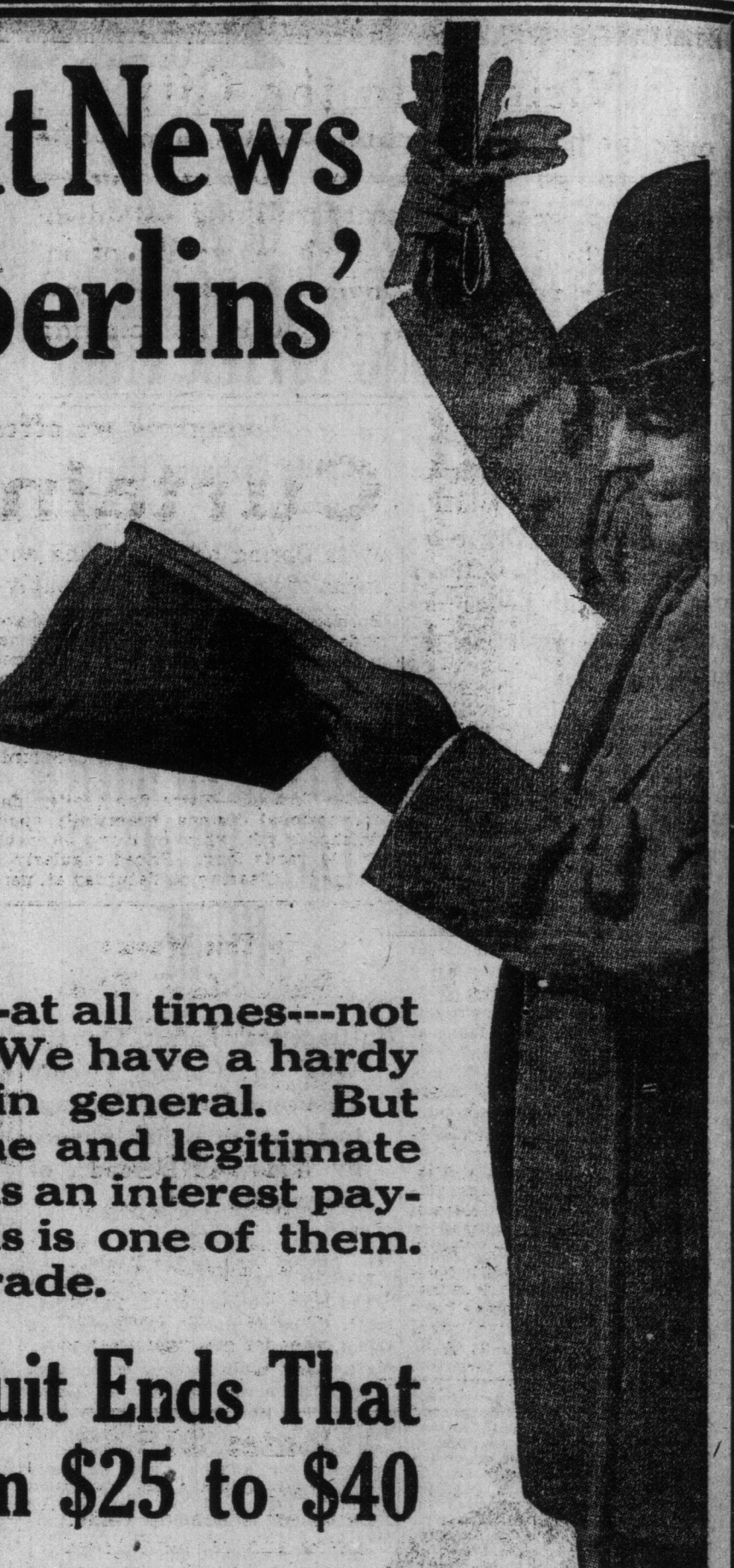

GRAND HAVEN, Mich., March 20.—(Can. Press)—Nineteen fishermen, after suffering all the terrors that hunger, cold and the menace of the ice crags of Lake Michigan could bring upon them, reached port here today in the fish tugs, Anna, Dorn Bos and Bos. They had been fast in the ice for three days and three nights until rescued yesterday by Pere Marquette car ferry No. 18. The boat left Grand Haven at dawn Monday.

STRIKE SETTLED.

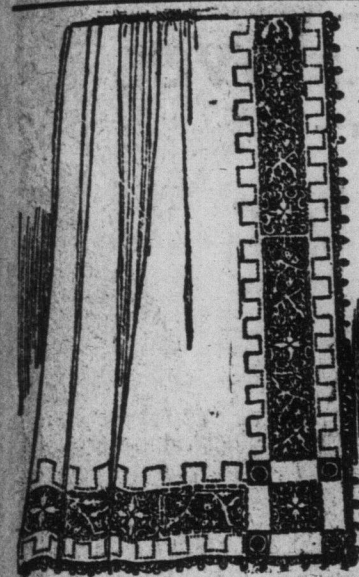

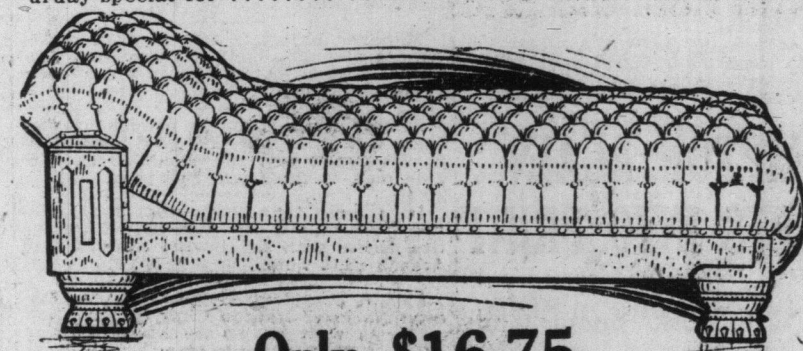

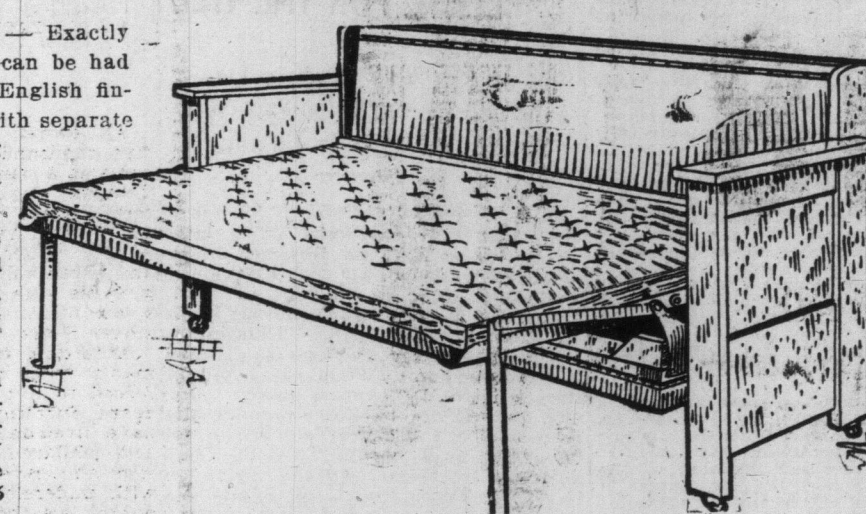

WIDOW CHARGED WITH KILLING ADMIRAL

She stands until Friday next week at 3.30 o'clock in the morning, until which time you stand committed to the Plymouth County jail without bond." Sheriff Condon then led her from the court room to a small ante room. The extreme calmness with which she took the ordeal was unchangeable to the very end.

No Bail Needed.

Mr. and Mrs. A. F. Jacobs, who had been summoned as witnesses at the inquest, which has now been closed, were in the court room at the time of the arraignment of the admiral's widow. The district attorney told them they would be wanted as witnesses in the trial, but he allowed them to leave without furnishing any bail for their appearance in court later.

At Plymouth prison, after changing her clothes to the prison garb, Mrs. Eaton called for writing paper and newspapers. "I want to keep busy while here," she said to Sheriff Porter, "just as I would if I was still in Assinippi with my household work to attend to."

Baring Home Life.

For ten days, or since the authorities first learned of the presence of arsenic in the rear-admiral's stomach, the authorities have tried to ascertain where the poison was bought, and have made every effort to lay bare the home life of the Eaton family. In the first quest they have not been successful. Along the second line of enquiry, a wealth of evidence has been furnished by friends of the family and neighbors. The picture was not an altogether pleasant one. The admiral and his wife, who was 20 years his

junior, did not always agree, it was said.

Both Married Before.

Both had been married before. The admiral's first wife was Mary Anne Varnum, whom he married at Draught in 1871, when he was a lieutenant in the navy. From his graduation at Annapolis until his retirement at the rank of rear admiral in 1905, the life of the naval officer was filled with honors, and he acquired a fortune.

Soon after his retirement he met Mrs. Jennie May Ainsworth, the daughter of George Harrison of Alexandria, Va. Mrs. Ainsworth later divorced her husband, D. H. Ainsworth, an employe of the senate at Washington, and she and the admiral were married in 1907.

Their courtship and relations after marriage were described by the admiral in a statement which he made during a brief estrangement from his wife four years ago, when he said: "I met Mrs. Ainsworth in Chicago, and at that time thought she was a widow, but, in fact, she was not actually divorced from her husband. It was not until just before my marriage that I learned she had a husband. Then she told me that her husband was alive and that she had just obtained a divorce from him in their rounds of drunkenness and desertion."

"During the time that I paid attention to her, knowing her straitened circumstances, and thinking that her husband was dead, I helped toward the support of herself and children, giving her money, but at the time I did not know for what purpose she was using it."

Paid for Divorce.

"Later, after the marriage, I learned inadvertently that I had been paying for her divorce proceedings which she had instituted against her husband. I married her because I had said I would, and was too much of a gentleman to withdraw my promise. She has always been a good wife." "Disappointed that a child had not been born to them, the admiral, about two years after his second marriage, secretly adopted an infant which he proclaimed as his own. The deception was successful for the time, but the baby died when but a few months old.

Mrs. Eaton declared that the infant had been poisoned, and an examination of the stomach was made. No poison was found, but as a result of her charge, Mrs. Eaton was estranged from her husband for a brief period. Then they were reconciled and again lived together.

With them at that time lived the two daughters of Mrs. Eaton by her earlier marriage, June and Dorothy. The former is now the wife of Ralph I. Keyes of Boston.

Strange Experiments.

It was said that Ainsworth, Mrs. Eaton's first husband, renewed friendly relations with his family, and was an occasional visitor at the home. It was about this time that Mrs. Eaton said that her husband was much interested in drugs and their effects upon persons and devoted much of his time to strange experiments. After their marriage the Eatons came Brookline. Soon afterwards the rear-admiral met with financial reverses and in his last days led an unpretentious life on a poultry farm in Norwell. His principal income was from his allowance as a retired naval officer, which amounted to \$4000 a year. It is understood that his estate is represented largely by a life insurance policy for \$6000.

"NEVER AGAIN," SAYS MAXINE ELLIOTT

Nat Goodwin's Former Wife Is Not Engaged to Tennis Player.

LONDON, March 20.—(Copyright).—"Never again," says Maxine Elliott, Nat Goodwin's former wife, in a cablegram from Cannes, Southern France, denying the rumour that she is married to Anthony F. Wilding, the international tennis champion. She adds: "I am not engaged and never intend to be." Mr. Wilding also denies that there is

any truth in the report that a marriage between Wilding and Miss Elliott took place last Friday in New York. He also informs The World that he will not go to the United States this year to play for the Davis Cup, inasmuch as he will have to remain here to practice for his title at the international tennis championships.

SIR LIPTON AGAIN GETS INTO PRINT

Tells New York Yacht Club Why His Challenge Should Have Been Accepted.

BELFAST, Ireland, March 20.—A request was sent to the New York Yacht Club, asking the Royal Yacht Club for a reconsideration of its refusal of Sir Thomas Lipton's challenge for the America's Cup. This was accompanied by a long statement from Sir Thomas Lipton, with which the committee of the Irish club signified its agreement.

The committee hopes that the harmonious relations of the two clubs will be further cemented by another successful series of races and therefore requests the New York Yacht Club to reconsider its challenge.

Sir Thomas Lipton's statement is as follows:

"I deeply regret that the New York Yacht Club has been unable to accept my challenge. After reading the explanation given of its refusal, I can only conclude that the challenge and the intentions of the challenger have been misinterpreted. The deed of gift states: 'The competing yachts or vessels if of one class shall be built not less than 66 feet, nor more than 90 feet at the water line.' The deed of gift also states that there shall be no time allowance.

"It must be presumed that the framers of the deed of gift intended that some reasonable meaning should be attached to their words, and they could never have contemplated such an absurdity as a challenger of 66 feet being met by a 90-foot defender.

"The deed of gift also requires that ten months prior to the race the challenger shall communicate the dimensions of his yacht, which dimensions shall not be exceeded. If the real meaning of the words quoted is that the challenger is the person to fix within the limitation of the deed of gift, the challenge is a challenge for a variation from the deed of gift in general rule. No such variation is asked for in this case and I fail to see that there is any analogy between the two challenges.

"It upon reconsideration, which I am sure enough to give this matter, they accept my interpretation of the deed of gift, I shall be happy to remove from my challenge the words to which they object.

"Thomas J. Lipton."

TWO MORE TROTTERS LEAVE FOR THE WEST

"K. of K." and "Tropic Dawn," Owned by W. J. Cowan, Will be Raced by Billy Fleming.

The exodus of eastern horsemen for the west still continues. The latest to decide to try his fortunes in the Western States is Billy Fleming, trainer of W. J. Cowan's horses at the Maple Stock Farm, Cannington, Ontario. Both are trotters and of the most promising kind. The former has had very little training, but is regarded as a superior colt. The filly raced some in the west last year as a 3-year-old, and it was on the strength of her performance at actual racing that Mr. Cowan bought her. Fleming will stop over at Chicago long enough to pick up a pacer for the rich 2.10 classes on the western circuit, and rumor has it that he will exercise an option obtained some time ago on a crack performer of the middle west last year.

Billy Fleming, it will be remembered, drove Joe Patchen II, 2:33 1/2, for R. J. Mackenzie last year on the big tracks, when that pacer was the leading money-winner of his set. He is an experienced driver, also last year was his first in high society, nevertheless he has been more than ordinarily successful on the half-mile tracks of Western Canada, where he has raced for a number of years before joining the Mackenzie stable as second trainer for Harry James. Fleming is as fearless as they make them, and is cool as the ever-green cucumber. He has a good pair of hands, is a good judge of pace and few teamsters have anything on him when it comes to "sighting" a trotter or pacer. He proved to be one of the most popular drivers that ever went down the line with a great horse, and his many friends will wish him every success in his forthcoming campaign out west.

Mr. Cowan, the owner of the horses that Fleming is to race this year, is an intimate friend of R. J. Mackenzie, and is the man who signed the cheque in payment for Joe Patchen II, when that noted pacer was bought of Thos. Hodgson of Orillia. He has extensive interests in Western Canada, where he is engaged in construction work on the Canadian Northern transcontinental lines.

Mr. Cowan is comparatively a new man in the ranks of campaigning owners, although he has conducted a model breeding farm at Cannington for several years. Few there are at all familiar with the horse that do not know "Jim" Cowan, and all know him to be a thorough sportsman in every sense of the term. He is worthy of all the good luck that can come to an owner.

GOOD FRIDAY.
 Good Friday, which is little more than a pleasant holiday to the mass of people, in the church circles one of the most sacred and solemn holy days of the ecclesiastical year. It is not necessary to enter into the controversial aspects of the questions that surround the establishment of such days or festivals. It is sufficient to recognize that Christendom is by no means united as to the necessity or propriety of such observances. This is more particularly true, of course, of the non-conformist churches.

There is a historical side to the question, quite outside church circles, which is constantly assuming greater importance in the schools. It is quite clear that the Christian fasts and festivals took the place of other celebrated on corresponding dates from the remotest antiquity. Religions which were ancient before Christianity or Judaism had an existence observed these dates for reasons and in ways which, but for a difference of names, were practically identical with our later forms. The study of comparative religion has emphasized facts of this kind, but, unfortunately, the emphasis generally seems to have been laid on the wrong place in considering the results. Christian scholars seem especially irritated at anything coming from early or alien sources which would tend to confirm the principles they adopt without recognizing the forms with which they are familiar.

The general tendency appears to be to find a broader basis for the principles of religion than sectarianism of any shade seems pleased to have forced upon it. Every form of religion is inclined to lay great stress upon its own uniqueness, and each resents the idea that it is not unique, but is paralleled elsewhere. But there can be no doubt of the broadening influence of the study of comparative religion as "Christianity" among very weak men there may be a tendency to think less of a good thing because it is not so rare as was supposed. But sensible men welcome all reinforcements to the army of justice, or, as the Bible translators made the word, righteousness. The Master Himself declared, "He that is not against us is with us." His disciples then and since are somewhat dubious about the statement.

The time may come when Good Friday and Easter Day will be regarded, thru the influence of some great unifying religious movement of the future, as occasions for celebrating the life and uprising, in the widest sense, of the Master of Life, not only in the Perfect Man, but in Perfect Man and a Perfect Humanity, and, not less, in the consummation of the sacrifice, mystical and spiritual, as St. Paul conceived it, and as St. John recorded it, of "the Lamb slain from the foundations of the world."

WILSON REVERSES TAFT'S POLICY
 President Wilson has disapproved the "dollar diplomacy" initiated by President Taft and his secretary of state which they were inclined to regard as the high water mark of their foreign policy. The immediate matter before the president was a request from the United States banking syndicate connected with the proposed Chinese loan for an explanation of the attitude of the new administration towards the scheme. The syndicate did not become associated with the banking groups of the other participating nations of its own volition, but in response to a request received from the United States Government and only on condition that it had the backing of the administration. Its appearance on the scene was not particularly welcome to certain of the powers, but, supported by the government, its claim to participate was conceded and the "six power group" was formed, consisting of representatives of Britain, France, Germany, the United States, Russia and Japan. Loans to China have usually had a political string attached to them, and it was of course this presumed advantage which underlay the course of the several governments.

As the terms offered were not acceptable to the Chinese Government, the negotiations were protracted and met with a snag in the shape of an advance made by an independent group of bankers, headed by Clegg & Co. of London. President Wilson has now made it clear that his administration will not be a party to the pledging of particular taxes, some of them antiquated and burdensome, to a cur-

rency, nor assist in requiring the administration of those taxes by foreign agents. He regards the assumption of responsibility of that kind, even by implication, as obnoxious to the principles upon which the United States Government rests, and he foresees that such an assumption might lead to forcible interference in the financial and even the political affairs of China, "that great oriental state, just now awakening to a consciousness of its power and its obligation to its people." The United States has always stood for the integrity of China, and this decision of the president restores its liberty of action in that connection.

LOCAL IMPROVEMENT CAR LINES
 The World seems to have shared in the misconception which was widely spread concerning the proposal to lay street car lines on the local improvement system. The explanation that the local improvement system is not intended at all somewhat relieves the situation. It may also allay the enthusiasm for the plan which was developing in some quarters.

What The World objects to, and would continue to object to, is the suggestion that both of petitioners, or groups of residents, or local interests of any kind, either directly or thru an alderman, should have the power to go before the city council and lobby for street car lines. The initiative for laying all such lines should not be vested in the aldermen or anyone behind the aldermen, but in the expert or experts constituted by the city as the authority for that purpose. No line should be laid which does not have the prospect of supporting business before it in the view of the city authority, whether that authority be a traffic commission or the city engineer. A local improvement plan would load the city up with lines doubtful as business propositions and based only on the hopes of real estate promoters.

Ald. Wickert refers to clause eleven in report number two of the special committee on transportation:
 "In so far as street car lines are concerned the local improvement plan would not mean that any street by petition could get better lines, but would, of course, be applicable only to a general traction scheme to be developed and adopted by the city."

He asserts that this covers everything in The World's contention. No doubt the intention is good, but we think the issue should be much more clearly defined. If Ald. Wickert is correct, then far from the plan being a local improvement scheme, all that the ratepayers could do would be to come forward should there be any delay in carrying out any part of the "general traction scheme to be developed and adopted by the city," and offer to assist in the financing of that portion in which they were concerned and so hasten its construction. If any ratepayers wish to do that, under the circumstances we note, no one could have any objection. But all this ought to be made perfectly clear.

We doubt if it will be necessary for the city to hold up any part of the "general traction scheme" for lack of funds. The civic lines will be a paying proposition from the start. They must be considered as a whole, and they must be considered in connection with the street railway company's franchise, which has only eight years of its life to run.

RADIUM AS A HEALING AGENT.
 From an editorial in the current number of the Canadian Lancet it appears that the official report of the work carried out at the London (Eng.) Radium Institute has just been issued, covering the period from August 14, 1911, to December 31, 1912. All kinds of cases were asked for and treated, and 637 patients were admitted for purposes of treatment and observation. The findings in general correspond with the results observed by other workers. Certain forms of malignant disease were found to be amenable to the action of radium, in which it had an alleviative effect, while in other cases no benefit was derived, or treatment was abandoned. However, the report is sufficiently satisfactory to justify the establishment of the institute and to encourage further experimentation.

FELL INTO CELLAR WAS BADLY INJURED
 After having spent the night in a deep cellar excavation, into which he had fallen, a man, 40 years of age, was discovered in a critical condition yesterday morning by two men from his home at 48 St. James' street. Collins had been proceeding to St. James' Anglican Church for the evening service, in the basement level of the excavation which had been started to protect pedestrians from a deep excavation just north of Howard Park avenue, where three stores are to be erected. He fell down the hole and received injuries which rendered him unconscious.

On being found yesterday morning he was rushed to a motor car hospital, where he now lies in a serious condition.

KINGSTON ARCHITECT DEAD.
 KINGSTON, March 19.—(Special.)—Herbert Smith, aged 47, a leading architect here for many years, died today after two weeks' illness from pneumonia. He was a prominent member of Catholic societies and the yacht club, having been secretary of the latter institution. He is survived by a wife and one son. Many fine buildings in the city were erected under his plans.

KINGSTON NEEDS.
 KINGSTON, March 19.—(Special.)—The board of education will ask the city council for \$223,395 for high school purposes and \$36,425 for public schools. These figures contain an appropriation for building technical education. Three large additions are to be made to schools during the year, and ultimately the amount required for the year will be about \$100,000.

Interesting Clash and Humorous Repartee at the Hearing.

Until yesterday afternoon the hearings held by Sir William Meredith on the Workmen's Compensation Act...

"I will not venture any suggestion when the clause is taken out of its context," said Mr. Wegenast.

"Don't you think, Mr. Wegenast, you should get down from your pedestal?" asked Sir William.

"No, Sir William, I am sorry, but this is the position I am obliged to take."

"Then I shall report that the gentleman who represented the manufacturers at this enquiry has refused to give any assistance in the preparation of the bill."

"Then your lordship will report what is untrue. I have devoted three years to the investigation," was Mr. Wegenast's heated retort.

Sir William: Is \$10 week too much to place as the average wage of the average working man in Ontario?

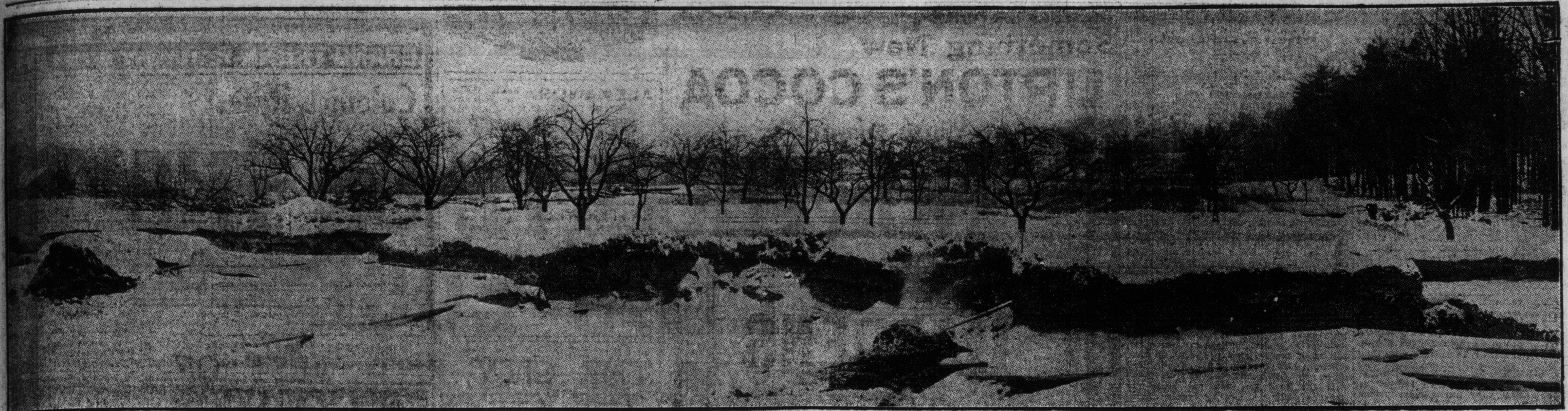

BUYING OF BUILDING LAND IS FEATURE OF REALTY MARKET

Persistent Enquiry For Lots For House Construction Is Predominant Note in Property Activity—All New Sections in Demand.

Agents who anticipated that the heavy sale of building land that was an unusual feature of winter business would mean a lesser turnover during the spring, admit cheerfully that they were out of their calculations. The past week has brought forth a wider and heavier enquiry, with larger resultant sales, than any similar period for months. Real building land, land improved sufficiently for the builder to go ahead with his work, is the most saleable thing on the realty market. The builders are not asking that every improvement be in, water and sidewalks suffice. They will wait for the sewers and the permanent pavements, and they are prepared to look ahead of the cars, provided the car-civic cars—are in operation this summer. They must have water connections for their building work. Level building land, in localities restricted to brick fronts only, brings from \$25 up, with only odd pieces at that figure. Vacancies on which can be built houses to sell from \$3500 to \$4500, bring \$45 to \$55 on an average, and builders often find it profitable to pay a little more for their frontage because of the added readiness in sale that the locality might bring. Building land with water in and improvements applied for, and in reasonable proximity to a projected car service at less than \$5, is scarce indeed and does not stay long on the market. Until there is more of it few six-roomed brick front \$2800 to \$3000 houses will be available, and this is the class of house thousands of people would like to buy. Until there are

more of this kind of land the great majority of people will continue to double up and those congested conditions that semi-philanthropic housing companies hope to relieve, will monthly be intensified. A few car lines out into the open fields about the city, and there would be no need to talk housing companies and labor in famines, and thousands upon thousands of feet frontage at \$35 would be available to the wage-earner. Heavy Sectional Sales. Cheap building land is scarce, but high-class property is just about as difficult to secure. There seems to be plenty of really good property on the market, but that is an appearance given by the plentifulty of publicity that the good lots receive. Builders are snapping up all the better class lots for this summer's work, and soon there will be practically no improved land available unless the city hurries along its spring improvement installations. The continuous and heavy purchases of North Toronto properties like Lawrence Park, Glebe Manor, Alexandra Gardens, Ansley Gardens and other desirable homelike locations are examples of the demand; and in Moore Park on the hill, in the St. Clair avenue section, along sections naturally favored in the Gerrard and Danforth districts, there is also a splendid volume of turnover. Much of the Business "Resales." A great deal of the lots being taken up by builders in subdivisions are "resales"—lots bought by investors from the subdividers, held a few months while improvements were approaching and coming in, and then turned over the builder. The record in Toronto is that few lots go direct from the real estate man who carries them from acreage into frontage to the builder. The reason is that the builder uses all his financial powers for quick purchases of land, for immediate building and for a speedy turnover. The middleman has great opportunities in building land.

SKYSCRAPER PROMOTERS WILL HAVE TO FIGHT FOR PERMITS

Council Decides to Stick to One Hundred and Thirty-Foot Limit in Future—Thick Walls Clause For Tall Buildings Discarded—Apartment House and Private Dwelling Rooms Must Have at Least One Window Opening to External Air.

Resuming consideration of the proposed building bylaw yesterday afternoon the city council by a close vote decided that the provision that certain walls must be increased by four and one-half inches in thickness below the uppermost 75 feet of the building and by an additional four and one-half inches below the uppermost 135 feet, adds no appreciable security to the building and should be removed from the bylaw.

School buildings were removed from the list of those that must be fireproof if over thirty-five feet high. After much discussion and voting on three amendments the clause limiting the height of buildings to 130 feet was adopted. The clause to prevent dwellings on front and rear of lots was strengthened, and another clause makes it imperative that every room of an apartment house or any dwelling must have a window opening to external air.

YORK ST. SALE AT FIFTY THOUSAND

Freehold Ownership in Three-Storey Buildings and Thirty Feet Frontage Transferred.

The three-storey brick building at 48 York street, with land 30 feet by 110, has been transferred from William Garside to Hugh White at a consideration of \$50,000.

The land has an assessment of \$15,000 and building \$15,000. Hugh White was a lessee of the property, which is just north of Front street and adjoins land owned by Sir William Mackenzie.

BARTHOU MAY BE FRENCH PREMIER

Will Give Definite Answer Today to Invitation to Form Cabinet.

PARIS, March 20.—(Can. Press).—Jean Barthou, minister of justice in the Briand cabinet which recently resigned, will give a definite answer tomorrow to the request of President Poincare that he form a new cabinet. He will consult with his friends regarding his decision, but it is considered practically certain that he will accept the task. M. Barthou said tonight that in the event of his acceptance, the two cardinal principles in his program would be "proportionality of representation and three years' service in the army. His first endeavor, he added, would be to try to induce the senatorial committee to accept the principle of representation by the majorities, the details of which could be arranged later in a spirit of conciliation. He hoped in this way to end the deadlock between the two houses of parliament.

STRIKE AT DOON NEAR END. BERLIN, Ont., March 20.—(Special).—T. J. Bileens, fair wage officer of the department of labor, Ottawa, was in Doon this afternoon investigating the strike of the Doon Twine and Cordage Company. The strikers are asking for an increase of ten cents a day. The wages now average \$7.10 per week for men and \$4.00 for girls. Most of the employees have returned to work, feeling satisfied that the labor officer will be able to effect a satisfactory settlement.

SENSATION COMING, SAYS LOVE
TWO WEEKS PRIOR TO TRAGEDY
EVIDENCE GIVEN BY A NEIGHBOR

Expert Evidence Indicated That Stains on Trousers of Accused Man Were Made by Human Blood, But Smock Worn on Day of Murder Could Not Be Found—Son Sticks to Evidence.

(By a Staff Reporter.)
OWEN SOUND, March 20.—(Special.)—"The next thing that happens in Ceylon will make all your eyes open."
"When did the prisoner say this?"
"About two weeks before the murder, it may have been longer."
Called by the crown to give evidence in the trial of Charles Henry Love, accused of murdering his wife at Ceylon, last December, James Radley declared that Love had made the above remark to him in an interview in his home.
This and other testimony of a like nature featured today's hearing of the case. Expert evidence showed that stains on the trousers of accused were made by human blood. "The crown adduced evidence to the effect that the suit of 'smocks' which Love was said to have worn on Monday, Dec. 3, had not been seen after that night."
Wearing Apparel Produced.
Matters were first seemed trifling, were gone into thoroughly by Crown Counsel Gamble. Pieces of wearing apparel belonging to Mrs. Love, and also garments owned by the man were submitted for the inspection of those who testified. In the absence of eye witnesses, the crown attempted to connect Love with the crime by means of this mute evidence.
Defence Counsel W. H. Wright subjected all the witnesses to a rigorous cross examination. He raked up points about almost each and every one of them so as to disprove their stories. His general line of attack was on the difference in the testimony as given at the coroner's and preliminary hearings and that offered at the present trial.

Boy's Nerves Shaken.
In examining Arnel Love, aged 14, Mr. Wright mercilessly propounded question after question to the lad and charged him with possessing a poor memory. Counsel succeeded in getting an admission that Arnel had been troubled with his nerves sometime back and had to drop several subjects at school.
In an effort to disconcert Mrs. Kennedy, the defence decried her education and forced her to write the words "Owen Sound" on a paper.
"That the blow on the head would have caused death in all probability, if there had been no other wounds, was the evidence of Dr. James McWilliams, who, with Dr. Ego, performed the post mortem. Both the doctors agreed that the death wound had been inflicted while the woman lay where found. They did not think that either of the knives used in the house could have made the cuts, as they were not sharp enough. To his lordship Dr. McWilliams admitted that, if the wounds were pressed firmly against the neck, the incisions might be deeper than the actual length of the blade."
Son's Testimony.
Questioned by Crown Counsel Gamble, Arnel Love added to the testimony which he gave on Wednesday. In many respects it was similar to that taken at the inquest, but on a few matters he was more definite.
During the time they were waiting for Mr. Colinson and Mr. Hepburn to arrive after the body had been discovered by Love in the cellar, Arnel and his father sat down on the lounge.
His father asked him if he saw anyone on his way to school Tuesday morning. When the boy enumerated several people, Love instructed him to tell everyone that he saw a strange-looking man and to describe him. Just then they heard footsteps.
"Did you tell that to anyone?" asked Mr. Gamble.
"Yes."
"Was it true?"
"No."
"Can you tell us anything about the clothes your father had on on Monday night?"
"He had on a pair of trousers faded and patched on one knee."
"What made you notice them?"
"Father poked his finger thru a hole in them, and said it was time he got a new pair."
Witness looked at two pairs of trousers. These, he declared, belonged to his father, but were not those which he wore on Monday night.
"When did you see the pair with the patch on the knee last?"
"On Monday night."
"What did he have on on Tuesday?"
"A pair of trousers similar to the one on Monday night."
"Do you remember what he wore on Wednesday?"
"No."
Judge's Query.
His Lordship: Are you able to tell the jury that you saw the patched trousers on Monday night, but did not see them after Monday night?"
"I can't remember seeing them."
To Mr. Wright, witness did not deny that he had complained of his nerves.
In answer to query if he had been taken in charge by inspector of Detectives Reburn, the boy replied he had. He had been clothed with the officer. The evidence which he formerly gave had been read over to him twice.
"You signed a statement?" continued Mr. Wright.
"Yes."

The boy told Mr. Wright that his mother had been displeased with him because he started out with another boy, armed with rifles, to see the world. This happened two weeks prior to the murder.
Taking up the statement made by Arnel, Mr. Wright wanted to know who were present at the time. According to the evidence, the illegitimate son of her father, and the surrogate declared he would use every precaution to keep their identity veiled.

Mother Disappeared.
The story told in the will is that Anonymous, who died some months ago, was married and had a daughter by the marriage; also that several years later and less than sixteen years ago he had a son born out of wedlock. The mother of the illegitimate child was baptised in the Roman Catholic Church and thereupon she married somebody else and disappeared.
Dr. T. A. Archibald, expert on blood stains, next took the stand. Two shirts were turned over to him by the provincial police. These were worn by Love until Constable Cook took them from the house.
On the right cuff of the black shirt he found a brown stain. This gave a chemical test of human blood. Under the microscope test it could not be determined definitely whether it was human blood or not. On the blue shirt he detected a blood stain on the right cuff, and a small spot near the chest opening. Test of the stains on the blue shirt convinced him that they were made by human blood.
George Beacraft, a teamster, who hauled coal from Ceylon to Owen Sound, testified concerning the trousers worn by Love on the Saturday prior to the murder. These were patched and the right knee was patched and put his finger in the hole, also remarking that he would have to soon get a new pair.

Scared Woman.
A scream not unlike that of a baby alarmed her one night as she was retiring, testified Mrs. Mary Rutledge, a neighbor of Love's. She heard this some time in the night, and at 11 o'clock. She could not place the date, but thought it was on the night not long before the body was found. Henry Love was walking in his kitchen Tuesday night, when he came to her house and she became frightened at his attitude. Mrs. Elizabeth Kennedy appeared to be all right. He asked Mrs. Kennedy when she had last seen Mrs. Love and she replied that it was on Monday night, coming from the Ceylon school.
Hereupon Love grasped the door knob, opened the door, and said he wasn't a wild or reckless man, he sometimes went to Radley's hotel on business. There was lots to eat and drink, and he did not know why she was more definite.
Calling at the Love home that night, Mrs. Kennedy found Love shaking the stove every one of the minutes, and he bright thing beside it. He insisted on showing her the rooms and the clothes of the missing woman, and Mrs. Kennedy declared she had never seen her. She identified a blue dress as the one she had seen on Mrs. Love on the Monday night.
At this point in the trial Inspector Reburn came into the room with several other detectives for the purpose of having the kitchen searched. Mr. Wright objected to the crown producing these things before the jury, but Mr. Gamble contended that every article of the clothes being covered with blood.
Odor of Burning Cloth.
Lionel Fawcett, who was doing some tailoring for the telephone company, also spoke to the accused as he sat in the sitting room about that time of the same morning.
Kennedy and Colinson houses about 5:30 on the Wednesday following Mrs. Love's disappearance, said Fawcett, he smelt an odor of burning cloth or hair coming from the vicinity of the house. There were several others with him at the time.
In describing the talk he had with accused, James Radley said that Love talked quite a bit, and the witness did not attach much importance to the prediction that he had made, which happens in Ceylon will make all your eyes open."

Will Finish Tomorrow.
His Lordship Judge Lennox declared that after a night session, so that the case could be concluded before Saturday. Crown Counsel Gamble objected, however, and stated that both defence and prosecution had decided the case would be finished by Saturday.
For his defence Mr. Wright will call several of the crown witnesses. He will attack the police for what he alleged to be third degree methods in securing evidence.
The addresses of counsel will likely be heard on Friday night and the case will then go to the jury. W. S. Mid-dleton, M.P., was present at the trial.

PROMOTES SYSTEM OF LABOR STORES
Labor Council is Urged to Tackle New Idea of Co-Operation.
A proposition is on foot to establish a system of co-operative union label stores throughout the whole of Ontario. With this idea in view R. W. Dominion, with promoting the new project, addressed the delegates from the various unions at the meeting of the Trades and Labor Council last night. The plan is to sell union made goods only, and the corporation costing \$1 each will be offered to members of the union.
The proposition will be put forward to all the unions in the city by their officers and a report will be made at the next meeting of the Trades and Labor Council.

SCANDAL IN NEW YORK FAMILY
REVEALED BY WILL IN COURT

Adopted Son of Dead Man's Daughter Turns Out to Be Her Brother—Will Stipulated That Boy's Adoption Was to Be Undone; But Judge Decided Otherwise.

Probably only the surrogate and officers of his court and the lawyers in the case know the identity of those involved. The surrogate declared he would use every precaution to keep their identity veiled.
The will of a man recently deceased reveals that the adopted son of a daughter of the testator is in reality her brother, the illegitimate son of her father. No name appears in the decision and the testator is known as "Anonymous" throughout the decision.
When asked if he would give any further information as to the years surrogate Fowler said he would not.
"I would rather go down and out of the office than reveal the name of this man," he said.
Asked if the man was poor, he answered quickly that he was not and then added, "That is, he was not too rich."
The surrogate said the boy involved in the case is under fourteen, is in a private school and his name is not in the facts of his birth would put a blight upon his life.

Must Be Undone.
"For in one clause of the will he provides that his daughter's adoption of the boy is to be undone within six months after his death, and the baptism name of the child is to be changed. Unless this is done within the six months, whatever bequests are made to the daughter in the will are immediately nullified, and these bequests are to go to the boy."
The matter came before the surrogate after a separate clause of the will appoints the daughter guardian of the boy, and the will does not specify that the adoption is to be undone to revoke this appointment.
The surrogate said that if necessary to protect the name of the boy he would give notice of the case sealed for three months.

FOREST HILL FRANCHISE
NEW COMPANY WILL NOT BE ABLE TO BEGIN OPERATIONS UNTIL RATEPAYERS VOTE FAVORABLY—YORK COUNTY MAY PURCHASE THE KINGSTON ROAD RADIAL LINE.

Questioned concerning the proposal that the county should unite with the City of Toronto in taking over the radial on the Kingston road, Reeve Corrie of Scarborough Township said: "I have nothing to say about that. There has been something in the newspapers, but the proposition has been considered by the township."

It is claimed that there is no possibility of the franchise being extended to the north end of the township, and that effect. For some years the service on the line has not been as good as it might be, and there is just possibility that the York Radial will not be particularly anxious to keep this line when their new Toronto Eastern is in operation.
Farmers in the vicinity of West Creek district are reported to be strongly in favor of the city and the county taking the line over, as it would enable them to get the benefit of hydro-electric power.
Discussing the proposal yesterday Mayor Hocken said: "The city has given notice of its intention of taking over the portion of the line within its own limits and I think it would be up to the county to take action and come out and buy the line. The running boards of mind and ready to co-operate with them as far as possible."

YORK TOWNSHIP.
The York Township Council held the regular meeting on Monday night at the Forest Hill Radial building.
When asked when construction would be started, T. G. Glover said: "The township will likely give a notice to that effect, but no definite announcement as to that until a by-law has been passed by the York Township Council."
The new line will start at Forest Hill and Dunvegan roads, run along Forest Hill, north on Bathurst and west on Eglington avenue and up Dufferin st.
The township council will not grant a franchise, however, without taking the matter up with the city, so that everything may be in shape for future annexation. They will rather demand from the company some cash consideration for the use of the roads. When an agreement has been outlined which is satisfactory to the city and the township council, a by-law will be submitted to the ratepayers who are properly owners of the roads.
In view of the fact that the good roads commission has already spent \$30,000 on the highway at Dufferin st. the township will likely have to be indemnified for any construction work done on the highway.
Councillor Miller of York Township said: "The township council has no intention of giving a council have no say in the matter, and after a satisfactory agreement is outlined, it rests with the ratepayers of the township."

SCARBORO TOWNSHIP.
Some time ago the residents in the Birch Cliff district petitioned the Scarborough council to open a road from Danforth avenue to the Kingston road. The proposed extension would be about a mile and would come out into the city and would be used by children suspected of having consumption. The opposition is more vigorous than ever. A petition has been presented to a meeting to be held in the Orange Hall on Saturday night to decide what further steps will be taken to block the proposition.
General satisfaction is expressed throughout the district at the way the roads have been drying up. The new tiles, where the sewers had been put

down, caused the bulk of the trouble last year, but these have all settled pretty well now and in a few weeks the roads should be in good shape.
WARD SEVEN.
A fractured thigh, numerous bruises, and a lacerated forehead, were sustained by Charles E. Schaffer shortly before 7 o'clock yesterday afternoon as he was walking on Dundas street. The injured man was riding east on a motor-cycle, and as he neared Indian Road a delivery wagon owned by Nelson Hallett & Johnston of 1632 Dundas street, and driven by Dorland Farley of 75 Hook street, turned the corner north to Dundas street. Schaffer, traveling fairly fast, was unable to stop his machine quickly enough, and ran obliquely into the horse, throwing the man to the pavement, while he was precipitated about 100 feet farther on. He was taken to Dr. J. J. Thompson's surgery nearby, where his injuries were attended, and was later removed in Speers ambulance to his home at 555 St. James street.
The firemen of Keele and Carlton stations had a long, laborious run yesterday afternoon about 2:15 to a fire alarm on the west end of Westwood in Weston Grove. BURLESQUE WILL
PLAY AT THE STAR

Local Theatre and One in Montreal Are in New Circuit.
"The Star Theatre will be playing burlesque next fall." This statement of Fred Star, proprietor of the Star Theatre, made at 10:30 o'clock last night, will relieve the anxiety of 30 or 40 thousand young men in Toronto and should not add to the anxiety of the ministers and moral reformers as Mr. Star says that the quality of burlesque will be of a higher class than ever before presented in Toronto.
The rumor that burlesque would cease to be played in the Star Theatre had its source in the report that the Columbia Amusement Company had absorbed the Empire Circuit and that burlesque would now be played in only 44 houses in the United States and Canada.
The rumor was true, but the result of the merger was that some of the proprietors of theatres which were in the Empire Circuit met in New York on Wednesday and decided to incorporate a gigantic circuit in opposition to the Columbia Amusement Company. The new circuit will be known as the Progressive Amusement Company. Mr. Star is a shareholder in it, along with

theatre men living in New York, Boston and other American cities.
"I was frozen out of the Columbia Circuit and I'm glad of it," said Mr. Star. "The Progressive Circuit will not be run by showmen in St. Louis and Cincinnati, but by showmen in New York. We will have 35 houses in the new wheel and will be ready for the opening of the season next fall."
"The formation of the Progressive Circuit means that millions more of capital will be invested in the theatres and this reason the burlesque will be much better than in the past. We can get a million dollars in Toronto for the circuit. Montreal will have an entirely new theatre in Montreal will be built by a Toronto millionaire."
The men in the new circuit will hold another meeting in New York in a few weeks, when the officers and directors will be appointed.
The following cable lends color to Mr. Star's statement that he was frozen out of the Columbia Circuit:
"Thos. S. Henry, Gayety Theatre, Toronto: Deny the story that Mr. Star is a stockholder in the Columbia Amusement Company in any of its subsidiary companies or in any enterprises that we are interested in. There are no merged wheels. The Columbia Amusement Company has absorbed the Empire Circuit and hereafter will control the burlesque situation in the United States and Canada and present clean burlesque. Sam A. Scribner."
TWO POLICEMEN INDICTED.
NEW YORK, March 20.—(Can. Press.)—Two more policemen were indicted by the grand jury today in District Attorney Whitman's efforts to break down the barriers of the "system." Patrolman Victor Meyer and Patrolman William J. Smith are accused of bribery. The true bill against Meyer was based on testimony given by Rosie Hertz, a convicted disorderly resort keeper, and released on bail. Smith will be arraigned tomorrow upon Mr. Whitman's return from Albany, where the prosecutor is in conference with Gov. Sulzer on the graft situation and other matters.
John J. Hartigan, the patrolman convicted last week for perjury, will not be sentenced until next Tuesday.

WILSON RESIGNS AS SECRETARY
First Assistant Secretary of State Bluntly Criticizes President
Special to The Toronto World.
WASHINGTON, March 20.—President Wilson today announced the resignation of Huntington Wilson as first assistant secretary of state. Mr. Wilson resigned because of the repudiation of "dollar diplomacy" as reflected in the statement issued by President Wilson Tuesday evening, refusing American support to the powerful group of Wall street brokers interested in the six-power loan to China.
Huntington Wilson, who helped the late secretary of state, Philander C. Knox, frame and develop "dollar diplomacy," intimates that he knew nothing of the president's statement until he saw it in the newspapers. That statement, he asserts, signified the adoption of a radically new far east policy by the United States. He sent his letter of resignation to the White House a few hours after the publication of the president's statement. President Wilson accepted the resignation today in a message of 55 words.
