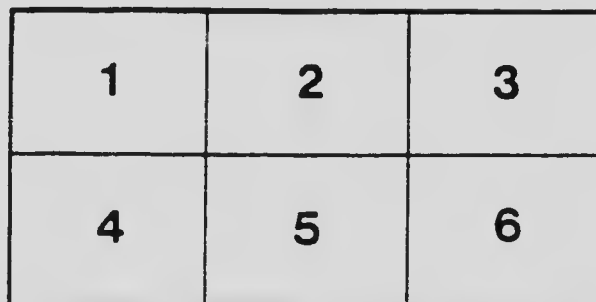
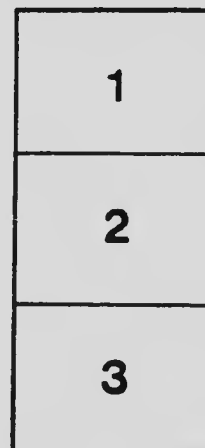

SIR,—I have the honour to hand you a report upon Ice Cream. One hundred and thirty six samples of the article were purchased by our inspectors, in September, October and November of last year and one sample in March of the present year.

The following is a synopsis of the results of analysis:—

Our standards for Ice Cream, published in November 1910 (G. 934) require 14 per cent of milk fat in ordinary Ice Cream, and 12 per cent milk fat in the article when fruit or nuts are present.

Samples which show less than one per cent shortage in butter fat, I have not declared to be adulterated, but have indicated as slightly below the required standard. Our last inspection of Ice Cream was made in September and October of 1910; and the report was published as Bulletin No. 218.

I beg to recommend publication of this report as Bulletin No. 276.
