*Wednesday, 7th December, 1859.  
11 o'clock A.M.*

The Grand Division of the Sons of Temperance of Canada West assembled at the Union School Buildings in the Town of Newmarket on the seventh day of December, 1859—the Grand Worthy Patriarch, Brother A. FAREWELL, presiding.

The Officers present were—E. STACEY, Grand Scribe; J. F. WRIGHT, Grand Conductor; W. WHEATON, Grand Sentinel; and Dr. J. BEATTY, Past Grand Worthy Patriarch.

The Rev. Dr. SHORTT, Grand Chaplain, and Rev. W. WILKINSON, Grand Worthy Associate, were unavoidably absent.

The Grand Worthy Patriarch appointed Representative Rev. R. D. WADSWORTH Grand Chaplain. ✓

A portion of Scripture was read, and prayer offered, by the Grand Chaplain.

The Minutes of the previous Session were read short and adopted.

The Grand Treasurer entered and took his seat.



On motion of Representative C. H. VANNORMAN, it was resolved—

That the Candidates now in waiting be only obligated.

The Grand Conductor introduced Representatives WILLIAM and STEPHEN TERRY, who were duly obligated.

Moved by Representative R. C. BENEDICT, and seconded by Representative F. A. OLIVER—

That Representatives J. ROBERTSON, J. EARLE and E. C. SLITER be added to the Committee on Cadet Constitution and By-Laws, and that matters appertaining thereto be referred to said Committee, and to report at this Session of the Grand Division. Carried.

Representative Rev. R. D. WADSWORTH, as Chairman of said Committee, invited suggestions in writing, to be handed to the Committee by Representatives as early as possible.

The Grand Worthy Patriarch submitted to the Grand Division his Annual Report as follows:—

#### Officers and Brothers—

Since you kindly placed me in the proud position of head of your organization, another year has been added to its history, and again has a kind Providence permitted us to assemble for the renewal of our vows to continue our efforts in the cause of virtue and sobriety; and to build up an institution which exists as a beacon light to guide the young, reclaim the wanderer, and make manifest the pathway of "Love, Purity and Fidelity."

The occasion is one of deep interest, not only to those whom you represent, but to the entire community. Your labors have reference not only to the present, but to all future time. Let us, therefore, engage in the pleasing duties of the Session with a zeal commensurate with the importance of the work we seek to accomplish.

I congratulate you upon your relative position in the National Division. There are in connection with that important body, as last reported, 41 Grand Divisions, numbering 1,985 Subordinates. Average number to each Grand Division, forty-one. Canada West stands first on the list, and has 335.

The number of members admitted to all the Subordinate Divisions during the last year is 37,987; average to each Grand Division, 926. Canada West stands second on the list, and admitted 4,018 new members. Total number of contributing members connected with the National Division 76,422; average to each Grand Division 1,864. Canada stands first on the list, and numbers 10,479. Total number of Females connected with the order 23,988; average to each Grand Division 588. Canada West stands second on the list, and numbers 3,468.

In the number of Temperance Meetings held, and Tracts distributed, Canada West is far ahead of any other Grand Division. Of the former you number 879; of the latter 12,676. These data are sufficient to show the

I can also congratulate you upon the present state and future prospects of the order within the jurisdiction of this Grand Division. Though our numbers have not materially increased since the Semi-Annual Session, yet the peace and tranquillity pervading the brotherhood, the activity and energy of very many Subordinate Divisions, and the healthy tone of public opinion upon the question of Prohibition, are cheering indications that seed has been sown in good ground, and that, ere long, we may look for a bountiful harvest.

During the past Summer and Autumn numerous public Temperance demonstrations have taken place, attended in nearly every instance with gratifying success. A considerable number of Deputies refer, in their communications, to those Soirees with much satisfaction. In many places loud calls are made for Lecturers during the approaching Winter. Not a few Divisions desire again to petition the Legislature in favor of Prohibition, and many Deputies bear testimony to the great good attending the admission to the Division of Lady Visitors.

Evidences are not wanting that, throughout the entire community, your organization is looked upon as an absolute necessity for the wellbeing of our beloved country, and a cherished refuge to thousands from the influence of the "all-pervading destroyer". Your spirit has been infused into nearly every neighborhood within your jurisdiction; and to be known as a consistent Son of Temperance, is to insure the respect of those with whom you have intercourse. Your spirit, with your petitions, has entered the Halls of Legislation, and the country's delegates, in Parliament assembled, have admitted the correctness of the principles of Prohibition.

The Act for the suppression of the traffic in liquors upon and near public works, the disfranchisement of inn and saloon keepers by the 73rd section of the Municipal Law, the two days prohibition of the Elective Franchise Act, and the Sunday anti-Liquor Law, are all trophies laid at your feet, and may fairly be received as precursors of your ultimate and glorious triumph.

The lawgiver who yields to the necessity of introducing Prohibition into certain places and on certain occasions, as in the Acts just referred to, has only to be consistent with the dictates of reason to grant the Prohibition for which you contend. He already admits that when men congregate at public works and upon election days, they are likely to become excited and act improperly under the influence of spirits. You say, with equal reason, that men are likely to become excited and act badly, under the influence of spirits, congregated at any place where liquors are freely used. He now admits the propriety of prohibition on *Saturday nights* and *Sunday mornings*. With equal reason you would extend the principle to *every night* and *every morning*. Had the Act for the abolition of slavery in the British West Indies only applied to certain places within those islands and on certain occasions, it would have been in harmony with, and quite as inconsistent as, our present Prohibitory Liquor Laws. But the spirit of philanthropy, and a due regard to consistency, impelled the British public, headed by the immortalized Wilberforce, to abolish the entire traffic in human beings at once and forever. Confiding in the impregnability of our position as prohibitionists, we may reasonably hope that the stamp of public disapprobation, embodied in the form of law, will, ere long, be placed upon the entire liquor traffic of Canada, and the mark of disfranchisement be indelibly fixed, not

only upon inn and saloon keepers, as at present, but upon all who may dare to engage in the traffic. The business, as an avocation, is bad, confessedly bad. Its legitimate fruits are at war with our best interests. Physically, mentally and morally; individually, socially and nationally, we must be losers by its continuance. All the better feelings of man's nature rise up against the traffic. The moral sentiment which naturally elevates the man above the mere animal creation is opposed to it; the principles of christianity which he cherishes discards it; and the patriotism glowing within his breast is hostile to it. The welfare alike of our friends, our fellow-men, and our country, demands the entire abolition of this traffic. What say you, brothers, shall this be accomplished? Let your affirmative response serve to cheer us on to renewed and increased efforts in the good cause. That important body of co-workers with you, the Good Templars, have requested your co-operation in the preparation and circulation of petitions to the Legislature in favor of the passage of a Prohibitory Law, and I suggest the appointment of a committee for such purpose.

Your attention is directed to the formation of a new Temperance organization in Montreal, called the "Canadian Anti-Liquor Traffic League," the declared object of which "is to enlighten and direct public opinion on the evils of the Liquor Traffic, and by all legitimate means to procure its total and immediate abolition."

This new movement is in the hands of some of the strongest Temperance men in the Province, men who have creditably and persistently sustained the staunch old Temperance Advocate under discouraging circumstances for over twenty years; and if it be possible to work the League up to the rank of an efficient and thorough organization, it will surely be done. In Canada West the Sons and Good Templars appear to occupy the ground which may successfully be taken by the League in Canada East. Annexed you will find a copy of the circulars and documents forwarded to me from the League office. I commend them to your careful consideration.

The subject of Temperance Lectures is one of much anxiety with your executive. I am of the opinion greater efforts than have hitherto been put forth should be made to call out and make use of more of the speaking talent found in Subordinate Divisions. At the same time, I think such arrangements might be made by the union of the Subordinate Divisions in sections of the country as would keep two or more travelling lecturers constantly in the field. Men of the right stamp can be found for such purpose provided an assurance could be given that they would be sustained. Bro. Hagarty has been favorably mentioned by many of my Deputies as a gifted, efficient and successful speaker. Bro. Patterson, who is now laboring in the lecturing department for the Montreal Temperance Society, would favor Upper Canada with his services for a time, if required. He is represented as being a powerful and agreeable speaker, and an honor to the Temperance cause. In this connection I desire to introduce the name of Amasa McCoy of Albany, N. Y., for several years the Editor of that valuable Temperance paper, *The Prohibitionist*; a gentleman of high moral standing, and of the first literary attainments. Known to be fluent as a speaker and profound as a reasoner, his services have been called into requisition before many of the Literary Associations in the adjoining Republic, and in some cities in Canada. This gentleman is engaged in writing a "Complete History of the Temperance Reform." For some time past he has been travelling with the view of collecting reliable statistical information relating to the history of

Temperance, and I have no doubt he could be induced to visit Canada with that object. He lectures occasionally on Temperance, and commands the attention of a large class of influential persons who seldom give themselves the trouble to attend Temperance meetings. Mr. McCoy's usual fee for a lecture to a Literary Association is \$100, but upon the subject of Temperance much less is expected. I submit to your consideration whether it would not be well to open a correspondence with the gentleman with the view of procuring his services for some of our large Towns and Cities. For this purpose a Committee might be appointed, through whom the desired information can be obtained.

There is a strong feeling with many Subordinate Divisions, and especially with the oldest and most experienced, to adopt some plan to facilitate the necessary routine business of the Divisions, with the view of having more time to devote to other interesting and profitable exercises, such as the delivery of short addresses, the reading of short essays, the debating of historical questions, and the introduction of vocal and instrumental music. These exercises, so far as they have been introduced, have rendered the meetings more attractive, and given a fresh impulse to the Order. I commend the plan to the consideration of the Grand Division.

I cannot better close this Report than by giving an extract from a former communication:

"In continuing your labors in the field of Temperance and Prohibition, be not forgetful to avail yourselves of all the instrumentation within your reach; organize Sections of Cadets wherever practicable, and cherish those young volunteers, for they are to supply our places in the Division room. If we cannot sober off the present generation, let us be instrumental in training up those into whose hands the weighty affairs of our progressive country will soon fall, to habits of sobriety. Support the Temperance Press, that silent power which sways the world. Call to your aid the enchantment of the human voice; and send forth honest, ardent men, whose truthful, burning words shall melt the heart and swell your ranks with zealous converts. And fail not to secure the potent aid of woman. Make your Division rooms attractive to your wives, sisters and daughters, and the triumph of your principles is certain."

I cannot close without bearing testimony to the watchful care of your Grand Scribe over the Order, and his unwearied devotion to its best interests, and to the very efficient and creditable manner in which that Officer discharges his arduous duties. To him, chiefly, am I indebted for the comparative lightness of my labors, as head of the Order, during the past year.

Brothers, accept my heartfelt thanks for the kind manner in which my frailties and incapacity have been passed over during my term of office, and the successful efforts which you have put forth to preserve, at all times, order and decorum in the Grand Division.

 WEST :

In presenting this my Annual Report, at the Eleventh Annual Session of this Grand Division, we recognize the protecting providence of God in giving us so large a measure of success, and upholding our hands in the cause we profess to love.

I am happy to state that since the last Semi-Annual Session, harmony and brotherly feeling have pervaded the ranks of our beloved Order, with the exception of some difficulties which appear to grow out of too close a contact with other associations. Many of the Divisions are still animated by the liveliest spirit, whilst a few are in a deplorable state of apathy or repose.

Sufficient Quarterly Returns have not been received from Subordinate Divisions to enable your Grand Scribe to present a correct estimate of "the state of the Order" in your jurisdiction, but it is firmly believed to be in about the same condition as when reported at the last Session of Grand Division.

I would remark that the members of the Resolute Division in disbanding did, with commendable zeal, resolve to re-enter "this circle of honor," and procured Clearance Cards for the purpose of joining other Divisions.

During the past year thirty-three Divisions have been added to the list, and it must be gratifying to know that those Divisions have already made rapid progress in our truly benevolent and philanthropic enterprise.

Twenty-six Sections of Cadets of Temperance have been organized since the Annual Session, and the progress of this Juvenile Order, although not rapid, is advancing favorably, and will receive fresh impetus when the amendments contemplated by your Committee are perfected.

Upon application received, copies of the Cadet work have been supplied to the Grand Divisions of Maine and New Brunswick.

For younger children the "Bands of Hope" Societies appear to be growing very popular, both in Great Britain and Canada. Of course this Grand Division organization cannot fail to take a deep interest in any association of the dear children whose future we would fain influence for good; surely in this movement, as in matters of higher import, our good brothers could well be employed in enrolling members and conducting Bands of Hope.

Whilst reviewing the result of the joint effort made last winter in getting up Petitions for a Prohibitory Liquor Law, we are happy to reflect that labor for the good of this hallowed cause is never lost, and although we did not gain the desired object at that time, we are not discouraged, and are resolved to make continuous efforts "till the victory is won." It is surely sufficient encouragement to find that the hearts of one hundred and ten thousand petitioners throbbed in unison with yours to procure that righteous enactment.

It will be a question presented at this Session: In what manner shall we again co-operate with the Independent Order of Good Templars of Canada in this labor of Love? How best promulgate petitions, so as to invoke the Legislature to abolish the infamous liquor traffic, and stay the evils connected with the abominable trade?

I would respectfully report that the Grand Scribe's department of the Grand Division labor has been attended to as usual. The Journal of the Proceedings of the Semi-annual Session was prepared and printed, and forwarded with despatch to the Order. Blank Returns, Credentials, By-Laws, and other requisites, have been procured. The Journal of Proceedings of the National Division was forwarded as soon as received to each Recording Scribe. The following particulars are presented for the consideration of the Grand Division :—

A new Grand Division for Washington Territory was reported, and also a Grand Division in Wales from the sister National Division of Great Britain and Ireland, making the fourth Grand Division organized in Great Britain.

That portion of the Most Worthy Scribe's Report relating to the duties of Deputies Grand Worthy Patriarch merits attention ; and that part alluding to printed forms for Deputies' Reports, might be adopted with advantage. At the same time Deputies need not be confined to these categorical replies. I beg leave to refer you to pp. 24, 25, 48, Journal of National Division.

There was no change made in the Constitution, but a Committee of three experienced Brethren was appointed to revise the Constitution and to adjust the actual or apparent discrepancy between it and the Revised Rules—in fact, to embody the Revised Rules in the Constitution. As soon as this work has been accomplished, I would suggest, that a new edition of the Grand Division Constitution and By-Laws be compiled and presented to this Grand Division for approval. The whole of the By-Laws, Resolutions, and Rules of this jurisdiction requires a careful revision, and an experienced Committee should be entrusted with the task.

Additional statistics are required by the National Division; therefore it will be necessary for the blank Quarterly Returns to have the following additional headings:—1st, Number of Boys in Temperance Associations in the jurisdiction; 2nd, How many and what Temperance Associations, of all kinds, meeting regularly, exclusive of our Divisions and youth in the jurisdiction; 3rd, Number of persons enrolled in such Associations: also the following addition of a new question to the Order of Business in Subordinate Divisions, page 38, Journal of National Division: "What have you done during the past week to advance the interests of the Order, and save your fellow-men from the evils of intemperance?"

I would recommend that the Journals of the National Division and Grand Division be carefully examined by the officers of Subordinate Divisions, and preserved for future reference.

The whole subject of benefits has undergone a complete change—in fact, the system in this jurisdiction appears to be nearly obsolete. I find for the last year \$784 was paid for benefits, and for the quarter last reported only \$109! Happily we now experience that "Temperance is the primary, and the beneficial system but a secondary, part of the work" of the Order.

To keep pace with the improvement of the times, I would beg leave to suggest that the accounts of the Grand Division be kept in dollars and cents, and to this end that the Capitation Tax amount for the future be four cents instead of four half-pence, commencing with the quarter beginning in January, and ending March, 1860.

Worthy Brothers, in conclusion I would express to you my sincere gratitude for the uniform kindness which I have received at your hands, and for the ready and efficient assistance so frequently rendered to me by the Grand Officers and the Brethren generally, in the discharge of the manifold duties of this office.

Commending you in your deliberations to the guidance and blessing of Divine Providence to give gracious assistance in your counsels, and when we again separate to our homes, may our hearts be still bound together in noble phalanx against the common foe, and warmed to greater earnestness and zeal to extend our beloved Order, to free our country from the pollution of the liquor traffic.

Your Committee, to whom was again referred the Report on certain alterations proposed to be made in the Constitution of Cadets of Temperance, beg leave to report that we recommend—

1st—That all the officers shall be elected by the Section, with the exception of a Worthy Patron and two Associates (one of whom shall act as Chaplain), who shall be Sons of Temperance in good standing, and elected by the Division ; and that it be necessary for the Worthy Patron, or one of his Associates, to be present at every regular meeting of the Section.

2nd—The Worthy Patron shall be responsible for a due observance of the laws and usages of the Order ; that he shall have charge of the funds of the Section, and shall be required to execute a bond with the Division for such amount as the Division may deem necessary.

3rd—The Worthy Patron shall permit no debts to be contracted incurring an expenditure beyond the amount of funds in his possession.

4th—The Worthy Patron and his Associates shall be amenable for their acts to the Division only.

5th—That in view of the evil influence arising from the example of Worthy Patrons of Sections being habitual users of tobacco, we strongly recommend that Divisions do appoint, when practicable, those members to fill the offices of Worthy Patron and Associates who abstain from the use of tobacco in every form.

6th—That Sections be allowed to regulate the amount of fees and dues, and that in accordance with the recommendation of the Grand Worthy Patriarch all surplus moneys shall be appropriated to the formation of libraries or similar means of literary improvement.

7th—That Sections, as often as possible, shall hold open meetings, to which the mothers, sisters and friends of the members may be admitted without first being visiting members of a Division.

8th—That Sections, where practicable, shall meet during the afternoon, and that in no case shall any Section remain longer in session than one hour and a half without the consent of the Worthy Patron.

9th—That the Executive Committee of the juvenile branch of this Order be authorized to revise the Constitution and By-Laws of the Cadets, embracing these recommendations as soon as possible.

The facts presented by our esteemed chief officer under the form of a statistical contrast, are very gratifying, and we may well respond to the congratulations offered thereupon; but your Committee desire to present, in the most forcible manner, the obligations and responsibilities which these facts impose upon the members of this Grand Division, and of every Subordinate Division, to be up and doing, that we may not merely maintain, but improve upon, our present status.

Incessant, earnest, well-directed labors, the determination never to be weary in well doing, and the conviction that we must succeed, are the conditions of our prosperity.

The progress in temperance legislation alluded to, though coming far short of what we require, are evidences that we have not spent "our strength for naught", and if true to our mission, every such step must add to the weight of our artillery, or perhaps we may justly consider them as rifling our cannon, by which we may acquire a longer and a surer range in our attacks upon the common foe.

It is most earnestly to be desired that all who are affiliated with us should be deeply convinced that our organization is an absolute necessity for the well-being of our beloved country, as a refuge to thousands from the destroyer, and as the *Director* of the public mind in those projects which we hope will one day crush the "destroyer".

The evil character of the traffic cannot be too forcibly impressed upon the mind: its footsteps are marked with human misery, lamentation and woe, and the end thereof is the embrace of the "worm that dieth not and of the fire that is not quenched."

Upon the subject of Petitions, your Committee appreciate the value thereof, and the benefits resulting; yet they submit whether, under existing circumstances, we might expect results from the immediate renewal of this process equal to the labors and expense necessary to secure a success.

We recognize with pleasure the zeal of our fellow-laborers, the "Good Templars", and recommend that this Division respond to the request to appoint a Committee, on behalf of our Grand Division, to meet one on behalf of the Good Templars. Your Committee submit, however, that said Committee be instructed to provide for petitions to be sent in to Parliament from every temperance organization, as from Grand Division and Grand Lodge, and from every Subordinate Division and Subordinate Lodge in the Canadas, as well as from every other association of this character in existence. We submit that this would be attended with much less labor and expense, and would impress the fact upon the minds of the community, of so large a number of existing organizations, ever alive to the great object of their existence, and ever ready, when the opportunity offered, to unite their forces, and, together, "to push the battle to the gates."

Your Committee have given careful attention to the proposal from the friends of our cause in Montreal, for the formation of a new temperance organization; and while we recommend the Grand Division to encourage every effort made for the accomplishment of the great object in view, we cannot recommend that our Order should be distracted from its own legitimate work by efforts in the direction alluded to.

The genuine spirit of our Order is that of an "Anti-Liquor Traffic Association", and we deem it to be our duty to maintain it in its greatest possible

efficiency, while we bid "God speed" to every organization which has the same object in view.

The subject of Temperance Lecturers has ever been one of anxiety and of great difficulty with us.

Your Committee submit that the Grand Division is not in a position to incur any pecuniary responsibility in this matter, and that experience teaches us that Subordinate Divisions do not respond to any general scheme thereupon, and we can only recommend that the subject be left for the arrangements which may be made by unions of effort in the various localities.

While anxious to encourage such an enterprise as that now undertaken by Mr. McCoy, your Committee cannot see that they can do otherwise than leave the matter for local management.

As to any alteration in the mode of conducting Subordinate Divisions, your Committee feel the necessity of making the meetings as attractive as possible, but are not prepared to offer any other suggestions than such as must arise from the observation of the Grand Worthy Patriarch, and the tact and good sense of the officers of Subordinate Divisions.

The best response this Grand Division can make to the Grand Worthy Patriarch, in reference to our esteemed Brother, the Grand Scribe, has already been made, that of re-electing him to his responsible duties for the seventh time.

Your Committee desire to record their high appreciation of the diligence and ability with which the duties of the Grand Worthy Patriarch have been discharged, and earnestly pray that our esteemed Brother may long be spared to unite his efforts with ours in this great and good cause.

Your Committee on the Report of our beloved Grand Scribe beg to present the following:—

We heartily concur in his grateful acknowledgment of God's providential care, and the measure of success which, with his blessing, has attended our labors during the past year. We deeply regret the instances cited which indicate that some of the professed friends of the Temperance reform are indifferent to obligations so exalted in their character and unchanging in their importance; and, also, that some Divisions have been remiss in their duty punctually to remit to the Grand Division their quarterly returns. We urge the importance of greater attention to this subject, in order that the Divisions may not place themselves in an unfair position, nor withhold the influence of their prosperity from the Order.

We respectfully suggest the appointment of committees, or such other agencies, by the Deputies Grand Worthy Patriarch, for the reorganization of defunct Divisions where practicable, and fraternal counsel where needful, for the resuscitation of Divisions not in working order.

We heartily endorse the suggestions of your Grand Scribe on the subject of public meetings, and trust that energetic efforts may be made during the winter by all our Divisions, in every available locality.

We rejoice in the good effected by the Bands of Hope, and trust your Deputies will give the matter due consideration, aiding Divisions in their formation.

We are confident that every wise effort for the obtainment of a Prohibitory Liquor Law has resulted in good, not merely upon the petitioners themselves in the enterprise, but also in enlightening our Legislators as to the public sentiment upon this question: and your Committee are of opinion that the joint action of all temperance organizations, in the support of trustworthy Parliamentary candidates, and petitions from these organizations, as such, will as efficiently, in the present state of things, conduce to the obtainment of our object.

Your Committee also recommend that the additional headings be prepared in the next printed quarterly returns, and the addition of a new question to the Order of Business in Subordinate Divisions—"What have you done during the past week to advance the interests of the Order and save your fellow-men from the evils of intemperance?"

We also recommend that the Journals of the National and Grand Divisions be carefully examined and preserved by each Subordinate Division.

We thoroughly concur with our esteemed Grand Scribe in his views of the benefit system, resting assured that Subordinate Divisions will speedily discover that the natural and happy fruits of the reform will soon obviate the necessity of, and render unnecessary, the benefit system.

The recommendation that the accounts of the Order be kept in dollars and cents, is obviously a correct one, and we advise that the capitation tax be four cents instead of twopence, commencing from 1st January next.

We observe with great pleasure that our esteemed Brother, J. A. DAVIDSON, is still laboring zealously, and with efficiency, in the promotion of the cause, and cordially commend him to the sympathy of the public and of this Grand Division.

this Grand Division should give no uncertain sound with respect to the duty of professors of religion on the subject of Total Abstinence, and which your Committee do not desire to put in place of religion, yet we are of opinion that, as a handmaid, much may be accomplished by the churches continuing to exert the influence which your Committee learn with pleasure they are exercising in many sections of the province. Your Committee therefore respectfully offer the following resolutions:—

1st.—That this Grand Division respectfully suggest to those churches that have no temperance organization in connection with such church, the establishment of one among each worshipping assembly under their care.

2nd.—That each Minister throughout the country is hereby respectfully solicited to preach before each of the congregations to whom they minister, at least one sermon a year, on the subject of temperance, enforcing the principle of total abstinence.
