CONSTITUTION

OF

The Toronto Ladies' Bible Association.

1st. That we form ourselves into an Association, in connexion with the Upper Canada Bible Society, for the purpose of contributing towards the circulation of the Holy Scriptures "without note of comment," particularly in Toronto and its vicinity; and that this Association be denominated, "THE TORONTO LADIES' BIBLE ASSOCIATION."

2. That all persons subscribing the sum of two shillings and sixpence per annum, payable in weekly, monthly, or quarterly payments; or making a donation of one pound, or upwards, at one time, shall be Members of this Association.

3. That the business of this Association shall be conducted by a Committee to be chosen annually, consisting of a President, Vice-Presidents, Treasurer and three Secretaries, and — other Members. Three-fourths of the most regular attendants shall be eligible for re-election.

4. That the Committee meet once a month, or oftener if necessary; on a day fixed by themselves; and that five Members form a quorum.

5. That for the purpose of soliciting and collecting donations and subscriptions, either for the general purposes of the Society, or for the purchase of Bibles and Testaments, by weekly or other payments, the Committee divide this neighbourhood into Districts; and appoint one or Collectors to each District; and that these contributions be paid to the Treasurer, at the Monthly Committee Meetings.

6. That the Committee make it their business to inquire whether any families, or individuals, residing within the limits of this Association, are in want of Bibles or Testaments, and unable to procure them; in which case it shall be the duty of the Committee to supply them therewith, at prime cost, or otherwise, according to their circumstances.

7. That the funds of this Association, or as much thereof as the Committee shall direct, whether arising from donations, subscriptions, or the sale of Bibles and Testaments, shall, from time to time, be expended in the purchase of Bibles and Testaments, at prime cost, to be sold to the poor in the neighbourhood, as before directed; and that any surplus which may arise, be paid into the funds of the Upper Canada Bible Society, in aid of its general purposes.

8. That a General Meeting of the Subscribers and Friends of the Association be held, (on such days as shall be fixed on by the Committee,) in each year, at seven o'clock in the evening; when the accounts, as audited by the Committee, shall be presented; the proceedings of the past year reported; and the Officers and Committee chosen for the ensuing year.

9. That a copy of these Rules, signed by the Secretaries, be transmitted to the Committee of the Upper Canada Bible Society, with a request that they will grant permission to lay out the funds of this Association in purchasing, at the Depository of said Society, Bibles and Testaments at cost prices.

THIRD REPORT

OF

The Toronto Ladies' Bible Association.

APRIL, 1849.

In presenting this the Third Annual Report of the operations of the Toronto Ladies' Bible Association, the Committee consider it unnecessary to go into any detailed explanation of the objects for which the Association was formed:—it is sufficiently known to those of the community who take an interest in Religious Societies, that it was formed for the purpose of aiding in the distribution of the Holy Scriptures, particularly in this City, upon a general plan, projected for similar Associations by the British and Foreign Bible Society.

Your Committee in carrying out the objects of the Association, during the past year, have followed the course adopted by the Committee of the preceding year, sub-dividing the City into Districts, and procuring, as far as possible, collectors for each District, whose duty it has been, to go from door to door, in the endeavour, to induce persons of all classes and opinions, to become periodical contributors to the funds of the Association, either by free donations or subscriptions for Bibles or Testaments.

Some of the collectors of the preceding year, have during the year now closed, resigned for various reasons, but your Committee have been enabled to supply their places by other Ladies; and your Committee with gratitude to Almighty God, express their belief that at the present time, the Society is in a condition of as much vigour and activity as at any period of its existence, notwithstanding the apprehension formerly entertained by some, that the Society would sink so soon as the excitement created by the novelty of the enterprise should wear off.

The past year has been one of severe pressure upon the humbler classes, amongst whom, in a great measure, the operations of the Association are carried on, and this state of things has produced a corresponding effect, in a sensible degree upon the success of the collectors, who have been often met with this apology for postponing the time of contributing, while a disposition to aid the object of the Society has been manifested.

Notwithstanding these adverse circumstances, however, your Committee have much pleasure in reporting, that during the year 73 persons have become subscribers, some for Bibles and some for Testaments, in addition to 323 during the two previous years, making a total of 396 who have become subscribers since the formation of the Society, and who either have been, or will be supplied through means of it with the Word of Life.

Of this number a portion had already possessed that precious word, and have become subscribers for various reasons; some for the sake of having a large family Bible; some because age had rendered it difficult for them to use their old Bibles; some because their families required an additional copy, and some

because they were willing to give to the collectors when asked, and preferred becoming subscribers for a Bible or Testament to becoming free contributors.

Your Committee trust that even in these cases, especially when age had enfeebled the sight, and the place of the old Bible now comparatively useless had never been supplied by a new one, and in these cases where conversations with the collectors may have aroused the attention of the parties applied to, the word of God which is quick and powerful may not have been uselessly distributed, but that it may have been frequently blessed for good to those who have received it.

There is another class to whom the labours of your Committee and the collectors are especially calculated to be beneficial, consisting of those who living in a state of ignorance or indifference as to divine things, and either having never received any religious instruction, or having lost any impressions ever made upon them, have become estranged from all that is good, and are destitute of a copy of the Scriptures. It has been the fate of the collectors to meet with persons of this character, who have yet when urged become subscribers, but who would never have been reached by a Society with operations differently conducted. The mode of payment by weekly subscriptions as small as the subscriber chooses has something in it that is tempting, and enables many to purchase who would never do so if required to make payment in any other manner.

When it is considered that the reading of the Holy Book is one of the surest means of arresting the attention of the unawakened sinner, and that the humbler classes seldom possess many books, and are therefore more likely to read the Bible when they purchase one. Your Committee feel that there is good ground for expressing a hope and confidence that much good will flow from the Bibles distributed through the agency of the collectors.

Your Committee have not the necessary materials for making classification of the subscribers upon which reliance could be placed, but they are satisfied that in a very large number of cases the parties who subscribe are those who stand much in need of spiritual instruction, and who may reasonably be expected to receive benefit from the possession of the great source from which that instruction is derived. Amongst others, your Committee are gratified to be able to state, that there are some Roman Catholics who are subscribers for Bibles and Testaments, in addition to others of the same religion, who are free contributors, and others who have been supplied with Bibles from the loan stock, of which your Committee will presently say a few words.

Your Committee have during the year delivered to subscribers 95 Bibles or Testaments, and by their list it appears that there are still 173 more subscribed for, and not yet delivered because not yet wholly paid for. In addition to these, 38 persons have been supplied from the Loan Stock of the Society, which it is perhaps unnecessary to explain, is a stock set apart for the purpose of supplying those whose circumstances do not enable them to purchase. To such persons it is considered preferable to make loans rather than absolute gifts, inasmuch as persons are much more likely to value books so received and to read them, and can be more frequently and readily addressed by the collectors on the subject of religion. But your Committee have in no case deemed it proper to ask for a return of the book so loaned.

Your Committee have good reason to believe that the books thus loaned have never been given except when a disposition to read them has been manifested, and that they have been received always with thankfulness, and sometimes with deep emotions of gratitude.

One of the collectors reports as follows:—"The Bible which the Committee voted to be given to a poor family by the name of — was received with tears of gratitude, and a promise given that it would be read daily. The man said he

would pray for me which was all he could do. They have gone to the States, and I think it is the only book they possess."

Another collector reports:—"M. B. still wishes to have the loan of the Bible a little longer, until he obtains sufficient work to bring him in a larger amount of wages and enable him to purchase one." Surely the existence of cases like these and those following, which can only be reached by such an Association, afford a strong motive for maintaining with vigour the operations of the Society.

Another collector writes:—"We had a very long conversation with an old woman, whose husband had just died at a very advanced age; on asking the state of his mind before death, she told us that he was quite comfortable, never having injured any one, or spoken ill of his neighbours, and that 'the Clergy' had visited him regularly. We endeavoured to point out to her that the righteousness of Christ was the only true ground for a sinner's hope, but found it difficult to persuade her that any thing more was necessary than simply our own good works." Again, "We found a poor coloured man very ill with consumption, who told us that he had only one Bible and that too small for him to read; we immediately procured one from the Loan Stock for him."

Another collector writes:—"In the next house the only person we saw was a girl about eighteen, who seemed not to know any thing of the Bible; indeed, it was difficult to decide whether or not she had ever heard of it."

Another writes:—"I have a very interesting case in my District, in the person of a very aged woman, who is in feeble health and a great sufferer. She seems very anxious about the salvation of her soul, but quite unable to comprehend the glorious plan of salvation through a crucified Saviour, and cannot believe that so great a sinner as herself has any claim upon his mercy. She always entreats me with great earnestness to pray for her, and says, she will try to pray for herself when her body is not so racked with pain as to absorb all her attention. I believe she is perfectly sincere, and humbly trust that He who causes light to shine out of darkness, will illuminate her heart before He remove her hence. She owned a Bible, but her daughter had lent it to a man who was unwilling to part with it."

Your Committee trust that the importance of maintaining the Association will be recognized by all those who consider these facts, and who set a proper estimate upon the results, which under God's blessing are likely to follow, in some cases at least, of the number supplied by the Society; and although from the scantiness of the reports made by the collectors, it is not possible to state results with reference to more than a few instances, arising from the distribution of Bibles and Testaments; yet your Committee are unwilling to suppose that only in such instances has good been done. Reading the precious Word of Life may like the seed sown be long concealed before it becomes visible above the surface; and when, to this consideration is added the reflection, that the copies of the Scriptures distributed may sometimes be untouched, until sickness or calamity, or some providential event directs attention to them, and that then the finding of the Word of God, may be like the finding of hidden treasure, making rich unto salvation; and when it is also remembered, that one Bible may be the means of opening the eyes not only of the family, to which it is given, but to others connected with that family, it is impossible to deny that so long as there are families to be found unsupplied with the Word of God, so long should the Association continue its labours, and that they should not be discouraged, even though at some periods no sensible results may be traced. Had the Missionaries who carried the Gospel to heathen lands, been driven from their fields of labour, because their labours had continued for years without any apparent influence produced, many lands now enjoying the blessing of Christianity might have been still enveloped in the darkness of idolatry, superstition and heathenism. It becomes us all to adopt such means as are calculated to be

productive of good, and await patiently until it shall please the Almighty to bless our efforts, and your Committee pray that He whose servants they are, will strengthen and enable them to prosecute their labours with increasing energy and activity, and that he will move the hearts of increasing numbers to co-operate with them, and that He will abundantly bless his own Word to those who may have it placed in their hands, through the medium of the Association.
