An Act to confirm the titles of the persons therein named to certain lands in Simcoe and Windham, in the County of Norfolk.

MATHEREAS the persons hereinafter named have by their Petitions Preamble. represented,—that they did respectively at various times, purchase bona fide in fee and for fair and valuable consideration, from a person calling himself Richard Metcalfe House, but whose true name it now 5 appears was Richard Stanford Groves, certain lands hereinafter more particularly described, which lands had been surreptitiously conveyed by the said House, otherwise Groves, to his infant children, to avoid the anticipated consequences of a certain law-suit at the time of such conveyance pending against him: And whereas during the last Session of Par-10 liament, the said House alias Groves, joined in the representations and prayer of the said Petition, and further represented that no other person or persons, party or parties, other than the said House alias Groves, his said children and the said Petitioners, were or could be in any wise affected by the confirmation of the said titles of the said Petitioners; And 15 whereas the said House alias Groves has since absconded, and the petitioners have in consequence prayed that to quiet their said titles an Act may be passed confirming the same, and authorizing them severally to sell and convey the said lands if they shall think fit, free from incumbrances, and it is expedient to grant the prayer of the said Petition; 20 Therefore Her Majesty, &c., enacts as follows:
